Upon arrival, I approached the front door and could hear a male yelling inside the residence. I knocked on the door and rang the doorbell several times while continuing to hear the same male continuing to yell. After knocking on the door once more, I observed an adult male begin walking to the front door. The adult male that opened the door would later be identified as Brett Cervantes. Cervantes asked me to follow him into a sitting room to the right of the main entrance. I asked him what was going on and he stated his mom was getting upset.

From Cervantes, I could detect a strong odor of an intoxicating beverage emanating from his breath. He also slurred his words while he spoke.

Cervantes stated his mom got upset when he questioned her about hitting a black man with a cane the day prior. At that time, I heard an elderly voice calling for Cervantes from the kitchen. I asked him to stay seated on the couch while I went to his mother, Carmen Cervantes.

I met Carmen near the front door and she stated her son, Brett Cervantes, was out of control and threatening her. I asked Carmen if there was anyone else inside the house and she stated her assistant, Susan Kamman, was in the kitchen. At that time I again asked Cervantes to stay seated on the couch and asked Carmen to follow me so I could check on Kamman.

I located Kamman standing by the garage door in the kitchen. Kamman appeared frightened and was visibly shaking. I asked Kamman to follow me into the living room so I could watch Cervantes sitting on the couch and Carmen who was now sitting at the dining room table. I asked Kamman

what happened and she stated Carmen's son, Brett Cervantes, was extremely intoxicated and had been yelling at both of them for the last hour. It started with him shouting from the basement that she needed to leave the house. Kamman stated Cervantes came up into the living room and sat on the couch and would yell at his mother and her while they were conducting his mother's business. Kamman stated Cervantes eventually came over to the table and sat down, where he continued to yell, demanding she leave the house. Kamman said he continued to yell for her to leave and at one point he attempted to close her laptop computer, to which his mom yelled at him not to touch it. He then stood up and told his mom to stay out of it, turning back to Kamman, pointing at her and telling her to leave. Kamman stated when he stood up to yell at his mom he knocked several items off the table and chair next to her.

While speaking with Kamman, Cervantes got up from the couch and attempted to go downstairs before I stopped him and ordered him back to the couch.

Officer Lantz arrived on scene and stood with Cervantes in the sitting room.

I then began speaking with Carmen about what occurred. She stated her son had been staying there for a little over a year and a half. an alcoholic and has gone into treatment several times. This evening, he was extremely intoxicated and began to confront her about an incident he believed happened the day before. Carmen stated he yelled at her, saying, "You cannot raise your cane towards a nigger." Carmen said the African American gentleman, Mars Howard, who is an old friend, was in her house helping her move some of her son's items into storage. Cervantes has been getting drunk every night for the last three months and this is the worst. Carmen stated when he starts yelling and getting in her face, she is frightened he may do something more. She stated in the past, he has thrown his cell phone at her, which was unreported.

I asked Carmen what she would like done and she stated she would like him arrested and taken to the police station so he could sober up. Carmen also stated if he would just go downstairs and go to sleep, everything would be ok in the morning because he is a completely different person when not intoxicated. Carmen stated she would press charges if he will not calm down. Carmen stated this is abuse what he is doing to me.

I advised her I would try to speak to Cervantes and see if he would comply by going to the basement and staying there for tonight, so not to cause any further disturbance.

I asked Cervantes if we could go downstairs so I could speak to him in private and he stated that was fine. While in the basement, I advised Cervantes he would need to stay down there for the remainder of the night

so not to continue disturbing his mother and her assistant, Kamman. Cervantes began to argue with me, stating this was his house and he did not have to stay down there if he did not want to. He also said Kamman is his assistant and he wants her out of his house right now. I advised Cervantes that Kamman was there working for his mother at that time and his mother did not want her to go. Cervantes began yelling up the stairs for Kamman and his mother. I advised Cervantes if he would stay down there, we could go as long as he left his mother and Kamman alone, to which he replied, "I want her out of here and I'm not going to do anything until she's gone." I asked him to calm down and he yelled, "I want her gone."

At that time, I advised Cervantes he was under arrest for Peace Disturbance/Domestic Assault, and to turn around and placed his hands behind his back. Cervantes complied and as I placed the handcuff onto his left wrist, Cervantes immediately flexed his arms and tried to spin out of mine and Officer Lantz's control. Officer Lantz and I gave Cervantes several orders to stop fighting and to relax so we could get the handcuff on. Cervantes continued trying to pull away and to spin around to face us. I ordered Cervantes to go to the ground several times, to which he did not comply.

In front of us was a large oak desk and to my left side was a column from floor to ceiling preventing us from going that way. I took control of both Cervantes' arms, allowing Officer Lantz to reposition so we could take Cervantes down to the ground to the right. With his right arm under my control, I released his left arm with the handcuff attached and performed an arm bar to take him to the ground. While turning to the right, Cervantes fell forward with all his weight pulling away, striking his face onto the ground. I followed him to the ground, taking control of both arms and attempting to continue the handcuffing. Cervantes continued resisting by kicking his legs, flexing his arms, and attempting to roll to the right and left. I then noticed a large amount of blood on the carpet underneath his face, which was coming from his nose.

Let it be noted, during this process, he continued to yell for Kamman and his mom.

After securing his left and right arms in the handcuffs, he was pat down for any weapons while on the ground, which was negative.

I asked Officer Lantz to get on the radio and ask for an ambulance and a supervisor to respond.

I then stood Cervantes up and asked him to put on his shoes that were on the floor near us. Cervantes continued to be argumentative and trying to pull away from my control. Cervantes kept stating that now he wants to talk. After Cervantes refused several times to put his shoes on, I told him to go up the stairs, to which he did not comply. I ordered him to walk up the stairs again and began pushing him from behind while Officer Lantz was in front of him, pulling on him. Halfway up the stairs, Cervantes laid down and refused to go any further. He stated he wasn't going to do anything else until he could speak to Kamman and his mother. At that time, myself and Officer Lantz forcibly lifting him up, getting his feet back under him and ordered him up the stairs, to which he complied.

At the top of the stairs, he tried to force his way to the right so he could go to the kitchen where his mother and Kamman were at. Myself and Officer Lantz were able to get him out the front door and escort him to my patrol car. While walking, he continued to yell and try to pull away from us. As we left the driveway, he forcibly stopped himself and turned to the right and blew the blood from his nose and spit the blood from his mouth onto me. We continued escorting Cervantes to my patrol car, where we leaned him up against it, stating an ambulance was on the way and he needed to calm down. Officer Lantz and I had to maintain constant control because he would attempt to pull away and turn on us.

Cervantes continued to struggle with us. Officer Lantz and I escorted Cervantes to the side of the road, where we were able to lay him onto his side, under control to better control him in his extremely agitated state. Cervantes yelled at a car that was driving by and continued to yell for his mother and Kamman to come out there. While Cervantes was on the ground, he continued kicking, rolling and tried to get away. Cervantes stated he wanted to get up off the wet ground. I told him we were not going to let you because you spit your blood at me. Cervantes said he was sorry for spitting at me and would not do it again. This went on for several minutes until he began to calm down. I advised Cervantes if he would remain calm for a minute, I would sit him up and if he was calm there for another minute, I would stand him up again to get us off the wet ground.

At that time, Monarch Fire Protection District Ambulance #2217 arrived on scene with Sgt. Bruegenhemke, DSN 5194, right behind.

We stood Cervantes up and escorted him to the back of the ambulance, where he was evaluated by paramedics.

Officer Lantz and Sgt. Bruegenhemke remained outside while I returned inside to collect further information from his mom and Kamman. While inside, I advised Carmen of the situation, told her he was going to be charged for Domestic Disturbance, Resisting Arrest and Assault on Law Enforcement Officer. Carmen immediately apologized for her son's behavior. Carmen stated when he is intoxicated, he becomes very violent

and argumentative and it continues to get worse until he stops drinking. Carmen stated he was extremely intoxicated tonight and had already fallen down the stairs a couple of times.

While speaking to Kamman again, she recalled while he was yelling at her he yelled at her that he had called her husband, Dennis, and he wanted her to go home. Kamman stated she called her husband, Dennis, and he told her Cervantes had not spoken to him that night. Again, both Carmen and Kamman stated they were very fearful of Cervantes and he was out of control. Kamman added she had been his friend for 14 years and has never seen him like this.

Officer Murphy, DSN 5253, who arrived on scene, escorted Monarch Fire Protection District to St. Luke's Hospital with Cervantes. A fit for confinement was obtained from Dr. M. Walsma. The doctor's findings were that his nose was not broken but was bleeding from trauma to his nose. There was no report of teeth, head, neck or back injury.

After obtaining the fit for confinement, Officer Murphy transported Cervantes to the Chesterfield Police Department, where he was booked on the charges of Domestic Disturbance, Resisting Arrest and Assault on Law Enforcement Officer.

Officer Caswell, DSN 5119, responded to the station to photograph the blood that was spit onto my uniform shirt for evidentiary purposes. See his supplemental report for further.

Cervantes was issued summonses for these charges and was available for bond after he had sobered up.

Nothing further.

#### NARRATIVE

In reference to the above listed case, I wish to add the following:
