# ALDERWOMAN QUESTIONS IF I KNOW WHAT I'M TALKING ABOUT AND QUESTIONS MY RECOLLECTION OF THE 2006 FIRE DISTRICT ANNEXATION

**ATTEMPT**: Ald. Lindsey Butler is not happy with my last newsletter and questioned my memory of the facts concerning the attempt annexation of Town and Country by the

West CO EMS & Fire Protection District in 2006 four years before she and her husband moved to Town and Country. Here is what she wrote me.

First, my suggestion to have the voters decide if we join the district is an example of true representative government. If the voters in any election (April or November) choose to do something then we know their will. Stating that April is low turnout and so shouldn't matter would affect the outcome of every elected officials seat. If the peoples will is to not join, then the city moves forward with knowing that we need to continue paying out of our budget. We also have an option to renegotiate or send out to bid. Either way, our expenses are going up with increased development in our town. In my opinion, the Mayor brought it up to try and confuse the true discussion, as we go into an election cycle. I didn't bring it up on Monday since I had already requested info from Ashley McNamara and Steve Garrett, so I was waiting on that info before speaking on the subject. Also, you suggested a property tax of \$0.20/100 instead of joining the district, which is still a tax on the people, but will also need to be discussed as our revenues are not increasing rapidly enough to cover costs. I just want the discussion to happen openly and not behind closed doors. The people should decide yes or no.

I have heard varying facts from several sources on the 2006 annexation talk and they differ from yours. The fact is that the city doesn't provide fire service, we pay for fire service and always will. So, we can ask voters their opinion on the matter and then go from there with bids and contracts. I want transparency and voter input. I will sunshine (if still available) all the correspondence from the residents that may have spoken up in 2006 on the annexation topic. The fact is that the new Board as you stated is also representative of new residents that may have not lived here then. But, overall a vote was never taken in 2006 and so the views were not heard. I am fine with a vote of yes or no, but unsure of your reasoning for not wanting the people to be part of the conversation on their service and taxes and then be the sole voice in deciding the fate of both.

Lindsey Butler questions my opinions and research into the 2006 annexation attempt by the fire district. Here is a brief statement of facts I wrote to several members of the media, then followed by emails to me on the annexation issue.

#### A 2006 Email from me to News Media:

Since 1983 the City of Town Country has had a contract with West County EMS and Fire Protection District (formerly Manchester Fire Protection District). Mayor Jon Dalton in December signed a new 5-year contract \$3.4 million-a-year deal with West CO EMS&FPD that took effect on January 1, 2006.

In February, just weeks after beginning a new contract the Fire District mounted a petition drive to annex all of the City of Town and Country. Currently the city property tax rate is zero and funds for city services, including funding the police department and the fire contract come out of sales taxes and commercial licenses and fees. Suddenly the fire district that just signed a new contract was trying to void the contract by annexing the City. Oddly Mayor Jon Dalton did not seem to be outraged that his residents would suddenly be paying 84-cents on each

\$100 evaluation to support services they were currently paying zero in property taxes for. .

The fire district hired political activists and their own off-duty firefighters who they sent in uniform into the neighborhoods collecting signatures. The fire department also hired a consultant and had architectural drawing of a new fire station they proposed building. However, Town and County was only averaging 1.8 calls a day for the fire truck and there was no large increase projected for fire service over the next 20-years.

It was then discovered that in 2005 when Mayor Dalton appointed a committee to review fire and EMS service and when he signed the contract he had actually been a paid LOBBYIST for the West County EMS and Fire Protection District in Jefferson City. He attempted to block release of his committee's report which recommended to the Board of Aldermen that the City help the fire district pass an annexation election.

(Although some committee members deny agreeing to such a recommendation.)

In late August there was enough backlash on the annexation issue from Town and Country citizens that the City hired a consultant (the second paid consultant on fire and EMS issues in two years) and the mayor applied pressure for the Fire District to drop the annexation election. In a special closed meeting and then in a hastily called Monday morning special meeting, the Fire Board decided to drop the annexation attempt.

If the fire district spent too much time and resources in Town and Country answering calls, why did they not simply stop providing fire service by letting the contract expire?

How much money did the fire district spend for this proposed annexation, including the architects for the proposed new fire station, political petition canvassers and off-duty union firefightersg, plus a consultant on an election that no one in Town and Country was interested in starting themselves?

How much did the City of Town and Country spend on two consultants within a year looking at the same issue, plus budgeted special mailings all the while the citizens being in the dark of the mayor's paid connection to the fire district? Why did not the mayor recuse himself from the entire issue of EMS and Fire Service knowing he had represented the Fire District.

This is everybody's money as Town and Country operates mostly on sales taxes...and business fees that are paid by people who are not residents.

Is this an example of "unnecessary use of equipment": A man up the street had a heart attack or stroke a few months ago, and the police were the first responders, but then came two more police cars, two fire trucks, and two paramedic vans. I wonder if the EMS & Fire District logs a call for each of those 4 fire/paramedic vehicles. I would like to see what you've presented previously. I think now when I speak Monday night I will just refer to what you and Mariette have presented, instead of trying to gin something up.

In a surprising twist, the West County EMS-Fire District Board voted unanimously last Thursday evening, August 24,2006, at 10:30 PM to withdraw its ballot initiative to annex the City of Town and Country into its

district. The withdrawal will be complete by 5:00 this afternoon. The letter requesting formal withdrawal is already in the hands of the St. Louis County Election Board

Mayor Dalton had been in conversation with the fire board and with Chief Dave Frazier for the prior week or so. He had informed them of the overwhelming opposition, of the fact that their initiative would never pass. He suggested that in view of the some twenty year congenial relationship we have had with the district, that the fire board ought to bring the matter to closure. The fire board apparently agreed. ...

Apparently being a former lobbyist for the Fire District, Mayor Dalton really knew what he was talking about when he was quoted in the paper saying for people not to be naive thinking the fire issue would not come up again, when the Fire District removed the annexation issue from the ballot. Hell it's only been six weeks!!!

I can only hope that the Board of Aldermen demand an answer from their contractor, the West County EMS and Fire Protection District concerning any knowledge as to who sent this mailing. This was a \$1,000 mailing, someone knows who did it. I also hope the Board posts on the T&C website our review of Ludwig Report and other information, such as the very small number of actual fire and EMS calls on a daily basis. The time is getting closer and closer for the City to consider its only fire and EMS service, if the Fire District doesn't want to shut up and honor the five-year contract. It seems as if the Fire District did not even wait until 2007 before starting another campaign!

**KEITH CHEUNG IS BACK IN TOWN AND COUNTRY COURTS AFTER BEING FIRED BY MAYOR DALTON:** In January of 2011 Keith Cheung was forced to take an indefinite leave in his position as Town and Country City Prosecutor. The move was made by Mayor Jon Dalton after Cheung, a member of the Curtis, Heinz, Garret and O'Keefe law firm, was disciplined by the Missouri Supreme Court for passing a note to a

County Judge during the trial of the Bella Villa Police Chief saying the judge needed to convict the police chief.

According to documents concerning the case, the judge stopped the trial, called the prosecutor, defense attorney and then Cheung into his Chambers at which time Cheung lied about the note. Here is the Supreme Court Reprimand:

March 1, 2011

Supreme Court No. SC91466

#### **ORDER**

Now at this day, the Court being sufficiently advised of and concerning the premises and having considered the statement of acceptance of the Disciplinary Hearing Panel decision pursuant to Rule 5.19(c);

The Court finds that the Respondent violated Rules 4-8.4(d), 4-8.4(c), and 4-3.5(d) of the Rules of Professional Conduct and should be disciplined;

Now, therefore, it is hereby ordered by this Court that the Respondent Keith K. Cheung is hereby reprimanded.

Fee pursuant to Rule 5.19(h) in the amount of \$750.00 payable to the Clerk of this Court to the credit of the Advisory Committee Fund taxed to Respondent.



Cheung, the lawyer representing the Ellisville City Council in their impeachment of Mayor Adam Paul, packing up after an impeachment hearing. Cheung's work was overturned by a Circuit Court judge who found no foundation for the impeachment

alleged by Cheung. Allegations against Paul by Cheung included that Paul talked to a resident about an issue before the Council.

While Cheung was on "Extended Leave" as prosecutor in Town and Country and fired in Ballwin, he represented a 4-time drunk driver in a T&C case. Here is what we wrote in 2013

Thomas M. Grate & Keith Cheung: Thomas Grate, 31, of 16567 Clayton Road in Wildwood has been convicted of DWI three times and was recently arrested for a fourth DWI in Town and Country. Grate was arrested passed out behind the wheel of his running automobile in Town and Country wine country, the subdivision off of Clayton where the streets all have wine names. He was arrested on Cabernet Drive at 4:09 in the afternoon on June 6. He was charged as a felony Persistent DWI offender on June 28.

Grate's attorney is Keith Cheung the former prosecutor in Town and Country, whose firm Curtis, Heinz, Garrett and O'Keefe still provides Town and Country with a City Attorney, Planning and Zoning Attorney and prosecutor. Cheung is also the current municipal judge in Ladue, Missouri. You likely also have been reading Cheung's name in this newsletter or the Post-Dispatch as he was the prosecutor in the ill-fated impeachment of Ellisville Mayor Adam Paul.

There is no reason for Cheung to ever again handle any cases as an assistant Town and Country Prosecutor. Of course his record has not bothered the City of Ladue, where Cheung is city judge or the City of Frontenac where he is the city prosecutor. These are excellent reasons why the municipal court system desperately needs to be overhauled and cleaned up.

Mayor Dalton keeps showing up for the lighting of the Maria de Villa Christmas tree located in front of the Senior Living Facility between the parking lot and the street. You might think the new Official City Gathering Place would have the city's official Christmas Tree, but it doesn't. I'm sure the users of the Town Square who gather on a daily basis (the geese) would appreciate it.

**SECOND TIME IN TWO MONTHS DALTON'S NOMINEE FOR EMPTY BOARD OF ALDERMEN SEAT WITHDRAWS**: Mayor Jon "Ethics Law Breaker, Cigarette Lobbyist and Stealer of Widow's Property for Nightclubs that Never Got Built" Dalton is 0-for-2 in finding people he nominates to fill an empty seat on the Board of Aldermen to stick around long enough to be confirmed by the Board of Aldermen.

Skip Mange quit was Ward 1 Alderman in the middle of September. Dalton announced it was very important to fill Mange's seat.

On October 11, 2019 Dalton announced his selection to replace Mange as Jon Serkes, who lives in the Barrington subdivision and was a former Frontenac Aldermen before moving to Town and Country. Dalton called for a special Aldermanic meeting at 6PM before the regular meeting on Monday October 14.

A number of alderpersons balked at not having a chance to review Serkes's background and speak with him. The confirmation was continued until October 28, but never occurred as Serkes withdrew from consideration.

Next at the November 25<sup>th</sup> Aldermanic meeting Dalton announced that he was nominating Ben Lawler, vice-president of Tom James, a men's suit company. The confirmation was then scheduled for Monday December 9.

The agenda for the 12/09 meeting was released on Friday December 6. The confirmation of Lawler was not on the agenda.

At the December 9 Board of Aldermen meeting I asked several people about the missing Lawler and missing agenda item.

On person motioned his head toward Dalton and said "You would have to ask him." Another said he didn't know. I emailed two alderpersons after the meeting and was told Lawler, like Serkes withdrew his name.

The December 9 meeting was the last one for the year. So that seat that had to be filled right away will have gone four months remaining empty. If Dalton finds someone to appoint their term would only be for three months or six meetings as the municipal election is on April 7.






**THEN AND NOW**: The supervisor of the Chesterfield Police Record was away and took a week to my request for mug shots of the suspects, Michael Pribble, 29, and

Shelby Roettger, 25, so I had to use some old mug shots I found online. Pribble's was from 2017 and Roettger's photo was from 2014. The pair committed a shoplifting theft from Wal Mart, a car chase ending in a crash, then fleeing the scene and eluding a search by officers, police dogs and a helicopter, then burglarizing an occupied house and finally asking a plain clothes police officer in an unmarked car if he could give them a ride. Both Pribble and Roettger are drug addicts with many drug arrests.

When I got the current mug shots from December 2, 2019 I almost gasped in the physical difference in the suspects over a few years.



# BRIDGETON MAN AND CHESTERFIELD WOMAN CHARGED WITH ARMED ROBBERY AND BURGALRY OF CHESTERFIELD RESIDENCE. On Sunday

November 17, 2019 several people led by Jesse Robinson, 22, of Bridgeton broke into the house at 1593 Claymont Estates Court and at gun point forced the resident, Adam Fox, to give up property. The house is also the residence of Wendy Fox who according to charging documents as not present at the time of the crime. In the getaway car was a Chesterfield resident, Katherine Skordos, 20 of 15485 Strollways Drive.

The suspects were armed with handguns or BB guns that resembled handguns. St. Charles Police later arrested the group for another robbery and shooting at cars.

18-6344 - Katherine Skordos was the driver of her Nissan Sentra and had two other subjects (co-defendant I.H. and a juvenile suspect) as passengers. Katherine said that they "evenly shot at things," 'Katherine stated that they saw a subject in a white car (identified as the victim C.L.) and she had a "gun in her hand" and she "scared him" and they drove off. Through co-defendant statement and the victim's statement, Katherine said to him "Do you want to die" while pointing the weapon at him. It was also their intention to "scare the victim" and they were "taunting" him. It should be noted that the BB Gun did resemble a real gun. According to the victim, he was emotionally distraught and believed that the weapon was real. While viewing Door Bell Camera Footage of the victim arriving home after the incident, you can see him visibly upset running into his residence and shouting that subjects just pointed a gun at him.

18-6343 - Katherine Skordos advised that she did "yell at the pizza guy and we scared him" and they took \$20.00 dollars from him. Katherine was identified by the victim (through a photo line up) as being the subject who was pointing the weapon at him and demanded the money. The victim said that the weapon did look real and he was emotionally distraught after the incident. The victim said he was in fear of his life which is why he gave them "what ever they wanted." Katerine did admit to saying to the victim "Do you want to die" and the victim said that right after she said that he provided her the money because he did not want to be shot.

The suspect vehicle was stopped and all three suspects were located within. Also located in the vehicle was two BB Guns that resembled real looking weapons. One of the BB Guns appears to be manufactured by "Glock" and had a light attached to it. The guns very much so resembled real lirearms and did not contain a orange tip. Also currency was located in the vehicle; however, the occupants claim it was theirs. Katherine said the stolen money was evenly distributed while another co-defendant said that the money was used to purchase gas or a BB Gun the evening after the incidents occurred.



### "SIDE ACCESS" DAN HURT OUT OF LUCK ON EATHERTON ROAD REZONING:

The first item discussed at the Chesterfield Planning and Public Works meeting was rezoning one 1-acre lot currently "Non-Urban" to "Planned Industrial" which is the zoning of the adjoining one acre lot at 318. N. Eatherton Road.



The City Planning Department found no issues with this rezoning request. But someone did.

In this case, with doing ZERO research Councilman "Mr Side Access" Dan Hurt is always looking for side or cross access to newly zoned lots saying it might be needed 50 years from now. He said he would "like to see the road across the street (Eatherton Road) have access to the property."

Planning Director Justin Wyse then mentioned that would not be something for Chesterfield to deal with. "That would be up to the City of Wildwood as that road is in Wildwood," said Wyse.

Actually it is not a public road, but a private road/driveway. (The Eatherton Road is in Chesterfield, but everything to the west from the edge of the road is in Wildwood.)



CHANGES TO PUBLIC HEARING SIGNS: At the last Planning and Public Works Committee there was a discussion that the current signs were to hard to read and staff was questioned about changing signs. Planning Director Justin Wyse said the current signs cost about \$30 and can not be reused as the date of the Planning Commission meeting on the sign is done by permanent marker. He then showed four sign sign mock ups.

Two councilperson said they thought the date on the sign was importment. Dan Hurt said it was misleading as matters can be continued. Mary Monachella said she liked the date, because without a deadline she would keep putting off calling to find out about the proporal..

Justin Wyse said the problem with signs with the Planning Commission date is you can only put them up 15 days in advance once the Planning Commission agenda is set. Without the date you can post the property for a longer period.

It was finally decided that the phone number to the Planning Department was the most important thing. It was suggested to drop the city's web address to allow the phone number to be larger.

The sign design was sent back for tweaking.

ASH TREE REMOVAL UPDATE AND 2020 BUDGET PROPOSALS: Jim Eckrich, the city's Public Works Director laid out the costs for 2020 as the Ash tree removal program enters its fifth year. The trees are beinig removed due to Ash Bore infestations that are killing the trees and making them dangerous. The city trees being removed are mostly on residential streets between the sidewalk and the street.

Through October 31 3,709 trees have been removed down slightly from the projected target of 3,840. Erkrich said the city was following behind due to having to deal with some larger trees. There is one street crew assinged exclusively to Ash tree removal. But there are additional costs.

- 1) \$300,000 is budgeted for contractors to repair sidewalks or streets damaged due to removal of trees with large roots or trees that had damaged sidewalks due to growth.
- **2) \$85,000** for contract tree service to deal with problem removal, such as trees under or having grown into utility wires.
- **3)** \$30,000 for stump grinding. This is down from \$75,000 in prior budgets due to unused funds.

- **4)** \$100,000 for planting new non-ash trees. Homeowners or subdivisions pay a portion for reforestation. The city estimates planting 520 new trees in 2020.
- **5)** \$45,000 for a temporary but full time employee to oversee the removal program.

It is projected the Ash Tree Removal Program for 2020 will cost about \$560,000.

The estimated final date of Ash Tree removal is 2022.

Councilman Tom DeCampi felt the temporary full time employee at \$45,000 was unnecessary. Jim Erkich said to remove that position would require members of removal crew to do administrative work/duties and slow tree removal.

The measure passed on a 3-to-1 vote with DeCampi voting no.

**WHERE DOES THE TIME GO?** The Washington Post reported on Tuesday who Pete Rahn just resigned effective in January as the director of Maryland Department of Transportation, s job he held since 2015. From 2004 to 2010 Rahn was the Director of MoDot.

Us old people immediately remember the name Pete Rahn because Pete Ryan was the Radio-TV columnist at the Globe Democrat for over three decades, in a 47-year career at the paper. Pete died on November 5, 2017. Pete Rahn the transportation guy is not the son of Pete the newspaper guy, but you would not think so looking at these two photos.





Pete Rahn at the Globe Democrat is credited with designing one of the first TV schedules for newspapers, when the four TV stations' shows would take ½ of the page top to bottom. Later the Globe-Democrat being the morning paper would list shows from sign-on to 6pm and the Post-Dispath as the afternoon paper would list them from 3-to-midnight.

Pete was originally listed the Radio-TV columnist for the Globe. In the early 1960s the paper would list the programs on the radio also. Radio personalities on KMOX, KSD, KXOX, KWK, WEW and KATZ still had followings.

By the 70's Pete was listed as the TV-Radio columnist.
