Here is the story: Graham has a habit of letting her dogs out the backdoor but she has no fence and the dogs often head toward I-270. She lives on Long Meadow Lane next to a road next to I-270.

The police kept writing her citations and it was not having any effect. The concern was about three issues.

- 1) The Dogs on I-270 could cause a serious crash of motorists trying to avoid hitting them.
- 2) The dogs could be hit and killed.
- 3) A police officer or dog loving motorist trying to rescue the dogs could be hit and killed.

So they decided to start arresting her for Cruelty to Animals. The first attempt included an addition charge of resisting arrest.



Here are the dogs on her website. Apparently Archie, who is the subject of a court order is the dog in the car on the right.



Last week T&C prosecutor Keith Cheung went to the Circuit Court looking for a court order to Graham reference the dogs. Here that is:

CONSENT ORDER AND JUDGMENT

Upon the joint application of the parties, the Court being fully advised enters the following Order and Judgment on Plaintiff, City of Town and Country, Missouri's Motion for Preliminary Injunction:

1. Defendant will immediately remove "Archie" the dog from the Property and ensure that "Archie" the dog is neither kept, harbored nor present in the City of Town and Country until after such date that a permanent, wired invisible fence system is properly installed at 14 Long Meadow Lane; "Archie" the dog has completed all training from Invisible Fence of St. Louis; and said system is inspected, and deemed satisfactory, by the City of Town and Country's designee.
2. Defendant will ensure that the invisible fence and all necessary components remain in place and properly functioning at all times.
3. Defendant has provided a signed contract with Invisible Fence of St. Louis with the estimated dates for installation of the permanent invisible fence system and any necessary training dates. Said contract is attached hereto as Exhibit A. The installation and training shall be completed by April 1, 2022. Any proposed changes to the estimated dates for installation of the fence system, or training dates, shall be provided in writing to Plaintiff and said proposed changes require written consent of Plaintiff, which consent shall not be unreasonably withheld.

4. Defendant shall cause "Archie" the dog to be present at 14 Long Meadows Lane, Town and Country, Missouri 63131 for training on the following dates and times:

March 11, 2022 beginning at Noon until training is complete,
March 15, 2022 beginning at 8:00 A.M. until training is complete, and
March 22, 2022 beginning at 8:00 A.M. until training is complete.

Should changes to the above training dates and times, or additional training be required beyond what is mentioned, Defendant shall notify Plaintiff in writing of the proposed changes or additional training dates and times, and receive express written consent from Plaintiff to conduct said trainings, which consent shall not be unreasonably withheld

6. Defendant shall notify Plaintiff upon completion of the installation and training, and schedule with Plaintiff an inspection of the invisible fence system. Said inspection shall occur within (5) days of said notification by Defendant.

7. Notice shall be given by Plaintiff to Defendant's attorney, Chad M. deRoode at cderoode@mlklaw.com, and by Defendant to Plaintiff's attorneys Keith Cheung at kcheung@chgolaw.com or Craig Smith at csmith@chgolaw.com.


5. In the event the invisible fence system is not fully installed and the training completed prior April 1, 2022, or other date consented to by Plaintiff, this matter shall be set for a hearing on Plaintiff's request for Permanent Mandatory Injunction on May 10, 2022 at 10:00am. or as soon as practicable by the Court.

6. This Preliminary Injunction shall remain in effect until either: (1) Plaintiff files confirmation with this Court that the permanent invisible fence has been installed, inspected, functions and is approved by Plaintiff; or (2) the date of the hearing on the Permanent Mandatory Injunction.

WHEREFORE, it is hereby adjudged, ordered and decreed that the Plaintiff's Request for Preliminary Injunction is GRANTED as set forth herein.

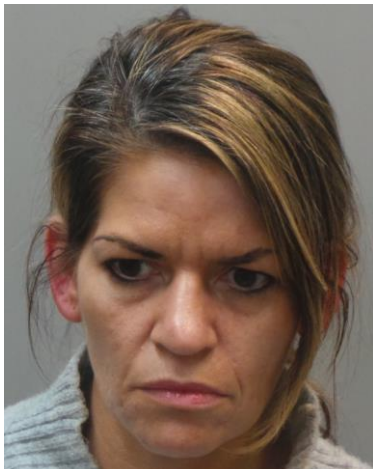

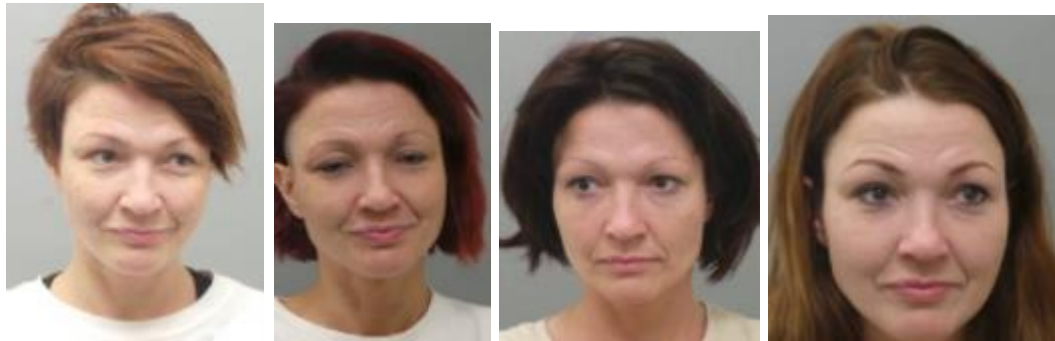

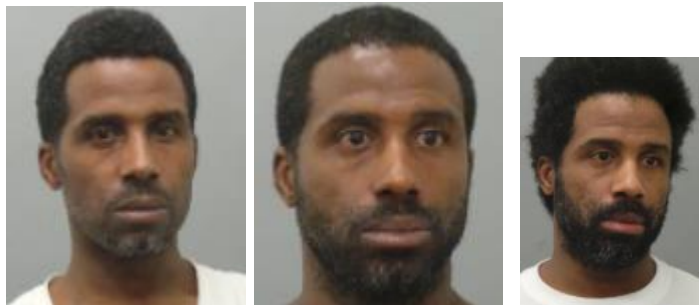

He was taken into custody Monday, June 17, and he was released the same day, according to court records.

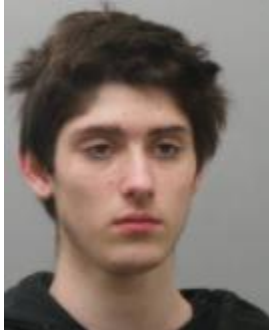

George Stock, whose engineering firm represents many developers and property owners before local city governments has the shopping center Town and Country Crossing as a client. As we reported in the past T&C Crossing wants to expand a building and reduce the east entrance to the center's promenade and water feature for a Chase Bank.

The project was voted down by the Planning and Zoning Commission on a 7-2 vote in February. That means the proposal pushed by Stock would need a super majority of at least six to be approved by the Board of Aldermen.

With only five aldermen in attendance on the dais voting it would be impossible to get a "super majority" vote. Stock requested the agenda items for the project be continued to the next meeting. It was a 5-0 vote to approve the continuance.

POLICE CHIEF James Cavins gave a short report on the city's one Flock Camera, plus three in subdivisions. These cameras are part of a system where stolen car license plates, stolen license plates themselves and persons with warrants connected to the license plates of car they were driving when first contacted by police plus the plates of cars used in crimes and kidnappings are all entered into a computer system.

The flock camera obtains the video of the license plate of a car that passes it and then compares it to its file base. If there is a hit an immediate notification goes to the local police.



Chief Cavins said that since January 24 thanks to the Flock camera the police have recovered a stolen car and made an arrest, recovered stolen license plates and arrested four people with outstanding warrants.

Chief Cavins added that there are three subdivisions with Flock camera that all are tied to the Police dispatch system.

Chief Cavins said that all the departments dispatched from the West County Police Dispatch out of the T&C station have Flock cameras Creve Coeur (with 3), Frontenac, and Ladue.

Chesterfield Police Chief Ray Johnston tells us that Chesterfield has 3 flock cameras on order and three subdivisions have cameras plus The District retail and entertainment center has 10 cameras accessible by Chesterfield PD.

PLENTY OF MONEY LEFT FOR A SPRING SNOWSTORM: City Administrator Bob Shelton announced at the beginning of the meeting that \$190,000 was budgeted for contractors to plow and treat city streets. (The City uses contractors for most Public Works functions with only two full time PW employees.) To date for the winter the City has only been billed \$105,000 for snow removal and paid the employees \$2,000 for overtime for plowing in two city trucks, leaving \$83,000 on the books for any Spring snow storms.
