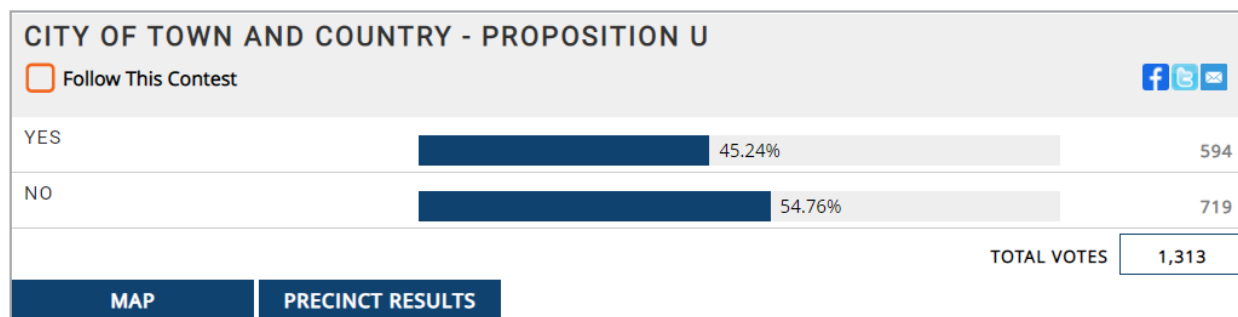
TOWN AND COUNTRY INTERNET SALES TAX LOSES FOR SECOND YEAR IN A ROW. Only a small number of Town and Country residents showed up to vote in Tuesday city election. All the aldermanic races were unopposed.

The race with the most votes in a town of 11,000 was Prop U to start charging city sales taxes on Internet purchased goods.

1,313 people voted on Prop U and it lost by a fairly large margin of NO-718, Yes 594.

This cost the city, as city wide mailers were sent out and the website had posts from the city urging people to vote yes.

An important thing to remember was Town and Country was originally populated by retirees moving out from Webster Groves and Kirkwood looking for one story ranch houses. While McMansions are taking over and more children moving into houses, there are still a number of retirees who really don't want to pay more taxes.



WEED HEADS TO PAY MORE FOR THEIR GRASS AT SHOPS: The proposal to add an additional 3% sales tax on top of regular sales tax on marijuana from approved shops passed the county wide ballot with 65% of the vote.

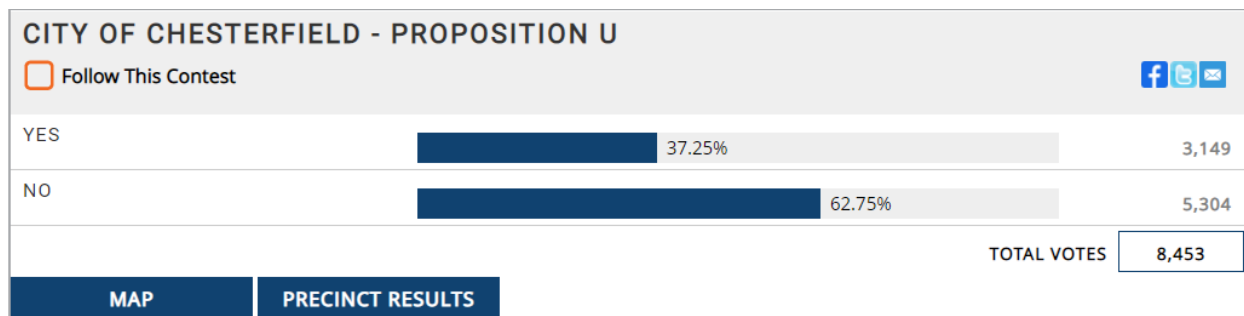

CHESTERFIELD VOTERS FOR SECOND YEAR IN A ROW LOUDLY TURNED DOWN SALES TAX ON INTERNET PURCHASES.

Unlike a closer election in Town and Country, voters loudly said NO at the polls on Tuesday defeating the Prop U tax issue with 59.13% NO votes. Voters were sending a clear message to Mayor Bob Nation, the City Council and staff after they voted against the sales tax in 2022.



Maybe the City should take a year off on this issue, as the NO votes remain high.

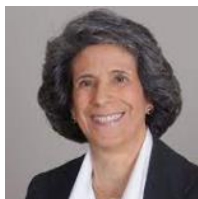
WAHL DEFEATS RIGHT WINGER TOCCO. Incumbent Aaron Wahl won his second term to the Chesterfield Ward 2 council seat 114-101 over right winger Patricia Tocco. 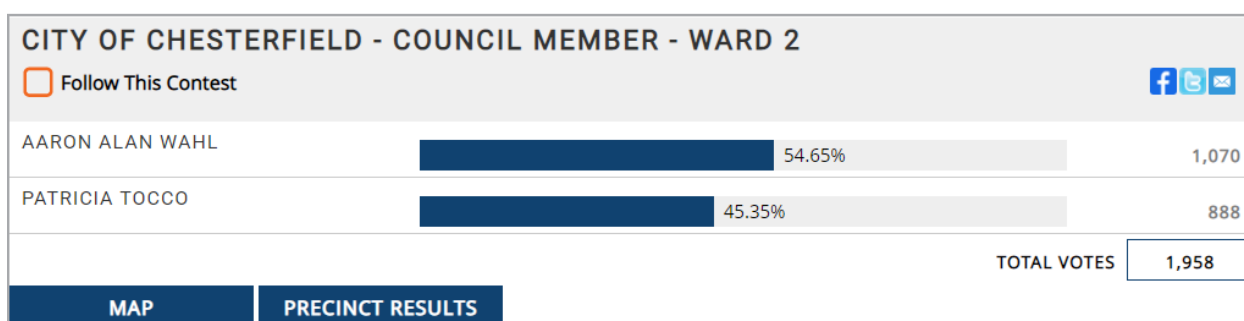

SPEAKING OF DECAMPI: The day before the election Tom DeCampi was fined \$2,000 (reduced to \$200) by the Missouri Ethics Commission for failing to report \$13,535 from his campaign fund to Ben Keathley who at the time was running for mayor against Bob Nation. DeCampi withdrew from the race after police had to remove him and his son from Best Buy for not wearing required masks at the height of the COVID pandemic. The \$13,535 went to mailers for Ben Keathley.

5. In the weeks leading up to the April 6, 2021, general election, Respondents directed the production and distribution of mailers that could reasonably be interpreted to advocate for a candidate and oppose another candidate in the April 6, 2021, general election.

6. After the election, on or about April 8, 2021, Respondents paid an invoice in the amount of \$13,535.22 for the production and distribution of the mailers.

7. Respondents did not file an 8 Day Before Report for the incurred expenditure associated with the mailers for the April 6, 2021, general election.

8. In the alternative, Respondents did not file a 30 Day After Election Report for the paid expenditure associated with the mailers for the April 6, 2021, general election.

9. The expense associated with the mailers was instead reported on the 2021 July Quarterly Report.

North Outer 40- On 2/17/2023 a white truck and a red car were involved in a road rage incident. Both vehicles pulled onto the parking lot of Top Golf and parked in separate rows. The driver of the white truck exited his vehicle, approached the 4 occupants inside the red car, and flourished a knife. One of the occupants of the red car showed the suspect he possessed a firearm. The suspect retreated to his truck, retrieved a 40 caliber Taurus handgun, and approached the car a second time while pointing his gun at the victims inside the red car. Two of the victims fled from the car on foot and contacted an Officer working a secondary assignment at Top Golf. The two victims remaining in the red car drove away from the suspect. The suspect returned to his truck, pursued them, and intentionally crashed into the red car on the lot of Main Event. Responding Officers located the truck, stopped it, and arrested the driver. At the time of his arrest, the suspect was in possession of the handgun and the knife. A computer records check revealed the suspect had a felony assault warrant from a jurisdiction in Illinois. Officers booked the suspect for Assault 2nd, Unlawful Use of a Weapon, Armed Criminal Action, Unlawful Possession of a Firearm (for possessing a firearm while a fugitive from justice), Property Damage, and the fugitive charge. In custody warrants were obtained with a bond of \$75,000.

BURGLARY 2ND

Finger Lake Drive- On 2/9/2023 officers responded to a call for a Burglary in progress The victims, who were not at home called in the burglary, as they were alerted by their camera system. The suspects gained entry after breaking the rear glass door. The victim gave a description of the vehicle that the suspects left in and a responding officer spotted it and attempted to stop it. The occupants jumped out of the vehicle, allowing it to continue into a wooded area off of Conway Rd. There were four suspects that ran into the woods. Officers pursued on foot and were able to take one suspect into custody. A perimeter was set up around the area and assistance in the form of two K-9 s and the County Helicopter were used. Assistance was also provided by the police departments of Town and Country, Ellisville and St. Louis County. No other suspects were located. The suspect who was taken into custody is a 41-year-old Columbian national. Warrants were obtained for Burglary 2nd Degree and Stealing Over. His Bond was set at \$50,000.

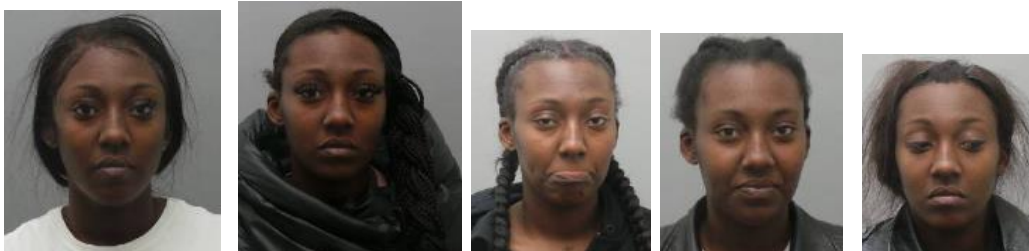

Officers of this department responded to calls for service to include sick cases, check welfare, suspicious persons, suspicious autos, alarms and persons with emotional issues while providing preventative patrols of residential neighborhoods and businesses.

At 0143AM, a call for an **Officer in Need of Aid** came out at I70 and 270. Officers from a St. Charles stolen vehicle task force had stopped a vehicle at this location and while conducting an investigation were struck by another vehicle. Four officers were injured with one being flown by helicopter to a hospital, one being transported by another police vehicle to the hospital, and the other two being transported by ambulance. Multiple civilians were also injured in the crash. The entire highway was shut down until all the injured were accounted for. Three chesterfield officers along with officers from Ellisville, Wildwood, Eureka, Ballwin, Manchester, Town and Country, and Creve Coeur responded to help with scene control. The Chesterfield officers reported a massive response from multiple other police agencies as well and returned to venue a half hour later as the Missouri State Highway Patrol took over the investigation. At the time of this report, the condition of the officers is unknown.

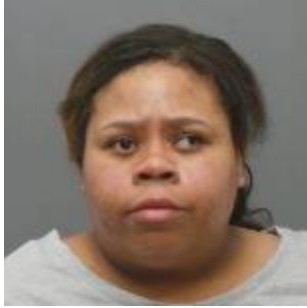

WE SAY GOODBYE TO A GUY WHO WOULD MAKE US LAUGH: Maybe it was because we lived in Washington DC for 16 years and enjoyed laughing at politicians, so we took notice of the death of Mark Russell. Mark was a political satirist who did his work in songs.



Mark, who took shots at both parties, was a comedy figure in D.C. playing a piano and singing his latest work in D.C. nightclubs, on stage and a regular on NPR and PBS broadcasts.

This are parts from a Washington Post obit after his death at 90, last week.

[Long an institution](#) on Washington's stages and in hotel bars, Mr. Russell gained a national following on public television, where for 30 years he made regular broadcasts. In the 1980s and 1990s, he took his show on the road, appearing in public and corporate venues in cities and towns across the country.

Mr. Russell composed and sang the material while accompanying himself on a piano, which for most of his career he played while standing up. He eventually decided that playing seated gave him more alacrity on the keyboard and was easier to improvise. "If a joke dies," he said, "it's easier to fill in."

Inspired by the social satirist Tom Lehrer and the comedian [Mort Sahl](#), Mr. Russell's humor could be biting and sarcastic, but his tone was amicable and good-natured and often had the ring of one friend teasing another. He aimed his satirical arrows at Republicans and Democrats alike. Each party, he said, "thinks the other has no sense of humor. They are both wrong."

Inspired by the social satirist Tom Lehrer and the comedian [Mort Sahl](#), Mr. Russell's humor could be biting and sarcastic, but his tone was amicable and good-natured and often had the ring of one friend teasing another. He aimed his satirical arrows at Republicans and Democrats alike. Each party, he said, "thinks the other has no sense of humor. They are both wrong."

So rich in satire were those Watergate years, Mr. Russell once said, that he could “just rip and read” his material right off the wire-service tickers. After President Richard M. Nixon resigned, he said, “I had to go back to writing my own material.”

The problem for Russell was that his material dealt with current politics. Unlike the Smothers Brothers and other comics of the time, people had a tendency to forget about one political event and move on to a more current one.
