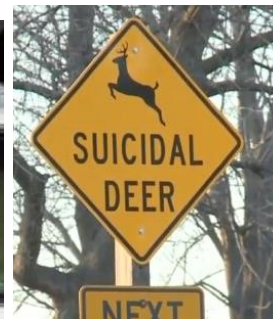

TOWN & COUNTRY ALDERMANIC MEETING April 10, 2023



Mayor's message: You are getting new taxes whether you like it or not.

Mayor (Dr) Charles Rehm opened the meeting saying how Prop U calling for sales taxes on items purchased off the internet was defeated. He added that that a property tax will have to be added in the 2024 budget. It has been 25-years since there was a city property tax in Town & Country.

Mayor Rehm failed to mention any budget cuts the city could make before adding a property tax. For instance the Board just voted to spend \$17,365 for the design of a new Parking Lot at Longview Park. This will be the second “new” parking lot for Longview Park the first in 2013. Do we really need new parking lots every 10 years?

In 2011 they floated the another idea to expand parking again only to be met with a wall of opposition from residents.

Other regular expenses are certain park programs, projects on private subdivision entrances, total playground replacements (over \$500,000) per park) instead of updating and repairing existing equipment, new sidewalk projects and more.

Keep in mind that the \$10,000,000 former Mayor Jon Dalton spent on the Town Square drained the city’s cash reserve. The Town Square could have been nice at half the cost.

Once you make budget cuts then ask for a property tax if needed.

MASON POINTE WOULD HAVE BEEN DEFEATED, INSTEAD IT GOT CONTINUED:

A bill was on the agenda to pass the new construction of senior living units (replacing some nursing units) at the Lutheran Senior Services. The project was facing heavy opposition from nearby residents.





This bill could not pass and instead got continued. It is not likely to pass in the future. Alderman Jeff Parrotte who as a member of the Planning and Zoning Commission voted for the project. He gave a speech at the BOA meeting stating due to citizen contacts with him he has changed his mind and will be voting NO..

Alderpersons Sue Allen and Fritz Wiesehan recused themselves for participating in the vote. Allen and her husband live at Mason Pointe and Wiesehan is a manager of the Mari de Villa, a competing nursing home and senior residence.



You need six yes votes for a bill like this pass. With two alderpersons missing and Parrotte stating he was voting NO it could not pass.

Lawyer and former Chesterfield Mayor John Nations was representing Lutheran Senior Services. He saw the handwriting on wall.

Lawyer Gerald Carmody was representing a homeowner opposing the project and had filed a 63-page report with the city and Alderpersons on why the project should be defeated. Nations said he needed time to study the report.

The Aldermen voted 6-0 for a 2-week continuance .

While there were residents at the meeting and a few spoke. The big difference between the first read on the bill and this Aldermanic meeting besides the vote was the first read meeting took 4 hours due to residents speaking and on Monday the Aldermanic meeting with 12 items on the agenda took 35 minutes.

One of the more amusing comments from a resident was, "You can't turn it into another Villages, like in Florida."

HI-JACKED TRUCK AFTER LONG CRASH CRASHED INTO MASON RIDGE ELEMENTARY SCHOOL.

According to a spokesperson for the Missouri State Highway Patrol, the vehicle was stolen out of Minnesota, and the truck company had tracked it by GPS.

Officers received a call just after 4 p.m. about the stolen vehicle. They had located the semi on Interstate 64 near Highway K and tried to stop the driver, but he refused to pull over, which then led to a chase. The pursuit's speed varied from 20 to 75 miles per hour.

Officers caught up with the suspect around St. Charles County; he then headed east into St. Louis County. The spokesperson said the driver then jumped out of the semi near Mason Ridge, and the truck rolled into a dumpster at Mason Ridge Elementary School to come to a stop.

The 31-year-old suspect, Bennie Robinson, is from Minnesota and is currently in a St. Charles County jail with a \$400,000 cash only bond.

He also was reported trying to carjack a woman on the school parking lot with a child in her car after running from the truck. Court Documents report that there were still 12 students at the school.

The Prosecuting Attorney of the County of St. Charles, State of Missouri, charges that the defendant, in violation of Section 569.080.1(2), RSMo, committed the class D felony of tampering in the first degree, punishable upon conviction under Sections 558.011 and 558.002, RSMo, in that on or about April 11, 2023, in the County of St. Charles, State of Missouri, the defendant knowingly and without the consent of the owner unlawfully operated a Mack truck, an automobile.

COUNT 2 Resisting Arrest/Detention/Stop By Fleeing - Creating A Substantial Risk Of Serious Injury/Death To Any Person

The Prosecuting Attorney of the County of St. Charles, State of Missouri, charges that the defendant, in violation of Section 575.150, RSMo, committed the class E felony of resisting a lawful stop, punishable upon conviction under Sections 558.002 and 558.011, RSMo, in that on or about April 11, 2023, in the County of St. Charles, State of Missouri, Sgt. Pleasant, a law enforcement officer, was attempting to make a lawful stop of defendant, and the defendant knew or reasonably should have known that the officer was making a lawful stop, and, for the purpose of preventing the officer from effecting the stop, resisted the stop of defendant by fleeing from the officer and defendant fled in such a manner that created a substantial risk of serious physical injury or death to other persons in that defendant operated a motor vehicle on Interstate 64 and was aggressively weaving through heavy traffic and running other motorists off of the Highway.

The facts that form the basis for this information and belief are contained in the attached statement(s) of facts, made a part hereof and submitted as a basis upon which this court may find the existence of probable cause.

Wherefore, the Prosecuting Attorney prays that a warrant be issued as provided by law.

1. I have probable cause to believe that **ROBINSON, BENNIE JEROME**, currently residing at **2136 GHE WE ZANCE LN, REMER, MN 56672**, born: **01/24/1992**, committed the offense(s) listed below on **04/11/2023 at 1602 hours**, at/on **IS-64 WESTBOUND, WEST OF MISSOURI 94, MO**

2. State the facts that support a finding of probable cause to believe crime(s) was/were committed and that the accused committed the crime(s)

1) On Tuesday, April 11, 2023, Troop C Communications broadcast a stolen Mack tractor truck, bearing Minnesota registration PZA0424, traveling westbound on Interstate 64, in St. Charles County Missouri. Troop C Communications advised the Mack's operator had stolen the vehicle from his employer and had removed the electrical equipment from the vehicle. I was stationary in the median on Interstate 64, west of Missouri 94, watching westbound traffic. At approximately 1626 hours, I observed the Mack pass my position in lane one. The driver, later identified as Bennie Jerome Robinson, date of birth January 24, 1992, of Remer, Minnesota, stared at me out the open driver's window of the Mack as he passed.

2) I activated my patrol vehicles emergency equipment to stop the Mack. Robinson shook his head and waved his arms out the open window, indicating that he was not going to stop. I pursued the Mack westbound on Interstate 64 to the Route N/Missouri 364 interchange. The Mack exited at Rt N and entered eastbound Interstate 64. During the westbound portion of the pursuit, Robinson utilized the left and rights shoulders to pass the heavy rush hour traffic. Risking injury and property damage to those on the roadway.

3) As the pursuit traveled east, the Mack traveled more than 75 miles per hour in 60 mile per hour speed zones. Robinson changed lanes aggressively and ran other motorists off the roadway to evade me.

4) At approximately 1643 hours, the pursuit entered St. Louis County. Corporal K. House, badge 931, attempted to deploy a tire deflation device to slow the Mack and end the pursuit. Robinson steered the vehicle off the right edge of the roadway to avoid the device and the pursuit continued. As we traveled east, traffic became more congested, and Robinson's movements became more hazardous. At Missouri 340, a Trooper D. Bert, badge 213, joined the pursuit. Robinson continued cutting off other vehicles and using shoulder to get through traffic. At 1653 hours, Robinson avoided a second tire deflation device set out by Town and Country Police Department.

5) At approximately 1653 hours, the Mack exited Interstate 64 at Mason Road. He eventually turned into Mason Ridge Elementary School, 715 S Mason Road. Robinson exited the Mack and fled on foot around the rear of the building. Trooper Bert and I gave chase. On the west side of the school, Robinson encountered Victim 1 and Victim 1's juvenile child. The child was seated in the rear of Victim 1's vehicle. Victim 1 was standing outside her vehicle. Robinson physically grabbed Victim 1 and demanded the keys to her vehicle. As this occurred, Trooper Bert, rounded the corner to the rear of the building and Robinson fled again. We chased Robinson south along the rear of the school until he encountered a fence. At approximately 1656 hours, Robinson surrendered and was arrested without further incident.

6) At approximately 1721 hours, the Mack was confirmed stolen by Troop C Communications.
