The first public speaker was Patricia Tocco who stated that despite losing to Aaron Wahl in the only contested race in the April Elections. She lost getting 46% of the vote. Also the sale of rolling papers had been prohibited, but with the State Law now allowing marijuana the restriction on rolling papers have been lifted.

NEW COMMITTEE ASSIGNMENTS: Mary Ann Mastorakos was elected as the 2023 President (mayor) Pro-Tem. This was not a surprise to the 80-plus pear old Mastorakos, who did a very good job in that position a couple of years ago, Mary Ann already had the names of committee chairs with her.






