Victim had checks stolen and later altered and then cashed at St. John's bank in north county. Possible suspect information was developed and the case was forwarded to the detective bureau.

23-1734 - Bank Robbery A Valley Park 22-year old arrested.

At approximately 11:00 AM this morning, officers were called to a bank robbery in progress at the Regions Bank at Chesterfield Airport Road and Chesterfield Industrial Boulevard. Upon arrival the suspect had already fled in a tan colored Honda sedan and no plate information was available. The suspect passed a note to the cashier but no weapon was displayed. The cashier followed protocol and placed money into the tan duffle bag the suspect brought with him. The suspect then exited the bank and drove south on Chesterfield Industrial Blvd until out of sight of bank employees. Investigation and ID work was completed by the officers on scene. Detectives who arrived to assist also developed information that the same suspect entered Chase Bank and PNC Bank on Chesterfield Airport Road but then exited without attempting a robbery or making

any transaction. Information was later developed on a possible suspect and vehicle license plate, and officers from several units are working together at this time to locate and apprehend the suspect.



The suspect Quinton Amant, 22, of Valley Park, was arrested two days after the robbery by the Florida Highway Patrol.



This was posted on Facebook by the Chesterfield Police on Monday May 1:

BANK ROBBERY:

On 04-27-2023, this department responded to a call for a Bank Robbery at Regions Bank located at 100 Chesterfield Industrial Blvd. Upon arrival, the Officers were advised that the suspect had fled the scene with an undetermined amount of cash.

Due to the dedication and hard work performed by the Officers and Investigators with this department, the suspect was identified and with the assistance of our friends with the Florida State Highway Patrol, the suspect was arrested and taken into custody on 04-29-2023. The suspect is identified as:

We are truly grateful for the assistance provided by the Florida State Highway Patrol, and we are grateful that no Bank employees were harmed physically. Although the suspect is in custody, this remains an active investigation.

We last wrote about Amant in our December 21, 2020 edition of Drunks and Thieves reporting that Amant on June 27, 2019 was arrested for stealing two bottles of Jim Beam from the Wal Mart Store. In 2020 he pled guilty to the theft and was fined \$300.

I have probable cause to believe that on April 27, 2023, at 100 Chesterfield Industrial Blvd, Quinton Amant, White, Male, DOB 01/18/2001, 6'02", 220lbs, committed one or more criminal offense(s).

Count: 01 **STEALING OR ATTEMPT TO STEAL - FROM FINANCIAL
INSTITUTION - CLASS B FELONY**

The facts supporting this belief are as follows: The defendant was identified as the person who entered the Regions Bank in Chesterfield on April 27, 2023, handed a note to the clerk requesting that she fill his bag with money, took the money, approximately \$2300, and left the location. The defendant's vehicle, which is registered to the defendant's father, was captured on camera in the vicinity.



CITY COUNCIL MEETING



The longest time spent during this Council meeting was on **Citizen Comments**.


Ron Cawood started his comments by trying to get the Council to drop common sense by including religion at Council meetings. Instead of the mayor leading the Council in the pledge of allegiance followed by a silent non-secular silent prayer, he asked for a pastor to give an opening prayer.



Next he went on to a topic where the Council should have their feet held to the fire. It involved the City spending \$9,000 on yard signs supporting the Proposition U ballot issue for a local sales tax on items purchased on the Internet. The same proposal lost in 2022.

Prop U lost by 63% (No votes) in the recent election. The Vote For Prop U yards signs were available for citizens to pick up at City Hall. A number of Anti-Prop U people also picked up the signs and changed them from Vote for Prop U to Vote No on Prop U.

“Signs in the road rights away in past elections were a NO-NO,” said Cawood pointing out that the city had placed Vote YES signs along public streets in violation of the ordinance.



Sarah Keathley spoke next and complained about Chesterfield spending City money on the Prop U political tax election.

Then Keathley praised Councilwoman Barb McGuinness for being the only councilperson to vote NO on spending city tax revenue on a political issue.

“I would like to thank Barb McGuinness for putting Chesterfield residents first,” she said.

She also complained about being blown off by a councilman who told her he wasn’t going to waste time answering her question about the Prop U spending. She said he told her “I don’t want to hear about it.”

Next it was **Patty Vietmeier** who asked a question.

“How and when is Mayor Nation and the rest of the Council going to pay back the money you wasted on Prop U? Please be respectful to the residents who voted against Prop U.

Lastly it was **Patricia Tocco** who lost to incumbent Aaron Wahl in the April election. Tocco continued to beat the drum about the clear opposition to Prop U and the City spending tax money to run a political campaign to vote for it.

Tocco did bring up the point that some City budget summaries assumed Prop U passed and included it. She was wrong. The budget summaries referred to Prop P for police and fire responders. Tocco has come to several Council meeting making claims that were false. This caused another lecture from Mayor Nation, but this time he kept his voice down.
