It was on May 20, 2021 Officer Erin O'Bryan was just out of the police academy was in field training for a short time when a driver from St. Charles in a Jeep on I-270 did not notice traffic backed up. He slammed into a BMW which then hit the T&C police car sending O'Bryan and her training officer, Officer Joshua Cook to the Hospital.

Now let's go to May 25, 2023. At 7:34pm Officer O'Bryan was driving with her red lights and siren on west bound Clayton Road to assist an officer with a suicidal subject, when a 20-year-old woman driving a Honda Pilot pulled out in front of her from a Principia School entrance. CRASH! The West County EMS and Fire Protection District ambulance gave her another ride to the Mercy Hospital ER, her second in 2-years. To avoid any conflict of interest, just like the 2021 I-270 crash, the Missouri Highway Patrol worked this one.

1. Music is background music—usually light jazz, classical, and or soft rock. The volume level is very moderate, so our servers are able to talk to our customers. On a scale of 1-10, we are generally on a 3 or 4.

- 2. Lighting-we uses the lighting that is on the building. We like to have candles on the tables for a soft glow, but that depends on the wind.
- 3. The patio typically has 3 servers assigned, that by no means indicates that all 3 servers are on the patio at one time.
- 4. Patio & restaurant narrative. We designed the inside of the restaurant and the menu to be an experience and we feel that the beautiful patio is an extension of the dining room but not an extra dining room. It has become an area to have a pre-dinner cocktail and appetizer, a coffee, and a dessert. We get fewer reservations specifying the patio, although it is definitely a must-see for our guests. The majority of our clientele dine inside.

HOUSE AND STABLE FORMERLY WITH A MASON ROAD ADDRESS BEFORE THE ARRIVAL OF THE EVIL ROB REHNQUIST, FOR SALE Jan Clayton is the owner of a 4,059 square foot farmhouse with a 15-stall horse stable and an adjoining 3-horse stable. The house was built on 4.3 acres in 1930. Jan Clayton has lived there since 1972. She had four horses and rented out stable space to residents who owned horses.





Then along came the evil Rob Rehnquist, house developer, who north on Mason Rd. clear-cut property for money first and people second. His work removed trees to squeeze into one more house while causing mass erosion, in one case damaging a 100-year farmhouse and property with flooding. The property owners sued him but the judgment did not cover all the damage.

Then the Board of Alderman in 2019 voted to allow Rehnquist to clear cut a wooded area behind a former pasture for he could build 7-house instead of three.

There was total citizen opposition to the way Rehnquist was damaging the land. There were so many people wanting to speak against the project at a Planning and Zoning meeting that the Aldermanic Chamber was full. The commission headed by Fred Meyland-Smith (who got Illinois license plates on a new car so he would not have to pay local sale taxes) ignored everyone and returned a 7-0 vote for Rehnquist.



























Here is some erosion caused by Rehnquist developments on property of long existing homes:







In his last subdivision on South Mason Road he bought the land in front of Mrs. Clayton's house and stables forcing her to change her address from Mason Road to Stonemont Court.

Stonemont Court was being built in front of Jan Clayton house and stable. During construction Rehnquist cut off her and the horses' water supply for close to a month. He

also provided a narrow driveway entrance to her property. Without a 20-foot right away Jan Clayton cannot sale her property for 4-houses by dividing the 4-plus acres into one acre lots.

The Clayton property is currently listed at \$1,395,000 for the 4.35 acres, stables, 94-year-old 4-bedroom, 3-baths, 4,059 square foot house.

# **Board of Aldermen Closed Special Meeting**

Notice is hereby given that the Board of Aldermen of the City of Town and Country, Missouri, will hold a Closed Special Meeting pursuant to Sections 610.021 (3) and (13) RSMo on Wednesday, MAY 31, 2023 at 2:00 PM, at the Municipal Center, 1011 Municipal Center Drive, Town and Country, MO, 63131 to discuss personnel matters.

According to the Sunshine Law closed meetings have to be voted on during an open public meeting, except in emergencies. This was not the case. This closed meeting was posted on the city's website, although hidden a bit.

# Closing a meeting

It's necessary to vote during an open meeting to hold a closed meeting for one of the specific authorized purposes. Notice must be given 24 hours in advance of the closed meeting and cite the specific section authorizing the closing by number. Legal actions is 610.021 [1], real estate is 610.021 [2], and personnel is 610.021 [3]. Meetings to open bids may be closed (610.021 [12]) until a contract is awarded or all bids are rejected. Bid specification preparation is 610.021 [11]. Preparation for contract negotiations is 610.021 [9]. Audits is 610.021 [17].

Next if a vote is taken that is a public record and has to be available to the public. If it is a personnel matter the person's name, assignment/job length of service has to be given, however discipline actions current or past do not have to be released.

# Records: care and custody

Every public governmental body must formally designate someone as custodian of records. For cities, this should probably be the clerk, as Chapter V. stated. The name and contact information for this person must be publicly posted (610.023).

All records of the city, with very few exceptions, are open to the public. The deadline to respond to requests for records is three business days. Sealed bids may be kept closed until the opening date. Personnel records beyond name, position, salary and length of service can and should be kept closed such as evaluations, reprimands or sick days used (610.021).

It seems that the public, residents and taxpayers have a right to know this limited information. Town and Country seems to be trying to keep it a secret.




