LONG TIME PROFESSIONAL ENGINEER, VETERAN DAVID HOUGH KICKED OFF OF TOWN & COUNTRY'S PUBLIC WORKS COMMISSION. David Hough, a Professional Engineer who in the 1980s served as T&C first City Engineer (non-paying volunteer position then) was recently called to City Administrator Bob Shelton's Office where he was told he was "fired" from the city's volunteer Public Works Commission.

As a professional engineer David offers to take City Staff and newly elected alderpersons on a tour of the city explaining geographical issues in building and stormwater flows. The southeast section of Town and Country was home for years to a large gravel quarry.



David thought his being kicked off the commission might have been comments about erosion effects on the large pond at the Longview Farm Park, when Honeysuckle plants next to the water were removed without full size replacement plants.

Dave said the erosion had filled the pond with mud during the spring rains, reducing the depth and making it hard for fish to survive.



IRONY: Besides the first Town and Country City Engineer being fired 43 years later from a volunteer position, there is another reason all this appears to be ironic.

I'll grant you coming from a family of engineers I understand this. If you ask a question of many people you might get a 5-minute answer in the case of David House you get a detailed answer that might take 15-minutes. Also Dave is not afraid to disagree and state problems with a popular project.

But the real irony is with Mayor Charles Rehm. Mayor Rehm wants to honor military vets and first responders associated with or residing in the city. According to the City's website \$1,500 has been raised for the \$300,000 for the below monument.



The irony is the City just "Fired" David Hough, who for over 20-years was an officer in the U.S. Coast Guard. He served at Coast Guard bases around the United States and overseas in American Territories and seaside U.S. Military bases where he was the commander of public works unit or of the entire base.



Created in 1790 the Coast Guard is the oldest Military Branch in the United States, and David Hough gave a part of his life as a Coast Guard Officer. In honor of his service to the United States and Town and Country he was called in and told he was "FIRED."

It is unknown at this time if this was a prank or a legitimate call for assistance although the subject was deceitful in many of his responses. Notifications made and the report will be forwarded to the detective bureau unless any further information is obtained during the overnight hours.

The officer who spoke with the subject is to be commended for his extreme patience and perseverance in keeping the subject on the phone and working to find a solution. An officer transported a subject in our custody for Felony Fugitive Warrants out of Franklin County to St. Louis County Intake after Franklin County advised they could not pick up for another two days.

Officers conducted traffic enforcement and made numerous business checks and contacts throughout the shift.

WHAT GOOD ARE THESE DWI AWARDS IF TIM ENGLEMEYER IS THE PROSECUTOR? Every year the Mothers Against Drunk Driving award three or four Chesterfield Officers for their work in arresting drunk drivers.

However, the arrests are only the halfway point in dealing with drunk drivers. Chesterfield, the mayor and city council fail miserably in doing the second half.

Tim Englemeyer, the most dangerous man in Chesterfield, is the city prosecuting attorney. When Rick Brunk was still judge they were a dangerous duo. If a DWI defendant hires a lawyer Englemeyer will recommend they be given a SIS no points, no fine and no permanent record. Unfortunately the new judge often goes along.

Often Englemeyer will reduce to companion charge such as speeding or reckless driving to a no-points Parking Violation with a \$191 fine. So the drunk driver leaves court with ZERO points on his record.

This sends a clear message to these officers getting these awards from MADD. Work as hard as you do because local lawyers need to make a living, but nothing serious is going to happen to them and the public will still be at risk and it looks like you are wasting your time.
