JUNE 12 BOARD OF ALDERMEN MEETING Hired Outside Law Firm



The regular meeting was over in 30 minutes. However, for the second consecutive meeting they went into Closed Secret No-Public-Allow meeting again reference a Personnel Issue/Legal Issue. They also voted to hire an outside law firm (Behr, McCarter, Potter and Neely) but did not say what general reason for engaging the firm is place of the City's firm Curtis, Heinz, Garrett & O'Keefe.

Two aldermen (Wiesehan & Francisco) were absent plus the empty chair from the Ward-4 Alderman Parrotte who resigned, meaning a single NO vote would defeat any bill. But that did not happen and all the voted were 5-0.

Police Chief James Cavins announced that two officers with still out on injury leave, but expected back soon. One was Erin O'Bryan who was injured in a crash as she was responding with red lights and siren to a call on May 25.

NO ONE AT MEETING QUESTION HOLDING A MEETING AT A BANK'S

CONFERENCE ROOM: On Wednesday June 28 at 9am a Board of Aldermen "Retreat Meeting" is still scheduled for the conference at the People's National Bank. Yes, a meeting of elected officials at a commercial location. No one at the June 12 meeting inquired about this or offered a resolution to move the meeting to a city owned site such as the Longview House at Longview City Park or back at city hall. I'd love to see enough alderpersons refuse to go to the bank. This is a meeting of Alderpersons and not the city administrator or the mayor. It should be at a public location.

Officers responded to the area of Chesterfield Mall for a report of a person threatening suicide with a knife. Officer Keathley located a 65 year old male subject near 49 Chesterfield Mall, the subject had severely cut his wrist with a box cutter. The subject had lost a significant amount of blood and was still actively bleeding. The officer secured the scene and then applied a tourniquet to the subjects arm and stopped the bleeding. EMS arrived on the scene shortly after and took over the medical treatment and then transported the subject to Mercy hospital with the tourniquet still in place. Other officers were able to locate and notify the subjects wife and then assisted the family in securing his vehicle and transporting themselves to the hospital. Last report from the hospital stated the subject had been treated and expected to survive. Outstanding job by all the officers involved, staff members at the hospital stated the quick actions of officer Keathley and the tourniquet application may have saved the subjects life.

Officers also conducted traffic enforcement and responded to calls for, auto accidents, traffic hazards, suspicious vehicles, peace disturbance, alarms, and sick cases, along with making routine patrols of businesses, neighborhoods, and parks.

Officers also provided extra patrol to neighborhoods and businesses as well as conducted traffic enforcement on area roadways.

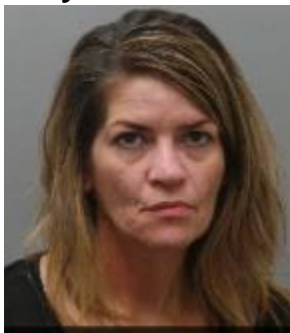
