Defendant is interviewed and admitted touching Victim's vagina and being sexually frustrated. Victim reported another incident approximately a year and a half ago in Indiana and tried to report that to her mother. Defendant admitted touching Victim in Indiana. I believe Defendant to be a threat to the community and crime victim based on the seriousness of the offense.



A handheld radio was located at the apartment complex in some bushes. The radio was placed into evidence. The officer will follow up with the complex to see if they were the owners.

Chesterfield Industrial Drive was closed for several hours for a major water main break. The shut off valve was located under blacktop.

Officers handled calls for service to include alarms, traffic crashes, sick cases, suspicious vehicles, person slumped (just asleep), notifications and accidental injuries.

# FORMER CHESTERFIELD POLICE OFFICER PLEADS GUILTY TO ASSAULT IN A VALLEY PARK BAR

Charles Thompson, an 8 ½ -year veteran of the Chesterfield Police Department has been charged with Felony Assault resulting in injuries from an off-duty bar fight at T.J. Wings in Valley Park that occurred on December 11. He resigned a few days after his arrest on December 11, 2021 by the County Police. When he was arrested he threatened to return and set fire to T.J. Wings. We reported this in our newsletter 535 on June 11, 2022.

On March 9, 2023 Thompson pled guilty to a reduced charge from Felony Assault to Misdemeanor Assault. He was sentenced to 9-months in jail, but the jail termed was stayed with a Suspended Execution of Sentence (SES) and a 1-year probation term. However, the crime and guilty plea will remain on a public record.

Count: 01 ASSAULT - 3RD DEGREE

I, <u>Adrienne Swan, DSN 4786, St. Louis County Police Department,</u> knowing that false statements on this form are punishable by law, state that the facts contained herein are true and documented in report number 21-48291. I have probable cause to believe that on December 11, 2021, at 550 Vance Rd, Charles Thompson, White, Male, DOB 04/07/1989, 6'05", 220lbs, committed one or more criminal offense(s).

Count: 01 ASSAULT - 3RD DEGREE

The facts supporting this belief are as follows: On 12/11/2021, I responded to 550 Vance Road (TJ Wings) in the City of Valley Park for a report of an assault. The call stated a customer had punched another customer, that he was currently at the bar, was wearing a plaid shirt, and had broken items at the bar. When another officer and I arrived, we saw a white male at the bar wearing a blue plaid shirt. He was the only person seated at the bar. I spoke to the bartender, who pointed to the man at the bar. Another officer approached the man, who we later identified as Charles Thompson

I approached another man, who had a cold compress on his eye, later identified as Jeff Wussler DOB 05/05/1982. Jeff told me that he was seated at the bar and was having a pleasant conversation with Charles Thompson. He stated that out of nowhere, Charles became enraged, stood up, and hit him causing him to fall to the ground. He said the bartender was able to pull Charles off him. I saw that Jeff's right eye was swollen, and saw a cut about 1 inch in length under his eye, which was bleeding. I also saw a lump on the right side of his head about 1 inch in diameter. I interviewed another employee of the establishment, who saw the incident. She said Charles had entered the establishment at about 12:30 a.m.

He had first got into a verbal altercation with an elderly patron, which caused that customer to leave. Then, she saw Charles approach and sit next to Jeff. She saw Charles become angry and hit Jeff in the right eye and jump on Jeff, which caused him to fall to the ground.

Further, that employee stated that Charles had identified himself as a police officer to multiple people at the bar, and had handed the bartender his business card. Diana described Charles' demeanor as "cocky" and said he was trying to intimidate people with his job. When I asked Charles what police agency he worked for, Charles aggressively told me to come over to him if he wanted to speak to him (Charles was seated in somewhat close proximity to where I was standing). I later obtained the card Charles had given the bartender, which reflected Charles worked for the Chesterfield Police Department.

Charles was advised he was under arrest for assault, and he was placed in handcuffs. When I was escorting Charles to my marked St. Louis County Police vehicle, Charles spontaneously stated he was going to set TJ Wings on fire.

While Charles was sitting in my vehicle, another officer approached me and stated Jeff had determined he did not want to press charges. I spoke to Jeff, and he stated he did not want to ruin Charles' career as a police officer, and was hesitant to cooperate. Charles could be heard from my vehicle saying he would "fuck him up" meaning Jeff. Charles continued his threats, and when I told him Jeff was completing a prosecution refusal form, Charles replied he did not care if he got fired.

Later, as part of my investigation, I viewed footage of the incident from a camera located at TJ Wings. That footage reflected that Charles sat down next to Jeff and they engaged in conversation. About 17 minutes later, Charles aggressively stood up and stood close to Jeff. Jeff stood up in a non-aggressive manner, and moments later, Charles struck Jeff in the right eye with his right elbow. The assault caused Jeff to fall back, then Charles jumped on top of Jeff, causing Jeff's body to slam into multiple chairs and hit the ground. The assault lasted approximately 1 minute and 15 seconds, before the bartender was able to pull Charles off Jeff.

On 12/14/2021, I made contact with Jeff, after Jeff had sent an email to the West County precinct advising he wanted to pursue prosecution. Jeff confirmed to me he did want to press charges against Charles. Additionally, he advised me that he had the following additional injuries: a lump on the back of his neck, a bruised tail bone and multiple scratches to his tail bone area, and pain in his right leg.

I have to say that the 100 officer Chesterfield Police Department is very professional and officers produce excellent police reports and thorough investigations in connection with arrests. The case of Charles Thompson could happen anywhere with off-duty alcohol consumption.


However there is one case involving a Chesterfield Police Officer like nothing I have seen anywhere. It came to light in 2014.

That is the case of David Cerna, who hid cameras in male public restrooms including one used by officers like the Mobil on the Run gas station on Clarkson Road and obtained videos of penises while people were urinating.

Someone tipped KTVI reporter Chris Hayes who alerted the Chesterfield Police. A 56-page investigation report resulted in Cerna being charged with

Cerna was sentenced to 60-days in jail on a St. Charles County case where he was recording persons using a glory hole in his front door at this house as he performed oral sex.

He also served one year for Invasion of Privacy in a Chesterfield case. But the far more serious charges in St. Louis County resulted in lengthy probation terms, but no jail time. He was arrested a couple times for Probation Violation for failing to provide current addresses.

Now he is in prison.

On 01/07/22 he was arrested and charged with Felony Failure to Register as a Sex Offender. On 08/11/22 he was sentenced to three years in prison.
