FIRING A POLICE CHIEF:

As we reported in our last newsletter Town & Country Police Chief was placed on Administrative Leave. That is normally a precursor to firing him.

Effective August 28, 2023 here is the State law on firing a police chief.

Title VIII PUBLIC OFFICERS AND EMPLOYEES, BONDS AND RECORDS

Chapter 106



Effective - 28 Aug 2013

106.273. Removal of chief law enforcement officer, when. — 1. For the purposes of this section, the following terms shall mean:

(1) "**Chief**", any nonelected chief law enforcement officer of any political subdivision;

(2) "**Just cause**", exists when a chief:

(a) Is unable to perform his or her duties with reasonable competence or reasonable safety as a result of a mental condition, including alcohol or substance abuse;

(b) Has committed any act, while engaged in the performance of his or her duties, that constitutes a reckless disregard for the safety of the public or another law enforcement officer;

(c) Has caused a material fact to be misrepresented for any improper or unlawful purpose;

(d) Acts in a manner for the sole purpose of furthering his or her self-interest or in a manner inconsistent with the interests of the public or the chief's governing body;

(e) Has been found to have violated any law, statute, or ordinance which constitutes a felony; or

(f) Has been deemed insubordinate or found to be in violation of a written established policy, unless such claimed insubordination or violation of a written established policy was a violation of any federal or state law or local ordinance.

2. A chief shall be subject to removal from office or employment by the appointing authority or the governing body of the political subdivision employing the chief if:

(1) The governing body of the political subdivision employing the chief issues a written notice to the chief whose removal is being sought no fewer than ten business days prior to the meeting at which his or her removal will be considered;

(2) The chief has been given written notice as to the governing body's intent to remove him or her. Such notice shall include:

(a) Charges specifying just cause for which removal is sought;

(b) A statement of facts that are alleged to constitute just cause for the chief's removal; and

(c) The date, time, and location of the meeting at which the chief's removal will be considered;

(3) The chief is given an opportunity to be heard before the governing body, together with any witnesses, evidence and counsel of his or her choosing; and

(4) The governing body, by two-thirds majority vote, finds just cause for removing the chief.

3. Upon the satisfaction of the removal procedure under subsection 2 of this section, the chief shall be immediately removed from his or her office, shall be relieved of all duties and responsibilities of said office, and shall be entitled to no further compensation or benefits not already earned, accrued, or agreed upon.

4. Any chief removed pursuant to subsection 3 of this section shall be issued a written notice of the grounds of his or her removal within fourteen calendar days of the removal.

The new law listing requirements for firing a Police Chief on August 28, 2023.

Prior to the State law taking effect, this is from the Town & Country ordinance book on removing a police chief:

- C. *Appointment And Term.* The Chief of Police shall be appointed by the Mayor with the approval of the Board of Aldermen and he/she shall hold his/her office subject to removal by the Mayor with the approval of the Board of Aldermen. The Chief of Police shall perform all duties of the Marshal as required by law.

23-2948 Drugs/CIT: A known female subject with mental health issues was staying in the Drury hotel on Chesterfield Centre. She became delusional and called 911 reporting she was hearing voices and her family was being attacked. Officers made contact with the female who would not open the door and told officers they were all going to die. Officers forced entry and secured the female for her safety. While in the room, officers observed in plain view suspected heroin and paraphernalia. Paramedics responded and determined the female should go to the hospital for an evaluation based on her erratic behavior.

Further investigation showed this was the same female who damaged a hotel room in Sonesta Suites last week and she had been committed at Mercy Hospital for psychological treatment until she was released on July 7th. She was once again admitted for a psychiatric assessment. The drugs and paraphernalia were seized and warrant application will be made on a later date. A CIT report was also completed. Drury management was notified of the minor door damage.

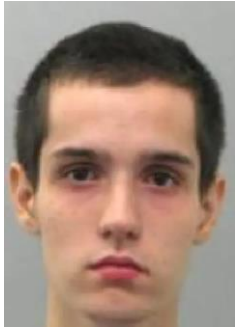


The facts supporting this belief are as follows: On March 7, 2023, officers received a report of a stealing over \$750 from Lowe's in Chesterfield from February 21, 2023. Witness reviewed the CCTV footage, which showed defendant entering the store and placing an EGO Power Station in his cart, along with other items. Witness identified defendant on video surveillance from the self-checkout due to having prior contact with defendant and observed defendant scan a bar code for a separate item on the top of the EGO box for \$99 instead of \$999 and exit the store. Officer went to defendant's residence, where the homeowner consented to officers searching the residence for defendant.

Officers, in plain view, observed an EGO Power Station. On April 19, 2023, officers received a report of a stealing over \$750 from Lowe's in Chesterfield from February 23, 2023. Witness, who is familiar with defendant, stated defendant entered the store and selected a Kitchenaid range hood valued at \$1379 but scanned a bar code for a \$33.73 shower rod at the self-checkout. Defendant was identified in face recognition surveillance photos by witness and officers who were familiar with defendant. Officers placed a wanted for defendant. On June 2, 2023, officer, who was familiar with defendant, observed defendant operating a motor vehicle at Clarkson near I-64. A computer inquiry revealed defendant had an active warrant. Officer located defendant parked at a gas station at 1789 Clarkson Rd. Officer approached the vehicle, and defendant reversed and sped out of the parking lot as officer yelled for defendant to stop. Officer followed defendant. Defendant drove at a high rate of speed and the pursuit was terminated. On July 12, 2023, officer observed defendant operating a motor vehicle at Clarkson and Baxter, and was aware defendant had a warrant for his arrest. Officer conducted a computer inquiry, identified defendant from previous interactions, and activated his emergency equipment. Defendant fled at a high rate of speed and drove on the shoulder around heavy traffic. Officer observed defendant at MO-340 before Interstate-64. On July 13, 2023, officer observed a wanted vehicle while on patrol. Officer made a U-turn on MO-340 and observed defendant as the driver of the vehicle and activated his emergency equipment. Defendant fled at a high rate of speed and swerved into the center median to go around traffic. Officer terminated the pursuit. On July 16, 2023, defendant was arrested in Maryland Heights for wanteds/warrants. Defendant admitted to officer he was driving the vehicle on July 13, 2023.

I believe that the defendant poses a danger to the community or to any other person because of the nature of the offenses listed above wherein defendant fled from police on three separate occasions, operating his motor vehicle at a high rate of speed, swerving around traffic, and driving on the shoulder of the roadway.

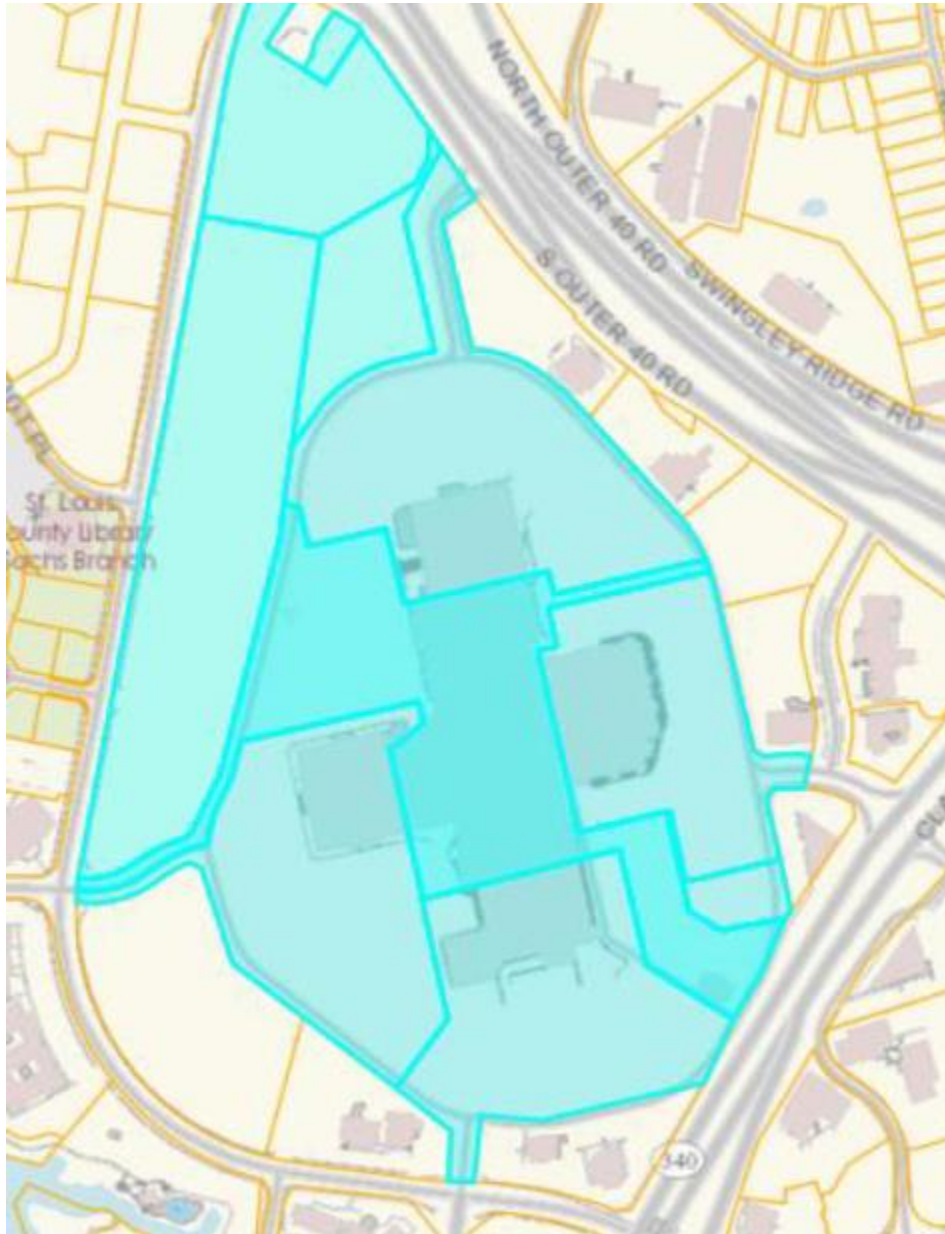

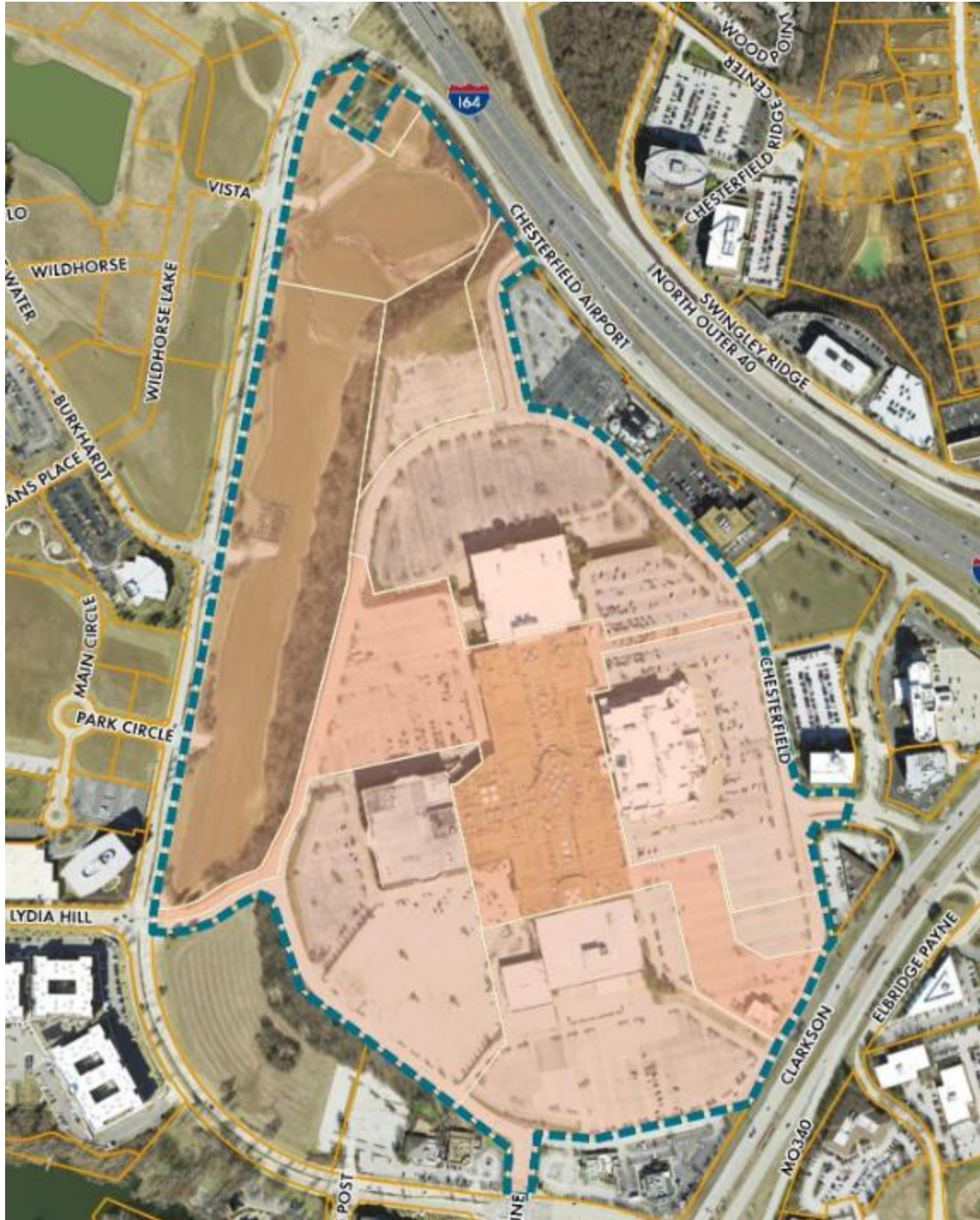

History of Chesterfield Mall

In 1974, Louis Sachs, a local real estate investor, sold the 60-acre area that would eventually become the 1.3 million square foot Chesterfield Mall (the "Mall") to Richard

Jacobs of the Cleveland-based retail developer Richard E. Jacobs Group. The Mall was built and eventually opened in 1976 as the sister mall to Jamestown Mall, located in north St. Louis. The Mall had two original anchor stores: (1) Sears and (2) Stix, Baer, and Fuller. In 1978, a four-screen cinema opened on an outparcel adjacent to the Mall. In 1981, a Famous-Barr store opened at the Mall. In 1984, Dillard's replaced Stix, Baer, and Fuller. In 1995, a new Famous-Barr store was built adjacent to that store's former space, which JCPenney would later take over. The Mall was renovated in 1996 with upgraded facades, interiors, and amenities. Famous-Barr remained a tenant until 2006, when it was replaced by Macy's, which has remained in operation until 2022. Dillard's remained in operation until 2016, when flood damage from bursting water piped caused the closure of the anchor. The temporary closure became permanent in 2017 due to dwindling sales at the Mall and changes in consumer behavior. Other notable former tenants include Houlihan's (1997-2014), California Pizza Kitchen (1997-2018), and Ann Taylor Loft (2006-2020)

Decline

The Mall's decline can be traced back to 2000, when anchor tenants began to vacate their locations. The four-screen cinema went through an ownership change in the mid-90s which eventually led to the theater's closure on November 5, 2000. Approximately five years later, the Mall's JCPenney store closed, and the space was demolished, which made way for many smaller shops and restaurants, including Border's Books, which closed in 2011. The Cheesecake Factory, an American Girl store, a food court, and a 14-screen AMC Megaplex opened between 2007 and 2018. The AMC Megaplex takes up a third floor that was constructed in 2016. Border's Books closed in 2011 and was replaced with Books-A-Million and, later, V-Stock. In March 2018, American Girl shuttered its location within the Mall. On May 31, 2018, Sears announced it would be closing as part of a plan to close 72 stores nationwide, including the location at the nearby South County Center. The Sears store closed in September 2018, leaving Macy's as the last remaining anchor store.

SECTION 3 THE REDEVELOPMENT PROJECT

As noted in Section 1 of this Plan, the Redevelopment Area presently consists of the Mall property, which comprises approximately 105 acres of land.² The Redevelopment Area includes the parcel identification numbers shown in Table 2-1 - Parcel Ownership and Use Data, located on the prior page. The table also lists each parcel's owner and current land use. This Development Plan envisions multiple projects across the Redevelopment Area. These projects will be referred to as the "Redevelopment Project(s)." It is expected that the Mall's redevelopment will be accomplished by TSG. As part of a total anticipated investment of nearly \$1.2 billion, the Mall will be redeveloped into a dense downtown area resulting in:

Phase 1

- Approximately 2,363 residential units comprising 2,798,000 square feet;

- Over 511,000 square feet of retail, grocery, and food and beverage space;
- More than 736,000 square feet of office space;
- A 259-room, 314,800 square foot hotel; and
- Over 2.9 million square feet of surface and structured parking.

Phase 2

- Approximately 362 residential units comprising 425,600 square feet of varying typologies;
- Approximately 1.43 million square feet of office typologies;
- Approximately 5,000 gross square feet of retail space; and
- 1.7 million square feet of structured parking.

The development of the Redevelopment Area will alleviate those conditions that qualify the Redevelopment Area as a “**Blighted Area**” and will facilitate its economic revitalization. The development will be completed in phases over the next ten to twelve years

Public hearing: The Blighting of a portion of Downtown Chesterfield had city Planning Director Justin Wyse lead things off. Dir. Wyse stated that all requirements have been met to declare the area blighted.

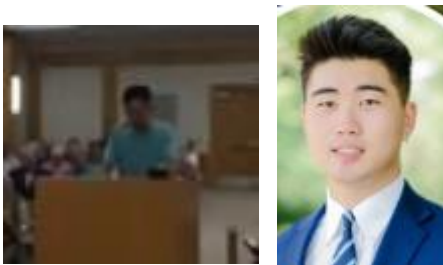
Regular meeting comments I could not keep up with all the speakers, but took notes on several that were interesting. Most wanted their voices heard before the Thursday July 20 Planning meeting with Rezoning on the agenda as speakers are not normally allowed.

Jason Zang (gave his address on Wydown and Councilman Hurt asked if the address was to a business or a house. Zang responded that it was on the campus of Washington University) derided residents against having high density housing. He claimed it would actually reduce traffic as condo and apartment residents could walk or ride bikes to supermarkets and other stores. Apparently someone carrying four full grocery bags makes for a perfect workout for walkers, especially when it 95-degrees according to Tang. Also what supermarket is going to open without a large parking lot and a place for delivery trucks.

Tang has never lived in Chesterfield and is from Boston, before he went to the Ivy League School of the Midwest, Washington University.

Tang in his very loud, almost shouted presentation, then used a word I have never heard in connection with a proposed project as a reason why Chesterfield needs a high density project.

“Chesterfield can escape from the suburban growth PONZI SCHEME,” he shouted.

REMEMBERING THE MALL; Tate Skinner, a Chesterfield resident who grew up in Chesterfield said he was in favor of the Mall project. He then took us back to his childhood and said how he and his friends would meet at the Chesterfield Mall and never spend any money, but just “Hang out.” Just what the merchants want to hear, he wasn’t even buying an Aunt Annie’s Pretzel.

CO-CHAIR OF CITIZEN FOR DEVELOPING DOWNTOWN CHESTERFIELD: Kelli Unnerstall with the group with the website and petition drive presented in this newsletter spoke. You would think that by their name they would be in favor of project. That is not the case. They say they are for the redevelopment of the mall property but against high density,

Kelli Unnerstall said that the residents are fearful of increased traffic, more stop lights, an adverse effort on city/fire services and more overcrowding for Parkway Schools.

Mayor Bob Nation then stopped her and attacked.

“Your website is devious and full of misinformation,” barked Mayor Nation.

This was posted online after the meeting concerning Mayor Nation’s treatment of Kelli Unnerstall:

I listened to the live stream council meeting on Monday (7/17). Kelli presented the concerns of this group very well. With grace and professionalism, Kelli also handled the rudeness that our mayor projected toward her. Thank you, Kelli for your presentation. And thanks to the other speakers who supported Kelli.

This group has my support.

CO-CHAIR ADDRESS DENSITY ISSUE The co-chair with Unnerstall, 80-year-old Ray Bosenbecker spoke next and said the plans they have seen so are included 2880 apartments or 2019 apartments. He said that many people living in one small area would change the character of Chesterfield and create a burden on the police, fire/EMS and the school district, with the current residents having to pay for new operational increases.

FINANCE PROFESSOR CLAIMS HIGH DENSITY IS NEEDED: Rob Rodermund, a finance professor at Lindenwood U. spoke and said the room full of residents wanting lower density were wrong.

“Housing has to be dense to support the businesses. We have to maintain the high density,” he said.

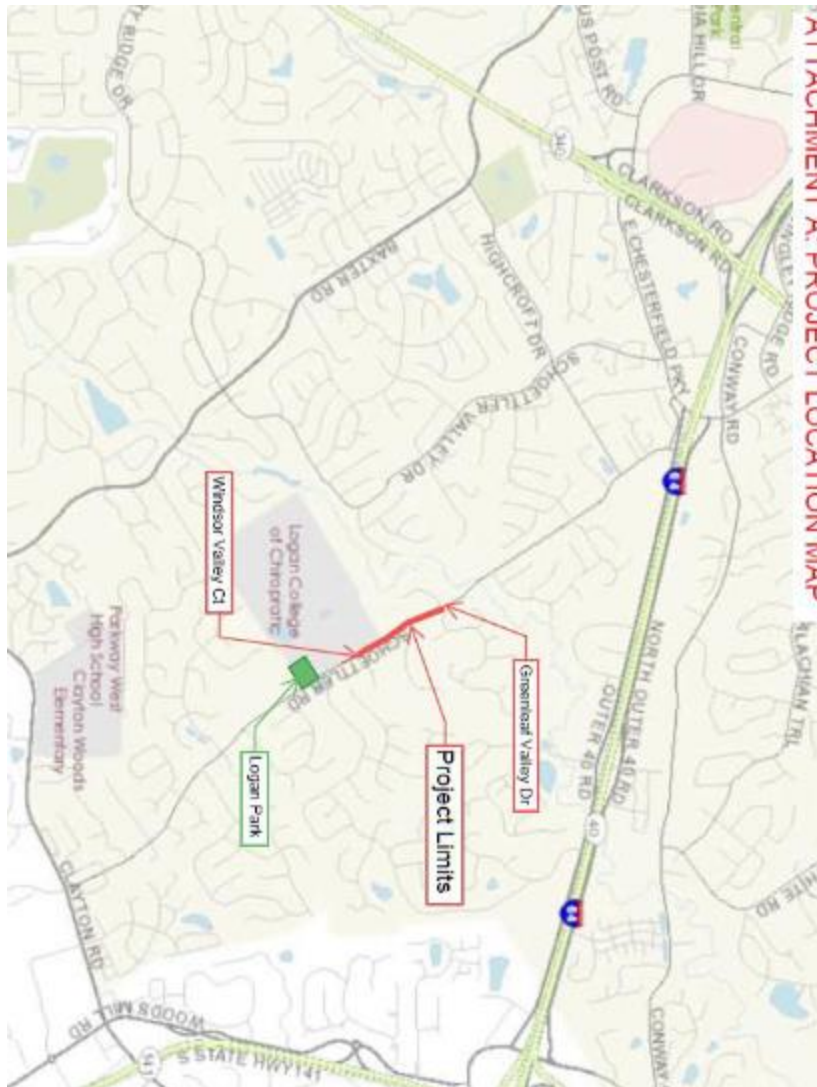

COURT RULING FOR THE CITY AGAINST CHARTER COMMUNICATIONS FOR NOT PAYING USER TAXES STANDS AS CHARTER DID NOT APPEAL.

In a memo from the City's special attorney, it appears as if Charter will have to pay Chesterfield **\$1,418,467** in back taxes for communications on cable bills paid by city residents to Charter.

NEW SIDEWALKS FOR SMALL SECTION OF SCHOETTLER ROAD, but don't plan to walk the dog on it for 3-years. The City is receiving a Transportation Grant for \$833,300 to add or replace a sidewalk plus road improvements on Schoettler Road from Windsor Valley Court to Greenleaf Valley Drive. The City will have to pay \$448,700. Design is scheduled in 2024, right of way acquisition in 2025 and construction not to start until 2026.

8:15 At the start of the fourth inning you buy another 12oz beer from a vendor.

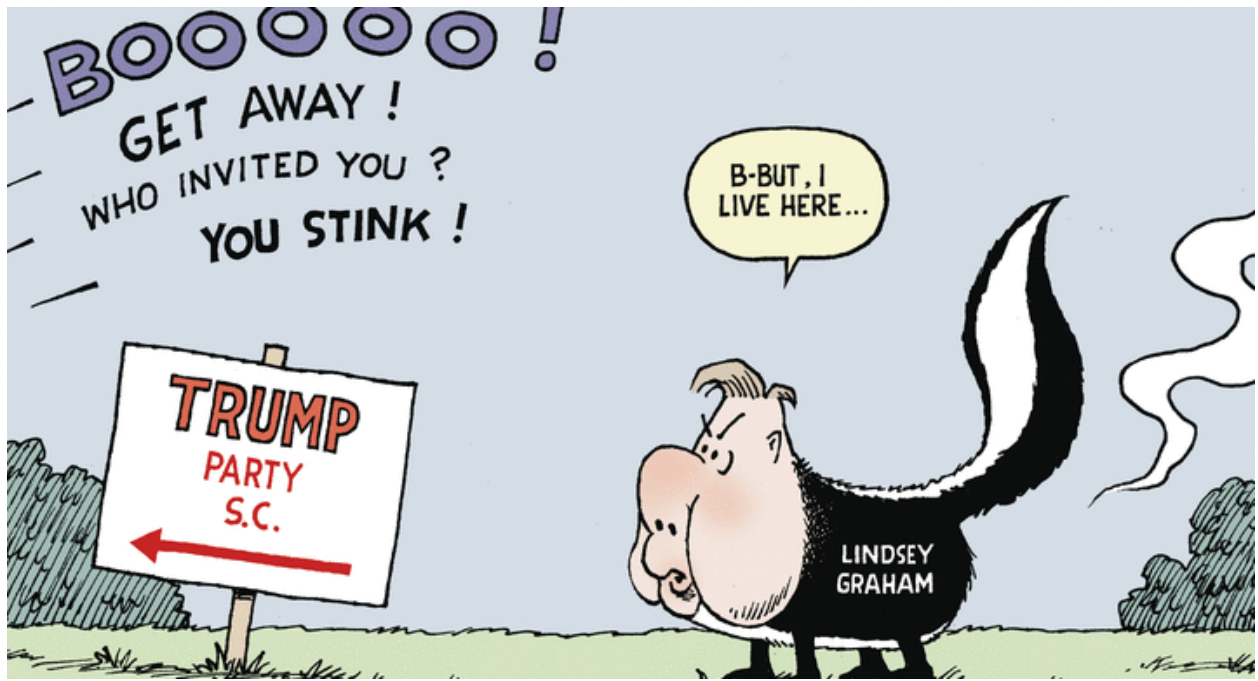

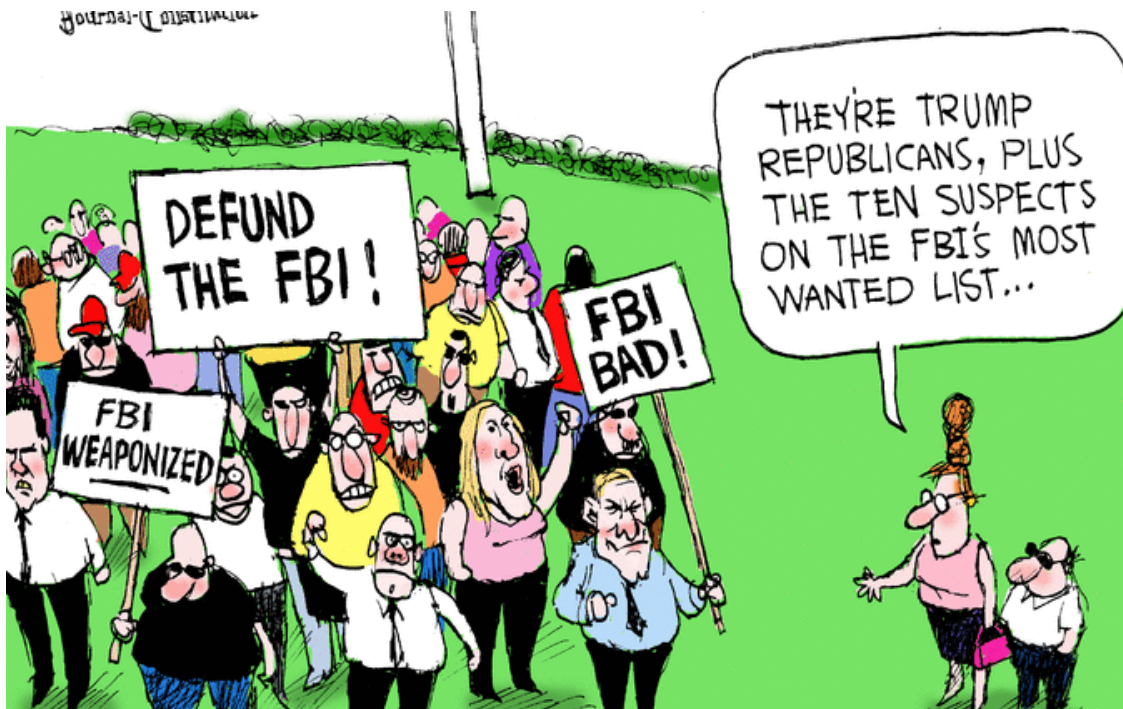
9:30 In the middle of the eighth inning and vendor is making one last trip. You buy another 12oz beer,
