

COUNT: 01 UNLAWFUL USE OF WEAPON - SHOOT AT/FROM MOTOR VEHICLE - CLASS B FELONY

That Terrell Tyreese Galvin, in violation of Section 571.030.1(9), RSMo, committed the class B felony of unlawful use of a weapon, punishable upon conviction under Sections 558.011 and 558.002, RSMo, in that on or about July 19, 2023 at 5:53 PM, on westbound Interstate 64 at Mason Road, in the County of St. Louis, State of Missouri, the defendant knowingly shot a firearm at a motor vehicle.

I, <u>Katie Exline</u>, <u>DSN 0123</u>, <u>Town and Country Police Department</u>, knowing that false statements on this form are punishable by law, state that the facts contained herein are true and documented in report number 23-828. I have probable cause to believe that on July 19, 2023, within St. Louis County, Terrell Galvin, Black, Male, 5'07", 270lbs, committed one or more criminal offense(s).

Count: 01 UNLAWFUL USE OF WEAPON - SHOOT AT/FROM MOTOR VEHICLE - CLASS B FELONY

The facts supporting this belief are as follows: Victim responded to the Town and Country police station and reported that she had been driving on westbound Interstate 64 when another driver drove alongside her and first pointed a gun at her then fired a shot at her vehicle. Victim took a photograph of the other car then drove to the Town and Country police station. Police contacted the registered owner of the vehicle who said his daughter was driving the car. Police spoke with the daughter and defendant (her fiance) who confirmed they had been in the vehicle at the time. Defendant and his fiancee initially told police that victim had pulled a gun and fired a shot at their vehicle first and then defendant shot back in self-defense. After both defendant and his fiancee responded to the Town and Country police station, they were separated, and defendant's fiancee subsequently admitted that defendant had fired the only shot. Defendant, confronted by this statement, eventually admitted that he had shot at victim but that she had not shot at him. The gun that he fired, a Glock 9mm, was recovered from defendant's mother's residence.

I believe that the defendant poses a danger to the community or to any other person because of the nature of this offense. A warrant is requested.



ASSAULT ON STEP DAUGHTER IN CHESTERFIELD VALLEY RESULTS IN A \$30,000 CASH ONLY BOND. We first reported on this two weeks ago. Here are some more details.

First from the County Prosecutor's Office.

Man charged for punching stepdaughter in bowling alley parking lot

The St. Louis County Prosecuting Attorney's Office has charged **Dakota Amerman**, 30, of Olney, Illinois, with Abuse or Neglect of a Child - No Sexual Contact, a Class D Felony.

The court set bond at \$30,000, cash-only.

According to a Chesterfield Police Department investigation, on August 5, 2023, the 17-year-old stepdaughter of the defendant was leaving a bowling alley with her family when she put her hands on her younger sibling's shoulders. The defendant told her to take her hands off the sibling then struck the victim multiple times. Officers observed bruising on the victim's left rib cage and the center of her back. Video surveillance footage showed the victim placing her hands on her sibling's shoulder, the defendant walking up and striking the victim, then the victim drop to the ground. The defendant admitted to striking the victim and demonstrated to officers that he struck her with a closed fist.

TWO POLICE OFFICERS RECEIVE CHIEF COMMENDATIONS FOR SAVING A 6-YEAR-OLD GIRLS LIFE IN A MOST UNUSUAL WAY



CHIEF'S COMMENDATION

OFFICER JOSEPH BREWER

OFFICER JOHN HARTMAN

On March 22nd, 2023, our department received a call of a child who had been struck by a car and was pinned under the rear tire. Officers John Hartman & Joseph Brewer were the first two officers to arrive. On their approach, they did in fact observe a little girl pinned under the rear tire of a vehicle. It was clear to these officers that the little girl's condition was dire, she was no longer breathing and that her life was in imminent danger.

Without hesitation, both officers attempted to lift the vehicle off of the girl but due to the excessive weight of the car, were unsuccessful. Not willing to accept tragedy, both officers summoned Herculean strength and once again attempted to lift the vehicle. It was then that the car was lifted. Officer Hartman released his grip and pulled the child from beneath the tire while Officer Brewer held strong.

Officer Hartman immediately started cardio-pulmonary resuscitation and continued until such time as he was relieved by paramedics. The child was treated at St. Louis Children's Hospital where she received specialized care, survived her injuries and was ultimately released. The staff at Children's Hospital explicitly stated that Officers Hartman and Brewer's actions were instrumental in saving the life of this young lady.

PUBLIC COMMENTS: You are supposed to be allowed four minutes to make comments on a certain issues at the start of meetings, unless of course you are speaking for an item Mayor Bob Nation supports. The first speaker **Ralph Pfremmer** supported this fact.

Pfremmer spoke and spoke, saying he lived in an apartment at the edge of Chesterfield Valley and how he just signed a new lease. He then went on and on about how high real estate prices and they were keeping him from buying a house. He next spoke how much he loved Chesterfield and went into great detail why. It was clear that sometime

in the evening Pfremmer was going to speak on favoring the Staenberg Group development of the Chesterfield Mall, the question was when?

At the four-minute mark Pfremmer was told by Mayor Nation that normally his time would be up, but since he is speaking on such an important issue he could continue. At about the 10-minute mark he stated how he favored the current Staenberg plan with no changes.

Rudermund spoke of being offended by persons (including council persons) who were trying to "torpedo" these p[ans. "I feel betrayed after all the time I put into this," he said.

Mary Brown, former councilwoman and former member of the Planning Commission said she was against Dan Hurt's amendment proposal and for the Staenberg plans.

Mike Doster, local Chesterfield lawyer representing the developers, stated that the developers were still requesting a postponement to review their plans and to decide if they would continue the development plans. Doster also stated he had no authority from his clients to field any questions. He added the letter filed with the city still stands.

DAN HURT DEFENDS HIS AMENDMENT Dan Hurt made a motion at the Planning Committee meeting to restrict the first floor area for residential units to a smaller area. The amendment passed 3-1 with chair Merrell Hanson voting no.

Hurt said at the committee meeting that Tim Lowe of the Staenberg Group did not necessarily want the current Staenberg plan to be use. Hurt added that the committee and the city cannot get permanent plans from Staenberg about the project.

Councilwoman Mary Monachella backed Hurt. "We want to make sure that the buildings are not all residential. It is not that we want to control this, but we want to make sure it is mixed use as we sold to our constituents."

The Hurt amendment died. It was a 4-4 vote with Hurt, Monachella, Bard McGuinness and Mary Ann Mastorakos voting for the amendment. Voting against it was Aaron Wahl, Michael Moore, Merrell Hanson and Gary Budor. The 4-4 tie was happily broken by Mayor Nation who voted against Hurt's amendment.

WHAT REVENUE SHORTAGE? Recently the Chesterfield Finance Department pointed out a possible future drop in sales tax revenue due to online shopping. Despite this warning the City Council voted to earmark \$500,000 from the General Fund to be used for future construction of Pickleball courts at an unknown date.

MORE PICKLEBALL ACTION: The council also voted to spend \$40,000 fencing and windscreens on the City pickleball courts in Chesterfield Valley. The complaint is on windy days the ball is blown around too much. To me this would just make more exciting play.



A BILL BEFORE THE COUNCIL WOULD ALLOW THE CITY COUNCIL TO VOTE MEMBERS OUT OF OFFICE FOR TALKING TO THE PUBLIC ABOUT CERTAIN ISSUES: There were proposed changes to an existing ordinance that calls for the possible impeachment of council members who discuss anything from a "closed to the public" session of the council. (addition in bold)

67. Rule 7. Any person in attendance at an executive session is honor-bound not to violate the confidentiality of the discussion taking place during the session, except as to any portions thereof which may clearly transgress the Sunshine Act. **Violation of this subsection may be cause for removal pursuant to RSMo 77.340**

Here is what RSMo 77.340 says:

— The mayor may, with the consent of a majority of all the members elected to the city council, remove from office, for cause shown, any elective officer of the city, such officer being first given opportunity, together with his witnesses, to be heard before the council, sitting as a court of impeachment.

This addition to the City Ordinance would mean:

A council person could not talk to a resident or answer a question about an issue discussed in closed session without being impeached.

A council person cannot take a public stand on an issue discussed in closed session without being impeached.

It would encourage the mayor to hold more closed secret sessions to avoid citizens' outrage on a subject.

It would take away the public's right to vote into office a council person for a two-year term. Likewise it would take away the public's ability to vote a councilperson out of office.

The last try at impeachment in Chesterfield was in November of 2015. The issue was to impeach current Mayor Bob Nation after he dropped a "F" bomb in his closed office with a female staffer present. The "F" bomb was directed at something the City Administrator Mike Herring did.

A special attorney hired by the City found there was not grounds for impeachment. This disappointed councilpersons Mike Casey, Elliott Grissom, Connie Fultz, former mayor John Nations' wife Bridget Nations and Bruce DeGroat.

The councilpersons decided to Censure Mayor Nation. This cost the city a lot of money in legal fees and staff time. Mayor Nation hired well known attorney Chet Pleban to represent him.

Mayor Nation was promptly reelected to two more terms. Fultz was voted out of office, Casey left office and Grissom left town.

After having gone through this waste of time and money, one might think Mayor Nation would have killed this change to impeach sitting councilperson talking about city issues. He didn't.



Enough councilpersons were suspect of this change that the bill was voted to be removed from the agenda and sent to the Finance and Administration Committee.


