THIRD USE: For two years the corner was used by the Missouri American Water CO. to store water main pipes being used as replacement in Town and Country and Parts of Des Peres.





That James Roger Paul Collier, in violation of Section 575.150, RSMo, committed the class E felony of resisting a lawful stop, punishable upon conviction under Sections 558.002 and 558.011, RSMo, in that on or about June 2, 2023, in the County of St. Louis, State of Missouri, Todd Lantz, a law enforcement officer, was attempting to make a lawful stop of defendant, and the defendant knew that the officer was making a lawful stop, and, for the purpose of preventing the officer from effecting the stop, resisted the stop of defendant by fleeing from the officer, and defendant fled in such a manner that created a substantial risk of serious physical injury or death to other persons in that defendant reversed as officer approached his vehicle and operated his vehicle at a high rate of speed.

# COUNT: 04 RESISTING ARREST/DETENTION/STOP BY FLEEING - CREATING A SUBSTANTIAL RISK OF SERIOUS INJURY/DEATH TO ANY PERSON

That James Roger Paul Collier, in violation of Section 575.150, RSMo, committed the class E felony of resisting a lawful stop, punishable upon conviction under Sections 558.002 and 558.011, RSMo, in that on or about July 12, 2023, in the County of St. Louis, State of Missouri, Matthew Niemeyer, a law enforcement officer, was attempting to make a lawful stop of defendant, and the defendant knew that the officer was making a lawful stop, and, for the purpose of preventing the officer from effecting the stop, resisted the stop of defendant by fleeing from the officer, and defendant fled in such a manner that created a substantial risk of serious physical injury or death to other persons in that defendant operated his motor vehicle at a high rate of speed and drove on the shoulder of the roadway to avoid heavy traffic.

# COUNT: 05 RESISTING ARREST/DETENTION/STOP BY FLEEING - CREATING A SUBSTANTIAL RISK OF SERIOUS INJURY/DEATH TO ANY PERSON

That James Roger Paul Collier, in violation of Section 575.150, RSMo, committed the class E felony of resisting a lawful stop, punishable upon conviction under Sections 558.002 and 558.011, RSMo, in that on or about July 13, 2023, in the County of St. Louis, State of Missouri, Matthew Niemeyer, a law enforcement officer, was attempting to make a lawful stop of defendant, and the defendant knew that the officer was making a lawful stop, and, for the purpose of preventing the officer from effecting the stop, resisted the stop of defendant by fleeing from the officer, and defendant fled in such a manner that created a substantial risk of serious physical injury or death to other persons in that defendant operated a motor vehicle at a high rate of speed and swerved into the center median to avoid traffic.

I, Steven Gorczyca, DSN 350, Chesterfield Police Department, knowing that false statements on this form are punishable by law, state that the facts contained herein are true and documented in report number 23-2340. I have probable cause to believe that on February 21, 2023, within St. Louis County, at 290 THF Blvd., 1789 Clarkson Rd., Clarkson and Baxter, and Chesterfield Pkwy E and MO-340, James Collier, White, Male, 5'11", 170lbs, committed one or more criminal offense(s).

The facts supporting this belief are as follows: On March 7, 2023, officers received a report of a stealing over \$750 from Lowe's in Chesterfield from February 21, 2023. Witness reviewed the CCTV footage, which showed defendant entering the store and placing an EGO Power Station in his cart, along with other items. Witness identified defendant on video surveillance from the self-checkout due to having prior contact with defendant and observed defendant scan a bar code for a separate item on the top of the EGO box for \$99 instead of \$999 and exit the store. Officer went to defendant's residence, where the homeowner consented to officers searching the residence for defendant.

Officers, in plain view, observed an EGO Power Station. On April 19, 2023. officers received a report of a stealing over \$750 from Lowe's in Chesterfield from February 23, 2023. Witness, who is familiar with defendant, stated defendant entered the store and selected a Kitchenaid range hood valued at \$1379 but scanned a bar code for a \$33.73 shower rod at the self-checkout. Defendant was identified in face recognition surveillance photos by witness and officers who were familiar with defendant. Officers placed a wanted for defendant. On June 2, 2023, officer, who was familiar with defendant, observed defendant operating a motor vehicle at Clarkson near I-64. A computer inquiry revealed defendant had an active warrant. Officer located defendant parked at a gas station at 1789 Clarkson Rd. Officer approached the vehicle, and defendant reversed and sped out of the parking lot as officer yelled for defendant to stop. Officer followed defendant. Defendant drove at a high rate of speed and the pursuit was terminated. On July 12, 2023, officer observed defendant operating a motor vehicle at Clarkson and and Baxter, and was aware defendant had a warrant for his arrest. Officer conducted a computer inquiry, identified defendant from previous interactions, and activated his emergency equipment. Defendant fled at a high rate of speed and drove on the shoulder around heavy traffic. Officer observed defendant at MO-340 before Interstate-64. On July 13, 2023, officer observed a wanted vehicle while on patrol. Officer made a U-turn on MO-340 and observed defendant as the driver of the vehicle and activated his emergency equipment. Defendant fled at a high rate of speed and swerved into the center median to go around traffic. Officer terminated the pursuit. On July 16, 2023, defendant was arrested in Maryland Heights for wanteds/warrants. Defendant admitted to officer he was driving the vehicle on July 13, 2023.

I believe that the defendant poses a danger to the community or to any other person because of the nature of the offenses listed above wherein defendant fled from police on three separate occasions, operating his motor vehicle at a high rate of speed, swerving around traffic, and driving on the shoulder of the roadway.



That Dawn Flores, in violation of Section 570.030, RSMo, committed the class B felony of stealing by deceit, punishable upon conviction under Section 558.011, RSMo, in that on or about September 1, 2023, in the County of St. Louis, State of Missouri, the defendant attempted to appropriate U.S. Currency which property was in the possession of Commerce Bank, a financial institution, and defendant attempted to appropriate such property from Commerce Bank and with the purpose to deprive Commerce Bank thereof by deceit in that the defendant represented to Commerce Bank that she was Debra Rich, a different individual who had a valid banking account at Commerce Bank, which representation was false and known by defendant to be false.

#### COUNT: 02 IDENTITY THEFT OR ATTEMPTED IDENTITY THEFT - 1ST OFFENSE

That Dawn Flores, in violation of Section 570.223, committed the class B misdemeaner of identity theft, punishable upon conviction under Section 558.011, RSMo, in that on or about September 1, 2023, in the County of St. Louis, State of Missouri, the defendant knowingly, with the intent to deceive or defraud, used a fake credit/debit card and a fake Colorado driver's license, a means of identification, not lawfully issued for defendant's use.

I, <u>Domenic Hoffmeister</u>, <u>DSN 0345</u>, <u>Chesterfield Police Department</u>, knowing that false statements on this form are punishable by law, state that the facts contained herein are true and documented in report number 23-3735. I have probable cause to believe that on September 1, 2023, within St. Louis County, [*include all dates and locations*], Dawn Flores, Black, Female, 5'07", 185lbs, committed one or more criminal offense(s).

Count: 01 STEALING OR ATTEMPT TO STEAL - FROM FINANCIAL INSTITUTION

Count: 02 IDENTITY THEFT OR ATTEMPTED IDENTITY THEFT - 1ST OFFENSE

The facts supporting this belief are as follows: On September 1, 2023, defendant attempted to withdraw \$3,000 via a home equity line of credit from the Commerce Bank in Chesterfield. Defendant produced a fake Colorado driver's license and fake credit/debit card that used the identification of Debra Rich in order to try an open the account. Employees recognized defendant from internal bulletins as having done thefts in similar ways in the recent past. Police were called and defendant was arrested.

I believe that the defendant will not appear in court in response to a criminal summons because she has no known Missouri residence and has arrests/convictions from at least 5 different states. Further, her criminal history indicates she has used over 20 different aliases.



#### CITY COUNCIL MEETING



**COUNCIL VOTES 8-0 FOR CHEATERFIELD MALL REDEVELOPMENT PLAN**. At the last Council meeting there was a 4-4 vote on an amendment to restrict residential housing in certain areas of the proposed Downtown Chesterfield proposal to replace the Chesterfield Mall. Mayor Bob Nation was happy to defeat the amendment in favor of the Steinberg Group doing the redevelopment project.

At the meeting on September 5 it was a lovefest. A compromise was reached on residential units in some commercial areas. To ensure things were clear Councilwoman Mary Monachella same this second amendment:

Amend Attachment A, Section I.A.2 by adding Section C as follows:

c. Parcels B1, B2 and B8 as shown on the preliminary Development Plan shall only be used for commercial uses as defined in Section 405.03.040 J, PC&R Planned Commercial & Residential District of the UDC and as permitted in this Attachment.

At the meeting Councilwoman Merrell Hansen moved to pass a compromise amendment plus the one by Monachella and it passed 8-0. Hanson said after the vote, "It (the 97 acre redevelopment) will be an impact on the future of our city."

Even the citizens that expressed opposition in part of the plan last month appeared to be for it. Kelli Unnerstall, the leader of Citizens For Developing Downtown Chesterfield which had over 1,000 people on petitions and emails opposing the original plans, spoke out in favor of the new plans and urged the Council to pass it.

One resident called the remains of the current Chesterfield Mall as a "wart on the city."





CITY COUNCIL APPROVES THE BALLWIN POLICE INSTALLING A FLOCK CAMERA JUST INSIDE CHESTERFIELD CITY LIMITS. The Council in a unanimous voice vote approved the Ballwin MO Police Department to install a Flock Camera just inside the Chesterfield city limits at Clayton Road and Henry Ave.

Chesterfield already has a number of FLOCK cameras in use. The cameras take images of license plates and cars when the license plates are entered into a data base as wanted vehicle vehicles in connection with crimes or having been stolen.

Chesterfield has had very good success finding and tracking cars license plates just involved in crimes in Chesterfield Valley retail district detected by FLOCK cameras.

Henry Avenue runs from Manchester Road in the City of Manchester, just east of the Ballwin city limits, north through a section of Ballwin including a commercial area on the south side of Clayton Road. All of the road (Clayton) is in the City of Chesterfield, plus a small portion of shoulder to the south.

Henry Road continues across Clayton Road into Schoettler Road in Chesterfield.






