
TOWN & COUNTRY ALDERMANIC MEETING



CITIZENS ARE UNANIMOUS AGAINST ADDITIONAL OUSIDE SEATING FOR BARS IN THE TOWN SQUARE: Bob Brickman the developer and owner of the center retail section of the Town Square wants to increase outside seating for the Wild Crush Wine Bar and the Cleaver and Cocktail restaurant and bar from 76 to 172 seats.

Town and Country Planning Director Ryan Spencer pointed out during the meeting that the patio is open to the public and not part of a lease to the bars. Citizens can sit on the patio in the chairs put out by the bars.

“I can tell how you can mitigate the sound. Vote against this,” said Mark Freyenberger.

“Think about having a wedding reception in your backyard every night.”

“They have lights and music on the patio and both are prohibited.”

“We moved from the Central West End to Town and Country for the peace and quiet,” said Nicole Alabach.

“We can hear conversations and aggressive loud talk, including bad language,” said Jenny Donovan.

“We were told this would be family friendly restaurants,” said Pat Wiese. “It is too much of an intrusion.”

“I’m hard of hearing and I can hear everything from there. You cannot turn that noise off,” said Rico Salmon.

“We were told this would be a place for walkers and bicyclists to stop at according to the former mayor. You need to withdraw this,” said Bill Frederick.

Former Alderman Skip Mange let this slip at a neighborhood meeting that then Mayor Jon Dalton wanted the Town Square and then wanted to buy the vacant property next to the firehouse across the street and build a new city hall.



Dalton promised a family friendly restaurant. That never happened, unless your 12-year-old likes whiskey sours. Brinkman promised an Ice Cream Parlor and that didn't happen. This is from the city's website when the Town Square was being developed:

Town Square Vision Statement

The Town Square should be a safe, welcoming, comfortable, public space that accommodates users of all ages, where friends and family can dine, shop, recreate and socialize through the day and evening. It should reflect the character, personality, culture and history of the community, while at the same time addressing the interests and concerns of the adjoining property owners. It needs to be a space that gives people a reason to come to it, along with a reason to stay and enjoy themselves.

Dalton spent \$10,000,000 from the city's cash reserve almost depleting it on the Town Square. Dalton has since gotten divorced and moved out of town.

Greetings elected officials and fellow residents of Town and Country,

We would like you to vote NO on the upcoming Blacksmith Grove CUP. As it stands now, the outdoor seating is already a nightly disturbance to the surrounding neighborhoods. This proposal would magnify this situation.

This proposal is in direct contrast to the agreement between the City and its residents as outlined by the original Town Square Task Force. It seems both the developer/owner and his tenets have total disregard for the quality of life and privacy of the adjoining property owners.

We respectfully ask that you deny this proposed CUP and either substantially limit or prohibit outdoor dining at the Town Square. None of this was envisioned when the original plans for the use of this property was decided upon.

Dear Elected Officials of the Board of Aldermen,

I'm writing to ask you to reject and not pass the CUP request by Bob Brinkman regarding outdoor dining at Blacksmith Grove. It's difficult to know where to begin explaining what a nuisance we already have with the current CUPs, so I'll simply say that passage of this ordinance as currently written will create nothing short of a bar scene in the backyards of all adjoining property owners and ruin our once quiet, peaceful neighborhoods.

With the current CUPs for Wild Crush allowing 28 seats on the patio and 48 seats at Cork & Cleaver, the intrusion of noise is beyond annoying. It's truly disruptive to any outdoor activities we might plan on our own patios and pool decks. Most evenings we can clearly hear conversations and language that are inappropriate for our children and grandchildren to hear. The more patrons at Wild Crush drink, the louder the noise. The louder the noise, the louder they have to shout over each other. Allowing amplified music will raise that noise level even more. And we certainly don't need that until 10:00 pm seven nights a week.

None of this is consistent with the original vision presented to the community and to the adjoining property owners. Passage of this CUP as written is a blank check for an anything-goes environment dropped into an otherwise quiet neighborhood where ordinary people, residents of Town and Country, just want to enjoy the what and the why we bought in Town and Country.

As our elected representatives you have a responsibility and an obligation to honor and to fulfill the agreement made by the City during development of this project. Please consider the long-term impact of this outrageous request on your constituents and vote NO on Brinkman's CUP.

BOARD OF ALDERMEN VOTE DOWN AMENDMENT TO ADD MORE PROTECTION FOR GRAND TREES FROM DEVELOPERS.

The Planning Commission vote 5-3 (with Mayor Rehm voting against it) to approve an amendment to the Grand Tree Ordinance making it more expensive for developers (not homeowners or subdivisions) to remove healthy Grand Trees. The money paid by developers would go into the city's tree fund. To read more on the Planning Commission vote see Newsletter 596,

This is from a memo from the Planning Director Ryan Spencer to alderpersons:

SUMMARY – The intention of this amendment is to amend regulations related to the replacement requirements for Grand Trees. The revision establishes a mandatory fee formula for the removal of any grand trees due to construction of a non-residential development or subdivision. The original amendment, as suggested by former Alderman Wittmaier, was to increase the replacement requirements for Grand Trees from 25% of the total caliper inches of the trees removed to 50%.

A P&Z subcommittee of (former) Alderman Parrotte and Commission member White met on May 3, 2023 to discuss the proposed amendment. It was the belief of the subcommittee that the 25% tree replacement requirement as adopted was sufficient and that an increase to 50% was not sustainable given the physical limitation of a property. For instance the replacement of ten, 20" grand trees (the minimum grand tree size) would trigger a replacement requirement of seventeen, 3" trees at 25%, but thirty-three, 3" trees at 50%.

On the other hand the subcommittee believed that a financial disincentive to remove grand trees in the first place would be more beneficial. Therefore, the subcommittee recommended, that in addition to replacement trees, a fee of \$30 per CSA (cross-sectional area) for 50% of the overall CSA of a grand tree that is removed should be required. Staff added a maximum charge of \$100,000 for the purpose of balancing the public benefit of preserving grand trees against the individual freedom and financial interests of the property owner.

To use Greystone as a recent example of how this amendment would apply:

Greystone Subdivision: 5 healthy, Grand Trees with a total caliper of 153" or 3,970csa were removed.

CURRENT STANDARD

25% replacement standard = 38" or 13- 3" trees or 25% fee (1,985csa x \$30 = \$29,775)

PROPOSED STANDARD

25% replacement standard = 38" or 13- 3" trees in addition to 50% fee (1,985csa x \$30 = \$59,550)

This was the amendment to the current ordinance:

- d. Replacement Requirements: Grand Trees that are removed due to disturbance that is necessary to permit construction, that are otherwise not dead, diseased, or a public hazard, shall require the installation of replacement trees equal to twenty-five (25%) of the total caliper inches of the Grand Trees that are removed.
- (1) ~~In lieu of~~ In addition to the installation of replacement trees a contribution to the designated City of Town and Country Tree Fund shall be made in the amount of thirty dollars (\$30.00) per square inch of ~~twenty-five percent (25%)~~ fifty percent (50%) of the cross-sectional area of the Grand Tree(s) removed up to an amount not to exceed one-hundred thousand dollars (\$100,000).
 - (2) Trees to be planted to meet requirements for new landscaping and bufferyards shall count as replacement trees.

This is an example of the killing trees without city permission by developer Rob Rehnquist.



Several alderpersons stated the amendment would add unfair costs for developers. Sue Allen said it was “Over Regulation.” Of course the existing regulation in the ordinance remained.

Only Alderwoman Barb Ann Hughes voted to add a layer of protection for the trees. Ironically Town and Country has been listed as a TREE CITY USA town.

I, Kyle Tyndell, DSN 0315, Chesterfield Police Department, knowing that false statements on this form are punishable by law, state that the facts contained herein are true and documented in report number 23-3814. While I am targeting January 2024 as an actual date for my retirement, I did want to provide this early notice so as to allow the City Administration sufficient time to plan for my replacement. Additionally, this will allow me sufficient time to seamlessly resolve a number of unfinished issues both within the Department and those resulting from my involvement with several local law enforcement organizations, prior to my departure. During this interim period I also stand ready in any way I may be of assistance with the process of recruitment and selection of a new Police Chief.

This past August 28, 2023 marked my completion of 35 years of service as Chief of Police for the City of Chesterfield. Suffice it to say, the opportunity to serve the City in this capacity has truly been the highlight of my Law Enforcement career. Thank you for all your support over the past years. As a result we have a tremendous amount of

talent within the department, and, I am pleased to say I am leaving the department in good hands, be it short term or long term.

Again, my formal notice of date specific resignation will be forthcoming.
