

Hello Ashley,

Will you please enter this email into the Board of Adjustment's record for the public hearing scheduled for 6PM on Monday, 10/16/2023 for Case No. 23-10?

I apologize for the length of this, but in addition to stating the reasons why I believe this appeal should be denied, I have tried to offer some suggestions for the lot owner and their architect to consider as possible solutions for the challenges they listed in their appeal.

(This letter from Rise Williamson is 3-pages long and a little too long to post in its entirety. Here are some highlights:)

This lot, at **1.75 acres**, has <u>more than enough space</u> to position such a large (over 9,000 sq. ft) home on it *without reducing the side setback minimums* calculated by T&C Zoning Regulations, Section 405.080 (determined to be 49.52 feet on each side for this home).

- 3. While the lot is 1.75 acres, only a small portion of it is on/along Karlin Drive. And this portion of the lot is on a fairly sharp curve on a downhill section of the street. If this appeal is granted, this very wide and large home will be positioned such that its size will appear to "dominate" this section of Karlin Drive.
- 4. Granting this appeal would also position this very large house so close to the neighboring homes that it would appear to be "squeezed in" between them.
- 5. If this appeal is granted, this 3-story home will be positioned such that it will appear to "tower over" the 2-story home on the downhill side (Lot 25 at 1949 Karlin Dr.).
- 6. Allowing this very large, 3-story home, to be squeezed in between two homes on such a small area on a dominate section of a dead-end street and "tower over "at least one of the neighboring homes would have a very real and potentially *substantial negative impact* on the resale value of not only both neighboring homes, but also the other homes on this short street.

To the Town & Country Board of Adjustments,

My name is Doug Rushing and I live at 13101 Thornhill Drive. I have lived at this address in Thornhill Estates for 21 years. I want to register my **opposition** to the request for a variance to the setbacks for the new construction at 1941 Karlin Drive. My home is located six lots from the proposed site. We have seen several of these very large homes constructed in our neighborhood over the past years. While they may not fit with the original styles of homes, as long as they comply with community guidelines they are welcome. However, we have seen some variances granted to homes in the past. The current request to allow reduced setbacks to property lines is unacceptable. The lot at 1941 Karlin is an odd shape, which is very unique to the Thornhill neighborhood. While this lot could still accommodate a more normal size home, it will not work for a nine thousand plus square foot mansion.

When I moved to the neighborhood in 2002, I enlisted an architect to design a plan to build an addition to my home as well as some major renovations of the current floor plan. After we identified a general contractor, we started the construction process. This included removing a very beautiful red maple tree. However, the T&C inspector soon notified me that my proposed plan would put my room addition too close to the property line and my neighbor's home. At significant expense to me, we had to modify the design plan in order to comply with T&C construction guidelines. However, I complied because that is why there are construction setback guidelines. In the case of 1941 Karlin, the owner and the designer must comply with the rules by modifying the floor plan or identifying a larger lot at another location.

BOARD OF ADJUSTMENT MEETING The meeting was held on Monday October 16, in the Aldermanic Chambers. All five members were present, plus the City Attorney Ed Sluys and City Clerk Ashley McNamara along with a court reporter and planning director Ryan Spencer.



It was established the house designing violated subdivision rules and City building codes concerning being too close to adjoining property.

The architect Jeff Day spoke first.



He claimed the house under current design could be placed further back on the lot, but would require truckloads of dirt. He claimed (we and others think falsely) that people driving by would only be able to see the roof of the house. He started to move the designed house to another location on the lot would require 200 truckloads of dirt. He then increased that number to 400 and then 600 truckloads of dirt. He finally stopped at 800 truckloads of dirt, but added that dirt for building projects is in short supply and he did not believe even 200 loads are currently available.

Day never suggested designing or building a smaller house.

Day also claimed over half the houses in the subdivision are in violation of codes. This seemed to be absurd as all lots are 1-acre plus in size and even the new bigger houses do not encroach on neighboring property.

Next it was Dr. Mohammed Zaheer Amin who currently lives in Town and Country on Weidman Road at Clayton Rd. His medical office is in Farmington, MO.



He stated there was nothing in his plans that was "not a reasonable house." It is a 9,300 sq foot house in the plans!

Next he claimed Thornhill Estates is "a very old subdivision." (It began in 1963 and finished in about 1970). Thornhill is NOT OLD. The subdivision where I grew up in in Webster Groves (Sherwood Forest) dates back to 1925. The house I grew up in was finished in 1933. Webster Park behind the Webster Library was built around 1900. Some neighborhoods in Kirkwood were built in the 1890s. Thornhill is not an old subdivision.

"The question is if you look around in the subdivision you see decent size houses."

This is the small house that Dr. Amin lives in on Weidman Road at Clayton Road in Town and Country. It is only on one-acre and is a mere 4,273 sq feet and valued at \$1,307,000 on the low side to \$1,574,000 on the high side.

SPEAKING IN OPPOSITION: Besides 49 emails from subdivision/city residents in opposition a number appeared at the meeting opposed to the requested adjustment.





Here are bits and pieces from some remarks by those in opposition.

"This is simply a self-created hardship by the property owner."

"When you buy a lot in Thornhill you sign the indentures. This is clearly not a hardship. He knew the rules."

"This can be eliminated by simply designing a smaller house."

THE VOTE: The vote was 4-1 against the plans and the violation of City Code concerning setback requirements.

The lone vote for violating the code came from board member Dr. Isam Hawatmeh. Here is Dr. Hawatmeh's modest house on Topping Manor Drive.

Not surprising the three letters expressing support for the plans all came from doctors with Middle Eastern heritage. The only vote for the plans despite overwhelming opposition and clear non-compliance is also by a doctor with a similar heritage as the other supporters.

It was interesting that the two Ward-2 alderpersons who voted to expand outdoor sitting for a bar and a restaurant at the Town Square despite huge opposition from residents were not present at the meeting.

The St. Louis County Prosecuting Attorney's Office has charged Michael Bender, 18, of Chesterfield with Burglary 1st Degree, a Class B Felony; Stealing a Motor Vehicle, a Class D Felony; and Stealing Credit Cards, a Class D Felony

The court set bond at \$75,000, cash-only, no 10% authorized.

According to a Chesterfield Police Department investigation, the victims discovered that their residence in Chesterfield had been entered overnight on October 10, 2023, through an open garage door and a 2016 Hyundai Sonata had been stolen from the garage. The keys to the car had been on a hook next to the door that led from the house to the garage. A purse, containing several credit cards, had been stolen from the same area of the house. Surveillance video from the QuikTrip showed the stolen vehicle being filled with gas by a white male. 
CHESTERFIELD CITY COUNCIL MEETING:
