The former small ranch house used to face Clayton Road. A McMansion was built facing Greenwich Green on a downward sloop. Quickly after construction the classic Mid-Century Modern house designed by well-known architect Ralph Fournier was being flooded. The Lambs, owner of the Fournier house at 603 Greenwich Green, sued the contractor and the City in 2018.

All this could have been avoided if the City under then Planning Director Craig Wilde would have enforced City Building Codes.

# ALDERPERSONS APPROVE THE STARBUCKS FOR CLAYTON AND BALLAS. THE REVENGE OF THE GHOST OF TIM HORTON.

In 2015 the Tim Horton's Donut and Coffee show along with a small branch bank was proposed for the Northeast corner of Clayton Road and Ballas Road.

Tim Horton's named after a Canadian hockey player (who died in a single car DWI crash after celebrating a victory) are very popular in Canada. It was voted down despite

29 letter/e-mails in favor of it and four against it. However there were a number of outspoken people at the meeting against donuts.





The corner had been an empty lot since a Shell gas station and repair garage was torn down. The empty lot was later used for a large-scale water pipe replacement project.





Three years after Tim Horton's was voted down, the zoning code was changed. Town and Country Planner Ryan Spencer stated at the October 24<sup>th</sup> BOA meeting that the property and the plans submitted meet all requirements.

City Administrator Bob Shelton stated that the biggest complaints he has received was from residents complaining about the empty lot and how the lot was used for a water pipe replacement construction project for several years. He also mentioned how Clayton and Ballas was an entry point to Town and Country.





At the meeting one nearby resident spoke in favor of the project saying she was tired of looking at the empty lot.

#### Opposed:

A resident said there were plenty of Starbucks in the area including two on Clayton Road at the West End of town, on Clayton Road and Lindbergh Blvd and another on Manchester in Des Peres and a new Starbucks would suck business away from them

The owner of the Starbucks at Clayton Road and Mason has an interest in the proposed Starbucks and said she is not concerned at all as her business continues to grow. She also mentioned that the Starbucks on Lindbergh at Clayton in Ladue draws a different clientele and is doing very well.

Another resident complained that it was unsafe for people to walk and get a cup of coffee due to a lack of sidewalks. It was pointed out the Starbucks proposal has sidewalks installed on Clayton Rd and Ballas abutting the property. It was added that the city cannot force the preexisting building owners across the street to install sidewalks.

Two residents wanted off-duty police officers to direct traffic at the Starbucks during peak periods.

A complaint was made that the Starbucks would not really being serving workers at two large nearby hospitals (Missouri Baptist and Mercy) as there are Starbucks in the hospitals. This was silly as 75% of the workers would be nowhere close to the Starbucks counters, as both hospitals have separate medical buildings and doctor's offices.

Another complaint was the traffic study was done in July when two nearby schools were off for the summer. A rep for the developer spoke and said the first traffic study was done on July 12 when the schools were closed, but they were aware of this and a second study was done on August 29, two weeks after the schools were in session, adding there was no difference in the overall traffic counts.

Perhaps the most outrageous comments came from attorney Mark Dunn who lives in a subdivision a block south of the intersection.

"It is a hazard. The lot is too small. It creates a negative situation for drivers. The priority of government is the safety of residents. There are no drive throughs at other Starbucks.

**23-4367 Miscellaneous Incident:** A call was received for a check the welfare on Ambridge Ct. involving an elderly female with medical conditions who wasn't answering the phone or answering the door. Family members and friends requested that forced entry be made and the fire department responded. However, no one was found inside. A check of area hospitals and other family did not reveal where the female was. After search efforts began, the female arrived home and had been with a health care aide who had taken her out on errands but did not tell anyone. The door was secured by the condominium maintenance staff.

Of note, when this call transitioned from a check the welfare to a priority missing person call, both the Fire and Police department immediately activated a Joint Incident command and began search efforts around the area. This seamless coordination was a result of training by both police and fire personnel during the last year and demonstrated how mutual aid training is so beneficial.



**23-4451 - Domestic Assault 4<sup>th</sup> degree - Deltona -** The victim's 18-year-old daughter struck her in the face with a closed fist causing a possible broken nose. The suspect was arrested, municipal warrant application to be made.

Officers responded to disturbances, traffic hazards, alarms, suspicious persons, and sick cases.

#### **DAY WATCH**

**23-4452 - Domestic Assault - Ryecroft Ct.:** Officers responded to a report of a juvenile refusing to attend school. Upon arrival, investigation revealed a parental discipline issue evolved into a physical altercation between juvenile siblings. The report will be forwarded to this department's juvenile detective for follow up.

**23-4454 - Larceny - Village Green Pkwy:** Victim reported her wallet was taken from her unlocked vehicle while she was dropping her child off at daycare. Investigation revealed the subject's credit cards were then used in Des Peres, and a check was forged and presented at a yet to be determined location.

**23-4456 - Fugitive arrest - Olive Blvd:** Officers conducted a traffic stop and found the driver to be revoked with several outstanding warrants from surrounding agencies. Driver was arrested and conveyed to Richmond Heights for processing on their charges.

**19-249 - MO Dept of Corrections-Pacific:** Upon completion of a prison sentence, subject was due to be released and was found to have active Chesterfield warrants. An officer responded and took the suspect in to custody for processing.

**No report - Clayton Road:** A manager of an independent living facility found a 98-year-old female to be missing from her apartment for an unknown amount of time. As officers arrived, she was located in a unit under construction on a different floor. Subject was evaluated by EMS and was medically cleared.

Officers also responded to other calls for service to include suspicious persons, motor vehicle crashes, alarms, sick cases. and a motorist assists.

Officers conducted traffic enforcement and also provided close patrol to Businesses, Parks, and Schools.

#### **AFTERNOON WATCH**

**23-4462 - Car Clouting -** THF: Officers responded to a call for a suspect breaking into vehicles. Officers located the suspect hiding in the bushes and arrested him. The juvenile suspect had multiple firearms in his possession, one of which was confirmed stolen. The suspect sustained a deep laceration and suffered significant blood loss from his shattering of car windows. Paramedics determined it was medically necessary to go to Mercy Hospital and conveyed him thereto. Officers obtained a Fit for Confinement and transported the suspect to juvenile intake. I appreciate the excellent job done by the responding Officers. I would also like to commend the Detectives who responded after the apprehension, conducted a more thorough canvass of the bushes, and located additional stolen property.

**Update to 23-4462 (Car Clouting from evening shift)** - Juvenile Intake agreed to hold the juvenile and the following charges were issued:

- (F)Stealing of a firearm from a vehicle.
- (F) Destruction of Property 1st
- (M) Stealing under \$500 x2

**23-4464 - Towed Auto** - Chesterfield Airport Road: An abandoned vehicle was towed from a private business.

**No Report - Found Dog - North Outer 40**: A citizen located a dog running loose at the athletic fields. An SEU Officer responded to the scene and reunited the dog with its owner.

Officers responded to other calls for service for motor vehicle crashes, suspicious persons, citizen contacts, sick cases, and others. They also conducted proactive traffic enforcement and regular patrols of neighborhoods and businesses.

**COURT JUDGEMENT OF \$2-Million AGAINST CHESTERFIELD**: Energy Marketing want to build a gas station, convenience store and car wash. They were turned down by the City of Chesterfield as the City wanted to limit left turns to and from the property.

Energy Marketing's traffic surveys showed no need to ban left turns, adding the Chesterfield had no right to control traffic on a St. Louis County road. A County traffic engineer agreed with Energy Marketing surveys that showed no need to ban left turns.

A smaller gas station moved onto the property with no car wash.

Energy Marketing filed suit in 2017 claiming Chesterfield unconstitutionally seized the property by not letting it do business. The suite originally wanted \$6,000,000.


There was a trial in October of 2023 and the jury found against Chesterfield. A verdict of \$2,000,000 followed.

The City's attorney Chris Granville filed a 28-page motion with the court to dismiss the lawsuit. It was turned down.
