INDICTMENT

COUNT ONE

The Grand Jury charges that:

On or about May 14, 2023, in the County of Saint Louis, within the Eastern District of Missouri,

MACE ANTHONY NOSOVITCH,

the Defendant herein, in connection with the attempted acquisition of a firearm, a Sig Sauer make, P320 model, 9mm caliber pistol, bearing serial number 58J496576, from Sentinel Arms D/B/A The Range St. Louis West, a licensed dealer of firearms within the meaning of Chapter 44 of Title 18, United States Code, knowingly made a false and/or fictitious written statement to Sentinel Arms D/B/A The Range St. Louis West, which statement was intended and likely to deceive Sentinel Arms D/B/A The Range St. Louis West, as to a fact material to the lawfulness of such sale of the said firearm to Defendant under Chapter 44 of Title 18, United States Code, in that Defendant did execute a Department of Justice, Bureau of Alcohol, Tobacco, Firearms, and Explosives form 4473, Firearms Transaction Record, to the effect that he was not subject to a court order restraining him from harassing, stalking, or threatening his intimate partner, when in fact, as Defendant then knew, he was subject to a court order restraining him from harassing, stalking, or threatening his intimate partner.

FROM THE FEDERAL DETECTION ORDER

OTHER REASONS OR FURTHER EXPLANATION:

On May 25, 2023, the undersigned held a detention hearing with defendant and counsel present. On May 31, 2023, the U.S. Pretrial Services Office filed a Bail Report with no objections and it is adopted by reference. Defendant worked as a medical doctor prior to having a massive stroke in November 2022 with lasting impact, including to his speech and physical abulation. He now resides with his parents in St. Louis County. Defendant's wife and two of his minor children live apart from him locally in the family home where he cannot reside because defendant is the respondent in a Ex-Parte Order of Protection matter pending in state court. His wife is the protected party. Defendant and his wife are in divorce proceedings. He is also on bond for felony stalking and a misdemeanor violation of an order of protection. Defendant argued that he is not a danger, nor will he flee. He is already subject to GPS monitoring and he is amenable to all conditions of release, including home detention. Pretrial release will help him facilitate his access to needed medical care.

The government offered the testimony of FBI Special Agent Cassandra McKenzie, who specializes in behavioral threat analysis. She testified consistent with the government's detention motion about events leading to this charge and her assessment that defendant poses a significant danger to another person and the community after he visited a local gun range and test fired at least two firearms on Mother's Day with a suppressor attachment. Defendant began the background check to purchase the firearm. Video surveillance and stills show that defendant was able to stand, shoot and manipulate the firearms without assistance. (Gov't Exs. 1A and 1B). Later the same day, he was allegedly in the backyard of the family home in violation of the order of protection. He has been seen at a sporting event of his child and near the school during afterschool pick up when the protected party was present. The FBI agent believes that defendant's grievance about the impending divorce and frustration about his circumstances is increasing the risk of harm to the community. The government also presented evidence that his GPS monitoring equipment is prone to fail at his apartment do to an unknown source of interference. Based on the above, defendant poses a serious risk of danger to the another person and the community. He also has access to significant financial resources and he faces a significant sentence if convicted, which gives him incentive to flee and not appear as ordered. For these reasons, he should be detained.

Part IV - Directions Regarding Detention

The defendant is remanded to the custody of the Attorney General or to the Attorney General's designated representative for confinement in a corrections facility separate, to the extent practicable, from persons awaiting or serving sentences or being held in custody pending appeal. The defendant must be afforded a reasonable opportunity for private consultation with defense counsel. On order of a court of the United States or on request of an attorney for the Government, the person in charge of the corrections facility must deliver the defendant to a United States Marshal for the purpose of an appearance in connection with a court proceeding.

COUNT: 01 STALKING - 1ST DEGREE - 1ST OFFENSE – CLASS E FELONY

That Mace Nosovitch , in violation of Section 565.225, RSMo, committed the class E felony of stalking in the first degree, punishable upon conviction under Sections 558.011 and 558.002, RSMo, in that on or between April 18, 2023 and May 2, 2023, in the County of St. Louis, State of Missouri, the defendant, through the defendant's course of conduct, purposely disturbed C.N. by entering onto the premises of Maryville University's baseball fields and coming within 500 feet of C.N., and thereby would have caused a reasonable person under the circumstances to be frightened, intimidated, or emotionally distressed, and at least one of defendant's actions was constituting the course of conduct in violation of an order of protection, which was issued on February 1, 2023 in cause number 23SL-PN00528, by making threatening advances and gestures towards C.N. and driving by C.N. honking his horn at her, after the defendant had received actual notice of such order on February 1, 2023.

COUNT: 02 VIOLATION OF ORDER OF PROTECTION FOR ADULT - 1ST OFFENSE - CLASS A MISDEMEANOR

That Mace Nosovitch , in violation of Sections 455.010 and 455.085, RSMo, committed the class A misdemeanor of violation of order of protection, punishable upon conviction under Sections 455.085, 558.002 and 558.011 in that on or about May 2, 2023, the defendant, having been served with a copy of an order of the Circuit Court of St. Louis County, cause 23SL-PN00528, that prohibited the defendant from coming within 500 feet of C.N., knowingly violated the terms and conditions of the order by being within 500 feet of C.N., and entering the premises of Whitfield near Kirk of the Hills Day School.

I, Katie Exline, DSN 0123, Town and Country Police Department, knowing that false statements on this form are punishable by law, state that the facts contained herein are true and documented in report number 23-00521. I have probable cause to believe that between April 18, 2023 and May 2, 2023, at 13446 Conway Rd. and 12928 Ladue Rd., Mace Nosovitch, White, Male, DOB 06/19/1975, 6'01", 190lbs, committed one or more criminal offense(s).


Count: 02 VIOLATION OF ORDER OF PROTECTION FOR ADULT - 1ST
OFFENSE

The facts supporting this belief are as follows: Defendant and victim are separated. Victim filed an order of protection against defendant on February 1, 2023, in cause 23SL-PN00528 in the Circuit Court of St. Louis County. The order was served on defendant on the same day, which prohibited him from coming within 500 feet of victim, her residence, place of employment or school. The order of protection only allowed defendant to be present at their children's sporting activities at Maryville University, but required him to stay at least 500 feet from victim and refrain from all contact with victim. Between April 18, 2023 and May 2, 2023, Defendant appeared multiple times at the Maryville University baseball fields and attempted to intimidate victim by pointing, cursing, and gesturing at victim, and pulling his vehicle up next to victim's vehicle and honking. On multiple other occasions, including May 2, 2023, defendant also showed up to the children's school, where he did not have permission to be, within 500 feet of victim, and would watch victim as she picked up the children from school. Due to the order of protection, all firearms were seized from defendant and he was prohibited from having them in his possession. On May 14, 2023, there was a NCIC hit that defendant was attempting to purchase a firearm.

I believe that the defendant poses a danger to a crime victim because defendant continues to violate an active order of protection, attempts to intimidate and curse at victim, and attempted to buy a firearm knowing he was prohibited from having them in his possession.

13 MONTHS AFTER STEALING \$1,400 FROM THE POLO STORE CHESTERFIELD POLICE MAKE ARRESTS. THEY WERE CHARGED WITH FELONIES BY THE COUNTY PROSECUTOR: Marla King would place the order of items she wanted stolen. 52-year-old Veronica Cooper of Jennings along with two juveniles would go out and steal it. On September 24, 2022 the group with King joining them hit the Polo Store at the Premium Outlet Mall in Chesterfield Valley for \$1,442 worth of items. They returned the next day and were stealing \$500 of goods when interrupted by store staff and arrested. Also stealing items was 29-year-old Marla King. King liked stealing in Chesterfield and apparently likes the police department too...she has been arrested six time in less than 2-years in Chesterfield.

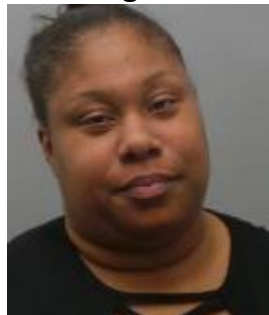

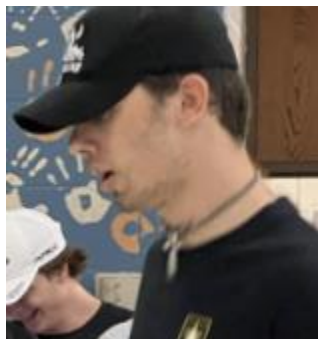

CHESTERFIELD CITY COUNCIL MEETING



NEW POLICE CHIEF ANNOUNCED: Chesterfield announced the upcoming appointment of the 34-year-old department's second police chief at the City Council meeting. Replacing the city's original and first chief, Ray Johnson, will be Capt. Cheryl Funkhouser.



Capt. Funkhouser started her police career with the University City Police Department and has been with Chesterfield for over 30 years. She has her masters degree in Public Safety and is a graduate of the FBI Academy outside of Washington, DC. The appointment of an existing command officer is a good move. When you hire an outsider they have a tendency to make rapid changes, which are not needed in Chesterfield.

This is from the City's website on her background with the city:

Throughout the course of her police career, she has served as a Field Training Officer, Bicycle Patrol Officer and D.A.R.E. officer. She has served as a department instructor in the topics of Firearms, Defensive Tactics, Force on Force, Racial Profiling, Officer Safety, Fair and Impartial Policing and Officer Wellness – Surviving Secondary Trauma. She also served as an instructor at the St Louis County and Municipal Police Academy as a Field Training Instructor trainer.

After the announcement of the retirement of Ray Johnson, Capt. Funkhouser already had strong support among councilpersons.

She will be the only current woman police chief in St. Louis County. As a 30-year law enforcement veteran including and as an ast. and acting police chief, I think this is a very good move by the City Council.

CHESTERFIELD, Mo., Nov. 7, 2023.— In a meeting held Monday, November 6, the City Council unanimously consented to Mayor Bob Nation's appointment of Captain Cheryl Funkhouser as the Chesterfield Police Department's next Chief of Police following Chief Ray Johnson's announcement in September of his intent to retire in early 2024.

Captain Funkhouser will serve as the City of Chesterfield's second Chief of Police in the city's history. Chief Ray Johnson's 35-year tenure dates back to Chesterfield's incorporation in 1988.

Captain Funkhouser began her law enforcement career in 1993 with the City of University City Police Department. Captain Funkhouser joined the City of Chesterfield in 1995 where she has served the Chesterfield community for 28 years in several community-facing and leadership roles. Beginning her career with Chesterfield as a patrol officer and community affairs specialist, Captain Funkhouser grew into her position within the Chesterfield Police Department after being promoted to sergeant and supervising the Bureau of Community Affairs and the Bureau of Uniformed Patrol. Over 12 years, she earned promotions from sergeant to lieutenant and then to captain, where she has served as Commander of the Division of Operational Support since 2017.

During her time with the City of Chesterfield, Captain Funkhouser continued her education by earning her Bachelor of Arts in Human Resource Management from Lindenwood University in 2008, graduating from the FBI National Academy – Session 279 in 2020, and earning her Master of Public Safety from the University of Virginia in 2022.

Former Chief of Police Ray Johnson will spend the final months of his career advising Captain Funkhouser in her transition into Chesterfield's next Chief of Police.

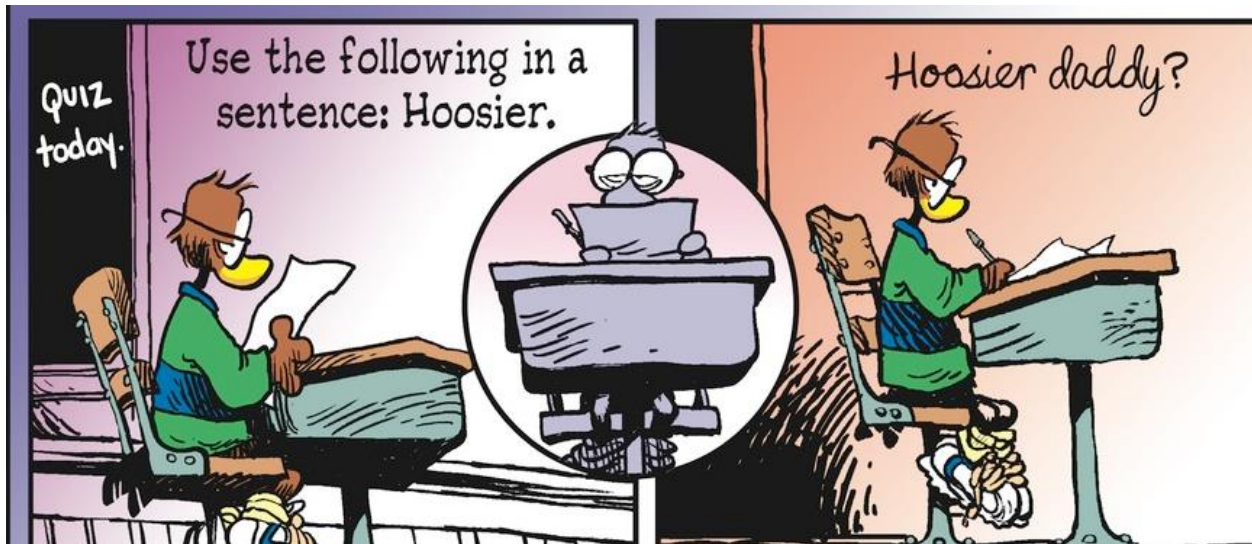
