Here is a photo of the playground at Town and Country's Longview Park. Of course the artificial turf has to be replaced upon wear conditions. But look at how much is being spent below the photo. Of the more than a half-million dollars, \$465,000 is from a Country Parks Grant. However that grant comes from the taxpayers' pocket country wide. The other \$100,000-plus is out of the Town & Country bank account.

RE: Longview Playground Equipment Purchase Order

REQUESTED ACTION – Approve a purchase for Hutchinson Recreation & Design in the amount of \$175,000. The equipment deposit is \$36,000, with the remainder due upon delivery.

The questions remain: is over \$500,000 necessary to replace playground equipment and turf? Are the kids playing on the equipment going to care about an updated aesthetic look?

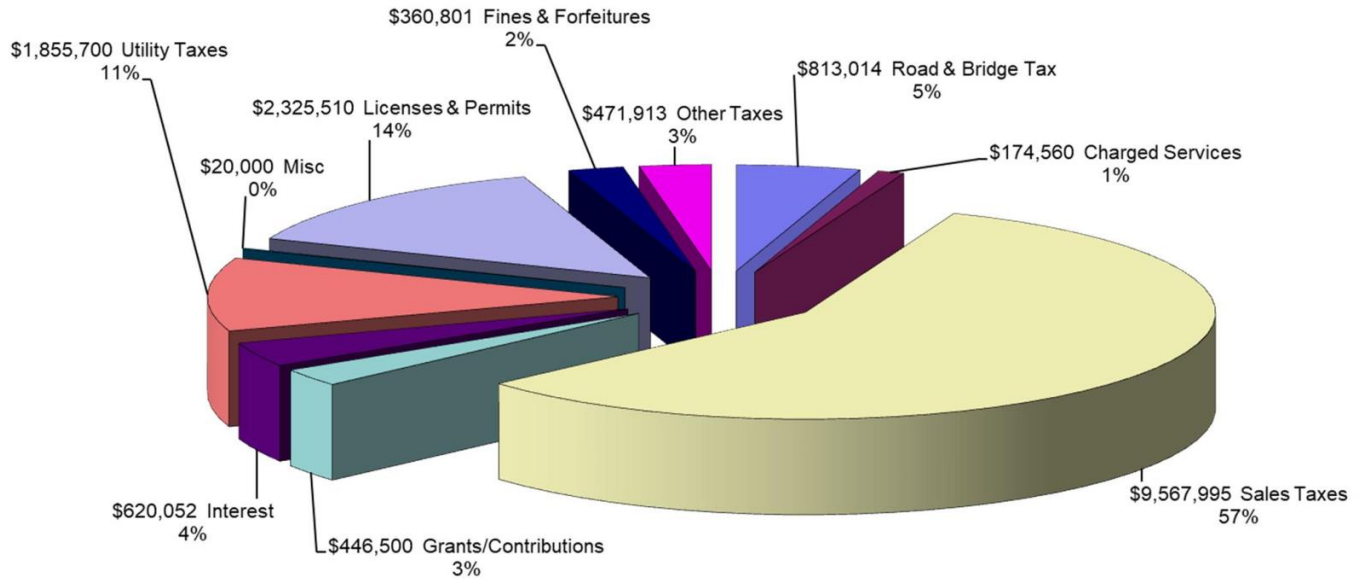
If I remember correctly the mayor had pushed a property tax that was on the ballot only to be defeated. The reason was that the City, thanks to former mayor/cigarette lobbyist Jon Dalton, spent \$10,000,000 on the Town Square to drain the City's budget reserve, but there is \$100,000 to spend on top of a \$435,000 grant for park equipment.

The Bill was first read on November 13 and will be voted on at the next meeting.

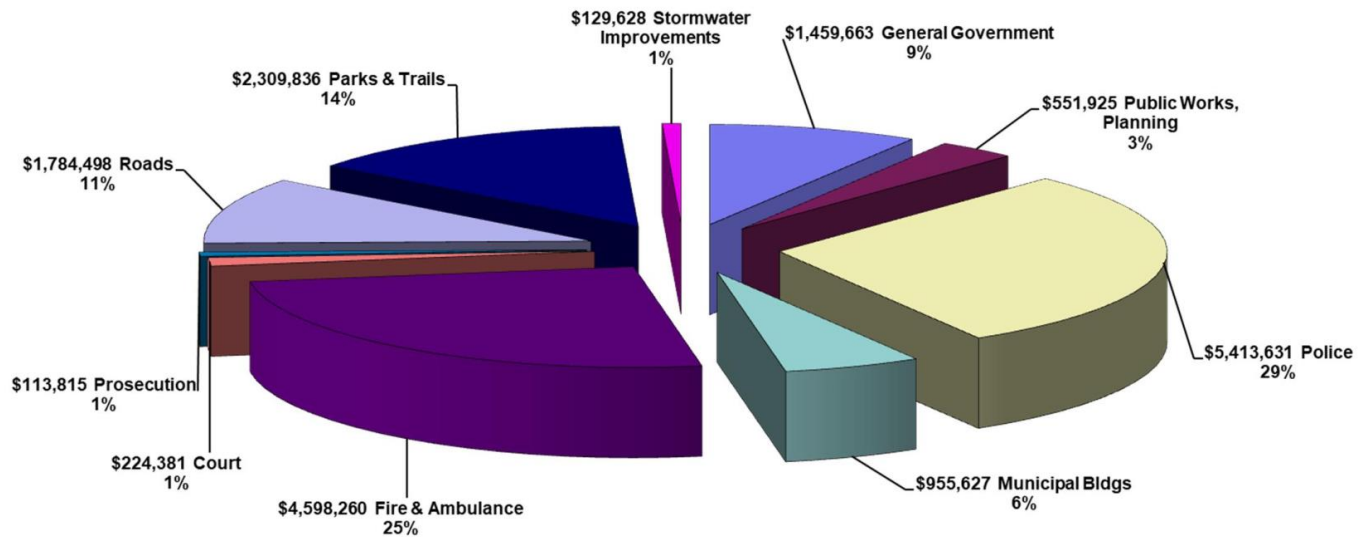
BUDGET: The pre-meeting agenda had just one item and was listed as the 2024 Draft Budget, but when we contacted the finance director for a copy of the "draft budget" she wrote back saying it was not yet completed. But I got a copy of Director Joan Jadali's presentation at the meeting. Here are a few highlights:

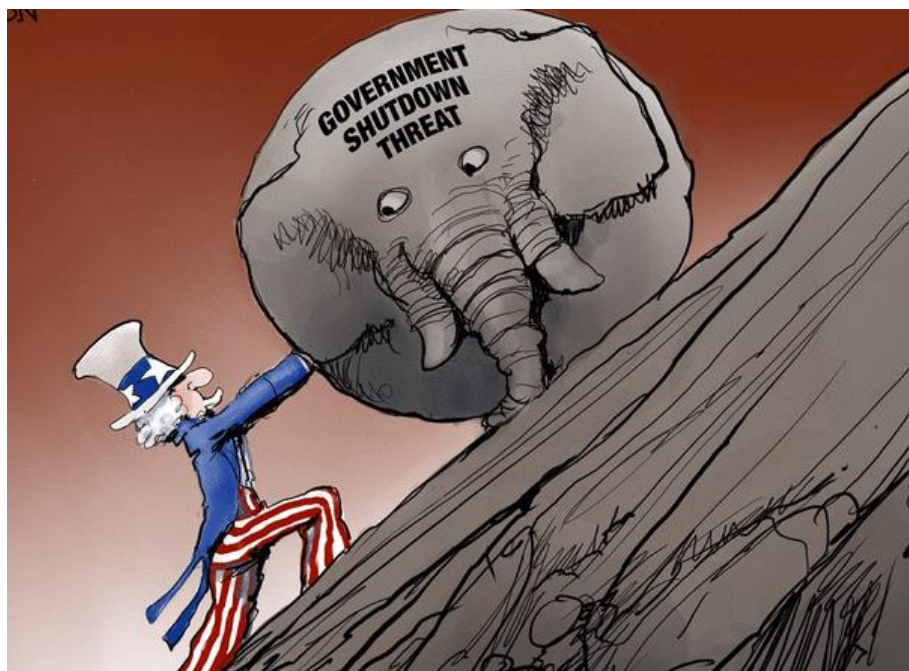
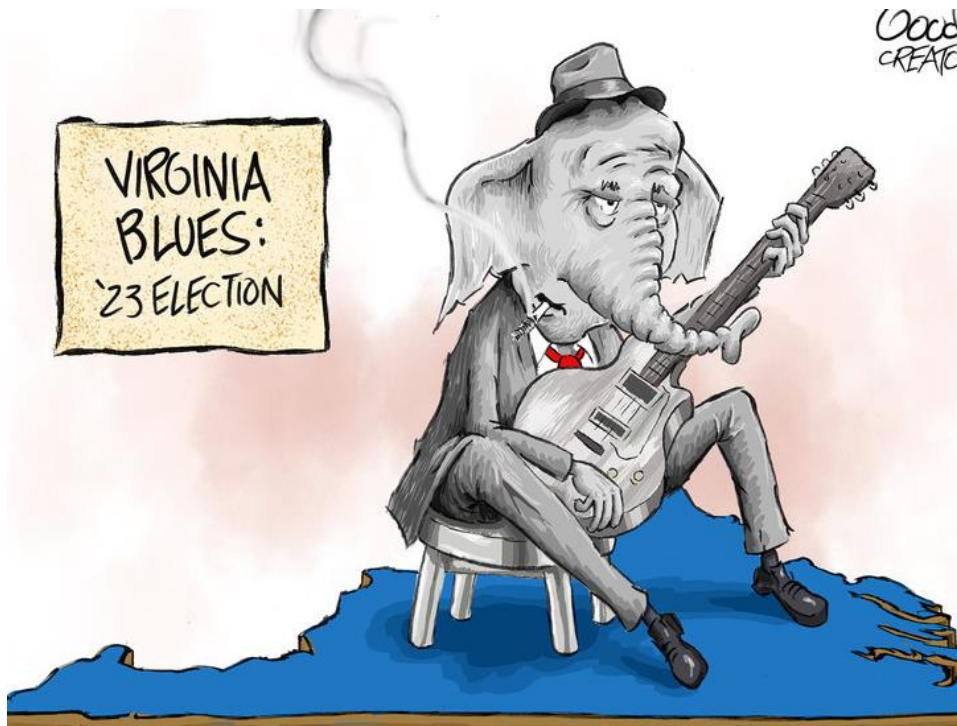


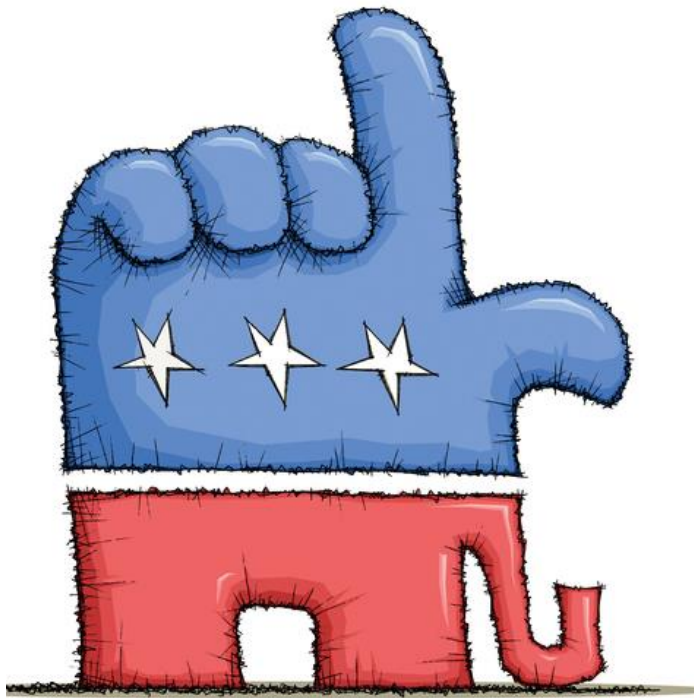
