NEW POLICE CHIEF NAMED IN TOWN AND COUNTRY There is a name change at the Town and Country Police Department, Danny Wilkey is now Daniel and most people are calling him Chief. On November 7 Wilkey was named Police Chief. He replaces James Cavins, who was suspended in July and fired (forced to resign) the first week in August for various reasons.



Chief Wilkey came to Town and Country after 8 ½ years with the Crystal City Police in Jefferson Country where he ran the detective unit. He was hired by Town and Country in May of 2014. He oversaw operations, admin and support for the last 4 ½ years.

He made the jump from Lieutenant over two captains to the chief's job. Actually his handling of departmental support staff made him the perfect candidate for the job, since that is the biggest function of a chief. Also as a current employee he is familiar with operations.

The other advantage Wilkey had was that he was fairly well liked by both City Hall staff and officers.

After the disaster of the Cavins' reign this appears to be a smart more. Cavins came from O'Fallon Illinois and really didn't know much about the department or area policed. Chief Wilkey managed to avoid much of the internal controversy created by Cavins that some supervisors and command officers didn't.

Assist Other Agency

Two officers from the Chesterfield Police Department helped Wildwood officers establish a perimeter on Shepard Road following a felony domestic incident. The suspect, armed with a handgun, escaped from Wildwood officers into a nearby wooded area. Additional assistance was provided by Eureka and Creve Coeur Police Departments, with Creve Coeur deploying a drone to aid in the search. After several hours, the search was discontinued, and our officers returned safely to their sectors.

CHESTERFIELD POLICE GET SUED FOR FALSE ARREST, BUT AFTER READING THE LAWSUIT IT SEEMS THE COUNTY POLICE SHOULD BE SUED. Perhaps you read the story about Tim Reinhardt being arrested on I-64 for a crime he did not commit. Upon getting a copy of the lawsuit filed in Federal Court it almost appears as if the wrong police department was named or at least not included. The following is from the lawsuit.

COMPLAINT

Plaintiff Timothy Reinhardt ("Mr. Reinhardt") brings this cause of action pursuant to 42 U.S.C. § 1983 to assert constitutional rights under the Fourth and Fourteenth Amendments to the Constitution of the United States, which were violated by Defendants City of Chesterfield, Missouri ("Defendant Chesterfield" or "City"), Lt. Lance Rouse, and Officer Gregory Rupp (collectively, the "Defendants"), through their use and abuse of an unlawful "Wanteds" procedure.

ALLEGATIONS

- 6. On November 17, 2022, Mr. Reinhardt drove to a store near Lindbergh Boulevard in South St. Louis County.
- 7. Mr. Reinhardt purchased a cord for his cellular phone, paid for it, and left soon after.
 - 8. He did not commit theft.
- 9. When Mr. Reinhardt returned to his vehicle, he unpackaged the cord he had just purchased and plugged it in so that he could charge his phone.
- 10. After Mr. Reinhardt paid for his item and left the store, a different man walked into the store and stole a personal computer.
- 11. The store manager saw this man, who was not Mr. Reinhardt, exit the store. The store manager claimed that this man stole a computer from the store.

- 12. The store manager did not follow the thief immediately out of the building nor did she track his direct whereabouts on the store's surveillance cameras.
 - 13. At some point after the thief left with the computer, the store manager belatedly went into the parking lot, where she saw Mr. Reinhardt and not the thief in Mr. Reinhardt's vehicle.
 - 14. The store manager took a photo of Mr. Reinhardt's vehicle and license plate, wrongly believing Mr. Reinhardt was the thief.
 - 15. The store manager then called the St. Louis County Police Department ("SLCPD"), who came and purportedly initiated an investigation.
 - 16. The store manager also provided the photo she took of Mr. Reinhardt's vehicle to the SLCPD.
 - 17. A simple review of the store video would have shown Mr. Reinhardt exiting the store before the thief entered it, completely exonerating Mr. Reinhardt. The store video would have also confirmed that Mr. Reinhardt did not possess a computer when he left the store.
 - 18. Using only the photograph of Mr. Reinhardt's vehicle provided by the store manager and not the store videos, SLCPD ran a search of the vehicle and learned the vehicle was registered to Mr. Reinhardt.
 - 19. After learning the name of Mr. Reinhardt, SLCPD obtained his photograph and brought a photo array to the store manager. The store manager incorrectly identified Reinhardt as the person whom she believed stole the computer.
- 20. Once again, SLCPD failed to compare the photo of the thief from the store's video system with the photo of Reinhardt. Doing so would have clearly exonerated Reinhardt.
- 21. Based on the foregoing information, SLCPD put out a warrantless "Wanted" for Mr. Reinhardt's arrest.
- 22. Less than two weeks later, on November 27, 2022, Mr. Reinhardt was finishing a courier route in Chesterfield and heading back to his home in the City.
- 23. On Interstate 64/40 headed eastbound, Mr. Reinhardt noticed police lights behind him.
- 24. He pulled over carefully, at which point Defendant Rouse commanded him on the police vehicle loudspeaker to get out of the vehicle and walk to the police car.

- 25. As Mr. Reinhardt walked carefully to the police vehicle, cars whizzed past him on the interstate.
- 26. Neither Defendant Rouse nor Defendant Rupp had probable cause to arrest Mr. Reinhardt and conducted no investigation to determine whether probable cause existed to substantiate an arrest.
- 27. Solely on the basis of the Wanted, Defendants Rouse and Rupp arrested Mr. Reinhardt and brought him to Chesterfield PD. Neither Defendant Rouse nor Defendant Rupp made any effort to determine the veracity, viability, or legality of the underlying Wanted.
- 28. There were no exigent circumstances to justify Mr. Reinhardt's arrest, there was no evanescent evidence, and he was not a fleeing felon. In the two weeks since he first was considered a suspect, no law enforcement agency applied for a warrant for Mr. Reinhardt's arrest.
- 29. Prior to his encounter with Defendants Rouse and Rupp, Mr. Reinhardt had a spotless criminal record and had never been arrested or jailed or even so much as been fingerprinted by police.
- 30. Nevertheless, Reinhardt was booked, photographed, and had his fingerprints taken at the Chesterfield jail.
- 31. At the Chesterfield jail, Mr. Reinhardt was provided with no information regarding his detention, nor was he provided any process. He was simply forced to sit at the jail based upon Chesterfield's decision to enforce the extrajudicial warrant issued by St. Louis County.
- 32. Once at the Chesterfield jail, Mr. Reinhardt waited for several hours until officers from St. Louis County picked him up and brought him to the County Justice Center in Clayton.
- 33. Mr. Reinhardt has suffered damages of emotional distress, humiliation, loss of liberty, physical discomfort, and loss of sleep.
- 34. On November 1, 2022—three weeks before Mr. Reinhardt's arrest—the Eighth Circuit declared St. Louis County's system of issuing Wanteds to be largely unconstitutional and limited to exigent circumstances where a warrant cannot be obtained in a timely manner. *Furlow v. Belmar*, 52 F.4th 393 (8th Cir. 2022).

35. The Furlow Court further held:

The old west-style "Wanted" posters and reward notices may have once permitted warrantless arrests of suspects pursuant to notices like Wanteds... but that practice lost its vitality in the twentieth century. Since at least the 1970s, case law has established that a warrantless arrest prompted by a notice from one officer to another is unconstitutional unless: (1) the arresting officer is able to make an independent finding of probable cause, *see Whiteley v. Warden, Wyo. State Penitentiary*, 401 U.S. 560, 568–69, 91 S.Ct. 1031, 28 L.Ed.2d 306 (1971) or (2) the arresting officer has been working closely with the officer who made the initial and valid probable cause determination, *see*, *e.g.*, *United States v. Stratton*, 453 F.2d 36, 37 (8th Cir. 1972); *United States v. Heisman*, 503 F.2d 1284, 1286–87, 1289–90 (8th Cir. 1974).

Furlow v. Belmar, 52 F.4th 393, 406 (8th Cir. 2022) (parenthetical explanations omitted).

- 36. Despite this long-standing case law, Chesterfield had for years enforced a policy of issuing and detaining individuals upon Wanteds.
- 37. After the *Furlow* ruling further clarified Eighth Circuit case law, Defendant City of Chesterfield still continued to unlawfully arrest and detain individuals on Wanteds.

There are seven more pages to this lawsuit, but this is the main section. It is also amazing that the St. Louis County Police are not co-defendants. The facts showed that the County Police were derelict in their duty from the start resulting in the unfair and illegal arrest of Tim Reinhardt.

43-years ago I moved to the west side of Missouri and was a police officer for 10-years at the Liberty Police Department (Liberty was famous for being one of the first cities in Missouri dating back to the 1820s and more famous for being the location of the first daylight bank robbery in the U.S. by the James Gang.).

Arrest wanteds were not used in the Kansas City region by police are in fact nowhere else in Missouri other than the St. Louis region. Officers had no idea what "arrest wanteds" were.

CITY COUNCIL MEETING



NEW PLAYGROUND AND RECONSTRUCTED ATHLETIC FIELD Last week we reported how Town and Country is spending over \$550,000 to replace a popular playground at Longview Park, using a County Parks Grant plus \$100,000 in City funds.

This appeared to be rather excessive and wasteful. Meanwhile out in Chesterfield Valley, the Chesterfield Parks Department has a bill before the Council to renovate the Miracle Baseball Field including a new scoreboard and build a playground for just \$546,250 from a Park Grant and only \$28,750 in City funds. Rental of the sports field will provide some recovered revenue to the City.



CRICKET ANYONE? Ever since he got elected in 2021 beating incumbent Michele Ohley by 5 votes, Ward-4 Councilmen Gary Budor has been pushing for a Cricket Field in Chesterfield Valley. The City has not been keen on spending money on a Cricket Field even through the native India population in town increases. The group had a cricket field in St. Charles County but lost the rights to the field.

Apparently a compromise is in sight that will not be a financial burden on the City's Park Department. The City will provide 4 acres of undeveloped park land to a cricket group to build and maintain a field. The renewable agreement is for 2-years. Here is a portion of a memo from City Administrator Mike Geisel followed by a vote from the Parks Committee.

As we have worked with the cricket community over the last few years, we have been unsuccessful in developing a mutually agreeable strategy to provide public cricket facilities. Under any scenario, creation of public cricket facilities will require considerable space and financial resources, including the ongoing operational expenditures. To date, a major obstacle has been the lack of a demonstrated demand commensurate with the commitment of public resources

In an effort to allow the cricket community to develop a program, demonstrate demand, while concurrently avoiding any significant public expense; I propose that the City consider granting a two year, non-exclusive license to a designated Chesterfield Cricket advocacy group, for the use of roughly a designated four (4) acre area on the undeveloped parcel at the east end of the Chesterfield Valley Athletic Complex.

Councilmember Wahl made a motion to accept the City Administrator's and the parks department recommendation as outlined in a October 26, 2023 memo from Mr. Geisel. It recommended designating four acres of currently undeveloped parkland east of CVAC, with the intent of a local athletic group, to fund, operate, and maintain cricket facilities, on a two-year agreement. The project would be completely funded and maintained by the cricket group with no city funding, maintenance or other resources provided by the city. The motion was seconded by Councilmember Monachella, and passed by voice vote of 3-0.





A WOODEN CARVING SCULPTURE FOR CENTRAL PARK: Also before the Council is a proposal for a wooden carved sculpture on a dead tree truck by Ryan Meyer of Festus. The cost of the sculpture is being donated by Rob Kilo and cost the city nothing.



It was mentioned the tree being considered for the carving might be too diseased and another one might have to be found.

Councilman Aarron Wahl then stated that he thought the submitted carving plan was ugly. "Is this a good piece of art? I don't get it," said Wahl. Other members disagreed with Wahl and he ended up voting for it.

FIREARM RESTRICTION ORDINANCE TO INCLUDE CITY PARKS FIRST READ.

The St. Louis County Council passed a recent ordinance making it illegal to carry guns into schools, courts and other government buildings, even if you have a conceal carry permit. However, the ordinance did not include municipalities, just unincorporated areas. The City of Chesterfield has a similar ordinance with one thing missing...PROHIBITING GUNS IN PARKS AND ON PARK PROPERTY.

Under the ordinance these are the locations where someone cannot carry a firearm:

- 1) Any law enforcement office.
- 2) Any jail, detention facility or juvenile detention facility.
- 3) With 25 feet of any polling place on election day.
- 4) Any courthouse or court office.
- 5) Any City Council meeting or any city owned building.
- 6) Bars and Taverns
- 7) Certain areas in an airport.
- 8) Any day care facility, elementary, secondary school or institute of higher education.
- 9) Any church without permission.
- 10) Any casino (none in Chesterfield)
- 11) Any gated amusement park.
- 12) Any post "No Firearms Allowed" private property.
- 13) Any sports arena sitting 5,000 or more.
- 14) Any hospital

15) City Parks

This addition of PARKS to the existing ordinance was read with a 7-1 vote to only first read the bill. A second reading and vote at a future meeting is required for passage. Councilman Aaron Wahl apparently thinks carrying guns in city parks is just fine. He did vote against having the bill even read for the first time.

Councilman Aaron Wahl, gun nut or someone who feels the need to be armed while taking a walk in the park?

COUNCIL VOTES TO REDUCE AUGUST HOURS AT THE AQUATIC CENTER AND RAISE PRICES FOR NON-RESIDENTS. This should have come as no surprise as there has been a shortage of lifeguards recently for the city pool. Since most of the lifeguards are students returning to class in August the Council voted to reduced pool hours for the last three weeks of its scheduled opening.

Here are the recommended hour changes per memo:

We currently close the facility on weekdays during the last two weeks of the season because most of our part-time staff go back to school. In 2023, many lifeguards went back to school the third week before our facility closes. In 2024, staff recommend reducing hours of operation for the third week before closing by the following. Open the leisure pool only from 12 - 4 p.m. (during school) and open the entire facility from 4 - 7 p.m (after school). All hours and openings depend on staffing levels.

Also the Council agreed with the Parks Department and voted to increase non-resident entry fees to the Aquatic Center from \$9 to \$11.
