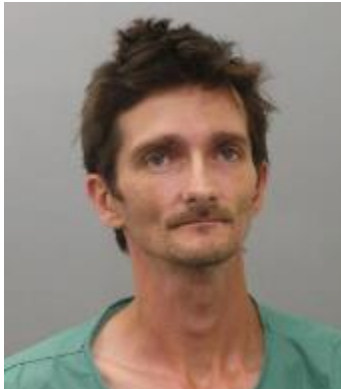

That Quinvon Quinton Reed, in violation of Section 570.030.1(3), RSMo, committed the class D felony of receiving stolen property, punishable upon conviction under sections 558.002 and 558.011, RSMo, in that on or about November 1, 2023 at 11729 Chandellay, in the County of St. Louis, State of Missouri, the defendant, with the purpose to deprive the owner of retained such property, knowing or believing that it had been stolen, and the property appropriated numerous tools, electrical supplies, plumbing supplies, painting supplies, and tile of a value of at least seven hundred fifty dollars,

I, Katie Exline DSN 123, Town and Country Police Department, knowing that false statements on this form are punishable by law, state that the facts contained herein are true and documented in report number 23-1235. I have probable cause to believe that on November 1, 2023, within St. Louis County, Quinvon Reed, Black, Male, 5'08", 175lbs, committed one or more criminal offense(s).

Count: 01 RECEIVING STOLEN PROPERTY - CLASS D FELONY


The facts supporting this belief are as follows:

Between October 25 and 26, 2023, a Morgan Company Design and Build trailer containing numerous construction tools and supplies was stolen. Total value of the stolen items was over \$20,000. On November 1, 2023, the defendant posted a miter saw and a stand for sale on Facebook Marketplace that was recognized by the victim. The defendant was arrested as he attempted to leave his residence to sell the items in a transaction arranged by the police. Officers

observed numerous stolen items in the defendant's garage. After consent was obtained the items were seized. Over \$6,000 of the victim's items were recovered. A search was obtained for the defendant's cell phone records and tower locations which revealed that the defendant was in the area of the theft on the night of October 25, 2023. The defendant told police he bought some of the items from two males who sold them from a van near Page and Skinker.

The State requests a warrant as the defendant has a pending case Stealing Over \$750 under cause number 23SL-CR05909 where the defendant has failed to appear for a court date of October 23, 2023.

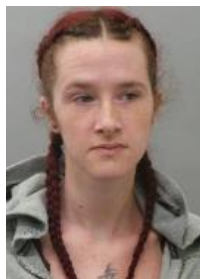

93-YEAR OLD DRIVER DIES AFTER RUNNING RED LIGHT IN TOWN AND COUNTRY ON THANKSGIVING

1: 05pm on Thanksgiving afternoon 93-year-old Victor J. Hezel of Craig View Drive in West County was SB on Hwy 141 at I-64. Timothy Bushur, of Chesterfield, was making a left turn on a green light. Hezel ran a solid red light in his 2009 GMC SUV and struck Bushur in his 2016 Ford Escape.

Hezel lost control and then struck a traffic light. Hezel was NOT wearing a seatbelt. Both drivers were transported to Mercy Hospital where Hezel was pronounced dead. The crash was investigated by the Highway Patrol.

NOVEMBER 2023 TOWN SQUARE COSTS: Former mayor Jon Dalton used \$10,000,000 to purchase a former gas station and 8-acres behind it and develop it for the "Town Square" He then sold off the center section of 2.5 acres to a developer for commercial a building. The city went on to install a large pond and build two pavilions, all that is being maintained by the city. The Return of White Buffalo for reducing Deer Population

Here is the memo in the 1st reading of a bill to rehire White Buffalo to cull (nice word for kill) up to 75 deer in Town and Country on approved sites. It is a little confusing because 50 deer being culled is also mentioned in the memo. It's a high and low amount. The Missouri Department of Conservation is recommending up to 100 deer.

The project is scheduled to start in January.

RE: 2024 Deer Management Proposal

SUMMARY- Bill No. 23-53 on the agenda for first reading November 27, provides for an agreement with White Buffalo to cull an estimated 75 deer. To maintain a reasonable population level, the Missouri Department of Conservation (MDC) recommends the removal of up to 100 deer in the winter of 2024. The 2024 proposed budget includes funding for 75 deer based on the number of sites expected and the 50 deer taken last year. Funding is broken down as follows and included in the proposed 2024 Budget:

\$39,561	White Buffalo for culling approximately 50 deer
8,250	Food processing for St. Louis Area Foodbank (\$110/deer)
<u>5,468</u>	Distance sampling (population estimate, completed every other year)
\$53,279	

There have been 30 recorded deer/vehicle collisions through October of this year, which is slightly ahead of the same 10-month period last year.

White Buffalo is currently scheduled for early January with additional commitments in Des Peres and Wildwood. Staff will be coordinating with MDC once again to donate up to a dozen deer to the Zoo Red Wolf Program.

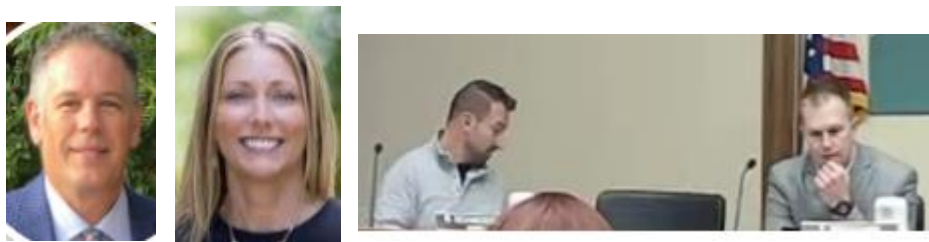

ALDERWOMAN HOLLY EVEN RESIGNS At the beginning of the Aldermanic meeting Mayor Charles Rehm announced the Ward-2 Alderwoman Holy Even has resigned as an Alderperson. Even was up for reelection in April 2024.

Even's husband Christopher Even assaulted her, held a gun against her head and threatened the shoot her for over a month before felony charges were filed against him.

She has a protection order to keep him away from her and their home.

Christopher Even was indicted by a Grand Jury two months after charges were filed on August 3. There was a December trial date, but now he and his lawyer are in settlement discussions with the County Prosecutor's Office.

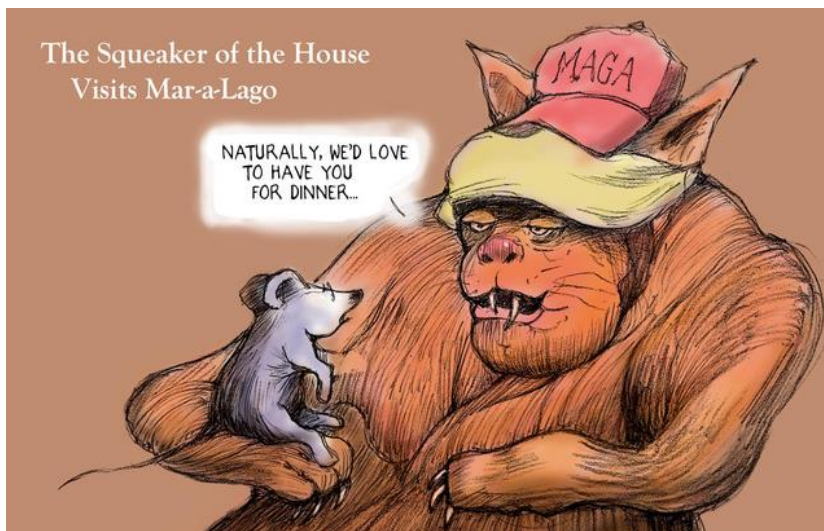
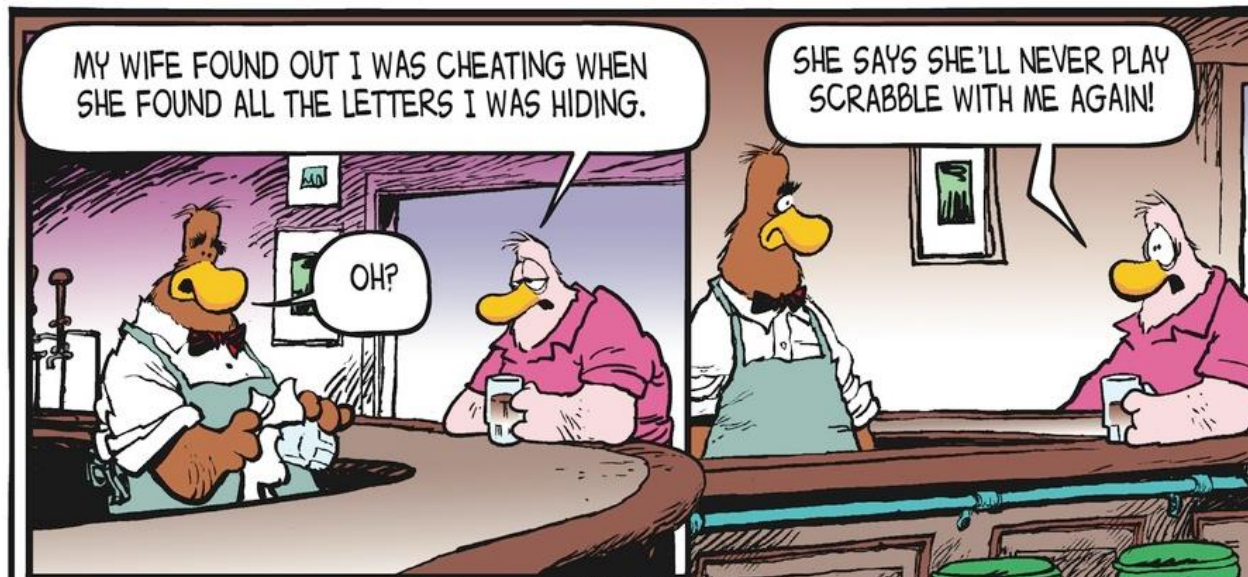
