

COUNCIL REFUSES TO PASS WEAPONS BAN TO CARRY CONCEALED WEAPONS IN CITY PARKS: At the November 6 meeting the Council voted 7-1 to advance a bill that included making carrying a concealed weapon in City Parks an ordinance violation. Councilman Aaron Wahl voted against moving the bill to a future agenda for a vote. The law with the amendment basically mirrors the County ordinance on firearms in parks.

The bill was on the Monday December 4th agenda. Before any vote, Wahl made a motion not to vote on the bill, but send it back to the Public Health and Safety Committee for reconsideration. Wahl, a chiropractor, stated that the amendment was illegal. City Attorney Chris Graville, A LAWYER, apparently did not as he had reviewed the amendment. When Wahl spoke he sounded like a very hardcore right wing gun person. Here is a little of his speech:

"No, I'm not promoting gun violence. This law does not conform to the State carry law. Guns don't kill people, people kill people using..."

"I move to hold a special meeting of the Council as a whole to consider this..."

His motion passed on a voice vote with no nays. No date was given for the "special meeting" so go ahead and carry any gun you want to in the parks as long as you conceal it.

118. If the Court determines that any part, section, or subsection of Ordinance Nos. 3217 and 3218 is unlawful, the entire ordinance is unlawful, such that no part, section, or subsection of the ordinance can be enforced. To the extent that Defendant wishes to proceed with a redevelopment plan for the Redevelopment Area, Defendant must begin anew with the tax increment financing process as mandated by and in accordance with the requirements of Missouri statutes, including, but not limited to, giving proper notice to interested parties, holding required public hearings with opportunity for public comment, and making proper findings supported by competent evidence to support the proposed redevelopment plan.

119. Plaintiff has been, and will be, required to incur attorney's fees and costs in challenging Chesterfield's arbitrary and unreasonable actions as set forth above. In light of the special circumstances presented herein, this Court should award Plaintiff its attorney's fees and costs incurred herein. WHEREFORE, Plaintiff prays that this Court:

a. Declare that Ordinances Nos. 3217 and 3218 are void, invalid and in violation of field Court Document Not an Official Court Document Not sections 99.800 to 99.865, R.S.Mo.;



REMEMBERING SANDRA DAY O'CONNOR

Sandra Day O'Connor, the first Supreme Court female justice who died on December 1, lived in Chevy Chase Village while I was a police officer there. I ever really knew her, but to waive when I saw outside working on her flowers. Her gardens, especially the ones in the backyard were her hobby when she was home.



This 3,192 sq foot house was built in 1918. Justice O'Connor bought in 1988 for \$660,000. Current estimates on the value are between \$3,100,000 and \$3,779,000.
