#### (Corrections shown in **bold**)

**SUMMARY-** Bill No. 23-53 on the agenda for first reading November 27, provides for an agreement with White Buffalo to cull an estimated 75 deer. To maintain a reasonable population level, the Missouri Department of Conservation (MDC) recommends the removal of up to 100 deer in the winter of 2024. The 2024 proposed budget includes funding for 75 deer based on the number of sites expected and the 50 deer taken last year. Funding is broken down as follows and included in the proposed 2024 Budget:

\$39,561 White Buffalo for culling approximately 75 deer
8,2509,000 Food processing for St. Louis Area Foodbank(\$110\$120/deer)
5,468 Distance sampling (population estimate)
\$53,279\$54,029

There have been 30 recorded deer/vehicle collisions through October of this year, which is slightly ahead of the same 10-month period last year.

White Buffalo is currently scheduled for early January with additional commitments in Des Peres and Wildwood. Staff will be coordinating with MDC once again to donate up to a dozen deer to the Zoo Red Wolf Program, *which would reduce the food processing expense by* \$1,440.

**FAMILIAR FACE FOR 2 TWO-YEAR WARD-2 TERM**: Al Gerber who beat me in 2010 and then later lost a reelection bid filed for the 2-year term on the Board of Aldermen. Al lives in the condos behind the Mason Village Shopping Center.



Al is a hardline Democrat who served the Missouri State Democratic Committee. He is closely associated with Principia and the Christian Science Church. He raised three times more money that I did.

In 2012 Gerber only got 40% of the vote and was easily defeated by Chuck Lenz. AFTER LOSING TO Lenz Gerber lost to Dean Plocher to replace disgraced John Diehl in the Missouri House, again getting just 40% of the vote.

Filing for municipal office ends on December 26.

Victim 1 said her and Vancardo were out earlier in the evening at a bar when Vancardo left her at the bar alone. Victim 1 informed me a friend of Vancardo drove her back to her residence. When she arrived her residence, Vancardo was already there with friend, who was a witness to the incident. Victim 1 asked Vancardo to leave the residence and when he refused a verbal argument began. Vancardo became irate and threw glasses inside the residence. He also began punching holes in the wall and pantry door as well as

- break photographs throughout the residence. Vancardo then began physically assaulting Victim 1 by punching her in the face and body with a closed fist causing her nose to bleed. Victim 1 said she was
- unsure who called the police; however, the O'Fallon Police Department arrived at her residence. While she was speaking to the Officers on scene, Victim 1 said Vancardo hid in the basement. Victim 1 informed me due to Vancardo punching her she suffered a chipped front tooth, a black eye, and multiple bruises to

include a large bruise on her left elbow. Victim 1 showed me the photographs taken from her cell phone of these injuries.

Victim I stated her Vancardo began verbally arguing when she began asking him to leave the residence due to his intoxication. The verbal argument escalated into a physical argument when Victim I said Vancardo began choking her while Victim I was sitting on the couch. Vancardo placed his hands around her neck

squeezing and choking her to the point she could no longer breath. Victim 1 said her daughter was

screaming at him to stop, which he finally did; however, when she stood up from the couch, he knocked her

over and pinned her face to the hard wood floor. Victim 1 stated while Vancardo was choking her she

thought she was going to die. Victim 1 advised she had bruising around her neck and on the right side of

her face from this incident. Victim 1 showed me photographs taken from her cell of these injuries. The many

#### 02/24/2022:

- Victim 1 advised her and Vancardo were out to dinner when he became extremely intoxicated. She was angry about this, and a verbal argument began in the vehicle on the drive back to their residence. Vancardo was irate and punched the windshield of the vehicle, causing it to crack. Upon their arrival to the residence,
- Victim 1 said she exited the vehicle and entered the residence. As she walked through the laundry room, Victim 1 said Vancardo grabbed her from behind and pushed her to the ground. Vancardo grabbed Victim 1's head and smashed her head into the ground numerous times causing her to bleed profusely. Victim 1

said her daughter was home at this time and when she walked into the laundry area after hearing the commotion, Victim 1 asked her to call the police. Vancardo would leave the laundry area and return only to continue physically assaulting Victim 1 by slamming her face into the ground. He retrieved her cell phone and threw it into the front yard causing the screen to crack. Victim 1 informed me she suffered two black

eyes, a broken nose, swollen face, and lips as well as burn marks from the floor.

#### 4/09/2022:

Victim 1 stated she was choked again by Vancardo, this time while on their bed. He placed his hands around her neck and squeezed hard enough for her to be unable to breath. Victim 1's daughter witnessed this incident and began crying for him to stop. Victim 1 said this has happened many times and this was just one particular incident.

#### 02/24/2023:

Victim 1 said she was at a restaurant with a friend when Vancardo arrived. A verbal argument ensued and Vancardo was escorted from the restaurant. Victim 1 also left the business and stopped at a local gas station when Vancardo also arrived at the business. Victim 1 requests Vancardo leave and when he refuses a verbal argument ensues while Victim 1 is standing the doorway of Vancardo's vehicle. Victim 1 is forced to enter the vehicle while Vancardo leaves the business. She states Vancardo began driving erratically, swerving, speeding, and slamming on his crakes all while grabbing her face with his hands leaving finger marks on her face. Upon arrival to Victim 1's residence, Vancardo jumped on top of Victim 1 while she laid in her bed. He proceeded to pin her down with his body weight and place his hands around her neck choking her until Victim 1's female friend, intervened and was ultimately assaulted by Vancardo as well.

3. I have reasonable grounds to believe that the defendant will not appear upon the summons or is a danger to the crime victim, the community or any other person because:

The victim is afraid of being killed by Vancardo. He continually harasses her and drives by her residence, even at times leaving items on her front porch. He continually calls her after she has requested, he not contact her. The victim has attempted to obtain an Order of Protection multiple times, yet the court date has been continued a multitude of times. The victim believes Vancardo will not stop until he physically hurts again.


