TOWN AND COUNTRY TOWN SQUARE EXPENSES: Remembering that in 2016 the Mayor/Cigarette Lobbyist Jon Dalton, along with aldermen Skip Magee and Fred Meyland Smith pushed the city to buy 9 acres where an out of business service station and ranch house were located. The land had a sharp decline making about half of it unbuildable. Dalton had connections with local developer Bob Brinkman who bought the center of the property for a commercial development. The city spent just at \$10,000,000 buying the land and then developing a park and lake behind the stores. The majority of the parking was for retail customers and not park users.

Word was Dalton also wanted to buy land next to the city's firehouse owned by the Principia School across the street for a new city hall. (That never happened.)

Despite stores and restaurants in the center of the property, the city maintains the property and park. The annual money spent some years has been \$100,000.

We have been tracking the money spent. This year it was \$70,895.

TOWN AND COUNTRY BOARD OF ALDERMEN MEETING Tuesday January 17, 2024



The first Board of Alderman meeting of 2024 set an example that might be hard to beat. It was over in 10 minutes.

The Alderpersons passed a resolution seeking \$1,150,045 in grant money from the the East-West Gateway Council of Cities for repaving Bopp Road from Clayton Road to the City Limits. The city would have to come up with more than \$800,000.

The Board also approved to spend \$15,734.16 for 187 tons of road salt.

Mayor Rehm also announced promotions in the police department.

At the end of the meeting the mayor also announced the retirement of Capt. Michael Defoe who was acting police chief when Chief James Cavins was forced to resign in August of 2023 after being suspended.



DeFoe basically called my wife a liar and never apologized. I had been writing newsletter articles about Federal convicted drug dealer, Brian Marchant-Calsyn who was living in a gated mcmansion on Topping Road. He was involved in a scam business with two other Town and Country residents, who were convicted of the scam and served short sentences. Marchant-Calsyn was not charged.



On April 11, 2012 I had worked as the PA announcer at a minor league ballpark in Illinois for a college night game. After getting home late, I work on the next newsletter and then went to bed around 3am 4/12.

Later on April 12, a large moving van showed up on Topping Road as Marchant-Calsyn was being evicted. Marchant-Calsyn after getting out of prison on the drug charges was involved in a business scam.

On that same morning, while I slept then Cpl. Defoe and another officer came to my house. Marchant-Calsyn complained I was taking photos of the eviction from a neighbor's yard. I wasn't. I was asleep. But even if I was there I'm unsure what law was being broken taking photos.

My wife was in the front yard doing gardening when DeFoe arrived in a marked police car. He said he wanted to see me and she told him I was still asleep from a late night. He didn't believe her and demanded to see me. She woke me up and I denied being anywhere but in bed.

It was later determined that the neighbor was taking the photos from his backyard. Perhaps DeFoe should have interviewed him for standing in his backyard.

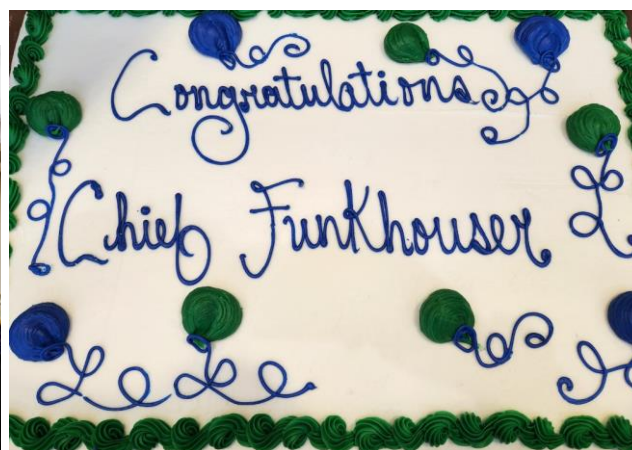

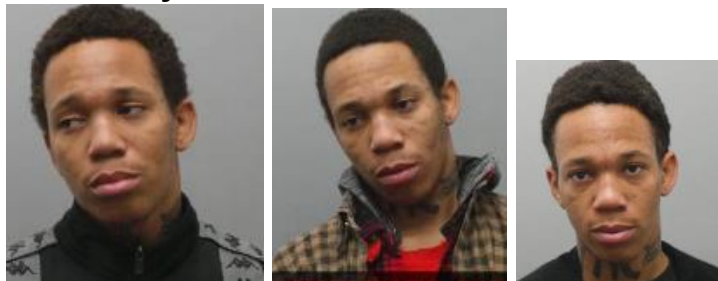

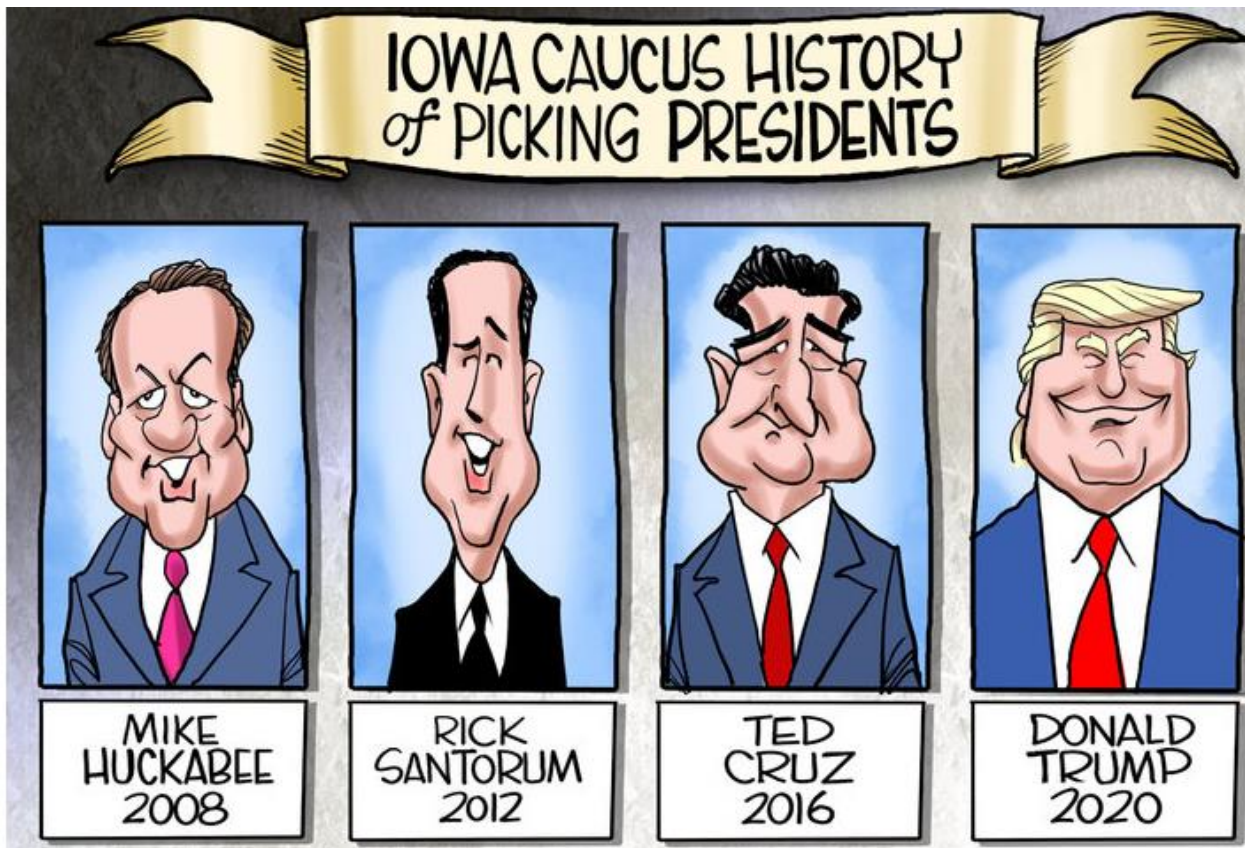
