# ANNUAL DEER HARVEST CONTRACTOR WHITE BUFFALO TAKES 89 DEER IN JANUARY.

In December Town and Country spent \$1,342.50 on Wild Deer feed to collect deer prior to the January White Buffalo deer harvest.

In January 2024 White Buffalo killed 89 deer. We went back 10 years when White Buffalo harvested 87 deer. This year like last year the deer were processed for food for poor families or donated to the St. Louis Zoo to feed carnivores. We hope to have a more detailed report next week.

### RECENTLY RETIRED TOWN AND COUNTRY POLICE SGT CHARGED WITH NINE COUNTS OF CHILD SEXUAL ABUSE IN JEFFERSON COUNTY

Jordan C. Fowle, 57, retired Town and Country Police Sergeant was charged on January 16, 2024 on nine counts of Sexual Child Abuse dating back to 2011.





### Jordan Fowle

Fowle retired in December of 2023 after 27 years with the Town and Country Police. He lives with his wife and the victims (a daughter and adopted daughter) in House Springs in Jefferson County. He urned himself in at the Jefferson Co. Jail on Tuesday 01/23.

Charges include Incest, Child Molestation, Sodomy, Endangering the Welfare of a Child. Many of the crimes are alleged to have occurred at his house while Fowle worked for the Town and Country Police. This is the Statement of Charges:

That the defendant, in violation of Section 566.068, RSMo, committed the class B felony of child molestation in the second degree punishable upon conviction under Section 558.011, RSMo, in that on or between December 1, 2019 and December 31, 2019, in the County of Jefferson, State of Missouri, the defendant, being more than four years older than Victim 1 and for the purpose of arousing or gratifying the sexual desire of the defendant, subjected Victim 1, who was then less than seventeen years of age, to sexual contact by touching Victim 1's breast with Defendant's hand, and defendant, engaged in this offense with a person the defendant knew to be defendant's descendant by blood or adoption.

1. I have probable cause to believe that on/between <u>August 2012 through July 2023</u>, in the County of Jefferson, State of Missouri, <u>Jordan C. Fowle</u>, committed one or more criminal offense(s):

### 2. The facts supporting this belief are as follows:

Victim #2 advised that while she was 13 years of age and in seventh grade (2012) Fowle responded to her bedroom where she had been sleeping and climbed into bed with her. Fowle is the adopted father of Victim #2. Fowle began to rub Victim #2's back, then proceeded to rub her bare breast and touched her vagina over her clothing. Victim #2 described Fowle as "rubbing" her vaginal area and during the rubbing there was semi-penetration of her vagina by Fowle's fingers. Victim #2 described similar instances of abuse occurring from Fowle over an extended period of time.

In 2015, While Victim #2 was 15 years of age, and a Freshman in High School, Fowle would force her to submit to strip searches, to ensure she was no longer self-harming. Fowle would inspect Victim #2's breast area by moving her bra and would move her panties aside to check her vaginal area. Victim #2 advised the strip searches continued over a period of time and resulted in her becoming fully nude during the search. When Fowle was complete with the strip searches of Victim #2 he would force her to sit upon his lap. During one instance Fowle made her sit in his lap while she was fully nude, facing him and straddling his legs. Fowle began to fondle her bare breasts and kissed her. Victim #2 advised during this instance Fowle pinned her against his body, refusing to allow her to pull away from him and with his arms wrapped around her, forcibly holding her in place.

Victim #2 described the kisses during the strip searches as being passionate, being kissed with force and aggression and being both open and closed mouth kisses, with Fowle sometimes utilizing his tongue during the kisses. Victim #2 recalled Fowle touching her vagina over her clothing during one instance during a strip search.

Victim #2 advised the actions of Fowle caused emotional distress to the extent she began to selfharm and was suicidal, resulting in several long term stays at mental health facilities.

Victim #1, who is the adopted daughter of Fowle, advised in December of 2019, while she was fourteen years of age, Fowle responded to her bedroom and sat next to her on her bed. Fowle then put his arm over Victim #1 preventing her from moving. Fowle proceeded to touch her bare breasts and bare vagina. Victim #1 described the touching as "groping" and occurring over and over again. Victim #1 advised this abuse occurred within her bedroom multiple times over several years.

Victim #1 described another instance, occurring approximately during the summer of 2020, when she was 15 years old. Victim #1 had been swimming within the pool at her home with Fowle. Victim #1 advised Fowle forced her to sit upon his lap in the pool, facing him. Fowle proceeded to grope her buttocks over her swimsuit. Victim #1 additionally stated Fowle would rub his erect penis upon her vaginal area while both of them were clothed in swimsuits. During this incident Fowle had held Victim #1 in place, having his hands on her lower hips, preventing her from moving away.

Victim #1 advised in approximately June 2023 Fowle responded to her bedroom, placed his arm over her and began touching her bare breast and vaginal area. Victim #1 attempted to move away and Fowle pulled her back towards himself using the arm he had placed over her. At no point did Victim #1 consent to the sexual contact by Fowle.

Victim #1 advised the incidents of sexual abuse caused emotional distress and she began to self-harm.

All above crimes occurred at the Victims' residence within House Springs, Missouri. J. Fowle was more than four years older than both victims at the times all offenses occurred.

Fowle also had responded to Victim #1's place of employment after she had left the home, causing her mental anguish and fear. Both victim's fear retaliation from Fowle, given he previously had been employed as a Police Officer within the State of Missouri and has access to firearms and access to law enforcement data bases which could disclose their phone numbers and current addresses.

The City of Town and Country recently learned that Jordan Fowle, a former employee, has been charged with multiple counts of both felony and misdemeanor sex crimes by the Jefferson County, MO. Prosecutor's Office.

The Town and Country Police Department has been in contact with the Jefferson County Sheriff's Office and has no reason at the present time to believe any alleged incidents occurred while Jordan Fowle was on duty, or otherwise acting in the official capacity of a Town and Country Police Officer.

Fowle had received several awards from Mothers Against Drunk Drivers for DWI arrests.

Fowle's has no bond on the arrest warrant with a bond hearing set for 01/29/24.

Fowle's attorney denies all the charges.

The salary was good and working conditions were good despite being a little boring. Due to pension and other issues some police departments won't hire anyone over 35. Town and Country would.

That has started to change as there are fewer recruits for police jobs. Most of Town and Country's newer officers have been youngest yet just graduating from area Police

Academies. However when hiring academy grads there is often as much as 6-months in-service training involved.

On January 17 Town and Country swore in its newest officer, 45-year-ol Wesley Besore who had been working at the Crystal City Police Department in Jefferson County.






### **NEW HOUSES FOR TOWN AND COUNTRY:**

**1941 Karlin revisited:** If you remember in September of 2023 there was considerable outrage from residents in the Thornhill Subdivision of plans for a new huge 9,329 sq ft house at 1941 Karlin Lane. That would violate setback laws by being too close to side lots. The plans were voted down by the Board of Adjustment.

The lawsuit by the Lambs against Town and Country by allowing the construction of a McMansion on a slope that flooded the mid-century modern house by the late architect Ralph Fournier.

The Lambs at 603 Greenwich Green allege a building permit under former Planning Director Craig Wilde should never have been issued. (Wilde later was forced to resign.)

The case was filed in 2021 and is still active. Town & Country's latest bill by the city's law firm was for \$2,234, bringing the total cost to the city to \$20,319.28.

## BOARD VOTES AGAINST A STATE REQUIRED TAX BREAK FOR PURCHASES OF

**FOOD**. I moved back to Missouri from Maryland, where the taxes were high with one exception. There was no sales tax on food items at the supermarket. You got taxed for soap, beverages, aerosols and other non-edibles, but not bread, meat, veggies and other food items.

The Board of Alderman passed a resolution 7-0 to urge Missouri senators and state reps not to pass any legislation lifting local sales tax on food. The claim was made such legislation would cost the Town and Country budget \$2,500,000 a year in lost tax revenue.

The claim was made that State elected reps during election years want to show voters they are for lowering taxes.

Keep in mind T&C did spend \$10,000,000 to buy land and develop the Town Square and is spending close to \$100,000 a year to maintain the property. T&C is spending \$10,000 a year to take over grass cutting at Mason Road and I-64 from the Missouri Highway Department to avoid the grass getting too long for some former aldermen.
