BOARD OF ALDERMEN MEETING



WAY AND MEANS COMMISSION VOTED TO PROPOSE THE ALDERMEN PLACE A 23-CENT PER \$100 VALUE ON THE BALLOT FOR A TAX INCREASE. We mentioned last week that the city is advertising to spend up to \$35,000 annually to market events at the Town Square and Longview House, a job Parks Director Anne Nixon, paid 111,000, already does. The city continues to pay a private landscaper over \$10,000 a year to cut the grass on I-64 and Mason Road. This was caused by former aldermen Fred Mayland-Smith and Skip Mange who felt the Missouri Highway Department wasn't cutting it often enough and the City should pay a landscaper to due MoDOT's job.

Until the city eliminates these wastes of money there should be no consideration of a real estate tax.

There was only one no vote for the proposed real estate tax by Ways and Means member Bob Aikin. This is from the unapproved minutes of the meeting on January 31.

"Ms. Fabick moved to recommend to the Board of Aldermen imposing a property tax in the amount of \$0.23 per \$100 of assessed value. The motion was seconded by Mr. Agha. A voice vote was held and the motion passed with Mr. Aikin voting nay."

The last time a proposal was sent to the Aldermen then placed on a ballot. It was voted down by the residents. This was possibly due to a possibility of the State Legislature ending city sales taxes on food at supermarkets. That has not happened yet.

FIXING THINGS FROM THE DALTON AND COPELAND ERA:

John Copeland who worked with me when I was a Det. Sgt. for the Rock Hill in the 1970s, was named Police Chief of Town and Country in 1997, replacing the original Police Chief Skip DelMar who was the Director the Public Safety Department (Police and Fire) and then just the police chief for 35 years.

Copeland was a captain at the time of the promotion. In 2004 when the Town and Country City Administrator quit to go to Ellisville Copeland was name “interim administrator.” By 2005 Jon (Cigarette Lobbyist) was mayor and suddenly Copeland was both the City Manager and Police Chief, a very odd and ethically challenged situation.

I had been an assistant police chief and I had travelled around the country writing over 150 articles for police magazines and never saw a similar situation. City administrators are supposed to oversee police departments. It is hard to have a city administrator take any action against the police department if they are also the police chief. This appeared to have involved ethically challenged former Mayor Dalton. Copeland was definitely a “Dalton yes-man.”

Copeland retired in April of 2013 (died of cancer in 2023) from both positions. The City Administrator post was taken by Gary Hoelzer, the assistant police chief while Police Captain Pat Kranz was name police chief. When Kranz retired, Hoelzer went back as Police Chief and the city hired Bob Shelton as city administrator.

Now the board of aldermen appear to be ready 11 years after the fact passing an ordinance that will keep police chiefs from being city administrator at the same time. The Board voted for the change to avoid this from happening again on a 7-0 vote.
