To repeat:

The Lambs at 603 Greenwich Green allege a building permit under former Planning Director Craig Wilde should never have been issued. (Wilde later was forced to resign.)

The case was filed in 2021 and is still active.

The latest bill is for **\$1,712.20**. This brings the total costs of defending the city over their screw up to **\$22,031.48**.

**Trial date moved way back**: On August 17, 2023 a jury trial date was set for April 8, 2024. However, now the trial date is set for December 2, 2024.

**CITY LAWYERS LOOKING AT GAMING MACHINES:** This is the city law firm's hourly bill for January 2024. The number-one billable issue is legal research of gambling machines.

# RETIRED TOWN AND COUNTRY POLICE OFFICER CHARGE WITH NINE COUNTS OF SEXUAL CHILD ABUSE WITH HIS OWN CHILDREN, OUT ON BOND.

Jordan G. Fowle, 57, who retired after 27 years on the Town and Country Police force was charged on January 16, 2024 Incest, Child Molestation, Sodomy, Endangering the Welfare of a Child. Many of the crimes are alleged to have occurred at his house over 11 years while Fowle worked for the Town and Country Police.

He turned himself in on January 23, 2024 at the Jefferson County Jail.

Incest (x2) Sexual Abuse 1st (x2) Child Molestation 1<sup>st</sup> Child Molestation 2<sup>nd</sup> (x2) Statutory Sodomy 1<sup>st</sup> Statutory Sodomy 2<sup>nd</sup> (x2) Endangering Welfare of Child 1<sup>st</sup> (x2) Kidnapping 3<sup>rd</sup> (x2) Harassment 1<sup>st</sup> (x2)



Originally he was held with NO BOND. On January 29 the judge set a cash bond of \$150,000 which Fowle posted that day. His first scheduled court appearance is on March 1, 2024.

**CITY COMMISSION WANTS 23-CENT PER \$100 PROPERTY TAX WHILE FORMER MAYOR JON DALTON'S GROSSLY OVER BUDGET TOWN SQUARE KEEPS RUNNING UP COSTS**. Dalton wanted to buy the 9-acres of a gas station and empty land, plus a ranch house and turn it into a combination business district and park. The estimated costs would be \$5,000,000. The actual costs came in at just over \$10,000,000.

The cost of maintaining the park area is not being shared by the businesses or landlord Bob Brinkman, but by the citizens of Town and Country. Last year those costs were \$70,895.

### TOWN AND COUNTRY BOARD OF ALDERMENT MEETING 02/26/24



This meeting only lasted 22 minutes. It would have been 15 minutes if the mayor didn't bring up the subject of maybe having just one Waste company for the city.

**WASTE MANAGEMENT** Before the vote approving the four waste haulers for another year the mayor asked about having just one waste hauler for the city and removing resident's and subdivision's right for a competitive waste hauler. These are the approved haulers:

- American Eagle Waste
- Gateway Disposal
- Republic Services
- Waste Management

We and our next door neighbor switched from Waste Management to American and saved a lot of money with better service. The mayor claims there would be reduced costs if only one company had a city wide contract.

In 2009 when I was an alderman when Ward 3 alderman Steve Fons wanted to do the same thing. That move would have forced an African-American family (Sanders) that had been providing services to the east side of Town and Country for over 50 years out of business. The single servicer proposal was killed.

Here are the problems with Mayor Rehms suggestion:

**One** It would strip residents' right to choose a hauler based not only on price but also on service.

**Two** As seen in other nearby cities when a single hauler's service deteriorates due to labor issues, finances or legal issues without the resident having the ability to find a new service.

Mayor Rehm said they should talk about this later. I hope he does and says, "Never mind."

**OUR VERY FAST LOCAL MAIL SERVICE**: In the middle of January 2024 we received a Christmas Card in the mail with a postmark from the second week December. We thought this has to be the latest Christmas Card the Postal Service has ever delivered. WE WERE WRONG!

On February 22, 2024 we received a Christmas Card from someone who lives on Clayton Road in the 63131 postal zone. It was postmarked December 16, 2023 and delivered 68 days later to our house also in the 63131 zone. It seemed like maybe we took the Christmas decorations down a little too soon.

# NEW PROPOSAL FOR THE STRIP CENTER AT WOODS MILL AND SOUTH FORTY:

Maryville University wanted an athletic center sitting 3,000, a dorm, a 5-story parking garage plus some businesses where the mostly empty strip center is now located. Neighbors of the gated nearby gated subdivision where the mayor lives and Sue Allen formerly lived helped kill the Maryville University project. Now there is a new one.



The biggest draw to the strip center was Massa's Italian restaurant. Massa's closed permanently on December 30.



Now there are new plans. Developer McBride-Berra has the purchase of the strip center under contract if their plans are approved by Town and Country.



Officers also conducted traffic stops and provided patrols of businesses, neighborhoods, and parks.



If you look at my arrest and citation records in the newsletters for people arrested in T&C and Chesterfield you will see a lot of "No Vehicle Insurance" cases. I think towing the car where the driver admits there is no insurance or at least unregistered vehicles or vehicle with expired plates (DOR requires proof of insurance for renewal). The vehicle would be released once the owner appears with proof of insurance. Too often police are just issuing a citation and the driver drives off still with no insurance waiting to cause a crash.
