PUBLIC HEARING AT MONDAY'S BOARD OF ALDERMENT MEETING ABOUT RAISING YOUR PROPERTY TAX FROM ZERO TO 23-CENTS A HUNDRED.

On March 11 at 7pm the Board of Aldermen will hold a PUBLIC HEARING on moving the property tax from ZERO to 23-cents per hundred assessed valuation. There has been fear the Missouri Legislature could end the sales tax on food, but as reported recently Rep. Brian Keithly who wrote the food tax elimination bill did not think it would pass.

There is an existing property tax that was lowered to zero in the 90s. So residents would not be able to vote on it, just alderpersons. It seems to be quite a jump from zero to 23-cents, perhaps half that much might be a better starting point. Here are the answers we received from the Finance Director, Joan Jadali and City Clerk Ashley McNamara about voting on it.

If it was a new property tax, then yes, it would require a vote of our residents. However, this is a reimposition of a tax that has been voluntarily reduced to zero since the 1990s. As a result, it only requires approval of the Board of Aldermen to be reimposed.

In non-reassessment years (even-numbered years) the property tax levy rate can be set by vote of the Board of Aldermen following a public hearing, up to the previously established ceiling.

I think before the city goes for a 23-cent property tax the proposed \$35,000 for a part time "marketer" for Park Department events should be dropped and continue to have Parks Director Anne Nixon do it. Also stop spending \$10,000 year to do MODOT's job of cutting the grass at the I-64-Mason Road interchange. Former aldermen Fred Meyland-Smith and Skip Mange did not think the Highway Department was cutting often enough and pushed the city to pay a contractor to cut Highway Department grass.

Since you don't get vote on this except by finding someone to run against those who voted for it and vote them out of office. You might want to email the board with your opinion.

This past Wednesday, officers from the departments' SEU, SRT, and Patrol units executed a search warrant in St. Louis County. She has many jobs including dealing with police reports, citizen requests and more. One of the more boring jobs has to be monitoring the department/city's 35 security cameras.

Checking the cameras on December 30 she observed that a prisoner in a holding cell was using a blanket trying to hang themselves. She immediately sent officers to the cell. The prisoner was not successful and transported to Mercy Hospital. Mason received a Life Saving Award from Chief Cheryl Funkhouser.

A HUGE SHOUT OUT goes to one of our Records Clerks, Jill Mason, as she was awarded a LIFE SAVING AWARD this past week.

Jill was honored with the award thanks to her heroic efforts, which saved a prisoner's life, while in custody here in our jail. One of her duties is to consistently monitor all 35 of the department's security cameras. Due to her diligent observations of the cell cameras, she was able to notice a prisoner using a blanket and a shirt in a somewhat suspicious manner. Thanks to the observation, she quickly alerted on-duty officers who responded to check on the prisoner. Upon the officer's response to the cell, they observed the prisoner had attempted to hang themselves, however, they were able to rescue the prisoner prior to losing consciousness. The prisoner was checked by EMS personnel and then conveyed to Mercy Hospital for appropriate treatment.

It is due to Ms. Mason's rapid and decisive response that contributed directly to the individual's survival. Her quick thinking ultimately played a key role in the saving of a human life, and thus is deserving of formal recognition.

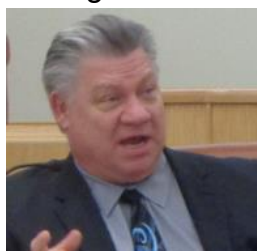

CHESTERFIELD CITY COUNCIL PASSES ORDINANCE WITH REQUIREMENTS FOR CITY ADMINISTRATOR'S RETIREMENT

Chesterfield City Administrator Mike Geisel is in his 60s and has hinted that his retirement will be within two years.

Here is what the City Council expects out of Geisel unlike other longtime employees retiring.



Instead of give 30 days notice Geisel will have to give 60-days notice.

Geisel shall continue to represent the City on the Monarch-Chesterfield Levee District Board of Directors (the “Levee Board”).

Geisel shall continue to represent the City on the Chesterfield Valley Transportation Development District (the “Valley TDD”).

Geisel shall continue to represent the City on the North Outer Forty Transportation Development District Board of Directors (the “Outer 40 TDD”).

Geisel shall continue to represent the City on the St. Louis Area Insurance Trust Board of Directors (the “SLAIT Board”).

The following terms shall apply to Geisel's employment during the Term:

A. Geisel shall continue to be employed by the City as an exempt professional employee for the Term.

B. The City Administrator shall serve as Geisel's direct supervisor.

C. Geisel shall serve in an administrative and advisory role to the Office of the City Administrator.

D. Upon the appointment of a City Administrator, Geisel shall no longer have the powers of the City Administrator as set forth in City Code and State

Statute, including, but not limited to, the authority to hire, terminate, or discipline any employee.

E. Geisel and City shall continue to be bound by terms, conditions, standards, policies, and procedures applicable to City employees, except where expressly modified herein.

RESPONSIBILITIES OF THE CITY

The City shall have the following obligations and duties to the City during the Term:

A. City shall provide an interim workspace for Geisel to perform his duties pursuant to this Agreement.

B. City shall provide computer hardware and office equipment for Geisel's non-exclusive use for Geisel to perform his duties pursuant to this Agreement.

C. City shall compensate Geisel on a bi-weekly basis, in the same manner and schedule as are all other full-time City employees, in a salary equal to forty percent (40%) of his total bi-weekly compensation that he was receiving shall not continue to accrue any paid leave, with the exception of earned long term service days.

E. Upon Geisel's date of retirement, as with all separating employees, he will be entitled to payment for all accrued vacation. He may elect, at his sole option, to delay payment for his accrued vacation time until the end of the Term of this agreement. If payment is delayed, the accrued vacation time will be paid at the compensation rate immediately prior to his retirement date as full time City Administrator.

All this doesn't sound like Mike Geisel is retiring but is required to have a part time job with his retirement benefits. At the first reading of the ordinance it was mentioned that Geisel helped with the terms of his retirement.

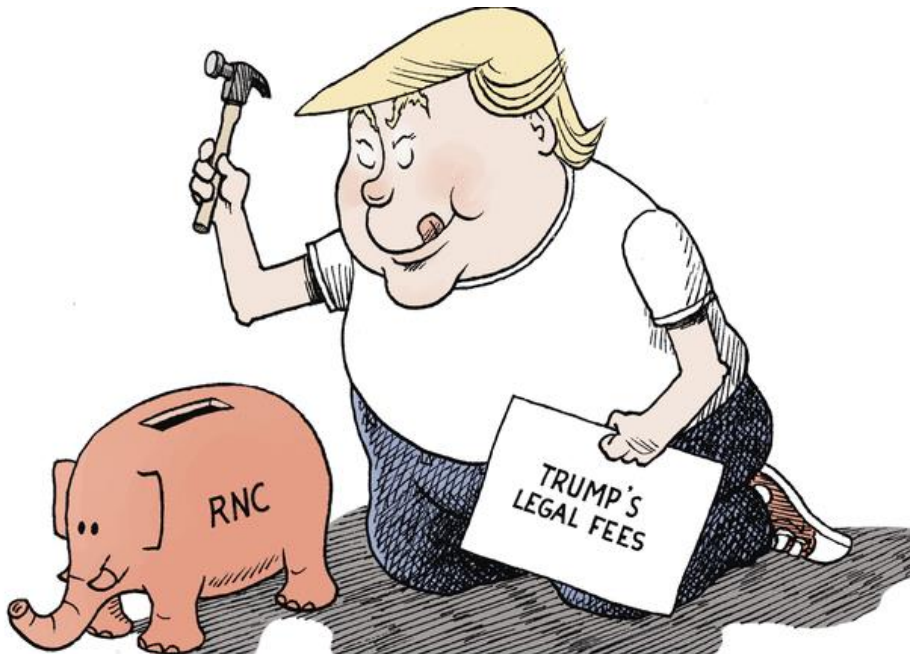
