TOWN AND COUNTRY PROPERTY TAX PROPOSAL: Town and Country was originally a community full of ranch houses occupied by retirees moving from the family's two story houses in Webster Groves and Kirkwood. There was a property tax to pay for police and fire service because there were no commercial areas except two gas station/repair shops at Clayton and Ballas and the gift shop at Missouri Baptist Hospital.

That changed with annexation and more commercial businesses supplying sale tax. In the 1990s the local property was lowered to zero. Now the city wants to put back a 23-cent per hundred valuation property tax. That might be fine for the people moving into multi-million dollar McMansions built after ranch houses were torn down. However, there are still plenty of retirees living in ranch houses in town. This proposed tax would have an effect on them.

A public hearing was held at the March 18 Board of Aldermen meeting.



City Finance Director Joan Jandail gave a rather long winded presentation on when the real estate tax is needed. She finished in 27 minutes. Hear is a link to listen to the presentation. Be sure to take some No-Doz.

She repeatedly hit on the fact the City is paying an EMS & Fire Protection District instead of the Protection District having a real estate tax on T&C homes. I think she was a little off base. When the City annexed a large section to the west of the original City Limits in the 1970s and was finally approved by the courts in 1985 they promised to continue to provide fire services. Instead of keeping the City Fire Department aldermen decided to hire a fire district. Fire & EMS service was promised to residents.

We looked at this when I was on the Board of Alderman. It would cost the City more than the Fire District if it restarted its own fire department for a couple of years (mostly for equipment purchases) and then would be cheaper than the Fire District. However longterm issues like retirements could come into play in 20 years.

The other issue brought up was how the fire station the city owns and city hall need \$10,000,000 to rehab both buildings. \$10,000,000...that is what the Town Square cost.

Additional Threats to Consider:


- Pending legislation would eliminate local sales taxes on groceries (annual loss of estimated \$2.5MM for all funds).

- Increasing office vacancies in our commercial real estate reduces business license and utility revenue.

Need for a Property Tax-Public Safety:

- The Board approved a competitive police pay plan for 2024 to attract and retain quality officers and bring us in line with peer cities.
- The \$4+ million the City ь contracts for and pays annually from the General Fund to provide 24/7 fire and emergency ambulance/ EMS and dispatch is much less than if residents were in the Fire District.
- More than 83% of the City's • General Fund annual budget is spent on public safety and related support functions.



Need for a Property Tax:

- The cost to fund upgrades to the City owned fire house, police department, City Hall and public works facilities is estimated roughly at \$10 million.
- The cost to maintain streets, sidewalk, and trail expenses exceed Road Fund revenue annually.
- Contract expenses to maintain beautiful parks, restrooms, and pavilions increase annually.
- High property values result from quality services and infrastructure.

Need for a Property Tax:

- With a levy of 23 cents, the total rate would be lower than peer cities except Des Peres who has Use Tax, ½ cent fire tax and marijuana sales taxes that we do not have.
- Town and Country levied a property tax from 1974 to 1996 ranging from 34 cents to \$1.00.
- The 23 cent recommendation allows the City to maintain quality police, fire, public works services and facilities without additional taxes such as use tax, fire tax, marijuana tax or residential utility tax.

(EDITORIAL NOTE; Town and Country was originally a Village and Villages could not have real estate taxes above 50-cent. The property tax had to be increased to continue services and voters changed the status from Village to City and the property tax went to \$1.00 until the annexation was approved with commercial and retail property entered the city.)

People speaking at the Public Hearing included former Alderman running for reelection going door to door with his ponytail, Al Gerber. Gerber said 4 people told him they were opposed to the real estate tax and one was for it.

Things were just opposite with the next three speakers, who were all were for the reinstated tax of 23-cents per \$100 valuation. Two were members of the Ways and Means Commission who voted for it after debating if it should 19-cents per \$100 and deciding on 23-cents.

Judging from the reaction of the alderperson this tax should be approved at the meeting. Several years ago the city wanted to reinstate the property tax of just 5-cents.

LETTERS AND EMAILS

AGAINST

Nick Conway of Ward-3 wrote a long email opposing the proposed T&C property tax. Here are some highlights:

In saying that, tax policy is certainly not politically balanced specifically property taxes. Town and Country has been known across St. Louis as a place with tax friendly policies specifically on Property Taxes. I think many residents have considered this when making their decision to move to Town and Country. To reverse this policy even slightly could significantly change the viewing of Town and Country by all St. Louis residence. As a resident who considered this policy before moving to Town and Country, I highly oppose any shift to this policy because of my concern on how Town and Country would be viewed by future residents and even current residents.

Finally, in speaking with others who live in Town and Country, one thing appears clear to me: THE RESIDENTS OF TOWN AND COUNTRY DO NOT SUPPORT A PROPERTY TAX INCREASE.

Rick Voytas, homeowner in Ward 3. He sent a very interesting letter and a very long letter. We had to edit some of it down.

I **strongly oppose** this new tax. When it comes to real estate and deriving as much government income from residential real estate as possible, St.

Louis County has been out of control and now Town and Country wants to add to the madness.

Every other year, St. Louis County reassesses my home. Every reassessment results in an initial 22-30% increase in market value. I always hire a real estate lawyer to contest the exorbitant tax increase. The county always rejects the lawyer's arguments. Then the lawyer goes to the state and the state always rules in favor of what they believe the real increase in market value which always is 14%. Then in the next reassessment period the County acts as if the state's market assessment means nothing and they assign another exorbitant market value for the next reassessment cycle. We repeat the process.

Now in addition to fighting St. Louis County and the State, now we have Town and Country entering the fray to get their additional 4.3% in real estate taxes on top of the over-valued market assessment of St. Louis County that results in increases in hundreds of dollars of real estate taxes every other year. Do our government officials in Town and Country have any connection with their constituents at all? It appears not.

My recommendation is that Town and Country go back to zero-based budgeting at take a fresh look at the amount of money Town and Country really needs - acknowledging that the citizens will not accept a tax increase.

I was underwhelmed with the BOA Meeting PowerPoint presentation.

This letter email is from George Tarlas, a member of the Ways and Means Commission who voted for the real estate tax. It has been edited due to size.

As I will be unable to make the Board of Aldermen meeting on Monday, I want to express my support for the recommendation to the Board of a property tax as discussed at our recent Ways & Means Commission meeting

The commission has reviewed and discussed other potential revenue sources, though the one meaningful incremental source – a use tax – has been voted down twice by residents. This doesn't leave a lot of options.

Town & Country is a special place to live with great city leadership, wonderful residents and beautiful properties. I believe the risk in the Board not passing a property tax would be potentially losing some of the high quality services and high quality staff that we all enjoy today, and to me, that is not an option.






