BOARD OF ALDERMEN MEETING On March 25



REESTABLISHING A PROPERTY TAX: At the request of City Administrator Bon Shelton, the board that seemed ready to pass the first real estate tax in 28 years, continued the matter until the first meeting in April. The city finance director Joan Jadali gave another presentation of why the tax was needed similar to the one she gave two weeks ago.

Two letters were received by the alderpersons from members of the City's Ways and Means Commission on why they should vote against the tax and why they should vote for the tax. Also there is another email to the Mayor against the tax proposal.

Resident LETTERS AGAINST:

This letter is from the lone member of the Ways and Means Commission who voted **against the city real estate proposal.**

Subject: Property Tax

My name is Bob Aikin. I've lived in Ward 1 at 12725 Clayton Road since 2014 and have served on Town and Country's Ways and Means Commission since 2018. I'm a CPA and have a master's in business administration. I served as President of a small insurance company for over 20 years and continue to work there full-time with the title of Past President.

I have great respect for the high standards demonstrated by Town and Country's Board of Aldermen. I've attended multiple BOA meetings and been impressed with the thoughtful way the city examines both sides of issues before acting.

However, it seems that no one is considering the case AGAINST establishing a property tax in 2024. I feel compelled to try to fill that void.

During my time on Ways and Means, the Commission has now recommended a property tax be established on three occasions. I voted in favor of a property tax on one of those occasions.

However, I voted against the 2024 property tax recommendation. I encourage the Board to also vote against the current property tax recommendation.

Reasons to vote No:

1. The city has operated without a property tax for 28 consecutive years. It has THRIVED during that period.
2. The General Fund balance increased from \$7.5 million in 2021 to \$8.2 million in 2022 and \$10.7 million in 2023. That's the highest balance since the Town Square project was funded. The trend for the General Fund Balance is POSITIVE!
3. The city's self-imposed goal is to maintain a general fund balance equal to at least 50% of annual general fund expenditures. In 2023, the general fund balance grew to 97% of annual general fund expenditures. That's almost DOUBLE the self-imposed safety net.
4. IF the General Fund Balance deteriorates and a need for a property tax arises, there will be an opportunity to set a property tax in 2026.

The Presentation Package:

I know that Board members have received a 20-page Property Tax Presentation designed to convince people to vote in favor of a property tax. It includes multiple projections, which all assume that the current positive General Fund Balance trend will dramatically reverse itself in 2024. That package projects that without a property tax, the General Fund Balance will nosedive by \$1.4 million in 2024 and by ever larger amounts in subsequent years.

Are those projections realistic? NO! They are not. For example, I calculate the most likely 12/31/2024 General Fund balance to be \$10,240,450 based on the 2024 budget recently approved by BOA. But the BOA property tax package assumes that 2024 expenses will exceed budget by \$1 million causing the 12/31/2024 projection to fall to \$9,240,450.

Thus, of the \$1.4 million 2024 nosedive that the package projects for the General Fund Balance, \$1 million, which is about 70% of that nosedive, has been created by an unrealistic assumption that 2024 expenses will exceed budget by \$1 million.

Is the BOA likely to approve \$1 million in unbudgeted 2024 expenses? I don't think so. Thus, I believe the package has understated the likely 12/31/2024 General Fund Balance by \$1 million, and that \$1 million General Fund Balance understatement gets carried forward to each of the subsequent projections.

The \$1 million understatement described in the preceding paragraph gets compounded by unrealistically low assumptions about future revenues. For example, according to page 68 of Town and Country's 2022 Annual Comprehensive Financial Report, the city's sales tax revenues have increased in 8 out of the last 9 years, from \$5.2 million in 2013 to \$8.6 million in 2022 for a 9-year average annual increase of about 7%. In 2023, sales tax revenue increased again by over 5%. Despite this consistently favorable growth in sales tax revenue, the package assumes that future revenues will only increase by 1.5% per year.

Overall, the 2024 presentation package projections are eerily similar to the property tax recommendations in 2020 and 2022. All three packages projected an immediate nosedive in the General Fund balance. Time has proven the 2020 projections and the 2022 projections to be very wrong. Given the similar unrealistic assumptions in the 2024 package, I view the 2024 package as misleading. I expect the future General Fund balances to be much better than the balances projected by the 2024 package.

Final Thoughts

I concede that at some point in the future, Town and Country may truly need a property tax. When that need arises, I will do my best to help get it passed.

But it would be short-sighted to impose a property tax now. It would:

1. Create an anti-tax backlash.
2. Divide the community.
3. Likely be quickly reversed.
4. Make it even harder to pass a Use Tax.
5. Reduce the credibility of city officials in the eyes of many residents.
6. Make it even harder to gain citizen support for a future property tax when it really is needed.

I urge you to hold off until 2026. The sky is not falling. Don't cry "wolf".

LETTER FOR THE REAL ESTATE TAX from another member of the Ways and Means Commission

My name is Janine Fabick. I am a retired CPA and have been a member of the Ways and Mean Commission for several years. I have also served on the Employee Benefit Commission and the Topping Road Task Force. I was employed for 20 years by Schowalter and Jabouri, a public accounting firm which had a very strong portfolio of auditing governmental entities from City's, Fire Protection Districts, and School Districts among others. This background has served me extremely well in my current role with Town and Country. I have been a resident since 2010 and my husband's parents first moved here in the 60's.

The issue of whether to put a property tax back in place has been at the forefront of our meetings since pre COVID. As residents we have been fortunate to have zero tax for the last

26 years despite not having any direct financial assistance with Fire and EMS services - something very unique to T&C.

Our current fund balances, while above the 50% threshold set for financial stability (which is extremely prudent and important for many reasons), are not truly reflective of the financial condition of the City. This is because one time revenues from governmental funding for COVID and the sale of property were put into operations instead of designating for capital purposes. Without this funding, operating balances would be under the designated threshold. This is going to catch up to our operating costs soon as there won't be these revenues to use in the future. In addition, because we are heavily dependent from sales tax revenue, and the majority comes from 10 entities of which that majority is grocery stores, any change in this stream of income will hugely impact our operations. There are several bills floating around Jeff City to eliminate food sales tax. The City cannot wait for that to happen and then react. Finally, because of COVID and other financial situations, several road, stormwater, and capital projects were delayed. Funds will be needed for all of this and there are NOT current funds to support all of what will be needed. So to adequately plan for this, the budget reflects \$1,000,000 a year to be put aside and accumulated so that when these projects are designated to start there will be funds to pay for them. Without this, important issues such as adequately maintaining roads, fixing storm water issues, replacing obsolete facilities etc cannot be undertaken.

The City has authority to put almost 46 cents in place. We have recommended half of this at 23 cents. Even at this amount the City will have the second lowest tax rate of any of our peer city's. What this will accomplish is assuring there will be no reduction of services in Fire, EMS and Police (which is almost 60% of our total budget). We will also be able to properly maintain roads, sewers, and facilities. And most importantly, we project this will fully satisfy the City's needs for many years and assure that the tax rate will not have to be increased. If, in fact, the City's financial situation should stabilize to where a portion of the taxes are not needed, a reduction in the rate can be done at any time.

Our commission does not take lightly putting a property tax back in place, but we have put this decision off for too long, and want to assure the City has the resources to maintain our community in the manner we have all come to expect and appreciate.
