ALDERPERSONS PASS FIRST REAL ESTATE PROPERTY TAX IN 27 YEARS. Prior to the vote Finance Director Joan Jadali gave her third presentation in the last three meetings. She was followed by City Administrator Bob Shelton.

The following points were raised supporting the increasing the tax from Zero to 23-cents per \$100 assessed valuation.

There is no more commercial retail property in city to generate sales tax. Of course there was until Board of Aldermen rezoned retail property to residential and allowed housing that did not meet the city's 1-acre lot and rear facing garages zoning requirements.

When Town and Country Crossing was first built the 2008 recession hit. The developer only had a 40% occupancy rate and was headed to default.

When first approved, a large area to the west was vacant, but zoned retail for future Businesses that would generate sales tax. Mayor Jon Dalton and Ald. Fred Meyland-Smith pushed a bill to rezone the property. However, subdivision developer Pulte Homes needed small lots for lots of homes, which violated T&C Zoning. The Aldermanic Board passed that too. So goodbye to future retail stores and sales tax.



Next there was the issue of rehabbing the City Hall and Police Station, that the finance Director and city administrator put at \$10,000,000. However Ald. Joe Kinsella's questions caused them to admit there had been no official cost estimate or bids.

Then there was the fire station. 12-years ago the City replaced the bay doors with windows to solid doors to reduce air conditioning cost and made other improvements. Now citing a leaky roof parking lot repaving and the need for more rehabbing the City Administrator stated the city hall and firehouse projects would cost \$14,000,000. Again there were no professional cost estimates.



Joan Jadali stated that the required 50% reserve of the annual budget would fall below 50% by 2017 or 2018 without the property tax. She added that the tax could be rescinded in the event of a strong budget in future years.

Ward 4 Ald. David Murphy seemed to be questioning the need for the tax, until the vote.

"I was hoping to have hard numbers on the improvements. Do we need to raise it to 23cents or is there another number?" Ald. Sue Allen, who is residing in an assisted facility spoke up. "When we don't have the money for a project, I don't think a lot of people in Town and Country want to hear there is no money."

The April 2 city election with two new alderpersons elected won't be certified by the Board of Elections for another week. Holly Even, who resigned due to a scandal, had an empty chair and defeated Alderwoman Michelle Francisco was missing for her last meeting as she was out of town with her kids to watch the Total Eclipse.

It seemed to make good sense to continue this issue until the two new aldermen are present for their first meeting later in April. However there did not appear to be too much good sense as not one person moved to continue the meeting.

The vote was 5-1 for the 23-cent tax with only Joe Kinsella voting "NO."

While no one has a lot of sympathy for property taxes on recently built multi-million dollar Mcmasions, there still are a number of retirees on fixed incomes living in ranch houses built in the 1960s, that an additional tax could burden.

This is why we have reduced the times it appears and we have shortened the length. FYI






