# PEEPING TOM CHESTERFIELD MAN CHARGED WITH INVASION OF PRI9VACY BY TAKING PHOTOS OF WOMEN THROUGH HOME WINDOWS:

**Update 24-1619 Invasion of Privacy –** Officers continued to investigate a subject, captured on a Ring camera, who was recording a female through her kitchen window. The subject was identified and arrested this morning. Officers interview the subject who admitted to recording females, who were in various stages of undress. Additionally the suspect granted access to his cell phone which revealed evidence of the same act at multiple locations in Chesterfield and surrounding Communities over the past year and a half. At the time of this report, Officers are applying for an in custody warrant.

Officers were successful and obtained four felony warrants on Surja Shah who was going to homes and through windows videoing or photographing partially clothed or nude women in their houses. Police identified four victims but believe there are more. They did seize his phone with videos. He said after his arrest that he could not help himself.

# CHARGES FILED ON SUSPECT IN INVASION OF PRIVACY

On 04-23-2024, officers with the Chesterfield Police Department investigated a report of a Suspicious Person, which led to the arrest of 39-year-old Chesterfield resident SURAJ SHARAD SHAH. An officer with the Chesterfield Police Department received a phone call, in which a female resident reported that her RING camera alerted to motion in the rear of her home. The resident reviewed the footage and reported that she believed an unknown male was looking through her window using some type of light. After speaking with the resident, officers responded to her home and reviewed the RING footage, then initiated an investigation.

After conducting a thorough investigation, the officers were able to positively identify the suspect, which led to the arrest of suspect SHAH without incident.

During the interview with officers, the suspect confessed to videotaping multiple victims in various stages of undress, or fully nude, using his cellphone without their knowledge or consent. SHAH is fully identified as:

SURAJ SHARAD SHAH DOB: 12/27/1984 HM ADD: 91 BURNING TREE DRIVE CHESTERFIELD MO, 63017

At the conclusion of the interview, the officers transported the suspect to the St. Louis County Justice Center where officers applied for warrants. After reviewing this case, the following charges were issued:


Bond for SURAJ SHARAD SHAH was set at \$150,000.00 with no ten percent.

Although charges were issued, this investigation is ongoing as additional victims were discovered and officers are continuing their efforts to identify each victim.

This investigation was made possible by the unwavering cooperation of the victims, as well as the residents who provided officers with valuable information that led to the identification of the suspect.

**UPDATE 05/04/24- 1619 (Invasion of Privacy)** - Officers served a search warrant on the suspect's residence and seized evidence related to the investigation.

The facts supporting this belief are as follows: The defendant was observed on video walking through the victim's backyard while appearing to film the victim's residence by utilizing his mobile phone. Police conducted an investigation, and obtained consent to view the contents of the defendant's mobile phone. The investigation revealed several videos of the victims in various states of undress taken through windows in the residence. The defendant was interviewed and confessed to the police that he had filmed the females at the victim's residence in various stages of undress without their knowledge or consent over the past several months. The defendant further stated that he had a problem and could not help himself.

A warrant is necessary to ensure the safety of the community and the victims in this case. The defendant has a prior arrest from 2019 in Town and Country Missouri for the same conduct. Further, the defendant advised police that he had filmed various women at various establishments in St. Louis County, including in dressing rooms. Police are attempting to identify additional victims based on these statements.





Do you need a business license or permit for a car storage business in Chesterfield? 300 cars can't be for one dealer.

#### **FIRST ANSWER**

According to our code (405.10.030 – Automobile storage land use definition), a business engaged in the storage of four-wheeled motor vehicles designed for passenger transport, including passenger cars and light-duty trucks (such as pickup trucks, sport utility vehicles, vans, and minivans) that are not sold on the premises would still require a business license as this use/business type is not exempt in our code.

According to Denise, Platinum Motor Company has closed based on a recent email from management of Chesterfield Mall tenants (Rick). I know I recently saw the cars were still on the property, so not sure of the date/timing....or if this is what he is asking about specifically.

#### SECOND ANSWER





This afternoon we confirmed the cars on the mall parking lot are overflow storage for Tesla, not Platinum Motor Company.

There is no code violation. Tesla has an active business license.

I believe Tesla Motor's license is to operate a sales office in Chesterfield Valley on Chesterfield Airport Road and not extend to Chesterfield Mall's parking lot for storage of hundreds of cars.

If they next decided to open a gas station on Chesterfield Airport Road they could not use the license for the Olive Blvd. station, they would have to get a separate license for the Chesterfield Airport Road station. Apparently the city is saying the Tesla doesn't need to do that when they open a new business of vehicle storage nowhere near their sales operation in Chesterfield Valley. (I keep starting to write "dealership" but it is not since it is company owned.).


## Tesla retreat from EV charging leaves growth of U.S. network in doubt

Sudden layoffs this week left Tesla construction vendors uncertain whether to carry on with the charging projects they were building.

Tesla's abrupt decision to lay off its electric-vehicle charging team and reduce its investments in public charging is a blow to the U.S. network, which has long relied on Elon Musk to build the bulk of the country's fast chargers.


