**MAY 18, 2024**

**ROAD RAGE SHOOTING ON I-64 AND I-270 IN TOWN AND COUNTRY. ONE DRIVER WAS SHOT AND INJURED.**

Here is the press release from the Town & Country PD ref the shooting:

**FOR IMMEDIATE RELEASE**

May 10, 2024

The Town and Country Police Department is investigating a shooting that occurred as a result of an apparent road rage incident on Wednesday, May 8<sup>th</sup>, at approximately 1:07 pm on westbound Interstate 64 near the Interstate 270 interchange. It was reported that a person occupying a gray Chrysler 300 or similar vehicle fired a weapon at another motorist who was operating a red Ford F150 Pickup, causing injury. The suspect vehicle continued onto southbound Interstate 270. The victim continued onto northbound Interstate 270 and drove himself to a nearby hospital where he was treated. The victim was later released and is recovering from his injuries. Investigators are reviewing video footage provided by Metro Transit Real Time Camera Center to identify a suspect vehicle and seeking any additional video that may have captured the incident.

We do not believe there is any active or ongoing threat to the public, but we need your assistance with identifying the suspect. We are asking that anyone who may have been in the area of the Interstate 64 and Interstate 270 interchange on Wednesday shortly after 1:00 pm who may have witnessed the incident, or any suspicious activity, contact our Detective Bureau or an on-duty supervisor at (314) 737-4600 with any information.

**NO-DOZ ALERT:** The plans, despite being voted down by P&Z were heard Monday with a public Hearing before the Board of Aldermen.



**HIGHLIGHTS OF THE PITCH BY MCBRIDE HOMES** Jennie Aumiller, who didn't look like she came from a construction site put on a 35-minute show.

She stated residents were overwhelming in support of the project, but later said it involved 20 people both in person and on zoom. She claimed living in this development would be “a once in a lifetime opportunity.” (it seems like you could find condos or houses like these across the country.)

**PRICE:** Aumiller said the price per unit would be between \$600,000 and \$900,000 depending on what extras a buyer wanted.

She also claimed the houses were for people across the board, new families to retirees. She then admitted no house would have a first floor master bedroom, meaning those retirees whose hips and legs are beginning to give out would be hiking upstairs.

Ald. Dave Murphy stated that some people are claiming “this is track housing.” Aumiller disagreed and said (a narrow house within an earshot of an interstate highway, with no yards and unattached garages) this would be “a luxury community.”

Murphy then mentioned that the number of houses on the 11.5 acres went down from 80 to 72 to 68, but the prices went up.

Ald. Fritz Wiesehan said that this would be the largest amount of houses per acre in the history of Town and Country. Aumiller replied that commercial is no longer viable at the location (Highway 141) was moved slightly to the east with no access to the property).

Ald. John Steinhubl made several points. First the idea having a restaurant, he thought would create parking issues, noise, smells and loud noise in the morning when trash is picked up. He suggested a club house instead.

A selling point for Aumiller was that the restaurant would create sales tax.

He perhaps was more on point after Aumiller calling these luxury houses, that residents would have to walk in the rain and snow from unattached garages, which would really be a hardship on the older retirees.

Questions by Ald. Joe Kinsella resulted in Aumiller saying homeowners would not have any control over the front of their houses as the Home Owners Association would maintain the front of all homes.


Ald. John Harder asked if MoDOT had approved plans since the development’s access and exit points are on a State road. Aumiller said the plans had been submitted, but there is no approval yet.

Tom Stern owner of the property said there have been five prior contacts for the property only to have them turned down by the City.





This is higher density housing than most residents or Board members would consider desirable, but what would be a satisfactory density for Town and Country.

I submit these comments as a citizen of Town and Country for your consideration.

I opposed the proposal by McBride and others to build 72 homes on this tract in the manner proposed.

If the Board wants to see this concept, go to the area that was Crestwood shopping center where McBride has constructed this type of home. The appearance is not compatible with the comprehensive plan, our zoning ordinances, or the character of Town and Country.

Twenty units on the Woods Mill property are entirely appropriate, along with the restaurant.

The developer of Woods Mill project essentially threatened the Commission, as was observed by the Chairman of the P&Z. "Accept this proposal or let the parcel decay." Most of the commissioners did not bend to that threat and voted to not approve at 6/3.

The petitioner spent an hour telling the commission that the Woods Mill lot was undevelopable. That is entirely disingenuous, when at the same meeting a developer showed how 20 homes on 10 acres along highway 40 are viable and another developer proposed 2-\$2,000,000 homes bordering the East side of Highway 141. Adjacencies to the highway and commercial areas do not make a lot undevelopable for residential use. Look to Town and Country Crossing for a local example.

As I mentioned at the hearing, this development does not provide appropriate space for guest parking. The applicant mentioned that parking will be restricted to one side of the residential streets. At 26 feet wide, the streets would need parking restrictions in order not to block trucks and fire department vehicles. Similar developments have areas along the residential streets for overflow guest parking, which should be provided in this proposal. The proposed streets will be persistently occupied by parked vehicles, which will be a nuisance for residents and first responders.

I am opposed to the use of alleys in our community, but if they are to exist. This is an urban concept, not compatible with Town and Country character. This is not an urban center, mixed use development, sending the wrong message. Town house development is appropriate for urban development, but this area would be a residential desert. There is nowhere for residents to walk or to participate in urban life, other than one restaurant.

I ask that the Board consider denying the petition in its present form.

(Dennis Bolazina is a longtime member of the P&Z Commission.)

I cannot recommend this proposal.

- It is nowhere envisioned in the 20-year Comprehensive Plan.
- It creates a Gateway that does not reflect what Town & Country is all about.
- A hasty decision on a development that is such a radical change from existing codes is a mistake.

I trust that you agree, and accept the Planning & Zoning Commission's recommendation to reject this rezoning and Site Plan.

While fully supportive of redeveloping the site in the form of residential housing, I have significant and specific reservations with the current McBride proposal. They are:

- 1) Density - by any definition, the current plan is for high density, tract housing bearing semblance to military barracks which is at least inconsistent with Town and Country standards and at worst non-compliant with existing city ordinances;
- 2) Traffic - the potential for up to 140 permanent additional resident owned vehicles, not including homeowner and restaurant guests and service vehicles, utilizing Woods Mill Road as currently configured daily;
- 3) On-site restaurant ownership, quality and control.

In evaluating redevelopment proposals such as this, it is incumbent on our Trustees, Mayor and Board of Alderman to take into consideration the likely impact on nearby property values and the quality of life on local residents. It is my opinion that the plan as currently proposed will be detrimental to both for reasons described above. That said, I would welcome the opportunity to consider and potentially support modifications to this proposal that would address, or better yet eliminate, my concerns and that would enhance property values and quality of life for those residents living close to this site. The current McBride proposal simply and fundamentally does not comply with the objectives in Section 405.1705 (C)...even with the flexibilities provided in the PNRD. That should be "case closed". Looking beyond those provisions, this plan is for an extreme version of tract homes - with each home in precise, lock step rows 8 ft. from the sidewalk. If you read the introduction to the Comprehensive Plan, it is clear this proposal does not fit.

**24-1804 - 154 THF Blvd (Mavy's)** - Unknown subjects stole over \$1000 worth of merchandise. Investigation ongoing

**24-1802 - Traffic accident with injuries - Olive/ Creve Couer Mill Rd** - Officers responded to a traffic collision at the intersection of Olive/ Creve Couer Mill Rd. The first arriving officer observed one of the vehicles begin to catch fire. He immediately grabbed his fire extinguisher and extinguished the flames, preventing any further issues. None of the injuries were life threatening.

**24-1806 - Warrant Arrest - Chesterfield Airport Rd/ 1<sup>st</sup> Community Dr** - A traffic stop resulted in the driver being arrested for warrants from another jurisdiction

**No report** - A tractor trailer hauling liquid fertilizer caught fire on westbound I-64 near Spirit of St Louis Blvd. causing westbound I64 to be shut down for over an hour. As of this report, 2 of 3 lanes are now open

Officers responded to calls for traffic collisions, alarms, sick cases, accidental injuries, motorist assists, and suspicious persons/ vehicles.

### AFTERNOON WATCH 05/08/24

**24-1682 (Update) - Larceny:** A Suspect in a felony theft surrendered herself to SEU Officers at the station. The suspect also had a Felony Warrant out of St. Louis County, a traffic warrant from another municipality, and a Felony Wanted out of St. Louis City. Upon completion of the booking process, she was placed in a cell and held awaiting pickup by St. Louis County, who had confirmed their warrant.

**No Report - Trespassing - St. Luke's:** Hospital staff called and requested police assistance removing a 78-year-old female who refused to leave when discharged. Upon arrival, they learned the female was homeless, believed she still needed medical care, and was fearful of being stranded in the storms. Officers contacted local shelters, the Missouri Department of Senior Services, local religious groups, and the United Way in an unsuccessful hours-long effort to locate a safe place for her to stay. Officers also contacted the woman's son, who had a wrathful disposition towards his mother and refused to take her in. The woman stated she believed she still needed medical attention for heart murmurs and was taken to Barnes Hospital for an evaluation at her request.

**No Report - Wrong Way Driver - I64E:** Town and Country Police advised they were attempting to stop a wrong-way driver going westbound in the eastbound lanes of I64. Chesterfield Officers responded to slow down and warn eastbound drivers and assisted in getting the vehicle stopped. The driver was a confused elderly male. Eastbound I64 was very briefly closed by Officers from both agencies to facilitate the removal of the car. Town and Country Officers waited with the driver until a family member arrived to care for him. An excellent demonstration of inter-agency cooperation to resolve a dangerous situation.

The Day Watch EOS report notes a tractor-trailer that caught fire. Evening Watch Officers continued to block traffic for several hours while some lanes remained open. Officers, with the assistance of MODOT, briefly shut down all lanes of the highway in one direction to allow the towing service to remove the trailer.

**Failure to Yield – W/B I-64/ Long Rd:** No report – A blue passenger vehicle with temp tags traveling in excess of 100mph failed to stop for a Chesterfield officer.
