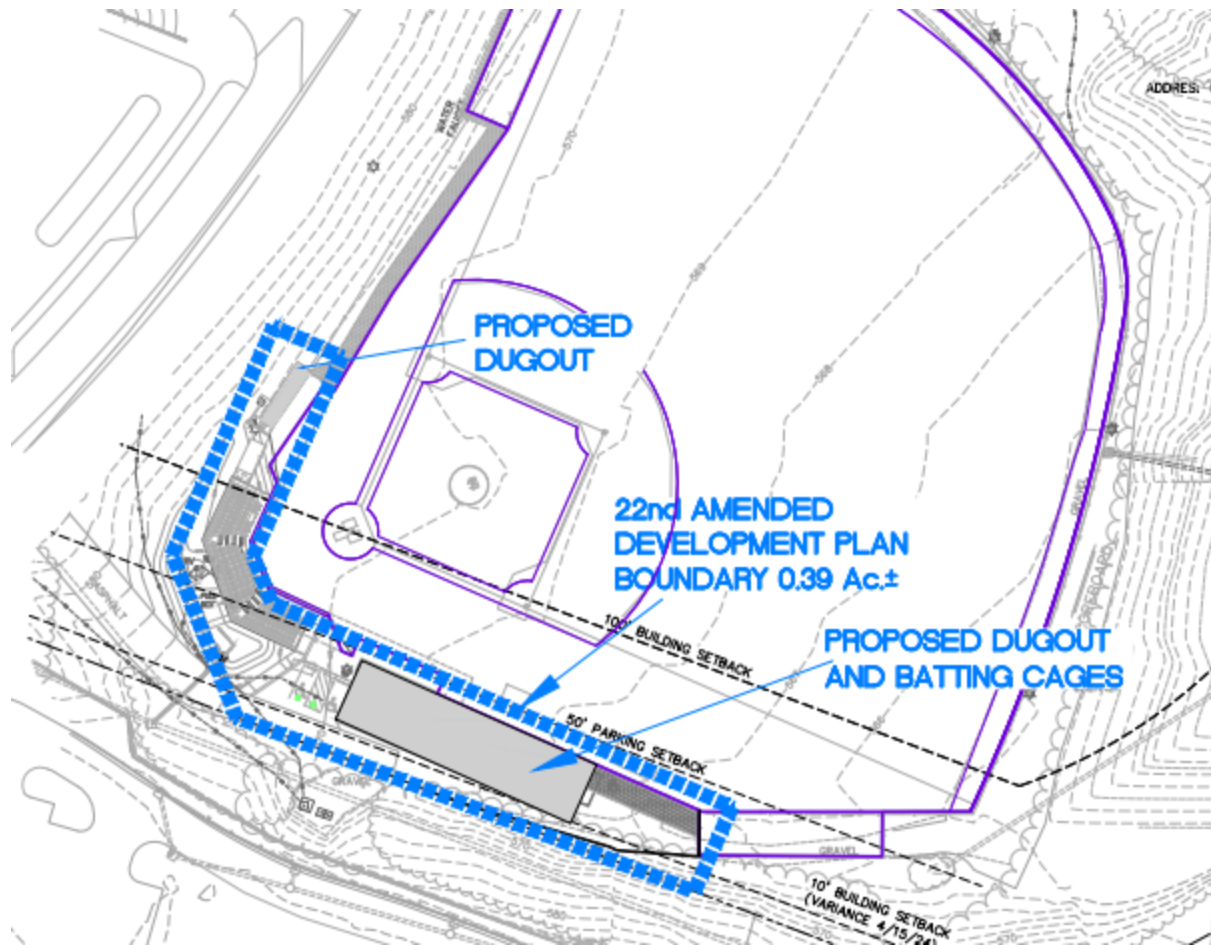
**JUNE 8, 2024**

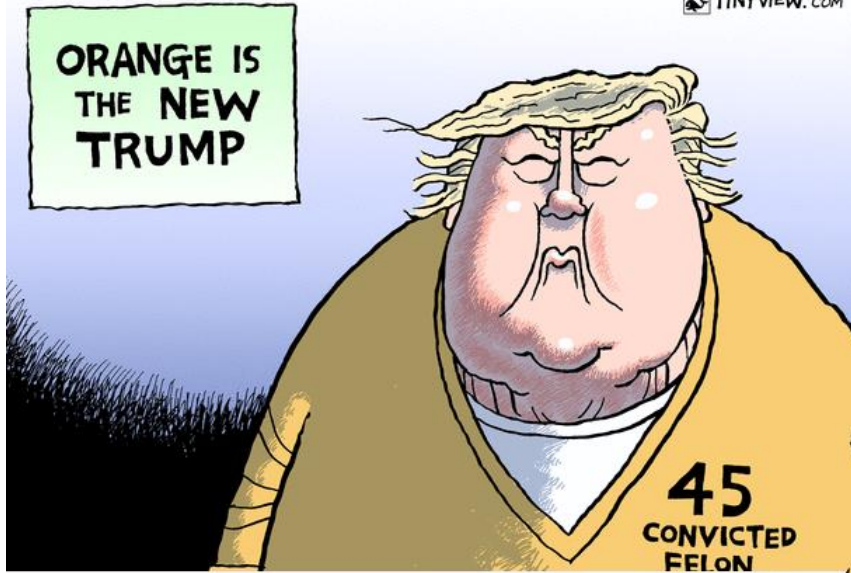

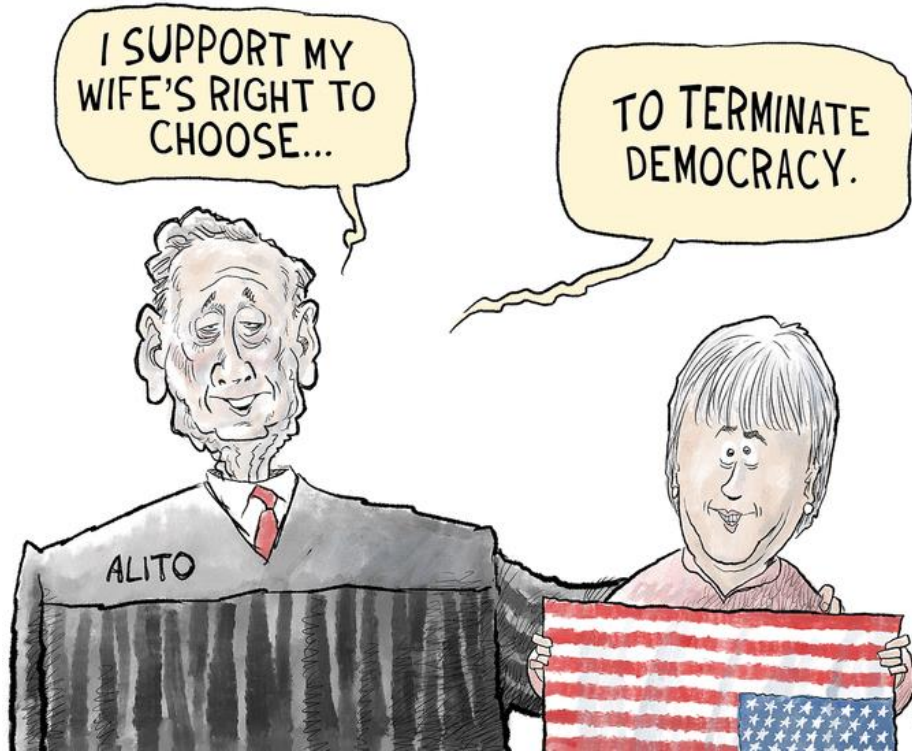






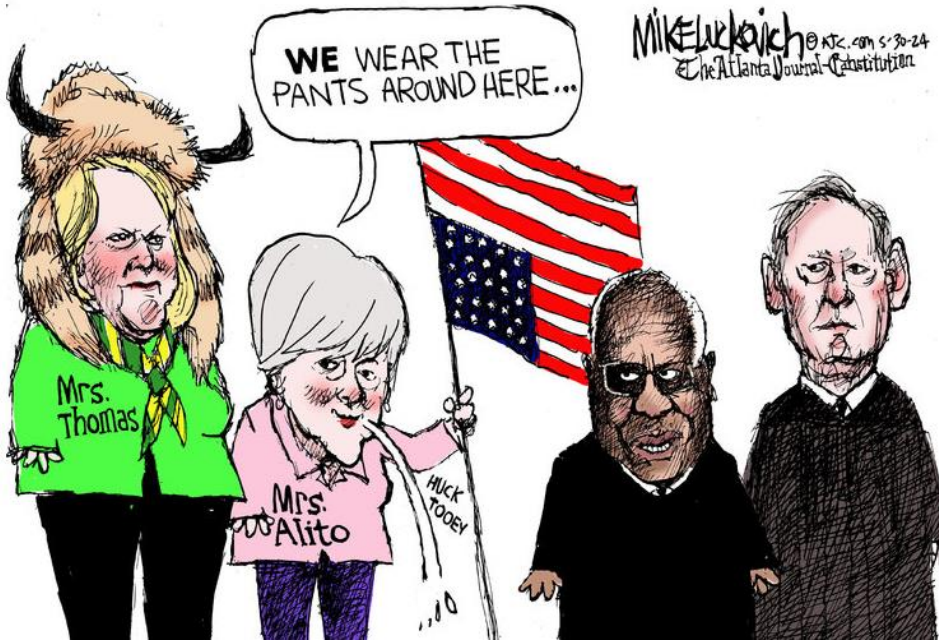
