



#### **CHESTERFIELD CITY COUNCIL MEETING**



#### MONARCH FIRE CHIEFS SPEAK ON TAX INCREASE ON AUGUST BALLOT:







Monarch Fire Protection Chief Russ Adams and Ast. Chief Nick Smith spoke at the beginning of the City Council Meeting pushing for the passage of their Prop A Tax Increase on the August ballot. The tax increase would be 19-cents per \$100 valuation.

Residential property is currently taxed at 87.4-cents per 100, while the commercial/retail tax is 95.8-cents per hundred. The tax would raise homeowner Fire District taxes to \$1.06.4 per hundred. The tax increase would put the Fire/EMS residential real estate tax to \$106.4 per \$100.

Ast. Chief Smith said the tax increase would only be \$12 for a \$400,000 house. Apparently he is blind to the fact there are more \$1,000,000-plus houses in Chesterfield than \$400,000 homes.

Smith also complained several times how the Hancock amendment (passed in 1980 by the Missouri legislature) has hurt in getting more revenue. Councilwomen Barb McGuinness shut him up by telling him that the Hancock amendment was passed to help stop "out of control" spending by municipalities (and Fire Districts too).

Both chiefs said the increased revenue was needed to hire 21 firefighter/EMTs, buy two more ambulances and to replace all firefighter protect jackets and pants at the cost of \$4,000 a person. (It has recently been determined that flame resistant material on current gear can cause infections when in contact with flames.)

Ast. Chief Smith mentioned some ambulance calls have taken 10 minutes to get to a residence. Most often if an ambulance is delayed a pumper truck with a crew of EMTs is already there treating the person. However, Smith did not mention how often this has actually happened. He also made a good point saying how the Chesterfield Valley athletic facilities, sporting events have increased along with a hockey rink.

The District operates four ambulance at their 5 fire stations. Clearly, they could add one ambulance with six more paramedics/EMTs to start with for less money.

The one thing that will be interesting to see is if Chesterfield voters would pass the tax. They already defeated twice placing local sales taxes on goods purchased off the Internet by large margins.

SUBDIVISION REPLACING CHESTERFIELD MANOR NURSING HOME MAYBE AROUND THE CORNER. Development engineer George Stock was at the meeting speaking on another matter, only to have Councilwoman Barb McGuinness asked him if

a developer was about to submit plans for a subdivision where the Chesterfield Manor Nursing Home was located at 14,001 Olive Blvd.

The nursing home closed in 1998 and was drawing complaints from nearby residences of teenagers trespassing and having parties.

Stock represented a developer in 2020 but withdrew site plans that were on the council agenda.








