As jerks once again bombarded their neighbors with loud ariel bombs apparently officers had their windows rolled up. There were no fireworks related citations issued.


It is pointless to have laws that are unenforced.





Perhaps the most interesting agenda item of the night involved no discussion. The developer of the 17 large house subdivision on 10 acres on North Forth Drive did not asked for a continuance on the plans and rezoning. They withdrew the entire the entire

plans and rezoning request. The planned Deer Hollow Subdivision now no longer an issue as the developer withdrew it.

MCBRIDE HOMES WITHDRAWS PLANS FOR THE 67 TOWNHOUSE STYLED

HOUSE ON 11 ACRES. Due to community concerns and how the development if approved would shatter Town & Country's 1 house on one acre standard and due to Aldermanic concerns along with the plans voted down by the Planning and Zoning Commission, McBride Homes withdrew their plans this week.

They promised to return with new plans for the property that is now a mostly vacant strip center.



The plans had the houses 15 feet apart with unattached garages and long alleys. McBride had continued the plans and rezoning three times before withdrawing them.
