GRAND JURY INDICTMENT ON TOWN & COUNTRY DRUNK DRIVER A Third DWI results in a Felony Grand Jury Indictment almost 2-years after the arrest. See the Indictment below.

25SL-CR01926

I, Steven Doll, DSN 0136, Town and Country Police Department, knowing that false statements on this form are punishable by law, state that the facts contained herein are true and documented in report number 23-1263. I have probable cause to believe that on November 5, 2023, within St. Louis County, Cappy Digirolamo, 66, White, Male, 5'10", 160lbs, committed one or more criminal offense(s).

Count: 01	DWI - AGGRAVATED - CLASS D FELONY
Count: 02	FAILED TO DRIVE WITHIN SINGLE LANE ON ROADWAY HAVING 3 OR MORE LANES - CLASS C MISDEMEANOR

The facts supporting this belief are as follows: The defendant was operating a motor vehicle on westbound I-64 near Mason Road and repeatedly failed to maintain a single lane. Officer Doll stopped the defendant and contacted him. The officer observed the defendant to have slurred speech, glassy and bloodshot eyes, a strong odor of an alcoholic beverage, and swayed while standing outside his vehicle. The defendant performed poorly on the field sobriety tests and refused a breathalyzer.



TOWN & COUNTRY CROSSING TO ADD ELECTRICAL RECHARGING STATIONS:

The plan is to remove 13 parking spaces in the middle of the lot of the Town & Country Crossing shopping center front of the Target store for 8 charging stations.


SPECIAL ENFORCEMENT UNIT

STEALING OVER \$750/ AGGRAVATED FELONY FLEEING

Outlet Blvd.- Three subjects stole \$7,751.00 worth of merchandise from True Religion and then fled from officers in their vehicle. Utilizing undercover Facebook accounts, SEU officers located the subjects selling the merchandise online. Officers acting in an undercover capacity were able to apprehend one subject. Information obtained from the interview led SEU officers to arrest the other two subjects the following day. CHILD ENDANGERMENT

The Chesterfield Police Department received a Division of Family Services (DFS) hotline report regarding child endangerment. The report outlined that a 4-year-old male was traveling in a vehicle with his parents and came into contact with fentanyl. The exposure caused the child to go into respiratory distress. The child was ultimately taken to Mercy Hospital, where he was intubated. Luckily, the child made a full recovery and was released to the care/custody of Family Services. During the original investigation, it was thought the incident happened in Chesterfield. However, after reviewing, it was learned that the incident happened in Overland, MO. The St. Louis County Prosecuting Attorney's Office and the Overland Police Department agreed it would be best if we continued the investigation. All 4 of the suspects have been identified, and charges are anticipated by the Prosecuting Attorney's Office.

KIDNAPPING/ DOMESTIC ASSAULT

On 07/09/2025, a resident of Chicago, IL responded to 17027 N. Outer 40 Road (The Main Event) and kidnapped his girlfriend, who was on a date with another man. Detectives responded and worked throughout the night to ensure a safe return of the victim. The suspect was identified, despite being given false information by the victim. It was confirmed the suspect fled back to Chicago and at-large warrants were issued for Kidnapping and Domestic Assault.


