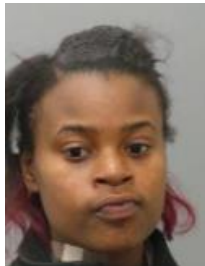

The new house will be at 12832 Topping Woods Estate Drive/



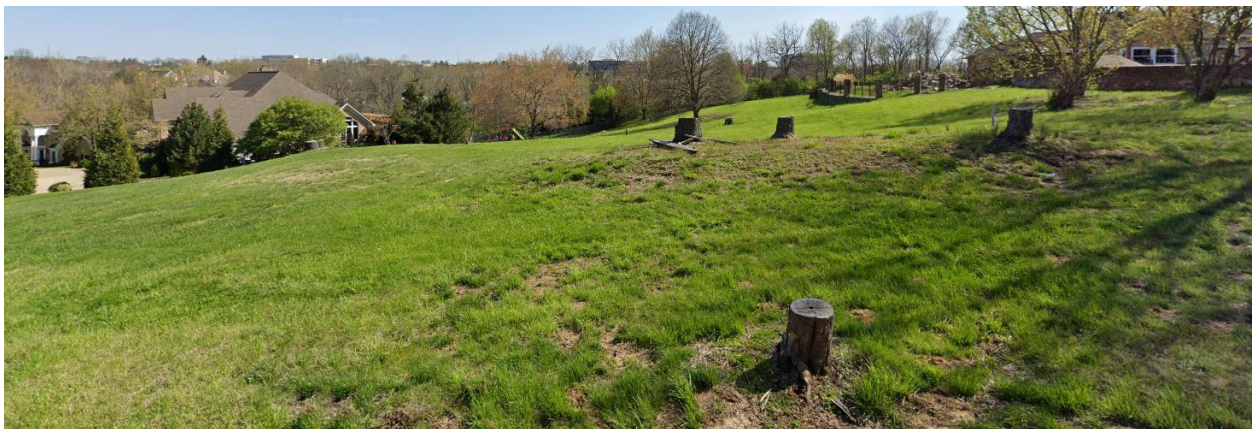

### **9-YEAR OLD BOY HIT GETTING OFF SCHOOL BUS BY DRIVER HIGH ON DRUGS:**

Here is the press release by the Chesterfield Chief of Police:

#### CHESTERFIELD POLICE OBTAIN WARRANTS IN CONNECTION WITH AN INTOXICATED DRIVER STRIKING A JUVENILE AND LEAVING THE SCENE

On August 27, 2025, a vehicle tried to improperly pass a school bus on Schoettler Road and struck and seriously injured a 9-year-old child on his way home from school. The vehicle left the scene of the crash. Chesterfield Police Officers responded promptly to the scene to assist paramedics and investigate the incident. Chesterfield Police Officers located the vehicle a short distance away and initiated a traffic stop. An investigation determined the driver was intoxicated by drugs.

The suspect has been arrested, and charges were issued by the St. Louis County Prosecuting Attorney's Office.

The suspect is identified as:

Dante Devito, 35 years old, from Chesterfield, MO

Charges: DWI - Serious Physical Injury – Class D Felony

Leaving the Scene of an Accident – Injury – Class E Felony

Bond: \$250,000

**COUNT: 01 DWI - SERIOUS PHYSICAL INJURY - CLASS D FELONY**

That Dante Daniel Devito, in violation of Section 577.010, committed the class-D felony of driving while intoxicated, punishable upon conviction under Sections 558.002, 558.011 and 577.010, RSMo, in that on or about August 27, 2025, 1965 Schoettler Rd, in the County of St. Louis, State of Missouri, the defendant operated a motor vehicle while under the influence of drugs, and acted with criminal negligence by passing a school bus by driving into opposing lanes of traffic, returned to his lane of travel and then struck a pedestrian, and as a result caused serious physical injury to Confidential Victim.

I, Greg Rupp, DSN 264, Chesterfield Police Department, knowing that false statements on this form are punishable by law, state that the facts contained herein are true and documented in report number 25-3820. I have probable cause to believe that on August 27, 2025, within St. Louis County, Dante Devito, White, Male, 5'08", 140lbs, committed one or more criminal offense(s).

Count: 01 DWI - SERIOUS PHYSICAL INJURY - CLASS D FELONY

Count: 02 LEAVING SCENE OF ACCIDENT - PHYSICAL INJURY - CLASS E FELONY

The facts supporting this belief are as follows: On Wednesday, August 27, 2025, at approximately 4:30 p.m., officers responded to the area of 1965 Schoettler Road for a report of a child being hit by a car, and the driver of the vehicle, a 2017 Buick Lacrosse, left the scene. Upon arrival, the officer made contact with the victim who was transported to the hospital. The officer observed a few car parts on the ground including a side mirror of the suspect vehicle that had fallen off from the accident. Officers stopped a vehicle matching the description provided, and the defendant was driving. A witness confirmed the vehicle was the same vehicle involved in the crash. The suspect vehicle was missing a mirror, and it matched the mirror found at the scene of the accident. The defendant was identified as the driver of the vehicle and initially said that the mirror had broken off a week earlier. The defendant's body was shaking and his eyes were bloodshot, and he appeared drowsy.

An officer read the defendant the Missouri Implied Consent Advisory, and the defendant agreed to provide a sample of his blood. The defendant waived Miranda and said that he did not know that he hit anybody. Footage from a Flock camera shows the defendant vehicle's mirror still attached to the vehicle just before the accident. En route to the hospital for the blood draw the defendant asked, "then after my blood draw I go to Chesterfield?" The officer said yes, and the defendant asked, "do I have bond or?" The officer said there was no bond, and the defendant asked, "I have to wait until I am not high anymore?" The defendant said, "I was off today. Today I was off so I smoked a little more than normal because I was off." When asked, on a scaled of 1 to 10 with 1 being sober and 10 being the highest he has ever been, what level of impairment did the defendant think he was, and the defendant said he was currently a 4 but at roadside he was closer to a 7. The defendant admitted he "heard something hit the side. So I didn't think I hit anything...So I heard something hit the side and then I didn't see anything so I thought it was a deer."

The victim suffered a fractured elbow and concussion as well as other injuries.

There is reason to believe the defendant poses a danger to the community and/or crime victim based on the above-outlined facts.

On 05/24/12 22-year-old Dante Devito of Chesterfield was accused of two counts of Destruction of Property. Chesterfield Police were called to the Shell gas station on Clayton Road. The dispatcher thought it was a hit and run action, but when police arrived and contacted an 18-year-old driver of a 2007 Chevrolet and her 17-year-old passenger they learned the call was about vandalism to a car.

Devito had an ongoing dispute with the girls over a personal relationship. The girls claimed that Devito had been in the gas station, saw them and then came running out and kicked the door to the car damaging it. The 17-year-old passenger reported that Devito had done a similar thing to her while she was driving her car.

The incident was caught on security video at the gas station. It showed Devito running out of the station and jumping and kicking the door of the car.

The driver said she told him, "You know this is on video, right?" She continued that he replied, "I don't care I own this Shell Station."



Unfortunately for him he didn't and the station management gave the police a DVD showing the incident.

Devito later came to the police station and admitted to the offense, claiming he thought the girls were following him to harass him.

On 02/07/13 Devito pled guilty to Littering (fined \$300.50) and Property Damage (fined \$125). Here was a non traffic case where an actual on-the-record conviction of the offense a defendant was charged with occurred.

Person's unknown used the victim's personal information to open a credit account in Texas. The victim first learned of this offense when he was served with a summons for not repaying thousands of dollars.

**25 - 3912 - Vehicle Crash:** While pulling into a parking spot at the medical building located at Baxter & Clarkson, the driver stepped on the gas pedal as opposed to the brake. **25-3920 - Stealing - Joyceridge Dr.** - Victim stated he believed his ex-girlfriend stole his phone. It was later revealed the phone had been returned. Investigation is ongoing.

**25-3921 - CIT - 307 S Woodsmill Rd (Brooking Park)** - Resident made suicidal comments to the staff. She was conveyed to Mercy Hospital for a mental health evaluation.

Officers responded to calls for traffic crashes, disturbances, alarms, sick cases, and suspicious persons/ vehicles.

**COUPLE INDICTED FOR RUNNING FRAUD CHURCHES IN FOUR STATES INCLUDING IN CHESTERFIELD:** Pair arrested by the FBI, owned large Chesterfield houses where they had numerous unpaid people running phone banks for donations to fraud churches.

David Taylor and Michelle Brannon were both indicted by a Federal Grand Jury in Detroit on 10-counts of fraud.. They operated churches or call-centers for fraud donations in four states.

**INDICTMENT**

THE GRAND JURY CHARGES:

**GENERAL ALLEGATIONS**

At all times relevant to this Indictment:

1. Kingdom of God Global Church (KOGGC), formerly known as Joshua Media Ministries International (JMMI), is an organization led by DAVID E. TAYLOR (TAYLOR).
2. MICHELLE BRANNON is the Executive Director of KOGGC.
3. BRANNON assists TAYLOR in managing KOGGC and carries out

TAYLOR's orders.

4. TAYLOR calls himself Apostle and Jesus's best friend. He claims he has had multiple face-to-face encounters with God and that God has given him the keys to the Kingdom on Earth.

5. TAYLOR established his first organized call center at 20320 Superior Road in Taylor, Michigan. The purpose of the call centers was to use phone solicitors to raise money from donors, purportedly to support the operations and ministry of KOGGC. TAYLOR has since opened and operated call centers in other locations in the United States including in Missouri, Florida, and Texas.

6. TAYLOR recruits individuals from across the country to work as phone solicitors at his call centers. Each day, his call center workers are instructed to make a specific number of calls or raise a specific dollar amount.

7. Call center workers are unpaid.

8. KOGGC receive millions of dollars in donations each year. TAYLOR uses these donations to support an extravagant personal lifestyle, including a series of residences, airline tickets, personal vehicles, and luxury goods.

9. KOGGC has received approximately \$50 million in donations since 2014.

10. TAYLOR also recruits individuals to work as his "armor bearers." Armor bearers work as TAYLOR's personal servants by fulfilling TAYLOR's demands.

11. TAYLOR demanded that his “armor bearers” provide food for him, transport him, maintain his houses and cars, transport women from ministry houses, airports, and other locations to TAYLOR’s location, and ensure the women transported to TAYLOR took Plan B emergency contraceptives.

12. Armor bearers, like call center workers, are unpaid.

13. If a call center worker or armor bearer does not fulfill TAYLOR’s goals or disobeys an order, that individual is punished.

14. Punishment includes humiliation, sleep deprivation, forced “repentance,” additional work, food restrictions, physical assaults, and threats of divine judgment in the form of sickness, accidents, death, and eternal damnation.

15. TAYLOR regularly claims that if an individual fails to obey his orders and commands, they are defying God and will suffer in Hell.

### **THE OBJECT OF THE CONSPIRACY**

18. The object of the conspiracy was for the defendants, and others known and unknown to the grand jury, to obtain the uncompensated labor and services of at least one victim in the Eastern District of Michigan and elsewhere.

### **THE MANNER AND MEANS OF THE CONSPIRACY**

19. The defendants controlled practically every aspect of the daily living of the call center workers and armor bearers (hereafter referred to collectively as “victims”).

20. TAYLOR created rules to control the victims and BRANNON enforced TAYLOR's rules.

21. TAYLOR and BRANNON demanded that victims cut off any family or friends that questioned TAYLOR or the righteousness of KOGGC.

22. TAYLOR and BRANNON demanded that full-time staff give up any outside employment.

23. Victims slept in the call center facility or in a "ministry" house.

The indictment is 23 pages long and too long to post, but we have to post this: some of the items Taylor and Brannon spent the donations on:

**CHESTERFIELD CITY COUNCIL MEETING** Due to the Labor Day holiday the Chesterfield City Council meeting was moved to Tuesday September 2. The Council did not spend \$17,300,000 on anything this meeting like they did on August 18, buying a 5-story office building and parking garage. But they did vote to spend some money.



**AQUATIC CENTER DESIGN CONTRACT:** The Aquatic Center that of course started off as the city's swimming pool and then rapidly expanded, will shut down after the 2027 season and then Chesterfield plans to spend around \$20,000,000 in rebuilding it.



On Tuesday the Council voted to spend \$596,000 on design plans for the new Aquatic Center.

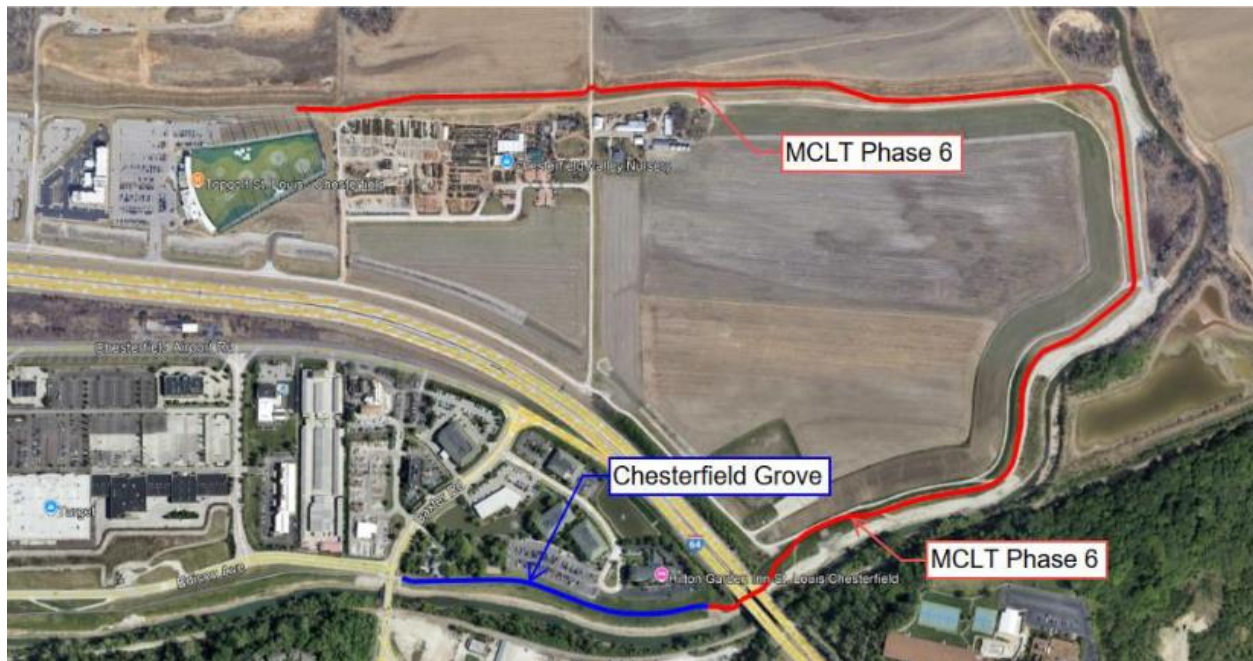


**PARK BANNERS:** Proposed banners to be hung on poles ref City Parks had the lowest price of the night at \$31,500. This was not passed and was sent back to the Parks Commission for further review. Some Councilpersons did not like them another question to me how motorists doing 40 mph on Chesterfield Airport Road could actually see them.



**FINISHING THE LEVEE TRAIL:** There is a sperate retail sales tax in Chesterfield Valley that doesn't go to the City, but goes to The Chesterfield Valley Transportation Development District. However, projects have to get City Council approval since the City eventually has to spend money to maintain them by the Parks Department and the police to patrol them.

To finish the Level Trail project that started years earlier the Council approved a \$903,800 project to complete the Trail funded by the Chesterfield Valley TDD.



**ANOTHER 6-2 VOTE:** This one was for the City to be a developer. See below: Both Barb McGuinness and Patricia Tocco felt the city's role was not to be a developer and voted NO.

**Bill No. 3557** - An ordinance of the City of Chesterfield, Missouri, designating the City as the developer of certain projects related to that portion of the redevelopment area designated as RPA 3 under the Chesterfield Regional Tax Increment Financing Redevelopment Plan & Project; authorizing certain actions relating thereto; and containing a severability clause. **(Second Reading) Planning Department recommends approval.**

**AN 8-0 VOTE ON SOMETHING MOST PEOPLE ASSOCIATE WITH CITY COUNCIL DUTIES:** The Council approved installation of a Stop Sign at Clock Plaza Tower and Chesterfield Commons East Drive.





**THERE IS STILL SIX WEEKS TO KILL THE OFFICE BUILDING DEAL.** The closing of real estate deal for the city to buy the 5-story office building for \$17,300,000 to get the parking garage and surface parking for events at the City's nearby amphitheater was approved on a 6-2 vote on August 18, with Bard McGuinness and Pat Tocco voting no.

The vote didn't close the deal however, as the closing date is on October 17.



The only citizen speaker at the start of the meeting was Ken Katt, a commercial property manager. Katt said he had mixed feeling about the purchase saying for a City to buy a commercial building would be like “trying to put a round peg in a square hole.”

The approval of the minutes from the August 18<sup>th</sup> meeting upset Councilwoman Tocco. She pointed out that at the August 4<sup>th</sup> meeting 15 residents spoke against the purchase and only 2 for spending \$17.3 million. She said the minutes from that meeting did not place “for” or “against” after the speakers’ names. However, the minutes of the August 18<sup>th</sup> meeting showed there were 12-for and 12-against and now had the speakers’ opinion of FOR or Against was printed after their names.

Tocco and Barb McGuinness still oppose the purchase and the amount of money being spent.
