TOWN AND COUNTRY WOMAN SUED FOR \$16-M. Jane Morrell, wife of Kevin Morrell of the troubled Green Street Real Estates Ventures, had guaranteed \$16.3-M in loans by the Midwest Regional Bank from 2019 to 2022, that defaulted. Her husband in Bankruptcy Court saw \$69-Million in debt disappear this summer. The Morrells live on South Mason Road next to Queeny Park/

Kevin Morrell had three lawsuits from banks filed against him, but got dropped in September of 2025 after bankruptcy was granted by the Federal Court.

In 2024 Green Street Real Estate owed St. Louis \$800.000 on its' office and property they hoped to develop.

BOARD OF ALDERMAN MEETING:



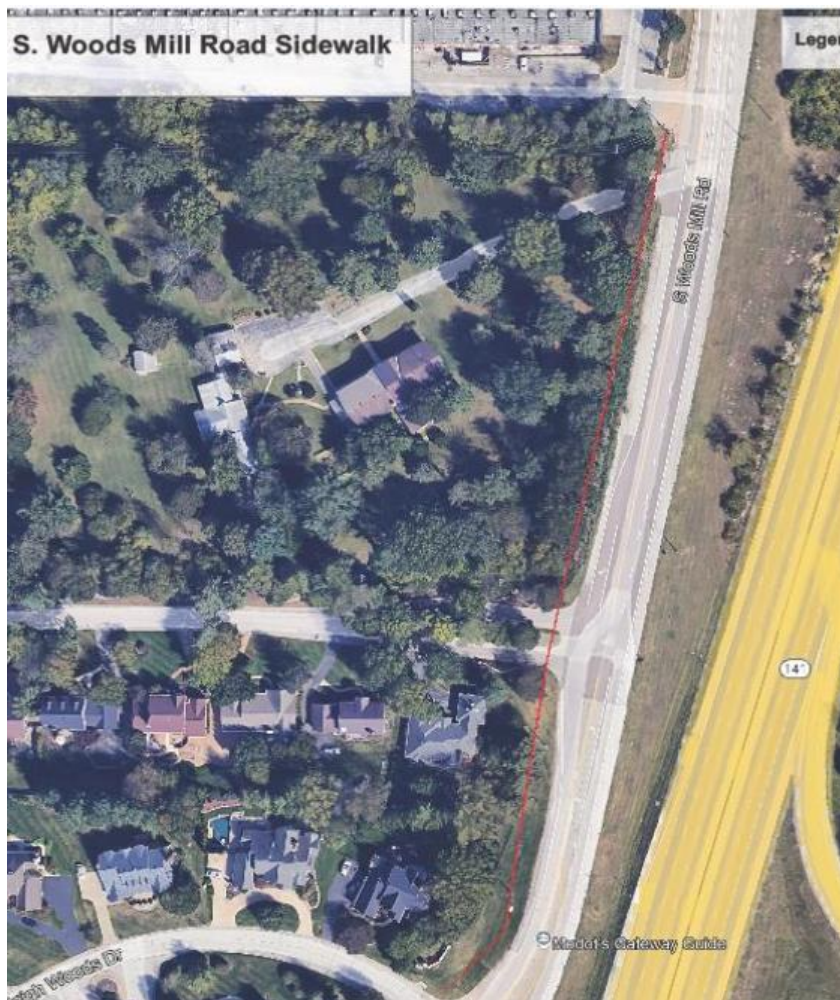
REAL ESTATE TAX GOES DOWN AND THEN UP. Last year the Aldermen raised the real estate on residential property from ZERO since 1997 to .23 cents per \$100 in 2024.

This year the plan was to lower it to 21-cents per 100. However, the Finance Committee voted to have it at 21.1-center per \$100.

Before the Board was the 21.1-cent rate when Aldman Al Gerber moved to make it 21.0-cents again. Gerber's motion did not receive a second and it died. The 21.1 passed.

There is hereby levied upon all residential property subject to taxation in the City of Town and Country, Missouri, an *ad valorem* tax levy of ~~\$0.2100~~ **\$0.2110** per one hundred dollars (\$100) assessed valuation as shown on the assessment books of St. Louis County, as converted and amended by the Board of Equalization and certified to by the County Clerk.

There was very little other business. The board voted to spend \$1705 to send Cpl. Dustin York to a week long FBI training class out of town. Also the board approved a \$16,900 design contract for sidewalk construction along Woods Mill Road..
