**25-4275 - Aggravated Fleeing**: A Special Enforcement Unit Officer made a traffic stop on Chesterfield Airport Road at Spirit. #### 25-4280 - Aggravated Fleeing - W I-64 / Boones Crossing Road

Officers stopped the driver of a green Nissan Maxima, who was slumped over the wheel at the traffic signal. The driver, an unknown male in his late 30s to early 40s, and a female front passenger of similar age both appeared heavily intoxicated. When officers approached on foot, the driver suddenly accelerated through the intersection and entered westbound I-64 from Boone's Crossing.

Officers attempted to locate the vehicle on I-64 without success. Officers did not engage in a pursuit, and the information was broadcast over the police radio. Town & Country Police attempted to stop the vehicle on eastbound I-64, but the vehicle failed to yield. The investigating officer obtained clear body camera footage of the driver and is actively working to identify him.

#### 25-4280 - (Update) Aggravated Fleeing

The investigating officer identified the driver who fled from officers on I-64 at Boones Crossing. The subject is a 46-year-old male with an extensive criminal history of violent crimes. He is currently on probation/parole for burglary 1st and has a prior record of drug distribution. He is also affiliated with a former problem residence on Park Forest

#### 25-4281 - Assist other Agency - 1789 Clarkson Road

At approximately 2:00 AM, officers responded to Clarkson Mobil regarding a 24-year-old male involved in a domestic violence incident. The male reported his ex-girlfriend discovered him with another woman and broke the rear window of his vehicle in St. Charles County. Officers observed a large amount of blood on the driver's side of the vehicle and a loaded firearm in plain view on the rear passenger seat.

The male admitted to assaulting the victim during this incident in St. Charles County and requested we take a property damage report. IILLEGAL ROMANIAN NATIONAL PLED GUILTY IN ST. LOUIS FEDERAL COURT TO STEALING IN A SLEIGHT OF HAND SCHEME INCLUDING IN CHESTERFIELD This is from the U.S. Attorney's Office:



ST. LOUIS – A Romanian national, who authorities say was in the country illegally, has <u>pleaded</u> <u>guilty to federal charges</u> tied to a national sleight-of-hand scheme that targeted the St. Louis area and at least 20 states.

Adrian Stoica, 46, pleaded guilty Thursday to three counts of wire fraud and one count of illegal entry into the United States.

Stoica admitted to carrying out at least 170 transactions at stores in 20 states from November 2021 to March 2025.

Investigators say, after cashiers scanned merchandise, prepaid gift cards, and electronic money transfers for Stoica, he would count out cash in piles to make it appear he was paying the full amount. He collected the piles and then slipped bills from the bottom of stacks into his pocket, short-changing stores by hundreds of dollars or more per transaction, then moving on to target another store elsewhere.

Stoica's plea agreement mentions three transactions in the St. Louis region.

On Feb. 17, 2023, he shortchanged a Chesterfield store by around \$860. On Sept. 7, 2023, he shortchanged a store in O'Fallon, Missouri by around \$690. The next day, he shortchanged a Fenton store by around \$660.

After his guilty plea, Stoica could face up to 62 years in prison and \$1 million in fines. He is also expected to be ordered to repay the stolen money and be deported, according to the U.S. Department of Justice.


The facts supporting this belief are as follows: On Wednesday, August 27, 2025, at approximately 4:30 p.m., officers responded to the area of 1965 Schoettler Road for a report of a child being hit by a car, and the driver of the vehicle, a 2017 Buick Lacrosse, left the scene. Upon arrival, the officer made contact with the victim who was transported to the hospital. The officer observed a few car parts on the ground including a sidemirror of the suspect vehicle that had fallen off from the accident. Officers stopped a vehicle matching the description provided, and the defendant was driving. A witness confirmed the vehicle was the same vehicle involved in the crash. The suspect vehicle was missing a mirror, and it matched the mirror

found at the scene of the accident. The defendant was identified as the driver of the vehicle and initially said that the mirror had broken off a week earlier. The defendant's body was shaking and his eyes were bloodshot, and he appeared drowsy.

An officer read the defendant the Missouri Implied Consent Advisory, and the defendant agreed to provide a sample of his blood. The defendant waived Miranda and said that he did not know that he hit anybody. Footage from a Flock camera shows the defendant vehicle's mirror still attached to the vehicle just before the accident. En route to the hospital for the blood draw the defendant asked, "then after my blood draw I go to Chesterfield?" The officer said yes, and the defendant asked, "do I have bond or?" The officer said there was no bond, and the defendant asked, "I have to wait until I am not high anymore?" The defendant said, "I was off today. Today I was off so I smoked a little more than normal because I was off." When asked, on a scaled of 1 to 10 with 1 being sober and 10 being the highest he has ever been, what level of impairment did the defendant think he was, and the defendant said he was currently a 4 but at roadside he was closer to a 7. The defendant admitted he "heard something hit the side. So I didn't think I hit anything...So I heard something hit the side and then I didn't see anything so I thought it was a deer."

The victim suffered a fractured elbow and concussion as well as other injuries. There is reason to believe the defendant poses a danger to the community and/or crime victim based on the above-outlined facts.

# The Sunday Tony Messenger's Post-Dispatch column take on the \$17.3-million purchase of an office building:

HESTERFIELD — Early last year, Bob Nation came across news that didn't pass his smell test.

Nation was mayor of Chesterfield at the time, and he and the city council were reviewing the annual goals of City Manager Mike Geisel. One of them was to complete the purchase of an office building near the city's Central Park.

Nation had heard nothing of the potential purchase of the Mass Mutual office building. It didn't make sense to him.

"For the mayor to not even be aware of that is completely inappropriate," Nation told me in a recent interview.

Nation's tenure as mayor ended in April. But he and other critics of the purchase — which was **approved by the council** in August — are putting on a full-court press before the deal is finalized, trying to convince council members to change their minds. Nation and others believe the purchase would be a big mistake.

There are several reasons the critics point to. Start with the \$17.3 million price tag, which is **\$3 million more** than the most recent appraisal. There are questions about the stated needs — a parking garage and space to expand city offices. There are questions about whether the city should be in the commercial real estate business.

Among the most important arguments: the plans have been brewing longer than most folks in Chesterfield realize, leaving a dark cloud of suspicion.

"It looks to me like they're ramrodding it through," says Jim Regna, a Chesterfield resident and retired banking executive.

He started paying attention to city council actions during the process to create a tax increment finance district, which will provide incentives for the redevelopment of the Chesterfield Mall site.

"They're not being transparent with the citizens of Chesterfield," Regna says.

That's been true since he was the mayor, Nation said. The council started discussing the purchase of the building and its parking garage in closed sessions last summer, Nation said. Among the biggest cheerleaders was Councilman Dan Hurt, who is now the mayor.

Nation didn't believe the city needed to buy a Class A office building. The owners weren't actually marketing it for sale. The initial appraisal seemed too high.

In January 2025, Nation raised another objection. In an email to city attorney Chris Graville, Nation said discussions about the purchase shouldn't be held behind closed doors. Missouri's Sunshine Law includes an exception for some real estate matters. That allows city councils in some circumstances to discuss the issues behind closed doors, particularly when "public knowledge of the transaction might adversely affect the legal consideration thereof."

In this case, the only potential buyer of the building, Nation said, was the city. Public discussions wouldn't change that. He told Graville and the council he wanted the discussions to take place in open session. The attorney disagreed.

At that point, discussions of the potential purchase slowed down until Nation was out of office and Hurt took over as mayor in April.

"They were slow-rolling me," Nation said. "Nothing happened until I was out of office."

Hurt did not return calls seeking comment.

It wasn't until recently that Nation realized the discussions had been going on "for some time." That's what a memo written by Giesel on July 13, 2023, indicates. The memo outlines a meeting between multiple city officials and the building's owners that took place the day before. The owners "expressed concern about confidentiality," the memo says, in fear that tenants would leave after hearing about a potential sale to the city.

"They had been talking about this for more than a year, and I had no knowledge of it," Nation said.

The secrecy is one reason why a watchdog group called the Holy Joe Society **sent a letter** to city leaders warning of potential legal action if the purchase goes through.

There is still time to stop the sale, says Kenny Kott, a Chesterfield resident who once managed commercial real estate. He has sent a series of letters to council members, urging them to look more carefully at the idea of turning themselves into commercial real estate managers at a time when the market "is soft."

"There is no financial benefit to the city whatsoever," Kott says. "Hopefully we can get them to stop before it's too late."

Parties have been discussing the City's intention to acquire the referenced property for some time. The meeting was requested by Chris Fox in response to the City's request for financial information necessary to develop a valuation for said property.

The ownership group expressed concern about confidentiality, in fear that tenants may hear rumors of a potential sale to the City and seek to terminate their lease. They may not desire to be tenants in a building that is owned, or even used by the City, specifically if one of the uses is a community center.

City representatives discussed the current status of the TIF, the timing of any funding mechanism to raise the capital to acquire the building, and the City's ultimate use of the building. We also discussed a desire that once the City acquired the building, that we would likely occupy one floor, but would hope that Gershman would continue to operate and manage the building independently.

Ownership has a blanket loan that is due in August of 2026, so that would be a preferred window to convey ownership.

City representatives expressed that there is no need for the City to own or occupy the facility immediately, and that the City prefers that current ownership & management continue to lease the building and attempt to maintain the revenue stream. Ownership indicated that they would be willing to provide high level cash flow information, but generally the building is operating at a net positive cash flow of roughly \$1.5 million/year.

The existing parking garage has ~288 spaces, and at current build costs, (\$40 - \$50k per spot) the garage value is roughly \$11,520,00 - \$14,400, and the building would be in addition to that. The building is the newest building in their portfolio and is of unique and notable architecture, having been designed by HOK. Paul Hylton indicated that their asking price would be in the neighborhood of \$20 million. New build costs are in the \$350 - \$400 per square foot range. The HOK building is roughly 98,000 square feet, over five floors. The TIF budget includes \$24 million for this purpose.

There was general conversation about the overall office market. Per Chris Fox, "everybody is waiting on the mall". There won't be any significant office building or movement in Chesterfield until after the mall settles out. In their opinion, this is what is causing Wildhorse Village delays, larger office users are waiting, preferring Mall space and once that happens, the market will backfill into Wildhorse Village. They also confirmed that the market will demand a dense residential component to be successful.

All parties seemed to be of a similar understanding in pursuing a sale to the City, and that it would be preferable to develop a sales contract expressing the terms and conditions, but the actual conveyance

Paul Hylton was going to develop a draft letter of intent for the City to consider, that would facilitate the next steps in moving towards a sales contract.

Meeting ended at roughly 12 noon.

I have a problem with Dan Hurt pushing to spend \$17.3 for and office building allegedly to obtain some parking spaces, but I have a bigger problem with Hurt refusing to answer a reporter's question about a Chesterfield political issue...after all that is the job of a mayor. The City Administrator also seems to have done some work on keeping the purchase of the office building from some of the Council for sometime.
