Officers also conducted proactive patrol of subdivisions, parks, (CVAC) retail and entertainment districts/venues as well as traffic enforcement.



ST. LOUIS, Mo. (First Alert 4) - Two people were arrested after police found \$18,000 worth of merchandise inside a hotel room on Monday.

According to the Chesterfield Police Department, officers responded to the Sunglass Hut at 18521 Outlet Boulevard on Monday for a report of larceny.

The manager told police she noticed some slots missing when she came into the store that day, and then saw two people on a security camera taking sunglasses from the store the day prior.

Police say the sunglasses were valued at over \$1,300.

The suspects' vehicle was later found at a hotel. After searching their room, officers found \$18,000 worth of merchandise.

One of the suspects admitted to stealing from seven different stores at the Chesterfield Premium Outlet Mall. In addition, both of them admitted to also stealing from the Premium Outlet Mall in Chicago.

The two suspects are identified as Rigoberta Vega, from New Jersey, and Shakera Brown, from Tennessee.

Both have been charged with stealing.

# TWO DRUG OVERDOSES AT MOBIL ON THE RUN IN CHESTERFIELD VALLEY

CHESTERFIELD, Mo. (First Alert 4) - A high school basketball coach's quick thinking and CPR training helped save two overdose victims at a Chesterfield convenience store.

Tim Bowdern was making his daily stop at an On The Run store when he found a man unconscious on the floor by the electronic slot machines.

"There's a man laying on the ground. Nobody's paying attention at all. He's just laying there on his side," Bowdern said.

Bowdern told an employee to call 911 and began administering aid to the unresponsive man.

"We got him over on his side, and that's when we saw drugs, some kind of a pipe," Bowdern said.

He started chest compressions until a Chesterfield police officer arrived and administered naloxone.

"She went right to it and probably saved his life. He was blue for at least five minutes," Bowdern said.

Sergeant Robert Powell with the Chesterfield Police Department said officers carry naloxone kits in their patrol cars.

"That training kicks in and you have to react," Powell said. "It highlights the level of training officers receive because in situations like this, every second counts."

Police found a second overdose victim while searching for the first man's vehicle.

"We were able to identify a vehicle, went to it, found someone else unresponsive. They had to breach the lock, pull that person out and perform medical assistance to them as well," Powell said.

Bowdern expressed frustration that other customers had not responded to the emergency before he took action.

"I felt like people didn't react the way I thought they would. We have a guy on the floor and nobody's reacting," Bowdern said.

Despite his concerns about bystander response, Bowdern praised the quick police response.

"It's a miracle that man's alive. I hope that guy realizes that people did respond," Bowdern said.





The City only received two bids and one was disqualified as it was improperly filed.


