The facts supporting this belief are as follows: On or about 10/13/25 I responded to vehicle crash and disturbance at Mike Duffy's Pub and Grill, 1024 Schnucks Woods Mill Plz. Upon arrival, I spoke with owner of BMW, Victim JG, who was a patron at the restaurant. Victim JG's car alarm goes off and Manager CS tells Victim JG that his car was struck in the parking lot. Victim goes outside and speaks with Defendant who struck his parked while attempting to park. Victim JG and Defendant exchange information and Victim JG goes back into restaurant. Approximately 10 minutes later Defendant gets out of his car and starts yelling to see the manager and wants to know who hit his car. Victim JG approaches to speak with Defendant again and Defendant punches Victim JG in the face. Off duty police officer Victim CB, is eating on the patio and intervenes but also gets punched in the face twice, breaking his Ray-ban sunglasses. Off -duty officer Victim CB pulls his concealed weapon and Defendant immediate leaves. Witnesses agree Defendant appeared very intoxicated. Defendant was found and arrested approximatelly 4 hours later was still very intoxicated at the time of the arrest. He is currenlty in custody in the Town and Country jail.

OVERDOSE

Chesterfield Airport Rd: Officers responded to the Mobil on the Run in the Valley for a report of an individual who had passed out while playing the slot machines. The first officer on scene began CPR after being unable to locate a pulse. Once a pulse was established, the officer administered Narcan, which revived the subject as EMS was in route. During the investigation, a Sergeant reviewed surveillance footage and identified the vehicle the subject had arrived in. Upon inspecting the vehicle, officers discovered a second individual in the midst of an overdose. Officers forced entry into the vehicle to allow paramedics to provide medical care. That subject also survived.

ROBBERY 1ST DEGREE/ARMED CRIMINAL ACTION/ POSSESSION OF A STOLEN FIREARM Chesterfield Airport Road - At 12:37 AM, officers were dispatched to Dave's Hot Chicken for a robbery in progress. The suspect, armed with a semi-automatic handgun, was last seen running toward Chesterfield Airport Road. Officers arrived within four minutes, established containment, and canvassed the area. The suspect emerged from a wooded area and was arrested. The 37-year-old male from East St. Louis, Illinois was found in possession of stolen money and a 9mm handgun previously reported stolen in Clayton, Missouri. Despite video evidence showing him in the same clothing, he denied committing the robbery. An Ellisville K-9 assisted with an article search, leading to the recovery of the money bag in a sewer drain near McBride and Sons Center Drive.

ORGANIZED RETAIL THEFT GREATER THAN \$10,000 **THF Blvd.**-A habitual shoplifter was identified after stealing from St. Louis and St. Charles area Lowe's Home Improvement stores. The subject stole approximately \$13,000 worth of merchandise. The subject was arrested and charged with Organized Retail Theft. In custody warrants were obtained for the subject with bond set at \$50,000.

ORGANIZED RETAIL THEFT GREATER THAN \$10,000 Outlet Blvd.-Two subjects stole \$1,300 worth of sunglasses from Sunglass Hut. Partnering with St. Charles City PD, the suspect vehicle was located at a motel in St. Charles City. The subsequent investigation led to the arrest of the subjects and the seizure of \$27,300 worth of merchandise seized from two motel rooms. Further investigation revealed they had traveled to Chicago, IL the previous day and stole merchandise from 13 retailers and while stealing from Sunglass Hut, they also stole merchandise from 10 other retailers at the St. Louis Premium Outlets. The subjects were held and in custody warrants were obtained. Bond was set at \$100,000 with no 10% being authorized.

STEALING UNDER \$750/ POSSESSION OF A CONTROLLED SUBSTANCE

THF Blvd.-SEU arrested a subject at Walmart for failing to scan \$282.25 worth of merchandise during checkout. During the arrest, suspected heroin was discovered concealed on the subject. The subject was arrested for Stealing, Possession of a Controlled Substance, and an active warrant. The subject was booked and held on the active warrant.

MISSING JUVENILE/ STATUTORY RAPE

On Saturday, October 25, 2025, Chesterfield Officers were contacted by the Columbus, OH Police Department regarding a missing juvenile. Initial information revealed the 13-year-old juvenile was likely staying at the Avalon Apartments in Chesterfield. Multiple attempts were made to locate the juvenile by officers, but these efforts were met with negative results. On Monday, October 27, the Detective Bureau took over the investigation. With the help of Homeland Security Investigations (HSI) Agents, Chesterfield Patrol Officers, and an Ellisville PD Officer, the juvenile was located. When located, the juvenile was with her 20-year-old boyfriend and a 23-year-old roommate. During the interview of the boyfriend, he admitted to having intercourse with the juvenile. He was ultimately charged with Statutory Rape 1st and was given NO BOND. The juvenile was transported to the St. Louis County Family Court where she awaits transport back to her family.

HARASSMENT 1ST DEGREE

Detectives assisted Patrol officers with an investigation involving a suspect harassing a victim residing in Chesterfield. Once the suspect was taken into custody, Detectives, along with the investigating officer, obtained a confession from the suspect.

OF NOTE

- The Sex Crimes Detective compiled an updated sex offender Halloween list for 2025 and distributed to officers on patrol October 31st.
- The Sex Crimes Detective attended a regional Multi-Disciplinary Team meeting where a case was highlighted involving a juvenile being referred to family court for sexual assault.
- Members of the Detective Bureau assisted SEU in three separate "buy busts" in the month of October. During the investigations, four subjects were arrested.

ARCHITECTURAL REVIEW BOARD ACTION

<u>Board Member Mehrtens</u> made a motion to forward <u>13490 Olive Blvd. (Take 5 Oil Change)</u> to Planning Commission with a recommendation of approval with the following conditions:

- The existing pavement be resealed.
- Updates and maintenance to the existing trash enclosure if not in working condition.
- The existing roof-mount satellite equipment be removed.

Board Member Lavrich seconded the motion. The motion passed by a voice vote of 4-0.

CHESTERFIELD CITY COUNCIL MEETING There were no controversial issues and only 8-0 votes on all agenda items. The meeting was over in 21 minutes.



Council approved \$125,000 to be removed from the Parks Department Budget reserve for activities in 2026 to celebrate the 250th anniversary of signing the Declaration of Independence. This is from the Council's agenda:

Highlights include enhancements to the City's 4th of July Celebration, with an estimated additional cost of \$40,000 beyond the current budget. Proposed enhanced features include a B-2 Bomber flyover, carnival-style attractions such as a large amusement slide, rock-climbing wall, and expanded entertainment offerings. A drone show has been recommended for inclusion at another major event, such as the Sounds of Summer Concert Series (potentially featuring a Toby

Keith tribute to his *Made in America* album) or the Fall Festival. More than 30 programs and events throughout the year will incorporate patriotic themes, activities, and giveaways. The celebration will culminate with the Veteran's Day event in November 2026.

A few questions I had, were there drones and B-52 Bomber is 1776? If not, do you need those to celebrate.

The Council is also looking for \$150 sponsorship of 250 American Flags that are planned to be situated along Veterans Place Drive. The City is hoping by sponsoring and paying for flags(some are donated) will generate \$12,,000 for the City.

Finally the City wants to go into the T-Shirt business and sell 500 250th Celebration T-Shirts generating \$7,500.

Additionally, the committee recommends selling **250th commemorative t-shirts**. Projected sales of 500 shirts at \$15 each could generate \$7,500. Further details regarding the proposed programs and events are provided in the attached documents.
