#### 25-4744- (Update)

The Special Enforcement Unit executed a search warrant in the City of O'Fallon in connection with an Organized Retail Crime investigation. The primary subject was taken into custody along with a second involved individual. The primary subject was charged with Organized Retail Crime over \$1,000, while the second subject was charged with Organized Retail Crime under \$1,000. 
#### 25-5287- Motor Vehicle Crash-Clarkson/Baxter Rd

# 17-YEAR-OLD HIGH SCHOOL STUDENT KILLED IN CRASH ON EATHERTON ROAD IN CHESTERFIELD

#### 25-5288-Motor Vehicle Crash with Fatality- S Eatherton/Hager Ln

A two-vehicle crash involving a Ford Taurus and a Ford Expedition occurred at the above location. Both occupants of the Taurus were transported to Mercy Hospital. One sustained substantial injury, and the other was later pronounced deceased. Both vehicles sustained disabling damage and were towed from the scene. The Traffic Bureau is conducting the crash reconstruction investigation.



Joyce C Weidenhoffer of Byrnes Mill

The driver of a Ford Edge lost control on Eatherton Rd, went into a ditch came back onto the road and struck Vehicle 2, a 2003 Ford Taurus, where Weidenhoffer was a right front seat passenger.

The driver of the striking vehicle, Jensen Vogt was injured, but declined any treatment.

The driver of the Ford Taurus, Charles Minder was badly injured and transported to Mercy Hospital. Weidenhoffer appear to be dead at the scene, but was transported by ambulance to Mercy Hospital where Dr. Chang declared her dead.

This is from the preliminary report:

V1 WAS TRAVELING NORTHBOUND ON EATHERTON RD AFTER LIONS HEAD. D1 STATED SHE WAS ROUNDING THE CURVE IN THE ROADWAY, "HYDROPLANED" AND IN AN ATTEMPT TO "ONLY HURT HER CAR" SHE SWERVED TO THE RIGHT TO GO INTO A DITCH ALONG THE ROADWAY. AFTER ENTERING THE DITCH SHE THEN RE-ENTERED THE ROADWAY, CROSSED OVER THE CENTER LINE AND STRUCK V2.

I SPOKE WITH ADAM TWELLMAN WHO ARRIVED ON SCENE JUST AFTER THE CRASH OCCURRED. TWELLMAN STATED HE DID NOT SEE THE CRASH BUT STOPPED AND EXITED HIS VEHICLE TO OFFER ASSISTANCE. DUE TO THE PASSENGER OF V2 (WEIDENHOFFER), WHO WAS NOT BREATHING AND HAD NO PULSE. TWELLMAN STATED HE ATTEMPTED TO REMOVE THE PASSENGER FROM V2 BUT WAS UNABLE TO BY HIMSELF. AN UNKNOWN MALE ENTERED THE REAR OF V2, LIFTED WEIDENHOFFER UP WHILE TWELLMAN PULLED HER OUT THROUGH THE PASSENGER SIDE WINDOW OF V2 THAT WAS ALREADY BROKEN OUT. AFTER PULLING WEIDENHOFFER FROM V2, HE LAID HER ON THE GROUND AND STARTED TO PERFORM CHEST COMPRESSIONS. TWELLMAN AND D1 ROTATED PERFORMING CHEST COMPRESSIONS UNTIL OFFICER SANDLER #387 ARRIVED ON SCENE AND TOOK OVER. THE UNKNOWN MALE LEFT THE SCENE AS EMERGENCY PERSONNEL ARRIVED ON SCENE.

# 25-5290 & 25-5291- Delayed Stealing-Outlet Blvd

The Special Enforcement Unit (SEU) took two reports concerning separate incidents of delayed theft. Investigations into both cases are ongoing.

### 25-5292-Stealing Over-THF

Two unidentified subjects stole merchandise and were last seen fleeing eastbound on Highway 64 in a U-Haul truck. A short time later, dispatch advised that the truck had crashed within Manchester's jurisdiction, where both subjects were taken into custody. SEU responded to assist Manchester authorities, and their investigation remains ongoing


#### Found Dog - 150 N Eatherton Road
