DRUNKS AND THIEVES 2024 PART 1

FEBRUARY 20, 2024

DRIVER STOPPED IN THE MIDDLE OF SCHOTTLER VALLEY ROAD AT 3:15am ASKED POLICE WHY THEY WERE BOTHERING HIM AND COULD NOT TELL THEM WHERE HE LIVED. It was a Friday night into Saturday morning at 3:15am on June 20, 2020 when Chesterfield Police Sgt. Teresa Koebbe radioed she was out with a drunk driver in the middle of Schoettler Valley Road. Officer Todd Lantz was close by and responded.



The driver Engin Imral, 58, of Clayton Estates Drive in Chesterfield said he was coming home from a Casino and stopped to check his phone. Officer Lantz reported he did not see a phone for Imral to check. Imral was behind the wheel of his 2012 Jeep Wrangler.

Officer Lantz reported that Imral was clearly drunk. This is from his report:



He was over 2-miles from his home and Officer Lantz asked what street he was on. He looked around and said, "Country Ridge" while he was in the middle of Schoettler Valley Road.

Officer Lantz had Imral get out of the car to do field sobriety tests, but Imral stumbled so badly no tests were given for the sake of his safety. He refused to take a field breath test and later at the police station he refused to take an "official breath test."

He was advised of his rights and agreed to be interviewed. When he was asked "what day is" he paused and said "I don't want to answer that without my lawyer." The interview was then stopped.

OUTCOME; Imral was in Chesterfield Muni Court on January 25, 2022 with DWI defense attorney Travis Noble. Imral pled guilty to DWI and was placed on a SES (suspended execution of sentence) probation term in lieu of 90 days in jail.

FROM UNDERWEAR TO SPEAKERS PAIR CAUGHT STEALING AT WALMART On



OUTCOME: Prior to Cook's next trip to prison on 04/28/22 he pled guilty in Chesterfield Muni Court and was sentenced to 10-days in jail.

THE RETURN OF LISA MARIE TACA AND ANOTHER STOLEN LIC PLATE We closed our last newsletter about Lisa Tacaa persistent shoplifter and druggie who had served prison time for drug dealing. Our last article dealt with Taca's arrest on May 24, 2020 for driving a car with stolen license plates. Her arrest record at the time included numerous stealing and drug charges.

Despite a long arrest record Chesterfield Prosecutor Tim Engelmeyer reduced the stolen license plate charges to a non-criminal Health Code Violation with a \$300 fine. That did not keep Taca from interacting with more Chesterfield police officers.

On Friday February 12, 2021, Chesterfield Officer Ty Seeger ran a computer check on the only single a license plate on a Chrysler SUV on the Mobil on the Run gas station lot on Clarkson Road. The plate came back stolen off a vehicle in Creve Coeur MO.

When Seeger stopped the Chrysler he contacted the driver Lisa M. Taca, 43, of Chesterfield, who stated the she did not know the license plate was stolen as the car was her brother's. This is what she said in 2020 when cited for having one stolen license plate on the vehicle and a different stolen plate on the floor inside the car.

A Creve Coeur Police Officer responded and seized the license plate.

Due to CoVID police were not transporting and booking all offenders, Taca was issued a citation for Possession of Stolen Property.

OUTCOME: On 08/22/23 Taca pled guilty in Chesterfield Municipal Court to the actual charge of Receiving Stolen Property and was fine \$150.

DRUNK DRIVER CLAIMS HE HAD ONLY 1-BEER, BUT AFTER FAILING ALL FIELD SOBRIETY TESTS, EXCLAIMED, "YOU GOT ME. I HAVE BEEN DRINKING." On Wednesday March 23, 2022 at about 11:16pm Chesterfield Officer Jeremy Holton stopped a Nissan pickup truck with an expired license plate that was turning from Clarkson Parkway onto WB I-64.

He contacted the driver, Steven Luke Holt, 43, and immediately smelled BOB (booze on breath) and noticed glassy eyes.

Holt stated that he had just one beer. Officer Holton had him exit the car and do field sobriety test which he constantly failed. Before the tests were over Holt said he didn't want to continue the tests and added, "You've got me. I've been drinking."

He was arrested and at the police station he agreed to take an official breath test that showed his BAC level at .245 or three times over the legal limit.

He agreed to be interviewed where he went back to having just has "one beer" but admitting that he considered himself intoxicated.

OUTCOME: On June 8, 2022 Holt pled guilty to DWI and was placed on a 2-year SES probation in lieu of 90-days in jail. He was fined \$55 for the expired license plates.

WALMART SHOPLIFTER SAID SHE WAS STRESSED OUT SINCE HER WIFE HAD SURGERY AS THE REASON FOR STEALING On Monday May 30, 2022 (Memorial Day) two Chesterfield Police Officers responded to the Wal Mart reference a shoplifter being held by store security for failing to scan \$56.58 worth of merchandise at the self-checkout.

On arrival Officers Mueller and Pousson contact the suspect, Amanda Kay Holt, 31, of St. Ann in the security office. The theft, although minor was on video. These are the items she left the store without paying for:

She admitted stealing the items. This is from the police report:

I read Amanda her rights per Miranda, to which she stated she understood and agreed to speak with me. Amanda stated she was stressed due to her wife feeling ill from a recent surgery and must have missed a few items at self checkout. Amanda stated she used to steal when she was younger but has not stolen anything recently.

Holt was issued a summons for stealing and released at the scene.

OUTCOME: On 10/22/22 Holt and a lawyer appeared in Chesterfield Municipal Court where City Prosecutor (most often non-prosecutor) Tim Engelmeyer reduced the stealing charge to a Health Code Violation with a \$300 fine.



OUTCOME: Julia Hopp arrived at Chesterfield Muni Court with a lawyer in tow. Prosecutor Tim Engelmeyer reduced the stealing charge to a Health Code Violation with a \$366 fine. Madison Burr came to Chesterfield Court with a lawyer on 09/16/22 and pled guilty to a reduced charge (that she didn't do) of Health Code Violation and was fined \$366.

SHOPLIFTER BRINGS WHOLE FAMILY TO THE SUNGLASS HUT TO STEAL GLASSES, PLACING THEM IN A STROLLER. This one might not be the lowest most miserable theft case, but it is close.

On Wednesday April 12, 2023 Timothy Z. Zollner, 43, of Olivette brought his two small children in strollers and their mother to the Chesterfield Valley Mall.

They enter the Sunglass Hut where the mother distracted the manager trying to return a pair of sunglasses not sold at the store. Meanwhile Zollner took a pair of \$98 children sunglasses on this 1-year-old's head. He later removed them from the boy's head and placed them under a blanket in the stroller. They then left the store as the staff called the police.

Three officers arrived and found they found them in the food area of the mall and contacted them. They denied stealing anything, but a check of the stroller revealed the sunglasses. Zollner said the child must have put them there. Store security video showed Zollner had done the deed.

Zollner was issued a citation for Stealing.

A LESSON NOT LEARNED: On November 3, 2023 Zollner, his wife without the kids retuned to Chesterfield. This time they were stealing from Wal Mart with Zollner under ringing at the self-checkout. After leaving the store Chesterfield Police arrived and the pair took off running. Timothy was stopped and arrested with stolen items seized and returned to Wal Mart.

OUTCOME: Zollner is a man with Federal Convictions, Felony Stealing convictions and local stealing offenses. On 08/22/23 Zollner appeared in Chesterfield Municipal Court with a lawyer from Clayton and of course Tim (let'm loose if they have a lawyer) Engelmeyer city prosecutor reduced that charge to a non-criminal health code violation. Zollner pled guilty to the offense he did not commit. He was fined \$200.

ALWAYS A BAD MOVE...WEAVING INTO THE LANE OF AN APPROACHING POLICE CAR. It was the day after St. Patrick's Day on Friday March 18, 2022 at 11:40pm. Town and Country Police Sgt. Freddie Yaakub was south on I-270 from Clayton Road when the driver of a Jeep Wrangler began to swerve back and forth in front of him.

After the 5th swerve, Sgt. Yaakub decided to stop the Jeep, The driver took 1/8 of a mile to pull over after he had started driving on the shoulder while drifting back on the roadway.

The driver Andrew Schmitz, 59, of Kirkwood, MO admitted it took him a while to pull over because he didn't "know where he was."

There was an immediate oder of BOB (booze on breath) and Schmitz stated he had a couple of beers in St. Louis while "partying."

Schmitz failed all the Field Sobriety Tests. A field breath test showed his BAC level at .145%. He was then arrested and taken to the Town and Country PD.

He then agreed to take an "official breath test" that showed his BAC level at .155%

He agreed to a post arrest interview, where the "two beers" he had changed into 3 7-to-9oz martinis. He was two days behind on the date stating he thought it was March 16 and not March 18.

Schmitz admitted that he thought he was intoxicated and should not be driving. He said he was only driving drunk because he was "going home."

OUTCOME: Schmitz had no other violations on his record. On 06/16/22 he appeared in Town & Country Court with a defense lawyer. He pled guilty to the DWI charge and was

given a 2-year SIS (no fine, no points and no permanent record) probation term. He also pled guilty to Improper Lane Use and was fine \$316,

OVERTAKING A POLICE CAR AT 98 MPH WHEN YOU ARE DRUNK IS ALWAYS A BAD IDEA: On Wednesday April 22, 2022 at 9:11 pm Town and Country Officer Eric Diaz was WB on I-64 from I-270 when he noticed a speeding car rapidly approaching him. He turned on his rear facing radar and clocked the car at 98mph in a 60 mph zone.

Diaz, a former State Trooper, resigned in March of 2023, after then Police Chief James Cavins claimed he would not promote Diaz due to complaints. Diaz file a sunshine request wanting to see the complaints. Cavins could not produce them because there were none. Cavins was later forced to resign over this and other issues.



Officer Diaz asked where Schnoebelen had been since he was going the opposite direction of Ladue. Schnoebelen stated he had been out with his girlfriend. When asked how much he had to drink Schnoebelen claimed a half-glass of wine. He agreed to take field sobriety tests which he failed. He then refused to take a "field breath test" or an official breath test at the police station. Both tests would have proved Schnoebelen had just a partial glass of wine or was lying about the ½-glass of wine.

He was arrested for DWI. At the police station he refused to be interviewed. He was issued citations for Speeding and DWI. Records showed that he had at least one prior DWI arrest in 2009 when he refused to take a beath test.

OUTCOME: On 03/16/23 Schnoebelen and a defense lawyer appeared in Town and Country Muni Court. He pled guilty to DWI and was given a 2-year No-Fine, No-Points and No Permanent Record, SIS probation. The 98 mph speeding charged was reduced to a Parking Violation with a \$191 fine. Schnoebelen left the courtroom with no-points on his record.

DRUNK DRIVER STARTS TO GO SOUTH ON I-270, THEN SWERVES AND GOES NORTH AND IS RELUCTANT TO PULL OVER

Town and Country Police Officer Josh Hamel was westbound on I-64 before Ballas Road. It was 12:28am on June 23, 2022 when he noticed a gold Toyota Camry in front of him weaving from lanes to lane. The driver began to exit to go south on I-270 and almost hit a guardrail. The car then changed lanes to the NB -270 exit still weaving.

Officer Hamel then got behind the car and attempted to stop it on I-270, but the driver drove north and exited on Ladue Road in Creve Coeur. The driver took Ladue Rd to Ballas Road and finally stopped at Sackston Woods subdivision. Officer Hamel spent almost 3-minutes trying to stop the car.

The driver, Daniel M. Scholey (with a British accent) got out of the car forcing Officer Hamel to order him back into the car. That is when Officer Hanel smelled a strong level of BOB (booze on breath). When asked, Scholey claimed he had one beer. That would dramatically change.

Scholey agreed to do field sobriety tests which he failed. He agreed to take a field Breath Test that showed his BAC to be .16% or double the level of intoxication. He was arrested and the car was towed.

At the police station Scholey agreed to take an "Official Breath Test" that showed his BAC level dropping but still very high at .153%.

Scholey agreed to be interviewed and the one-beer change to drinking 2- beers from 10:30pm to midnight (must have been 24oz servings) at a downtown hotel. He admitted that he considered himself intoxicated.

Scholey, who does marketing for the St. Louis University Billikens, was issued citations for lane weaving and DWI.

OUTCOME: On 01/06/23 Scholey along with a lawyer appeared in Town and Country Municipal Court where he pled guilty to DWI and received a 2-year SIS (no-points, no fine, no permanent record) probation. His guilty plea to Improper Lane Use was reduced to a Parking Violation with a \$191 fine. Not bad for someone double the limit. Had this occurred in Scholey's native England he would have been fined and lost his rights to drive for a year. This was Town and Country Law at its worst.

DRUNK DRIVER SWERVING OVER 2-LANES ON I-64 CLAIMED HE WASN'T DRUNK, BUT TEXTING HIS GIRLFRIEND. On Thursday night into Friday morning 06/11/21at 1:43 am Town and Country Police Officer Alexander Gowen was stationary running radar and checking traffic on WB I-64 after I-270.Officer Gowen didn't see a speeding car, but a driver of a black Audi A4 driving in two lanes of the marked Interstate.

Officer Gowen followed the Audi and it continued to swerve or at time drive between two lanes, He stopped that car on WB I-64 at Timberlake where he contacted the driver, Matthew J. Schulz, 26, of Ballwin.

Schulz agreed to take field sobriety tests which he failed. He then continues to deny having anything to drink. He then agreed to take a field breath test. The test showed Schulz BAC level to be more than twice the legal limit at .169%. Schulz was arrested for DWI and his car was towed.


At the police station Schulz agreed to take an "official" breath test. That test showed that Schulz's BAC level was dropping over the last hour, but he was still very drunk at .138% BAC.

Schulz refused to be interviewed. He was issued citations for DWI and Fail to Drive in a Single Lane and released to a sober party.

OUTCOME: On May 18, 2022 Schulz appeared in Town and Country Municipal Court with a defense attorney, and pled guilty to DWI. He was placed on a 2-year SIS (no fine, no points and no permanent record) probation term. The Illegal Lane Use charge was reduced to a Parking Violation with a \$191 fine. A drunk driver who was all over the highway, lied to the arresting officer and tested very drunk left the courtroom with No-Points on his driving record. Town and Country justice taking care of defense attorneys before ever thinking about public safety.

THE TOWN AND COUNTRY PUBLIC WORKS EMPLOYEE WITNESSES A RETURN THIEF TO HOME DEPOT. On Saturday November 28, 2020 Tom Thousand the Town and Country Public Works foreman was leaving the shopping center where Home Depot is located stopped at a red light at Manchester Road.

While stopped he noticed a tan Chevrolet Malibu with Illinois license plates, drive to the intersection away from Home Depot at a high rate of speed. While at the stoplight the driver, an older black male, began changing his sweatshirt and hat. When the light changed to green the driver took off at a high rate of speed going east on Manchester Rd.

On Monday 11/30/20 Thousand was back in the parking lot of Home Deport in his Town and Country Public Works pickup truck. There he observed the same Chevy Impala and watched a the same black/male walked out of the store carrying unbagged items, which he placed in the trunk. This time Thousand wrote down the license plate number.

Thousand reported this to the Town and Country Detective Unit on Monday. They in turn contacted the Home Depot store security which located on video recordings the suspect stealing a \$129 saw, a \$99 battery pack and a \$50 hoodie on 11/28 and \$179 in goods on 11/30.

From the security images the detectives were able to identify the suspect as Michael NMN Smith 59. An arrest order was issued and on December 13, 2020 Smith was arrested for Stealing in Bridgeton and eventually turned over to the Town and Country PD.

At the police station he confessed to the two Home Depot thefts.

That was not the last time Smith would visit the Manchester Meadows shopping center in Town and Country. On July 10, 2021 at 2:48 Smith was back at the shopping center this time stealing \$236 in liquor from the Total Wine and More store that he placed in the same Chevy Impala. Total Wine and More delayed reporting the theft two days when they turned over the video of T&C PD.

At the Town and Country Police station Smith agreed to be interviewed. He was shown photos of him stealing in the Total Wine and More store. He recognized one photo and added that he wasn't sure about the other one since he is a "crack addict" and has a bad memory. He was later released to Kirkwood PD.

OUTCOME: Smith was sentenced to short jail terms on a number of cases. However, while the felony stealing cases sat in St. Louis County Courts a 2021 Felony Stealing case in St. Peters resulted in a 7-year prison sentence after Smith Pled Guilty on January 11, 2024 in St. Charles Co Circuit Court.
