"I HAVEN'T BEEN DRINKING" BUT SPEEDING 92 MPH, WITH A FAKE DRIVERS' LIC AND A BAC LEVEL OF .178%

On Sunday November 21, 2021 Town & Country Police Cpl. Steve Doll at 2:16am clocked a car at 92 MPH on NB 270 approaching I-64. On a Saturday night after midnight this can still be a busy stretch of highway.

Cpl. Doll stopped the black Mazda and contacted Victor Lopez, 19, of St. Peters, MO. Lopez had a front seat passenger. He added he was not in a hurry and was taking the passenger home.

Cpl. Doll detected the use of alcohol on Lopez, however Lopez denied having anything to drink. This is from the police report:

Lopez continued to deny having anything to drink and asked to be given a breath. But first Cpl. Doll preformed field sobriety tests, which Lopez failed. Next came the field breath test that showed Lozez was more than double the alcohol level testing at a BAC level of .178%.



When Lopez was getting out of the car Cpl. Doll spied what appeared to be another Missouri Drivers' License with Lopez's photo on it. It was a fake license showing the 19-year-old Lopez to be 22 with a date of birth in 1999. He also found an empty beer can behind the drivers' seat.

Lopez was arrested for DWI. Another officer took the passenger to the police station to call someone to pick him up,

At the police station Lopez agreed to take another breath test. This test showed his BAC level was dropping as it was .151%. Despite the tests and failing the balance tests Lopez in an interview stated he was not intoxicated, but now admitted drinking 4 or 5 beers over 2-hours.

NOVEMBER 21, 2021A BUSY NIGHT FOR TOWN & COUNTRY POLICE AND DRUNK DRIVERS. 29 minutes before Cpl. Doll was dealing with drunk driver Victor Lopez on I-270, Officer Wesley Laney was on I-64 arresting Francis K. Mathenge, 37, a Kenya native now living in Maplewood for DWI.

Officer Laney noticed a black Nissan to his rear going slow. He radar showed the car doing 40 mph. As he car approached Laney he also notice it was weaving from lane to lane.

He then stopped the car on EB I-64 after I-270. The driver Francis Mathenge, 37 of Maplewood was contacted.


When asked if he knew why he was being stopped, Mathenge stated it was because he was lane weaving. Officer Laney immediately noticed the Mathenge had been drinking. This is from his police report:

It was a night for lying drunk drivers. Just like Lopez did after 2am Mathenge did before 2am and denied having anything to drink. The field sobriety tests started with one of my favorites, the backward alphabet recital beginning with the letter "J" and stopping with the letter "Y." Here are the results of that test, which was followed by a counting test:

Mathenge then was removed from the car for balance tests which he failed. He agreed to take a field breath test. For a guy who claimed to have nothing the drink the test revealed his BAC Level at .152%.



Mathenge was arrested and taken to the Town & Country Police station. There he was booked and processed. He refused to take an "official" breath test or be interviewed.

DRIVER ADMITED HAVING A DRINKING PROBLEM AND QUICKLY PROVED IT It was Friday night into Saturday on June 5, 2021 at 3:24am Town and Country police officer Jordan Fowle was WB on Hwy 64 from I-270 when he notice a black Kia approaching at a high rate of speed.


The radar in his fully marked police indicated the black Kia was travelling at 91 MPH in the 60 MPH zone. Cpl. Fowle stopped the Kia on I-64 after Mason Road and contacted the driver, **Derrick Blake McKee**, 31, of Wentzville.

McKee admitted speeding but denied doing 91 MPH. He claimed he was only doing 75 mph in a 60 zone.

McKee appeared to have been drinking. He at first claimed he had just one margarita. He admitted having a past drinking problem. This is from the police report:

Out of the car McKee failed sobriety tests, including counting, reciting the alphabet and balance tests. He was arrested for DWI and Speeding and taken to the Town and Country Police station. There a field breath test showed his BAC level to be .195%.




McKee agreed to take an "Official Breath Test, but the T&C Instrument had not been recertified. He was driven to Creve Coeur PD where he took the test. The test showed

McKee BAC level was dropping but was still more than double the legal limit at .16%.





The defendant then walked to 1215 Paloma Drive where she unlawfully entered the victim's residence, confronted the victim, and took the victim's car keys and cell phone. The defendant was arrested at the scene in possession of the victim's cell phone and has been identified as the perpetrator of the offenses.


There is reason to believe that the defendant poses a danger to the community because the defendant has prior arrests for Robbery Second Degree, Possession of Controlled Substance Felony, Stealing a Motor Vehicle, and Trafficking in Stolen Identities. The defendant currently has six felony cases pending in the St. Louis County Circuit Court and was on bond for the offense Involuntary Manslaughter.





On arrival Officer Diaz smelled strong (BOB)...booze on breath coming from the driver, Brittany McDermott, 20, of Pevely, MO.


McDermott stated she only had two Truly Mango drinks while at a "get together" nearby and that she was unfamiliar with the area. However, there was another open half-filled can on the rear floorboard.



McDermott agreed to take field sobriety tests which she failed. A field breath test showed she was double the legal limit at .168%. She was arrested for DWI. This was from the crash report.


At the police station she agreed to take an official breath test, that showed her BAC level was now at .149%.



In an interview, despite crashing and the two BAC reading, McDermott said she did not consider herself intoxicates.

McDermott was cited for DWI and released to a sober person.

OUTCOME: On 02/17/22 McDermott pled guilty to DWI. Judge Andrea Niehoff placed her on a SIS (no-points, no-fine, no permanent record) probation for two years.

PICKUP TRUCK DRIVER VERY DRUNK AS MOTORISTS CALL IN HIM DRIVING OFF I-64 AND WEAVING AS OFFICER PULLS BEHIND HIM AND WATCHES THE SHOW.

On 02/02/21 at 1:13am Chesterfield Police Officer Ryan Broeker was WB on I-64 at Chesterfield Parkway. On the Saturday night into Sunday he found himself behind a white Chevrolet pickup truck whose driving was badly weaving and driving onto the shoulder. AS Officer Broeker was pulling over the truck the dispatcher advised of calls from motorists about the pickup truck.



The driver of the truck, Bryan Fritz, 31, of St. Peters was clearly drunk. He agreed to do sobriety tests, which Officer Broeker had to stop because Fritz's balance was so unsure he was afraid Fritz would fall. Fritz was arrested and taken to the Chesterfield Poice Station. This is from the police report.

Fritz agreed to take a breath test. The results showed his BAC level at .218%. In an interview Fritz said he had 2 beers over $2\frac{1}{2}$ hours at the Oyster Bar. He then changed that to three beers. He stated he thought he was intoxicated.

OUTCOME: CHESTERFIELD PROSECUTOR TIM ENGELMEYER AGAIN "SAYS TO HELL WITH PUBLIC SAFETY": Fritz was represented by Tim Devereux, a former well known Ast. Prosecutor dating back to the days when I was a police detective.

Engelmeyer is famous for reducing charges and never trying people represented by local attorneys. This was one of those cases. Despite Fritz weaving, driving off the road, drawing phone calls to the police from concerned citizens Fritz left Chesterfield Court with no points on his driver's license.

Engelmeyer reduced the DWI to a non-alcohol offense to Careless and Imprudent Driving. The Fritz pled guilty to C&I and was placed on a SIS "No Fine, No Points, No Permanent Record" Probation.

Engelmeyer then reduced the Improper Lane Use that dealt with the weaving to a Parking Violation and a \$191 fine.

Fritz left with absolutely NO POINTS on his driving record and no DWI conviction despite admitting that he was drunk.

MARIJUANA USERS DENIED SMOKING WEED IN THE CAR DESPITE STRONG ODOR, BONG IN BACKSEAT, DILATED EYES Crystal Fuller, 31, of Chesterfield was driving a 2007 Dodge Van on Chesterfield Parkway West at 1:35 in the afternoon on March 14, 2020 with six-month expired license plates.

She was stopped by Chesterfield Police Officer Brendan Steber.



When Steber contacted Fuller with her window down. It was like being at a rock concert in 1979. He was greeted by a heavy smell of marijuana.

Officer Steber immediately noticed the following about Fuller (from the police report)

- Her eyes were bloodshot.
- Her pupils were initially constricted, but were later dilated.
- Her reaction times seemed slow / delayed.
- Her entire body seemed to be shaking and fidgeting out of nervousness.

Fuller denied smoking any marijuana at first (this from the report:

I asked Fuller when she last possessed or smoked Marijuana inside or around her vehicle. Fuller paused, looked away and said "Uhm... Probably about a year ago... I moved here in November [2019] and I absolutely haven't had any since".

Fuller who lived a few blocks from the traffic stop changed her answer big time a couple minutes later. (From the report)

needed to be aware of, Fuller hesitated before saying "No... No..." and then admitting "I did smoke [Marijuana] like before I got in the car...".

She was arrested for DWI-Drugs. She was taken to St. Luke's Hospital for a blood draw that she had agreed to. After the blood draw she was taken to the police station for booking.

Fuller also agreed to interviewed. Here is part of the interview that reduced the last smoking of from 2019 to 03/14/20 just before she drove off from her Chesterfield apartment.

OUTCOME: The charges were filed in Chesterfield Municipal Court where the most dangerous man in Chesterfield is the prosecutor.

21 months after her arrest Fuller appeared in Chesterfield Court. She pled guilty to DWI-D and was given a SIS probation term, with no fine, no points, no permanent record.

To P.A. Engelmeyer someone as high as a Chinese balloon driving in the middle of the, having just smoked weed in her car, lied to the police deserved not to get any points or pay a fine. Let's see how much this offense cost. Two police officers making the arrest. Nursing staff at St. Luke's Hospital to draw blood. Highway Patrol lab staff to test the blood. There was all this and Fuller did not pay a fine to cover it.

Possession of the marijuana smoking bong was reduced by Engelmeyer to a Health code violation with a \$349 fine.

HOME DEPOT CASH REGISTER EMPLOYEE STEALING LITTLE AT A TIME: The Security Manager Waeltz at Home Depot noticed very small thefts of cash from register.

When he had time he researched the thefts and found the same employee was the only one on the cash register at the time of the theft.

There was a problem. There was only video of \$144 of thefts. The employee was Blake S. Foster, 26, of O'Fallon, MO. Security Manager Waeltz wanted for Foster to be on duty and called the Chesterfield Police. Waeltz already had Foster in the security office when Officer James Dammrich responded at 3:56pm on 02/13/20. After viewing the video and obtaining a report from the security manager.

At the police station Foster made a full confession. He said he thought he had stolen \$600 over the last month that he used to repay a loan from a friend.

He was issued a citation and released.



OUTCOME: Chesterfield Prosecutor Tim "Let em Loose if the hired a lawyer" Engelmeyer is also the Judge in O'Fallon, MO.

On 04/06/22 Engelmeyer accepted a Guilty Plea for guilty from Foster for a theft in O'Fallon that occurred on 08/08/21. Foster was given a SIS "No fine, No Permanent Record" probation from Engelmeyer.

On 11/14/22 Foster appeared in Chesterfield Court for the stealing charge at Home Deport. Engelmeyer either did not remember putting Foster on probation for stealing in O'Fallon or repeat thieves are fine with him.

In Chesterfield he reduced the charge to a non-criminal charge of Health Code Violation and Foster was fined \$250.

Once on arrival Officer York had the security manager Mark Duncan state the suspect was on video.



Early stated they were coming from her friend Joe's house in Creve Coeur. When asked if they had been drinking there Lessie said "No" and Early said "Yes."

Lessie failed several sobriety tests and was arrested. This is when Early state she had a confession to make. She said she was driving and switched seat with Lessie as the blue police light came on and they were driving on the shoulder of Des Peres Road.

The two officers' observation and the video recorder in the Des Peres squad car said otherwise

At the Town and Country Police station Lessie was books and agreed to take a breath test. The results were just over the intoxication line at .086% BAC.

At the police station Lessie was playing along with the "I wasn't driving" lie.

Lessie wanted to make a statement reference the stop. He stated he was asleep in the passenger seat and was woken up by Early, she told him to get behind the wheel in the drivers seat. Lessie stated he jumped in the driver seat and saw the lights behind him. Lessie stated he placed the vehicle in park and was contacted by the police. I asked him if the vehicle was in drive when he jumped in the driver seat and he stated, "Yes." I then asked him if he physically placed the vehicle in park while in the driver seat and he replied, "Yes." I asked him when the switch happened and he replied it was when they were stopped on the shoulder. It should be noted that the vehicle did not come to a complete stop until Sgt Van Mierlo was in front of the vehicle and he could easily see inside the front window. I later contacted Sgt Van Mierlo and he stated that Lessie was behind the wheel and he did not observe a switch of the driver. I requested a copy of his in car video and he was able to provide it. I seized the CD of his video as evidence. I properly marked it and placed it in the evidence locker.

In another post-arrest interview Lessie again claimed he was driving the car. He admitted that he was intoxicated.
