#### **DRUNKS AND THIEVES 2023 PART 5**

**80 MPH WHILE DRUNK ON A THURSDAY NIGHT-FRIDAY MORNING CLEARLY INCREASES CHANCES WITH YOU MEETING A COP** While in the City every night can be very busy for the police. In the wealthy suburbs it is a different story.

Liquor creates business and liquor issues such as DWI, car wrecks, family disturbances, bar fights most usually keeps the cops busy on Friday and Saturday nights. Police are busy two nights a week and often looking for things to do on the other five overnight shifts.

So on a Thursday night April 15, 2021shift into Friday morning Town and Country Officer Dustin York had plenty of time to deal with arrests.

On WB I-64 he spied a 2017 Chevrolet being driven by Joseph F. Meyer, 24, of Chesterfield at a high rate of speed. His moving radar clocked the car at 80mph in the 60 mph zone. He caught up and stopped the car on I-64 at Timberlake Parkway in Chesterfield.

Upon contacting Meyer it was clear he had been drinking. Meyer said he had no idea why he was being stopped and was not aware he had been speeding. York's observation of Meyer is in the police report:



Meyer failed sobriety tests. He had said he had a "few drinks, but nothing crazy." When pressed what a "few drinks were he replied "4 beers."

He was arrested and at the police station he agreed to take a breath test but refused to be interview.

The results of the BA test showed Meyer was indeed drunk. He tested at **0.137%**.

He was cited for DWI, Speeding and Fail to Provide Proof of Insurance. He had no priors.

**OUTCOME**: On 01/20/22 Meyer pled guilty to DWI in T&C Court. He was placed on a 2-year SIS (No Points, No Fine and No Permanent record). He also pled guilty to speeding and was fined \$116.

**DRUNK DRIVER REFUSED ALL TESTS, BUT HIS BREATH AND BALANCE GAVE HIM AWAY** It was Thursday morning April 14, 2022. Chesterfield Officer Cody Debisschop was on the "midnight shift." Cody was 4 months out of the police academy and being sworn in.




At 2am while on Chesterfield Parkway West he noticed a jeep in front of him serving. The Jeep's driver stopped at a red light on the wrong side of the center line.

Officer Debisschop pulled the jeep over after the driver originally refused to stop. Upon contacting the driver, Darin J. Everett, 57, he immediately noticed a strong odor of Booze on Everett's breath. The officer asked where Everett was coming from and he said, "A business diner." (I hope he wasn't expected to be at work at 8AM)

When asked how much he had to drink his reply as "I had some." When asked how much "some" was he replied "two beers." Officer Debisschop opened the driver's door and told Everett to exit. When he did he stumbled losing his balance. Officer Debisschop requested he do some field sobriety tests and Everett refused.

He was arrested. At the police station he refused to take an official breath test.





Everett had no prior alcohol arrests.

**OUTCOME** On 09/113/22 he pled guilty to DWI and was placed on a SIS (No-fine, No-points, No-permanent record) probation. The Improper Lanes Use charge was reduced to a \$191 parking ticket. The Fail to Yield to a police car resulted in a \$191 fine on a conviction of a moving violation.

## A COUPLE USE WASTE CAN PURCHASE TO HIDE MERCHANDIS THAT WAS NOT SCANNED.

On Saturday November 19, 2019 at 7:04pm a couple had left Warren County, Missouri and came to the Chesterfield Walmart Store where they were going to try the Trash Can scheme where they placed a trash can with lid in the shopping car and paid for it at a self- serve register, but forgetting to pay for the items they placed inside the trashcan.

The male was Charles John Ross, 25, of Warrenton MO.. Ross was on video taking part in the stealing.

The woman, Brittany Rae Garten, 35, of Wright City MO.

As Garten remained in the store, Ross walked outside where he was arrested for Stealing. He was taken to the Security Office out of the view of Garten. There he saw that the police were watching Garten on video and he began to scream that the Police were wasting the taxpayers money as he did not do anything, that Garten was the one stealing. Ross was also in possession of a felony drug.

Garten exited the store and was promptly arrested. She gave a full confession including Ross' involvement with the theft.

**OUTCOME** Garten received 10 days in jail while Ross got 90-days in jail before being sentenced to 7-years for a Robbery in St. Charles.

**SHOPPING WITH MOM AND STEALING**: On Sunday afternoon 08/28/22 Chesterfield Police were called to the Wal Mart store ref a shoplifter. By the time police arrived the suspect Kristine Durr, 36, was in the security office.

Her mother arrived and was upset saying how "her daughter doesn't steal." Durr's shopping bag was then opened and the following stolen property was found at the bottom of the bag:

Durr had no prior record and was issued a Stealing Summons by the police and a No Trespassing order for all Wal Mart stores. She was release from the store.

**Outcome** On 02/02/23 Durr pled guilty to a reduced charge of a Health Code Violation and was fine \$300.

SHOPLIFTER REPLACES HIS BROKEN WRIST WATCH STEALS A REPLACMENT AND THEN STEALS A CELL PHONE: On 01/03/19 three Chesterfield Police Officers responded to the Wall Mart store ref a theft in progress.

Store Security had Patrick Adam Gabbert, on video switching his broken written watch with a new one placing the broken one in the box. He then put the stolen watch on his wrist.

Next he was then seen taking a \$179 Galaxy Cell Phone from the box placing in it in his pocket.

Gabbert was arrested as he left the store. He claimed he was homeless and needed money but showed a Richmond Heights address.

A computer check showed outstanding theft warrants in Clayton, Wentzville, Brentwood and St. Louis.

**OUTCOME**: Despite being on video committing the crime, having four prior felony convictions, on 05/18/21 Gabbert appeared before the two most dangerous men in Chesterfield, Prosecutor Tim Engelmeyer and Judge Rick Brunk, both who will reduced any criminal charge to a non-criminal offense if you hire a lawyer. The allegedly "Homeless" Gabbert hired a St. Louis Lawyer and the theft charge was reduced to a Health Code Violation with a \$355 fine. (It was one of Brunk's last day on the bench being forced to retired due to age.

#### **UNLUCKY 13 TATTOO LEADS TO THEFT ARREST**

On April 21, 2021 Chesterfield Police Officer Trevor McBride responded to the Lowes Store in Chesterfield Valley for a delayed theft report. The theft was of \$500 worth of tools on Friday April 16, 2021 near closing time. Lowes provided security recording of the suspect. At the time Officer McBride did not have much to go on.

The images of the suspect were posted on the Chesterfield PD facebook page including him carrying the \$499 box of tools to a waiting pickup truck..

The next day Officer McBride was contacted by an officer with the St. Charles County Sexual Enf Unit. She said she recognized the suspect thanks to the tattoos on his legs and that he was Brian Gartland.



An arrest order was entered into the police computer system.

On May 24, 2021 Gartland was arrested by the St. Peters Police as a fugitive from Chesterfield.

Officer McBride picked him up and once in the police car he wanted to confess to the theft at the Chesterfield Home Depot. Officer McBride mentioned the was at Lowes and Gartland corrected himself.

This is from the police report:

I responded, "it is a stealing but from Lowes."

Gartland then explained "oh yeah, well I save you the trouble, I'm your guy." Gartland was going through severe withdrawals and did not speak further.

**CHESTERFIELD OUTCOME**: On 06/01/22 Gartland pled guilty to Stealing, two months before being sentenced to 10-years prison on felonies in St. Charles Co. He was fined \$400.

## SHOPLIFTER USED HER OWN CARDS AT SELF-CHECKOUT REGISTER WHILE NOT PAYING FOR \$165 WORTH OF ITMES, BUT PAYING \$5.76 FOR BANANAS

On March 27, 2022 Sarah Matava, 29, came to the Town and Country Schnucks store in Town and Country. She shopped (stealing) a number of items totaling \$159 and went to a self-checkout register and only paid for some bananas while stealing \$159 worth of other products.

Store security became suspicious and followed on video Matava through the store and watched her wheel out of the store a cart with the following items she never paid for:

Matava qualified as A STUPID thieve as she used her Schnucks Rewards Card and a debit card to purchase the bananas.

T&C Officer Eric Diaz was able to match Matava's imagine at Schnucks with her driver's license photo on file in the state computer system.

Matava was contacted by Officer Diaz and turned herself in on April 5.

She admitted to the theft and provided the following written statement:

"I, Sarah Matava, was deliberately not scanning or mispricing items at Town and Country Schnucks. I am so sorry, what I did was extremely wrong. I have done this at multiple locations and am currently talking with a psychiatrist."

**OUTCOME:** Despite 5 prior Stealing arrests all ending is No-Record, No-Fine SIS probations, Matava was represented by a lawyer, so she got the defense attorney special in Town and Country. She was given her sixth SIS probation for thefts within a year in West County cities.

**NOTHING LIKE A 12 NOON DRUNK DRIVER** On Saturday October 2, 2020 around 12:40pm Town and Country Officer Dustin York was on WB I-64 at Mason Road when he noticed a black BMW in front of him travelling at a high speed. His moving radar unit clocked the car at 96MPH in the 60 mph zone.

Officer York watched as the BMW changed lanes to the right and narrowly missed hitting a car.

York managed to pull the BMW over at Timmerlake Manor Parkway and contacted the driver, Brandy Menley, 43, of Alton Illinois. It quickly became clear that Menley had been drinking. He asked where she was going and Menley said to Chesterfield Mall to pick up her son This is from the police report.

She said her last drink was at 8am. That would later change after her arrest.

Menley failed field sobriety tests and a field breath test showed she was well over the legal limit at .185%.

Despite saying she lived in Alton, IL she had a Missouri Drivers' License,

She was arrested for DWI, Speeding and Fail to Signal Lane Change.

At the police station she agreed to take an official Breath Test. That showed her BAC level to be at .184%.

In a post-arrest interview Menley's story changed, Instead of quiting drinking at 8am, she said she started at 11am. This is from the police report of her interview:

**OUTCOME:** On 02/17/22 Menley pled guilty in T&C Court to DWI. She was fined \$466 and given a SES Probation in lieu of 30 days jail. The speeding charge resulted in another \$466 fine.

**EX-CON OUT OF PRISON FOR TWO WEEKS BEGINS PASSING FORGED CHECKS AT AREA BANKS**: On May 14, 2020 Michael Travis Mittrucker, 36, was released from prison. By May 27 he was committing a series of felonies in West County passing bad checks at First Bank branches on the account of Willow Landscaping.

Among his victims was the First Bank in the Lamp and Lantern Village in Town and Country where he chased a \$1,922 check. He was also successful in Des Peres, while the branch in Creve Coeur refused to accept the check.

He was arrested for attempting to pass a fraudulent check in Brentwood. On June 6 he had been released and Town and Country detectives went to and address in St. Louis County and arrested him for the Forgery.

At the T&C Police station he confessed but his story kept changing. He told Detective Katie Exline he was at St. Patrick's Center (halfway house) when a person he knew only as "Jimmy Smith" was paying him \$200 to go to area banks and cash \$1,900 checks. That would later change to how he was paid just \$100.


"Jimmy Smith" would later change to "two black guys" in a red Dodge Pickup truck was having him cash the checks. He said he did not know their names or have their phone number. He added that the pair took him to a Wal Mart in Illinois where they purchased him construction worker clothes to wear when cashing the checks.

After making verbal confessions he declined to make a written statement. He did state, "I'm fucked. I did it."

**OUTCOME**: Mittrucker had been sentenced eight times for 34 years in prison (some sentences overlapping) and numerous times to jail sentences under 1-year. The St. Charles County courts and Camden County court didn't put up with Mittrucker's crimes and sentenced him to prison. That would not happen in St. Louis County.

On 02/24/23 he pled guilty to the T&C case and the Des Peres felonies cases involving using fake checks to steal thousand of dollars from area banks and was placed 5-years probation.

# **WELCOME TO THE UNITED STATES. NO SPEEDING OR DRUNK DRIVING PLEASE.** On 07/05/22 Monday night-Tuesday morning at 12:14am Town and Country Officer Dustin York was west on I-64 before Ballas Road when he saw a car approaching him from the rear at a high rate of speed. His moving radar clocked the car at 87 MPH.


Officer York was able to stop the Mustang after it exited to NB I-270.

He contacted the driver who spoke only Spanish. He produced a Panama drivers' license that show the driver was Pablo Montoya, 41, from Panama City. The Mustang was a rental car out of Michigan. Montoya was staying with his daughter in Maryland Heights.

Officer York could immediately tell that Montoya had been drinking. Officer York could not find a Spanish speaking officer. The daughter translated. Out of the car Montoya failed field sobriety tests. A field breath test showed his BAC level at.



He was arrested. At the police station Montoya agreed to take an Official BAC test. That test showed his level had dropped but was still at an intoxicated level of .106% BAC.

**OUTCOME:** Less than two months after his arrest Montoya was in T&C municipal court on 09/01/22. He pled guilty to both DWI and Speeding. He was fined \$466 for the DWI and \$216 for speeding 87 in a 60 zone.

**UNLOCKED LOCKER RESULTS IN A STOLEN DODGE PICKUP TRUCK AT GOLD'S GYM:** On January 16, 2020 (2 months before COVID pandemic shut down most gyms) the victim parked his 2014 Blue Dodge Ram pickup truck in a handicapped spot in front of the Town and Country Gold's Gym on Manchester Rd at 7pm.

He went to the locker room and put his workout bag and laptop in Locker 114 and then locked it. He further placed his jacket with truck keys in locker 113 which he did not lock.

10 minutes later two subjects from North St. Louis County with 3-day temporary gym passes arrived. They did not make it to the gym floor, instead they started searching for unlocked lockers. They found the keys to the Dodge Pickup and from another locker a cellphone. As they were leaving they were confronted by the owner of the cellphone that they dropped on the floor.

They exited and took the pickup truck.

Officer Diaz asked for a copy of the Gold's Gym security video and was refused being told he needed a subpoena. So much for looking to help a customer and the police.

The pair then began driving around West County to steal from more Gold's locker rooms. They stole a Jeep in Chesterfield at a Gold's Gym and also in Ellisville. They were arrested in Hazelwood in a stolen vehicle.

Det. Jason Sapienaz interviewed the two suspects **Samuel H. Roberson**, 18 and **Randy Lewis Moore**, 18. On January 22 the pair were arrested at the Chesterfield Police Department. Chesterfield Detective Clayton McGee said that Moore had confessed to the Chesterfield theft and to stealing the Dodge Pickup truck in Town and Country and identified Robinson as his partner who drove him to locations of thefts which also included the Jeep and an Infiniti.

Moore also confessed to Det. Sapienaz after being taken to the Town & Country Police Station.

Robinson refused to make any statement. Soon he would never be making any statement of any kind.



**OUTCOME**: Moore was an amazing 18-year-old crime wave. He was arrested and found guilty of committing 12 Auto Thefts, 2 Burglary First Degrees and a Robbery. He is currently in prison serving numerous 7-year sentences and two 15-year sentences.

**DRUNK DRIVER CAN'T FIND A LANE TO DRIVE IN OR A TOILET TO PISS IN**. On Friday night into Saturday morning 12/28/19 at about 1:28a, Town and Country Police Cpl. Chris Moore was completing a traffic stop on WB I-64 and pulling back onto I-64 when Moore noticed a GMC pickup straddling between two lanes.

Munguia failed field sobriety tests and a field breath test showed a BAC level of.138. In the vehicle

Munguia was arrested for DWI and Improper Lane Use. A Town and Country officer gave the passenger (also intoxicated) to his Chesterfield residence.

Munguia, 39, a Nicaragua native and now a Little Rock, AR resident, agreed to take an official Breath Test at the Police Station. The test results showed a BAC level of .127%.

In an interview at the police station Munguia stated he did not think he was intoxicated. He said he had consumed six Corona Extra beers earlier in the evening.

Munguia asked to use a restroom. He was taken to a toilet in a holding cell. When he returned it was clear he had urinated in his pants. A check around the toilet in the cell showed that the floor covered in piss rather than in the toilet.

**OUTCOME**: On 09/20/22 Munguia found his way back to Town and Country. He pled guilty to DWI and was given a 2-year SIS (No-Fine, No-Points, No Permanent Record) probation term. He also was fined \$191 for Improper Lane Use.
