

# TWO FELONY WOMEN SHOPLIFTERS ARRESTED, AS ONE LEADS CHESTERFIELD OFFICERS ON A WILD CHASE

It was Thursday November 15, 2018 at 2:46pm when Chesterfield Police officers received a call of two women shoplifters at Dick's Sporting Goods in Chesterfield Valley with a large amount of items. (\$1,214.83 of loot)



The store manager saw the suspects get into a white Nissan and drive off. Chesterfield Officer Brown spotted the Nissan in the immediate area on THF Blvd and Chesterfield Commons Road occupied by two female that matched the description of the suspects. Officer Brown stopped the car that pulled into the parking lot of Lion's Choice.

The passenger, **Jasmine Bolden**, 25, fled the scene. As Officer Brown arrested the second suspect, driver **Elysia Mosley**, 28, Officer Emily Pacheco gave chase on foot of Bolden. It was not a short chase.

This is from the police report:

Officer Pacheco, DSN 330, located Bolden running across Chesterfield Airport Rd. She witnessed Bolden flee through the parking lot of IHOP located at 4 McBride and Son Center. Officer Pacheco began pursuing Bolden on foot. Bolden then jumped down an approximate 10 foot embankment into thick trees and bushes. She then crossed a drainage ditch and ran up the steep exit ramp of Interstate-64 and Boones Bolden fled across the Eastbound lanes of Interstate-64, jumped over the large concrete median, then crossed the Westbound lanes of Interstate-64, just West of Boones Crossing. Officer Bromwich, Officer Beckman, DSN 141, and Officer Wood, DSN 312 responded to the North side of Interstate-64 in an attempt to intercept Bolden. Officer Bromwich located Bolden on the North side of Interstate-64, and upon giving the command for her to stop, Bolden fled South, into the Westbound lanes of Interstate-64. Officer Bromwich pursued Bolden on foot, and caught up to her in the number 3 lane (fast lane) of Interstate-64. Upon Officer Bromwich making contact with Bolden, he reached out with his left hand to grab hold of her shoulder, but also inadvertently grabbed her long braided hair covering her shoulder. Bolden then fell to the ground in the fast lane. Officer Bromwich drug Bolden to the inside shoulder of Interstate-64 in an attempt to remove her from oncoming traffic and bring her to safety. Bolden still refused to comply to Officer Bromwich's orders. Officer Beckman and Officer Wood arrived and assisted in placing Bolden into handcuffs behind her back, double locked, and checked for proper fit.

Inside the Nissan a search revealed lots of stolen items from area stores.

At the police station both Mosley and Bolden were read their Miranda Rights and both confessed.


Mosley stated that she picked up Bolden at Bolden's home on Arco St in St. Louis, at which time Bolden place items in her trunk. She stated that Bolden is a "Booster" and sells stolen property on the internet.

Mosley said they went to Dick's Sporting Goods where she just stole the "Adidas stuff" and Bolden stole the rest.

When Bolden was interviewed she admitted doing the thefts at Dick's Sporting Goods, but claimed she did not know about the other stolen items, claiming Mosley had stolen it.

Bolden was held pending warrant application charged with Felony Stealing and Felony Resisting Arrest. This was not Bolden's first encounter with Chesterfield officers. In 2017 she arrested for Felony Stealing, in 2015 she was arrested for Robbery. Her favorite place to steal now is West County Center in Des Peres. Mosley was booked for Felony Stealing and released pending warrant application.

**OUTCOME**: Jasmine Bolden pled guilty to the 2019 Chesterfield charges on 10/24/23 and was sentenced to 2-years in prison. She served less than the two years and found a new place to steal at the West County Mall in Des Peres, where judge Charles Billings refuses to spend some city money and actually jail her for the 7 arrests. He accepted her guilty pleas and issues no fines or jail.

Mosley pled guilty to the Chesterfield Charges on 10/31/19 and was sentence to 3-years in prison, but was allowed to serve just 120-days shock prison time.

SUSPECTS USE 3-DAY COMP PASS TO GOLD'S GYM TO STEAL CARS IN ST. LOUIS COUNTY. When I received the report it only had one suspect whose name and statements was not redacted-blacked out. We could only guess the other suspects were under 18-years-old or they had SIS probation terms that had expired.

However, the main suspect, Randy Lewis Moore, 18, of Hazelwood was listed in the police report. It was not Moore's first time stealing cars.

On January 16, 2020 at 8:38pm the Chesterfield Police were dispatched to the Gold's Gym on Clayton Road. The victim stated he arrived 7:30pm to swim and left his car keys in his coat pocket. When he returned to the locker he noticed his clothes had been moved inside the locker. He went outside and discovered his car keys were gone as was his 2012 Jeep Grand Cherokee from the parking lot. Inside the Jeep was his wallet and credit cards.

The Jeep and a stolen Infinity had been observed on the lot at a Quick Trip in Ellisville. A review later of surveillance video showed that there was also a stolen Dodge Ram.

The next day, 01/17/20 the Jeep was recovered by Hazelwood Police on Dunn Road with Randy Moore and a juvenile in the car. Both were arrested.

On January 18<sup>th</sup> officers were contacted by the owner of the stolen Jeep telling them they missed a cellphone that he found in the Jeep.

Later, on the morning of January 18 Moore was interviewed. After waiving his Miranda Rights, he admitted stealing the Jeep. He stated a friend (juvenile) went to work stealing on January 16.

Moore stated they accidentally stole the founded cellphone while in the locker room of the Gold's Gym in Florissant.

Later they and two others went to the Gold's Gym in Town and Country. While working as a lookout his friend went into the locker and stole a vehicle key fob.

Outside on the parking lot they pushed the key fob and located the Dodge Ram truck, which they stole.

The two then drove to Gold's Gym in Chesterfield, found a a fob in the locker room and stole the Jeep Grand Cherokee. Next ,they went to the Ellisville Gold's Gym and found another key fob in the locker room. They were stopped by two employees wanting to know where they were going. They said they forgot their "water bottles" leaving them in their car. They then found a silver Infiniti on the lot that they stole.

Most of Gold's Gyms closed with the outbreak of COVID in 2021.

DRIVER PASSED OUT ON DRUGS.. CONCERNED PASSERBY DROVE THE SUBJECT AND CAR TO THE PARKING LOT OF THE CHESTERFIELD MALL WHERE POLICE MADE THE ARREST: It was at 8:37 in the morning on Monday June 22, 2020 when David Morrissey, 24, from Ballwin was passed out drunk behind the wheel of his 2002 GMC Envoy on the Olive exit from I-64. A good Samaritan stopped, got the keys from Morrissey and drove the GMC and Morrissey to the parking lot of the then Chesterfield Mall and called police.

A number of Chesterfield Officers responded. Morrissey was given sobriety tests which he failed, but there was no evidence of him consuming alcohol. A search of the GMC discovered the drugs, marijuana and heroin residue on spoons along with needles. Morrissey had puncture marks on blood vessels on his hands.

Also found in the vehicle was a .410 shotgun and ammo.

A pat down of Morrissey revealed marijuana and marijuana pipe on him. He asked Officer Saffa if she found any syringes in the car. She said she had and Morrissey then claimed he was a former heroin addict and still will stick himself with syringes.

The passerby said that Morrissey was driving erratically on I-64, exited at Olive and apparently fell asleep or passed out at the stoplight. Morrissey told him that he was just tired. He then offered to drive the car to the Chesterfield Mall lot.

Based on the evidence, Saffa arrested Morrissey for DWI-D, Possession of Marijuana (still illegal), and Possession of Drug Paraphernalia.

On the scene Morrissey refused to go to a hospital for a blood draw. At the police station he refused to be interviewed.

The County Prosecutor's Office refused to issue charges so all charges where filed in Chesterfield Municipal Court.

**OUTCOME**: On 08/24/21 the DWID was reduced to Careless & Impudent Driving with a \$191 fine. The Drug charge was reduced to Ordinance Violation with a \$300 fine, the Unregistered Vehicle was a \$50 fine and the Improper Lane Use Charge was a \$200 fine.




### CRIMINALS FROM ST. LOUIS SPEND AN AUGUST SUNDAY STEALING IN

**CHESTERFIELD**: A male and a female were in the Ralph Loren Polo store in the Chesterfield District Retail and entertainment center on North Hwy 40 Drive stealing a large amount of merchandise. It was on Sunday August 8, 2021. The police were called and arriving officers saw the suspect carrying large amounts of clothes while running to a car in the parking lot.



The suspects got into the backseat as police cars approached the getaway car's driver tried to flee. The Chesterfield Police are banned from long distance pursuits of suspect vehicles. The suspects may have gotten away but the driver crashed the red Chevrolet Impala against a curb turning out of the parking lot onto Boone's Crossing and then to North Outer Forty Road. The crash blew out a tire and damaged the wheel making the car impossible to drive.



The male suspect was identified as Corney A. Moorehead, 31.. The female was identified as Janielle Janay Phillips, 31. Moorehead refused to exit the car and then refused to follow any orders.

The loot stolen from the Polo store totaled \$2,879.98.

Also found in the car were stolen items taken that day from Chesterfield stores, Walmart, Target and Nordstrom.

Besides the stolen property officers seized two loaded Glock handguns from the center console and under the drivers' seat.

The theft suspects and the driver, Darris Moorehead, were arrested. All three had outstanding warrants from other jurisdictions.

No one gave a statement after being advised of their Miranda Rights.



**OUTCOME:** No felony charge was filed against Corney Moorehead, who pled guilty to Resisting Arrest in Chesterfield Court on 10/18/22 and was fine \$350. There are no longer any open public records concerning Darris Moorehead's charges. He was shot and killed on September 11, 2022 during a drug deal according to St. Louis Police.

Phillps' case was not filed as a felony and was held in Chesterfield City Court. On 11/17/23 she was sentenced to 10 days jail for Receiving Stolen Property and Resisting Arrest.

# SUSPECT CAUGHT STEALING AT WALMART. SHE WAS TAKEN TO THE STORE SECURITY OFFICE WITH HER CART WITH STOLEN ITEMS, BUT SUDDENLY FLED PUSHING THE CART WITH HER.

On Saturday January 29, 2022 around 7pm Walmart security was watching Bianca N. Morganfield, 34, who had a shopping cart that was full of food items and other merchandise. Morganfield went to the grocery scanners and failed to scan turkey legs. Another security agent pointed this out, she scanned them and he left.

She was apparently worried about being watch and left packages of lobster legs. She then placed a box of frozen chicken wings and a Slow Cooker that she did not pay for on the bottom of the cart and put a large box of toilet paper she also did not pay for on top of them.

Store security stopped her and took her to the security office and called the police. She then bolted out of the office pushing the cart and leaving the store only to be stopped by Police Officer Ashley Saffa.

It wasn't exactly a big haul. The total amount of stolen goods was \$49.80.

**OUTCOME**: On 12/20/22 Morganfield pled guilty to a reduced charge of Health Code Vio and was fined \$366.

**STEALING TRADING CARDS ALSO RESULTS IN A DRUG ARREST**: On August 2, 20222 Eric J. Monton, 49,(now 53) had caught the eye of Walmart Security. They watched as he took a large amount of trading cards, that he removed from the packages. He then got two boxes of envelopes, empty out the boxes then hiding the trading cards in the boxes.

He went to the checkout and paid for the envelope boxes that no longer held any envelopes. By now security had called the Chesterfield Police and Officers Ovca and Dammrich responded.

Monton walked outside and was confronted by Officer Ovca. The stolen trading cards valued at \$220.80 were inside the envelope boxes. A pat down on Monton also revealed a baggie of marijuana. If you are going somewhere to steal you really should leave the drugs and weed at home.

Monton caught a break and rather than being arrested and booked he was issued citations.



Moreno-Loredo did not speak or understand much English. He told officer he only had one beer at a friend's house.

He could not understand the instructions to do balance and walking sobriety tests. He did agree to take a Field Breath Test that show his Alcohol level to be .242 or three times over the legal limit. Indicating his "one beer" was huge.



He was arrested. At the police station he was given a Miranda Warning form in Spanish, along with the a printed form on the Missouri Law on taking breath tests, also in Spanish. He was able to answer a few question in English. He continued the "1-beer" answer to how much he had to drink and did not consider himself intoxicated, despite being passed out in the middle of the road.

He agreed to take an "Official Breath Test.' The test showed his BAC level was dropping at .177%, but he was still very drunk

**OUTCOME**: On May 8, 2024 Moreno-Loredo pled guilty to DWI in Chesterfield Court and place on s 2-year SIS (no points, no permanent record and no conviction) probation. The obstructing Traffic charge was reduced to a \$191 parking violation. The Open Container charged was reduced to a Non-Traffic Health Code violation with a \$316 fine. Moreno-Loredo left the courtroom with NO POINTS on his driving record. Another fine example of Justice in Chesterfield and the City Court looking out for the safety of motorists and residents.

### A WOMAN FROM VALLEY PARK SPENDS A SUNDAY STEALING AT NIKE

I read Morgan her Miranda rights. Morgan indicated she understood her rights. Morgan stated she went to Nike to return some items. Morgan stated the line was too long to return the items so she stole a few shirts and left. Morgan expressed the idea multiple times that it was not a big deal because she only took a few shirts. Morgan expressed multiple times that she should not get arrested for only stealing a few shirts.

The police report showed that more than "a few shirts."

# WOMEN PUT BAG FULL OF STOLEN CLOTHES IN BUSHES AS SHE FLED FROM OFFICERS

Chesterfield Police Officers Stephan Gorczyca and Alida Hindman were on foot patrol at the Premium Outlet Mall on July 14, 2024 when a mall security officer came up to them and said a Hispanic female had been in one store attempting to steal items but was unsuccessful, but went to another store. The women then walked out of a nearby Hollister Clothing Store carrying a large bag.

The officers said they needed to speak to her causing her to quickly walk away. Officer Gorczyan got into his nearby patrol car and cut her off.

The 25-year-old woman identified herself as Lydia Morales Gonzalez. She said she did not speak English but had a translator device with. She no longer had the large bag of clothes.

Through the device, she said "I'm sorry I can pay for the items. Meanwhile Officer Hindman found the bag of \$655 worth of stolen clothes from Hollister hidden in a bush. The bag was lined with foil to silence theft detectors on the clothes.

For some reason Morales Gonzalez was not arrested, fingerprinted and photographed at the police station. Morales Gonzalez claimed to be homeless. She was issued citations for Stealing, and Possession of a Theft Device (the bag with foil).

We could not find any other arrests or citations in Morales Gonzalez's name.

**OUTCOME**: On 08/13/24 Morales Gonzalez appeared in Chesterfield City Court. She pled guilty to Stealing and was fined \$300. The Possession of Theft Device was reduced to a Misc. Ord Violation with a \$150 fine. The fines were paid in December of 2024.
