

## DRUNKS AND THIEVES 2023 PART 9

### **DRUNK CAR SALESMAN DRIVING AN ALFA ROMEO ON I-270 WEAVING BADLY CLAIMING HE WAS GIVEN DRINKS AT WORK BECAUSE HE HAD A "GOOD MONTH."**

It was just after midnight Tuesday night into Wednesday morning (12:06am) on December 1, 2021. Town and Country Police Cpl. Steve Doll was north on I-270 and noticed a silver Alfa Romeo in front of him weaving across three lanes.

Cpl. Doll stopped the car on I-270 at Clayton Road. When he contacted the driver Najja Polack, 45, he smelled a heavy odor of BOB (Booze on Breath). Polack said he was at work and going home in the 13700 block of Clayton Road in Town and Country. It should be noted that there are no exits to Clayton Road on I-270.

He refused to tell Cpl. Doll where he worked or give him a business card. (He was a car salesman at Jim Butler Alfa Romeo on Manchester Road in Maplewood, MO. Turning from Manchester onto I-270 would not take him home on Clayton Road.)

Once an assisting officer arrived, Cpl. Doll had Polack exit the car to do field sobriety tests. While exiting the car Polack said, "I am a moron." Polack was failing the tests which were stopped after he fell down.

At first Polack said he had a couple of drinks. He later changed that to "I'm not going to lie to you I probably had four. I had a good month."

After falling during the sobriety tests, he was arrested. The Alfa Romeo was towed.

At the police station Polack agreed to take a breath test. The results showed he was more than double the legal limit at .188% BAC.

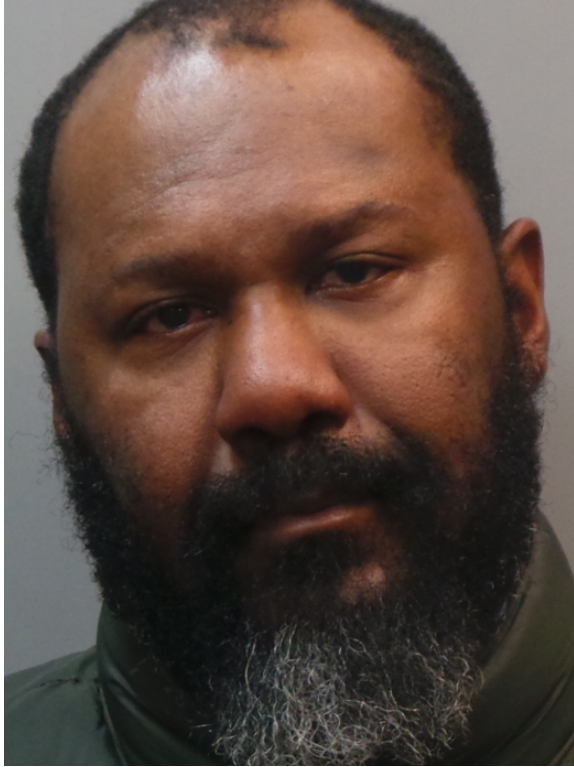

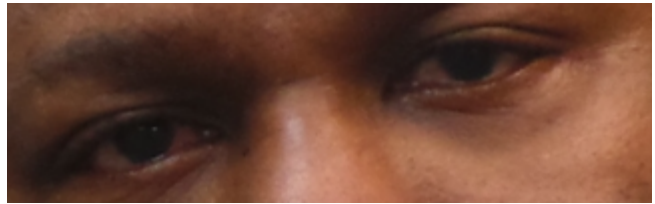

**OUTCOME:** On 07/06/22 Polack appeared in Town and Country Municipal Court and pled guilty to DWI. He was placed on a 2-year SIS (No-points, No-Fine, No Permanent record) probation term. He also pled guilty to Lane Weaving and was fined \$191 with points.

**VERY DRUNK DRIVER DOING 100 MPH ON A WHEEL RIM AND STOPPED BY AN OFF-DUTY HAZELWOOD OFFICER ON I-270.**

It was three days before the night of drunk drivers, December 28, 2021 at 11:22 pm Town and Country Police Officer Eric Diaz responded to a report of an off-duty police officer following a drunk driver on SB 1-270. Officer Diaz was on I-64 and Ballas Road.

He quickly found the drunk driver, Melissa Piper, 31, stopped in the right lane of I-270 in a 2020 Mazda SUV. Behind her was Hazelwood Officer Kyle Hunt who had a single rotating red light on his car.

Officer Hunt stated that at I-270 and Pave Ave Piper almost hit his car. He followed her and saw she was doing 100 MPH in fast lane and then swerving across all lanes as the left front tire was gone and she was driving on the rim.

She stopped for Officer Hunt's red light in a lane of traffic.

Officer Diaz contacted Piper and found her to be very drunk. This is from his report:

Officer Diaz asked Piper "What's going on?" She replied that she was trying to get her husband to pick her up. She said she was coming from the Corner Bar in O'Fallon, Missouri and was going home (South County). She admitted that she knew she did not have a left front tire, but did not know how that happened. When asked why she stopped her car in a lane on I-270 she replied, "I thought I should stop."

She agreed to take field sobriety tests. She failed the one given but Officer Diaz discontinued the tests due to Piper's bad balance for fear she would fall.

She failed verbal tests involving counting and reciting the alphabet. She refused to take a field Breath test. She was then arrested for DWI and transported to the Town and Country Police Station.

She also refused to take an "Official Breath Test" and to be interviewed.

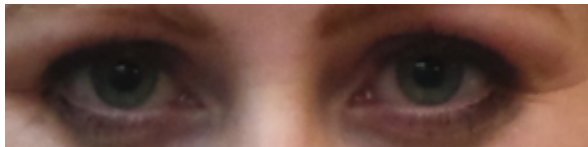

**OUTCOME:** On 01/17/23 Piper pled guilty to DWI in Town and Country Municipal Court. Despite being very drunk, refusing to take a breath test, speeding and driving on I-270 on three tires, Piper was placed on a SIS (No-points, No-Fine, No permanent record) probation. She had hired defense attorney Travis Noble who specializes in DWI cases and has most municipal judges and prosecutors are scared senseless of him.

**WITNESS CALLS 9-1-1 AFTER DRUNK DRIVER HITS MEDIAN ON BALLAS ROAD.**

At 2:05 am Saturday night into Sunday morning September 5, 2021 a motorist witnessed the driver of a Honda Fit going north on Ballas Road past I-64 and strike a center road median. The witness reported the driver than made a U-Turn, went south and turned into Missouri Baptist Hospital.

Town and Country Police Sgt. Chris Moore was close by and responded. He found the Honda and the driver, Nicole Pollard, who was standing outside of the running auto. Sgt. Moore said hello and asked "what's happening?"

Pollard's response was a bit confusing. "My tire thing...and I'm running over it."

Sgt. Moore pointed out the car had old damage and some brand new damage. She denied there was new damage. Pollard complained that there was something dragging under her tire.

Pollard's statements then got more bizarre. Sgt. Moore asked her where she was going and her reply was "Home." He then asked where she was coming from and she again

said "Home." Sgt. Moore pointed out that if that was the case they wouldn't be standing in the parking lot. She then stated, "I went to Jack N uhhh...uhh. I mean I was going to...long pause." Sgt. Moore asked if she meant White Castle and she nodded yes.

Cpl. Greg Messmer pulled up to assist and Pollard said "You guys are freaking me out and then began to cry.

She agreed to take field sobriety tests. She passed the counting and ABCs portion of the test but failed the walking and balance tests. When Sgt. Moore asked her to do the "walk and turn" test she stated "Are you serious, you already know I have been drinking." She then refused to do any more tests including a Field Breath Test.

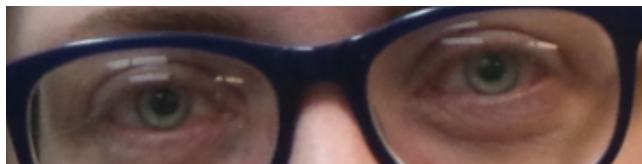

**OUTCOME:** On June 2, 2022 Pollard pled guilty to DWI and was placed on a 2-year SES Probation in lieu of 30-days in jail. She got the DWI points on her driving record.

**DRINKING ALL NIGHT AT BILLY G'S IN KIRKWOOD, CHESTERFIELD WOMAN DRUNK DRIVER ARRESTED IN TOWN AND COUNTRY ENDS UP WITH NO POINTS.**

On Saturday night into Sunday morning 06/14/20 at 1am Town and Country Police Sgt. Freddie Yaakub was west on I-64 and noticed that the car in front of him (Toyota Camry) was clearly speeding. His forward moving radar showed the Camry was doing 85MPH in the 60 MPH zone. The driver of the Toyota, Karlyn Poole, 31, of Chesterfield then exited onto SB Hwy 141 and began lane weaving and speeding. Sgt. Yaakub clocked her doing 65 in a 50 mph zone on Hwy 141.

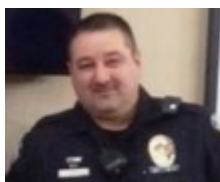
Sgt. Yaakub stopped her on Woods Mill at Clayton Road. He asked why she was speeding and where she was going. She said she was going home as her mother texted her saying she was worried about her. Poole said she was coming from Billy G's Restaurant in downtown Kirkwood on Argonne across from the train station where she said she had dinner. Sgt. Yaakub thought she possibly had more than dinner since it was 1am.

She appeared to Sgt. Yaakub to be intoxicated. This is from his report:

Poole agreed to do field sobriety tests. She failed the balance and walking tests. She agreed to take a field breath test that showed her BAC level to be .131.%.

Despite being clearly drunk she denied being intoxicated and claimed she only had 1 beer.

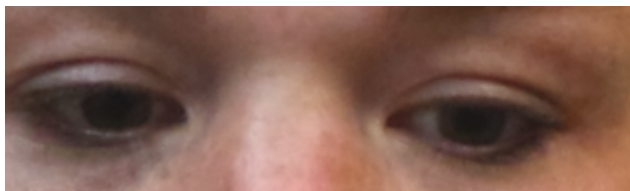
She was arrested for DWI and Speeding.

This was not Poole's first time at the Drunk Driving rodeo. On 09/02/13 she was arrested for DWI in St. Louis County and refused to take a Breath Test.

**OUTCOME:** On 09/21/22 the charges were transferred by Poole's attorney to the County Associate Circuit Court. There she pled guilty to DWI and was placed on a SIS (No-Points, No-Fine, No-permanent record) probation term. Her speeding charge was reduced to a \$191 Parking Violation. Despite being transfer to the Circuit Court Town and Country Prosecutor Keith Cheung handled the case including reducing charges.

A 2-time drunk driver left the court room with no points on her driving record. Another excellent example of Cheung putting defense attorneys making money over the public's safety.

### **DRUNK DRIVER CRASHED IN CENTER LANE ON I-64, BUT THE CAR AND DRIVER STRUCK WERE NO LONGER AT THE SCENE.**

On Monday April 19, 2021 at 9:26PM Town and Country Police Officer Dustin York was dispatched to a crash blocking one lane of traffic on EB I-64 at I-270. On his arrival a Missouri Department of Transportation (MoDOT) truck was pushing the Dodge Dart on the shoulder.

Officer York contacted the driver, Jon Rodney Pounds who stated that a box looking car stopped in front of him causing the crash, possibly a Kia, but Pounds could provide no other information including the color of the car.

Officer York was told there had been a female in the car, but she was no longer on the scene. He saw a woman on foot on the South Forty Outer Road when he was responding to the call, but officers could not find her.

Officer York could tell that Pounds was drunk. This is from his report:

Pounds at first denied having anything to drink. He later changed that to "a little bit." He could not produce a drivers' license and admitted that he did not have any car insurance. He agreed to take field sobriety tests, which he failed. He agreed to take a Field Breath Test that showed his BAC level at .141%. Pounds was then arrested for DWI, No License, following too Close and No Insurance.

Besides the smell of booze on Pounds' breath, Officer York also smelled burnt marijuana. A check of the car before it was towed revealed a plastic baggie of marijuana on the floor by the driver's seat and a marijuana grinder in the backseat area.

**OUTCOME:** On 01/20/22 Pounds appeared in Town & Country Court. He pled guilty to DWI and was given a 2-year SIS (No-fine, No-points, No-permanent record) probation term. The Following Too Closely was reduced to a Parking Violation with a \$191 fine, the Possession of Marijuana charge was reduced to Littering with a \$350 fine and the No Auto Insurance was also reduced to Littering with a \$166 fine. Pounds, who was drunk and high, crashed his car on I-64 and had no Auto Insurance left the courtroom with NO POINTS on this driving record.

#### **18-YEAR-OLD DOING 140 MPH AT NOON ON I-64 WHILE HIGH ON WEED**

**CAUSES 4-CAR CRASH:** It was just after noon on Saturday January 26, 2023 when a St. Louis County Police Officer saw a 2012 Infiniti occupied by several people doing a 140 MPH on EB I-64 in Chesterfield in the Chesterfield Valley area. He did not give chase, but by radio notified Chesterfield Officers of the car.

The Chesterfield officers did not intercept the car, because it crashed (4-car crash) at I-64 and Chesterfield Parkway. The driver and three passengers fled the car running toward a trailer park alongside the highway. It was muddy and all four were found with some missing shoes and their pants caked in mud.

Officers found the interior of the car reeked of the smell of burnt marijuana as did the four 18-year-old males. Officers found lots of marijuana in the car and cigars. It was clear they had been hollowing out the cigars, replacing the tobacco with pot and then smoking "blunts."

Three of the persons identified Daymon Moore was the driver. One said Moore had picked him up "to smoke weed and cruise." Officer Todd Lantz handled the DWI-D reports. Moore that a cut on his head from the crash. Officer Lantz reported that Moore smelled of marijuana talking to him. Officer Lantz rode in the ambulance as Moore was transported to Mercy Hospital. He described Moore's overall condition as:

At the hospital he read Moore the Implied Consent for breath or blood tests and asked to submit to a blood test..

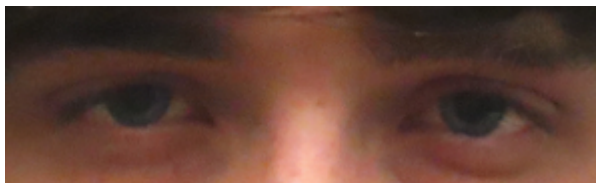
"I'm not doing anything without my fucking attorney and my mom," replied Moore.



Officer Lantz also advised him of his rights per the Miranda Ruling and the 18-year-old Moore refused to answer any questions. He was given an opportunity to call a lawyer and did nothing and then refused to submit to a blood draw.

At the police station Moore was issued citations for DWI-D With Injuries, Leaving the Scene of an Accident with Injuries, Unregistered Vehicle, No Auto Insurance. The drug charges will be forwarded to the County Prosecutors' Office for consideration.

**OUTCOME:** This was not the case of an 18- year youngster making a mistake. On June 6, 2032 Moore had a Felony Assault, Burglary & Stealing and two serious speeding charges pending.

However, all this meant nothing to the Court in Chesterfield as City Prosecutor Tim Englemeyer played a game of Let's Make a Deal and collect some money. The DWI-D

charge was reduced to Careless and Impudent Driving and Moore was placed on a 2-year SIS (no points, no-fine, no-permanent record) Probation. The Careless Driving citation that caused the 4-car collision resulting in a Guilty Plea resulting in 2-points on his record and a \$191 fine. The Leaving the Scene of an Accident charge was reduced to a Parking Violation with a \$191 fine. There was a \$43 fine for the Unregistered Vehicle citation.

The County prosecutor sent the marijuana possession charge back to city court. Moore was fined \$366 fine. Two of the three passengers were charged with Possession of Marijuana. One case was dropped and the other was reduced to a Health Code Violation.

### **COUPLE WORKING BANQUET AT THE DOUBLE TREE HOTEL STEAL GUEST'S PURSE**

Cortez V. Moore of St. Louis and Tatyana Harbert from North St. Louis County were working the tables at a convention banquet at the Double Tree Hotel on February 29, 2020. Both came to their job in Harbert's 2008 Chrysler.

The victim, a guest at the banquet, was seated at a table being serviced by Moore and Harbert. She had placed her purse under her chair.



When getting ready to leave the victim discovered her purse, with her cellphone, a credit card and cash was missing. She used her husband's cellphone and began pinging her phone, which showed that it was still in the immediate area outside of the hotel.

Officer Kyle Tyndell contacted hotel management and learned that Moore and Harbert were working the area where the victim and her husband were seated.

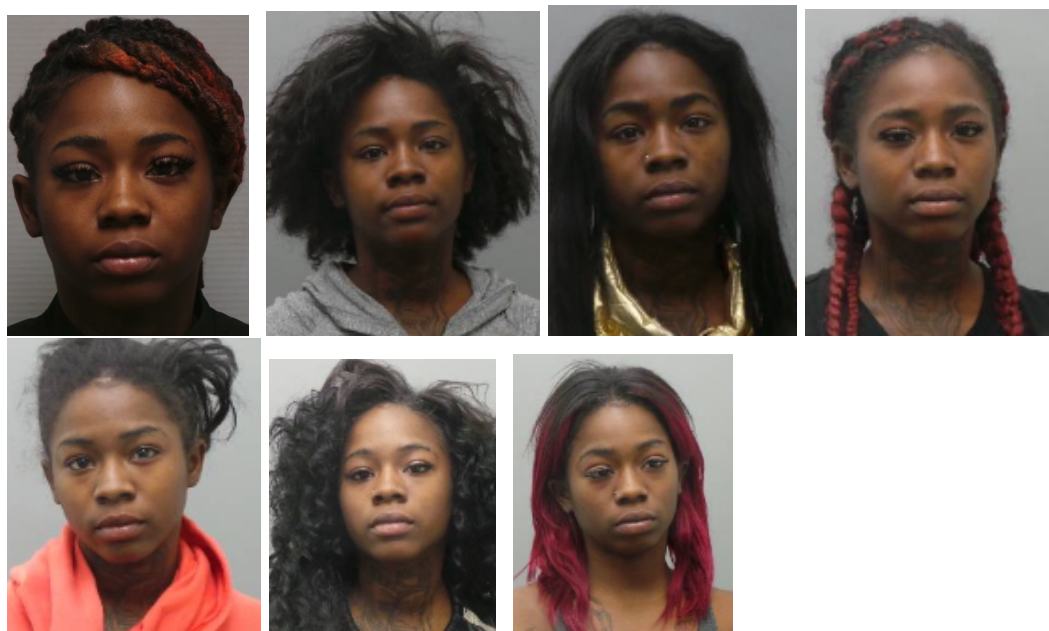
Meanwhile other Chesterfield officers found Moore and Harbert on the parking lot in a Chrysler with expired Wisconsin Temp tags. On the rear floorboard was the purse. Also in the rear passenger compartment was the phone being pinged.

Both Harbert and Moore were arrested for Stealing. Harbert was also arrested for Possession of Marijuana found in the car.

At the police station in an interview Moore said he had no idea how the stolen purse and phone ended up in the car.

While Harbert was being advised of her right per Miranda she became more and more verbally upset. She refused to answer any questions.

Officer Bromwich's attention was suddenly drawn to Lawn and Garden Department where an alarm was sounding and a man was running out pushing a shopping cart.



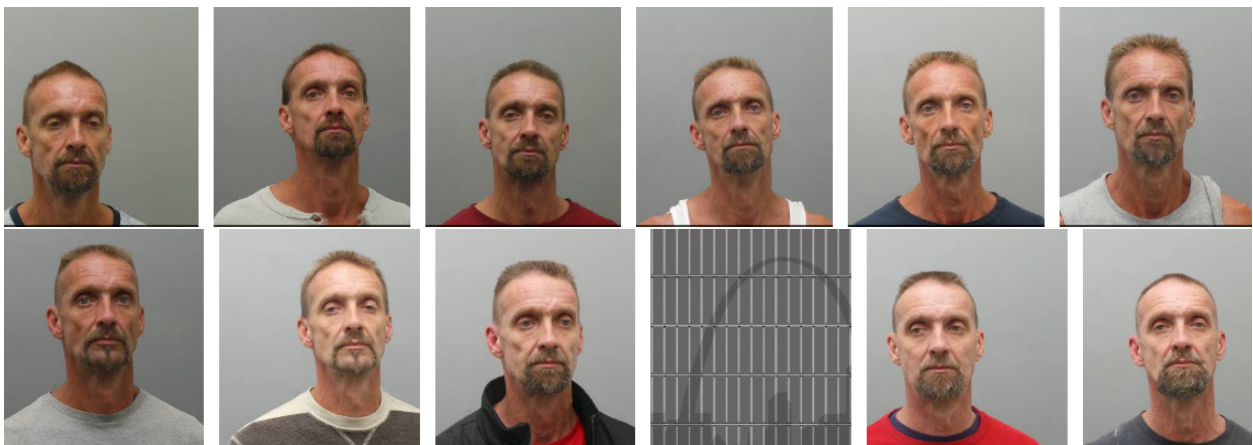

The truck was being driven by Curtis Harger, 40, of Overland.

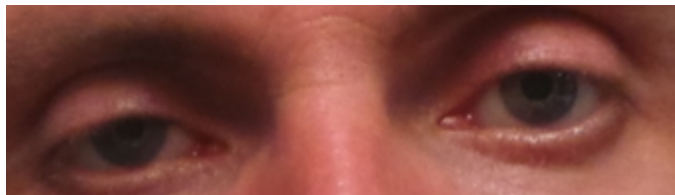
