DRUNK 26-YR-OLD TEACHER ARRESTED FOR SPEEDING AND WEAVING INTO THE ONCOMING LANE

On Thursday October 6, 2022 at about 9:09pm Town and Country Police Officer Alexander Gowen was on the side of Conway Road east of Mason Road. At that time Officer Gowen clocked a red Chevrolet Malibu approaching him from the east clearly speeding. The rear radar in his patrol car clocked the car at 47mph in the 35 zone.

West of Mason Road the driver weaved to the right on the shoulder and then to the left with half the car being in the oncoming lane.

Officer Gowen got the driver to pull over, but the car was now blocking the WB lane of Conway Road.

He contacted the driver, **Christina Elizabeth Goetz**, 26, of Maryland Heights. He immediately could tell she had been drinking. He asked for her drivers' license and insurance card. She handed him the drivers' license and a Bank ATM card. She said the reason she weaved into the oncoming lane was because she was lost and looking at her cellphone. She was never able to produce the insurance information. This is from the police report:

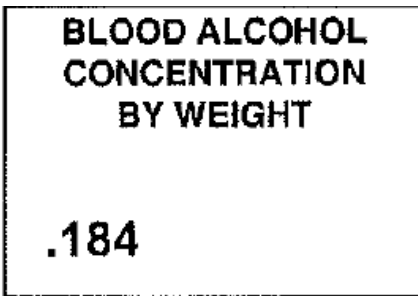
After Goetz failed six field sobriety tests, she agreed to take a field breath test. The showed her BAC level to be .188%.

Goetz stated that she had been at a restaurant with friends and had ONE martini. At first she said she did not know the name of the restaurant/bar but sometime later it turned out to be Duffy's on Clayton Road at Woods Mill Rd.



Goetz was arrested and taken to the Town and Country Police Station. Goetz agreed to take an official breath test, but the BA and Town and Country was down, so Officer Gowen drove her to the Creve Coeur Police station where she took the BA test.

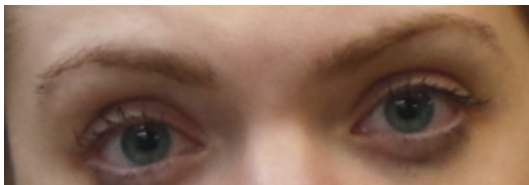
At 10:39pm (1-hr and 30-minutes after being stopped the BAC level was about the same. It was now .184%.



Back at the Town & Country Police Station Goetz during booking said she was a teacher at a local Christian School. In an interview she said she had a beer at her house. The amount of drinks changed from 1-martini to 2 or 3 dry martinis at Duffy's. She also stated that she considered herself intoxicated. Rather than calling someone to pick her, she decided to sleep and sober up in a jail cell.

OUTCOME: On March 8, 2024 Goetz pled guilty to DWI and was placed on a 2-year probation requiring she attend a Substance Abuse Program and a Victim's Impact Panel. The Speeding charge was reduced to a \$66 parking violation. She pled guilty to the Improper Lane Use charge and was fined \$116 and got 2-points on he drivers' license.

CPL. EXLINE FOLLOWS A WEAVING VEHICLE ON I-64 ONLY TO FIND A VERY DRUNK SPANISH SPEAKING MEXICAN NATIONAL BEHIND THE WHEEL. It was on August 10, 2024 at 1:47am. Town & Country PD officer Katie Exline had been promoted and was no longer in the Detective Bureau, she was now a supervisor and found herself on the midnight shift.

While driving east on I-64 after Mason Road she observed a blue Ford Fusion in front of her weaving from lane to lane and on to the shoulder. She activated her police car's flashing lights and siren. The driver continued on I-64 going from 62 mph to 37 mph before pulling over at the Spoeede Road exit..

When she reached the car the interior reeked of the smell of alcohol on the driver's and passenger's breath. She asked the driver for his drivers' license and he produced a Mexican Consulate Card identifying him as Eduardo Gomez Ortega, 33. Gomez Ortega did not speak English. One of the passengers was an American who was drunk, but volunteered to briefly translate.

Gomez-Ortega denied having anything to drink. Cpl. Exline knew otherwise. This is from the police report.

Frontenac Officer Baez who spoke Spanish arrived and took over translating duties.

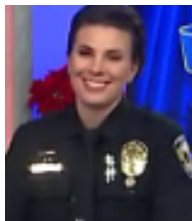
Gomez-Ortega failed all the field sobriety test and tested .21% on a field breath test.

He was arrested and taken to the Town and Country Police Station. The Ford was towed as the two passengers were both drunk.

At the police station Gomez-Ortega agreed to take an Official Breath Test but could not provide an adequate breath sample to be tested. Officer Baez continued to be the translator.

In an interview conducted by Officer Baez, Gomez-Ortega stated he had three beers and tequila shots (which he later changed to 1 shot) at the Factory in Chesterfield. He said his last drink was right before he left to drive home to the Tower Grove Park area in St. Louis. Gomez-Ortega stated that he considered himself intoxicated.

Here is something different that likely would not happen now. As Gomez-Ortega did not have a Green Card and appeared to be in the U.S. illegally, Cpl Exline called ICE and was told they only dealt with foreigners being charged with felonies. Of course that was in 2024 and not 2025.

Gomez-Ortega was charged with DWI, Fail to Yield to Emergency Vehicle, Improper Lane Use and No Drivers' License.

OUTCOME: We could not find any other Missouri arrests or citations against Gomez-Ortega. On January 9, 2025 Gomez Ortega with a lawyer pled guilty to DWI and was

placed on a 2-year SIS (no fine, no points, no permanent record) probation. He also pled guilty to No Drivers' License and was fined \$191. The Town and Country prosecutor reduced the Improper Lane Use charge to a Parking Violation with a \$191 fine.

DRUNK DRIVER STOPPED AFTER WEAIVING ON I-64 AND I-270 REFUSES TO TAKE BREATH TESTS, A PATTERN OF HIS.

On Friday night into Saturday at 1:19am on 10/09/21 Town and Country Officer Eric Diaz was east on I-64 and saw the driver of a 2009 Audi SUV weaving lane to lane and then on the shoulder.

As the vehicle exited to NB I-270 the driver continued to weave and fail to signal lane changes. Officer Diaz stopped the driver on NB I-270 just passed I-64. When Officer Diaz walked up to the Audi he could smell booze on the breath of the driver, **Robert W Govero**, 51, of Maryland Heights. Officer Diaz told Govero that he could smell alcohol on his breath and asked how much he had to drink. Govero claimed 2-glasses of win on a date. He added that he was weaving because he was "texting" his date.

Govero agreed to take field sobriety tests which he badly failed. This is from the police report:

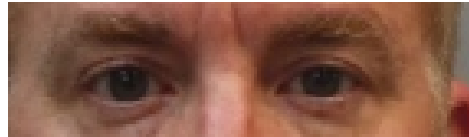
Govero also refused to take a field breath test. He was then arrested for DWI.

At the police station Govero refused to be interviewed or to take an OFFICIAL BREATH TEST. This was the fourth time Govero had been arrested for DWI and refused to take a breath test.

This case was originally filed in City Court but moved to State Court on 08/11/22.

OUTCOME On June 9, 2023 Govero pled guilty in State Court to DWI and was placed on a 2-year SES probation term in lieu of 6-months jail and was ordered to install an alcohol interlock device on his car and attend DWI programs and pay T&C Police \$146 in costs of his arrest.

DRUNK DRIVER WHO WAS A BARTENDER CLAIMED HE HAD NOTHING TO DRINK. FACTS SAID OTHERWISE

On Saturday night into Sunday Morning at 3:16am on December 10, 2023 Town & Country Police Sgt. Freddie Yaakub was westbound on I-64 at Mason Road when he saw a car in his rearview mirror speeding well over the speed limit.

The rear radar on Sgt. Yaankub's patrol car showed the car was doing 90mph in the 60 zone. The Subaru was still speeding when the driver passed Sgt. Yaakub, who then followed the car watching the driver weave from lane to lane.

Sgt. Yaakub stopped the car on the WB Hwy I-64 exit to Timberlake Parkway in Chesterfield. Sgt. Yaakub had to contact the driver and tell him to pull to the right.

Sgt. Yaakub found there was an odor of alcohol in the car and on the driver's breath. The driver, Alex Graville, 28, of O'Fallon, Mo said he is a bartender at the St. Louis Club. Graville apologized for doing 90 mph and said he thought he was only doing 75 mph (which is 15 mph over the limit. He said he was weaving because he was on his cellphone.

Graville denied having anything to drink on the street. That would change at the Police Station. This is from Sgt. Yaakub's report:

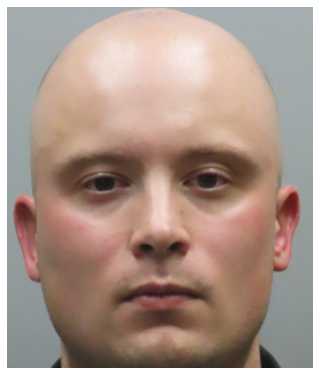

Despite claiming that he had nothing to drink, Graville refused to take a field breath test.

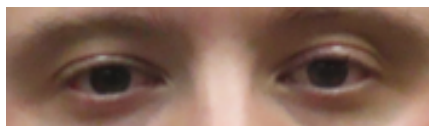
He failed field sobriety tests and was arrested for DWI, Speeding 90-60 and Lane Weaving.

At the Police Station Graville agreed to take an "Official Breath Test" that showed he had been drinking and had a BAC level of .103%.

He agreed to be interviewed and now admitted drinking saying he had 3-Old Fashions in an hour after the St. Louis Club closed, drinking with other employees. However despite 3-Old Fashions in 60 minutes and the BA test result he did not consider himself intoxicated.

OUTCOME: Alex Graviile was represented by Chris Graviile, the City Attorney in Chesterfield and the Prosecutor in Ballwin and Lake St. Louis, the City Judge in Glendale and Oakland. This might be a shock but Alex Graviile left Town and Country Court with no points on his driving record. The DWI was a SIS (no points, no fine, no jail) probation term. The Speeding 90-in-60 zone was reduced to a Parking Violation with a \$191 fine. The weaving charge was also turned into a Parking Violation with a \$191 fine. This is another case in City Court of a defense attorney coming before the safety of the public or the hard working police officers dealing with drunk drivers.

VERY DRUNK DRIVER DROPPING “F BOMBS” WEAVING ONTO THE SHOULDER AND REFUSING TO DO ANY SOBRIETY TESTS. Town & County Police Officer Daniel Duddleston was working the Afternoon Shift on Thursday December 1, 2022. He was driving his patrol car at 7:16pm north on Hwy 141 south of Conway Rd. when he saw a Acura in front of him swerving onto the right shoulder and then swerving to the left across two lanes and then partially onto the left shoulder barely missing another car.

Officer Duddleston turned on his flashing lights and siren to stop the car. Finally the driver stopped in the left turn lane at Brooking Park Drive, but before Officer Duddleston could get out of his police car, the driver took off at high speed.

The driver finally stopped at Ladue Road, partially blocking the right lane of Hwy 141. Officer Duddleston contacted the driver, David Jerome Green, 49, from Ballwin. It was clear to Officer Duddleston that Green had been drinking and was drunk and had vomited on himself.

This is from his report:

I contacted the white male driver on the driver's side of the Acura. I immediately detected a strong odor of intoxicants and vomit emitting from the vehicle. I also noticed the driver's eyes were bloodshot and glassy.

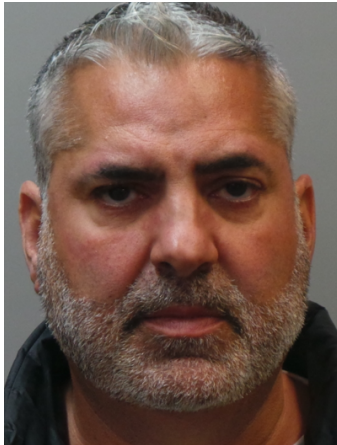

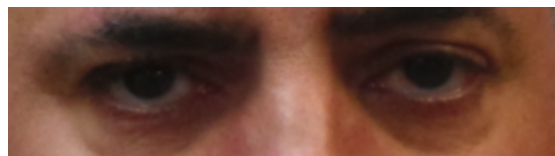
When told to step from his car, Green repeatedly said he would not causing Officer Duddleston to tell him he would be arrested for Resisting Arrest. Green finally stumbled out of the car and had to hold onto the car to keep from falling. Green refused to do any field sobriety tests or take a field Breath Test. He was then arrested.

Officer Duddleston noticed that Green's knuckles on his left hand were swollen and bleeding. Green said he fell down while at the Hive bar in Creve Coeur. He also said he fell because he was in an altercation with some patrons at the bar.

During booking at the police station Green began dropping a number of "F Bombs" in the direction of Officer Duddleston. He also refused to take an Official Breath Test.

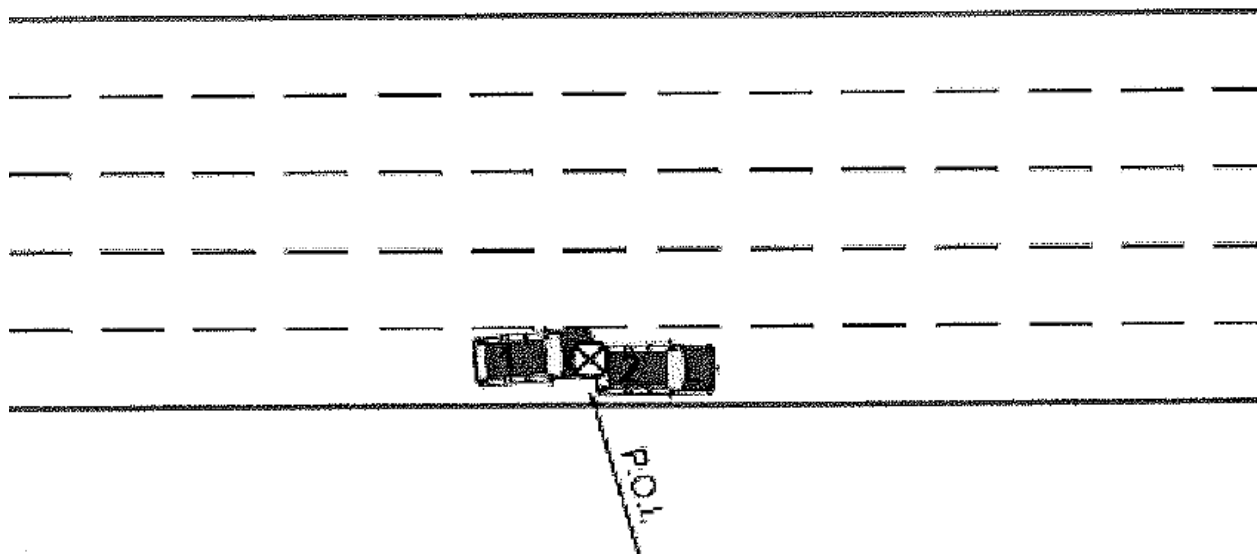

OUTCOME: Mr. DWI Defense Attorney, Travis Nobel, represented Green. The DWI was dropped to a Parking Violation with a \$191 fine. The Improper Lane Use charge was first dropped to Fail to Signal and then dropped to a Parking Vio with a \$181 fine.

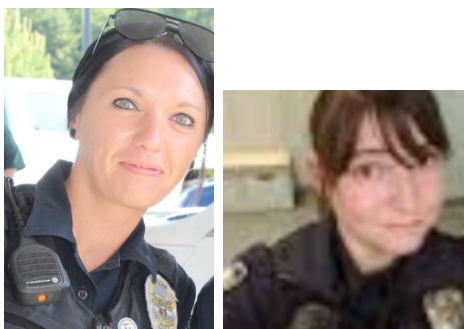
DRUNK DRIVER COMING HOME FROM A WEDDING RECEPTION REAR ENDS A CAR ON I-64 NEAR MASON ROAD AND FLEES.

At 8:49pm on Saturday night November 25, 2023 **Karen Ann Greiner**, 44, of Creve Coeur was driving home in her Jeep Cherokee, from a wedding reception in St. Charles. On I-64 near Mason Road she rear ended a 2016 Toyota Highlander in the right lane. She briefly stopped but then fled the scene followed by the owner of the Toyota, who was calling 9-1-1.

The victim followed Greiner, off of I-64 to the parking lot of the Parkway NE Middle School on Coeur De Ville Drive in Creve Coeur. A Creve Coeur officer responded and detained Greiner. Town & Country officers Lauren Wolfe and Corey Gassier arrived a short time later.

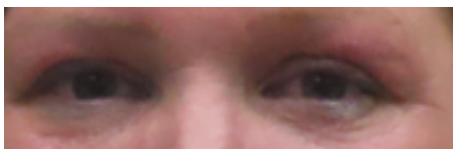
Gassier contacted Greiner, who told her she was afraid to stop on the interstate after the crash. When asked she stated she had 5-beers at the wedding reception. That would later charge to something stronger in an interview at the police station. Her eyes were bloodshot and breath smelled strongly of booze.

Greiner failed field sobriety tests and agreed to take a field breath test that was more than double the legal limit at .177% BAC. She was arrested by Officer Gassier while Officer Wolfe completed the crash report. Wolfe found an open 750ml bottle of Tequila on the floor.

At the police station Greiner's BAC level was dropping slightly to .169%. In an interview Greiner stated she thought she was intoxicated. The 5-beers she claimed she had earlier changed to 5-White Claw Vodka-soda.

OUTCOME: Greiner hired DWI defense attorney Travis Noble, who most prosecutors and judges are afraid of. On 09/19/24 Greiner pled guilty to DWI and Leaving the Scene of a Crash. On both charges she was given 2-year SIS (no fine, no points and permanent record) probation terms.

WELL KNOWN SHOPLIFTER RETURNS TO TOWN AND COUNTRY HOME DEPOT TO STEAL.

Anthony Hafer, 60, of St. Peters, is a well known shoplifter at Home Depot stores with his photo on Home Depot security websites. On Tuesday September 14, 2021 he decided to go the Town and Country Home Depot on Manchester Road.

A security agent recognized him immediately after he entered the store through the Lumber Department. The agent watched Hafer put on his COVID face mask after entering the store, then watched as Hafer went to the Tool Department. Hafer took a \$119 Milwaukee Replacement Battery cut off the security device and stuff the battery down the front of his pants.

He then walked out of the store followed by the Security Agent, who called out, "Hey Tony." This caused Hafer to say, "Awe shit!" He gave up the Milwaukee Battery, but refused to go back into the store with security. He got into a nearby Toyota Tacoma and drove off the lot. The Town and Country Police were called and one officer looked for the vehicle without any luck.

Hafer was identified and entered into the Police Computer System with an "Arrest Order."

On 10/17/21 he was arrested as a Fugitive from Town and Country by the Maryland Heights PD. At the T&C Police Station Hafer said he did not remember stealing anything at Home Depot. Hafer said he was stealing from Home Depot stores "due to hard financial times." He then remembered the stealing by saying he gave the battery back thinking it would make him look good in front of a judge.

OUTCOME: Despite his record the Town & Country Court let Hafer off with a slap on the wrist. The case was filed in Municipal Court. On 02/08/24 he pled guilty and was sentenced to 1-day in jail and given credit for the day he was in jail prior to court after his arrest for Failure to Appear.

THE RETURN OF ANTHONY HAFER: On February 6, 2024 at 2:28 in the afternoon Hafer returned to the Town & Country Home Depot store. His actions were a repeat of his 2021 visit to the store. He was exceptionally stupid as he was known as a thief by the staff and security officers at the store.

If anything Hafer is consistent. He was seen stealing a dual pack of Milwaukee Batteries valued at \$229. He left the store and entered a red Toyota Highlander as a passenger.

Sgt. Chris Moore and Officer Ross Sheridan responded. Sgt. Moore went west on Manchester where the Highlander fled. He found the vehicle in the parking lot of Walmart in Manchester. As he watched from a distance he saw Hafer walk across the parking lot and entered the Highlander.

Officer Sheridan was assisting now. Sgt. Moore had noticed at first that Hafer was bent over and could not be seen. Hafer was ordered out of the car. A search of the car revealed the stolen Milwaukee batteries were under the passenger seat.

The driver of the Toyota, that was unregistered with illegal license plates was: Michael Kopp 49. He said that Hafer asked him to drive him to some stores so he could steal. It seemed like Kopp was the “wheel man” and an active participant in the theft, but he was released

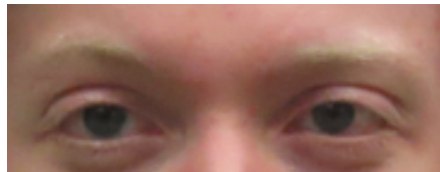
