**DRUNK DRIVER CLAIMS HE WASN'T DRINKING DESPITE 2 OPEN BEER CANS ON CENTER CONSOLE.** Town and Country Officer Ryan Schneider was on the midnight shift on Saturday night into Sunday. At about 12:30am July 23, 2023 he was westbound on I-64 and noticed the driver of silver Ford Pickup truck in front of him swerving from lane to lane.

He pulled the driver, Jonathan Mac Harris, 27, of O'Fallon MO, over and upon contacting him smelled a strong odor or BOB (booze on Breath), that Harris' eyes were bloodshot and his speech was slurred. Harris denied having had anything to drink. His drivers' license was suspended from an earlier DWI arrest.

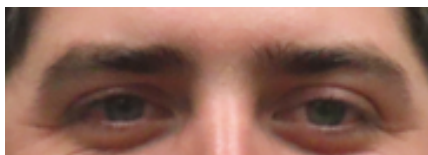
Harris was able to recite the alphabet "D-R" but could not tell Officer Schneider how many quarters were in \$2.75 of quarters saying, "math was not my strong suit."

Harris refused to perform any field sobriety tests or to take a field breath test to prove he had not been drinking. He said, "I have always been told not to do it (field tests) whether I have been drinking or not." Officer Schneider found two open partially filled cans of Busch Beer Light in the center console cup holder.

Harris was arrested, transported to the police station and issued citation for DWI, Open Container (alcohol) and Driving While Suspended. His pickup truck had been towed. His wife was called and picked him up.

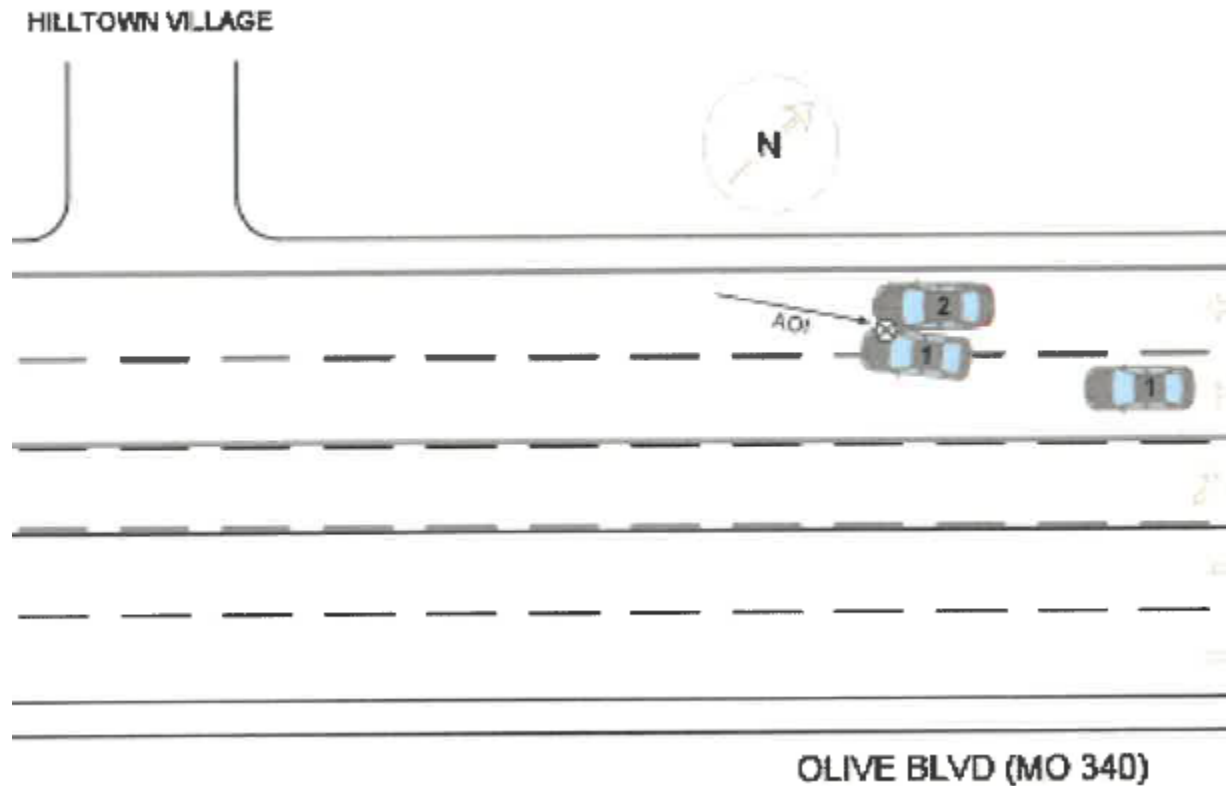

**OUTCOME:** On 10/17/24 Harris Pled guilty to DWI and was placed on a 2-year SES (Suspend Execution of Sentence meaning the guilty plea and charge stays on his record) Probation Term. He was also fined \$466 on the DWI charge. He was also fined \$466 for Driving While Suspended. While on probation on May 11, 2025 he was arrested for DWI in Cottleville, Mo/ He now has four DWI arrests in 3 years.

**DRIVER WHO CAUSED CRASH ON OLIVE AND HILLTOP VILLAGE TESTED .00 ON BREATH TEST BUT WAS VERY HIGH ON DRUGS.** It was 3:53pm on Thursday Afternoon September 6, 2018 when Chesterfield Police Officer Matt Adams was dispatched to an auto accident on Olive Blvd and Hilltop Village.

When he arrived the driver of a 2014 Honda, Darren Nauert, stated he must have "dozed off" when he drove into the side of a 2018 Honda CRV in the curb lane on Olive.



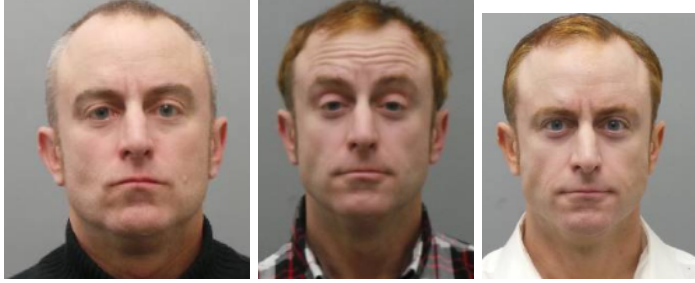
Nauert seemed to be impaired and failed field sobriety tests. But he tested for no alcohol on a breath test.

He was arrested and after booking taken to St. Luke's Hospital for a blood draw.

On September 25, 2018 the blood results came back. Nauert was almost a human pharmacy with all the drugs in his system. This is from the report:

**The report showed the blood tested positive for Morphine, Codeine, Fentanyl, Amphetamine, Methamphetamine, Diazepam, Nordiazepam, Temazepam, Oxazepam, Sertraline, and Diphenhydramine.**

His prior DWI convictions are no longer available for public view but are available to police.

**OUTCOME:** On 06/22/22, four years after his arrest, he pled guilty to Felony DWID in Assoc Circuit Court and was placed on a SES probation term meaning the points were on his license. The Fail to Exercise the Highest Degree of Care was reduced in City Court to a Parking Violation with a \$198 fine.

**WEAVING DRUNK DRIVER HAS A HARD TIME SAYING THE ALPHABET THEN REFUSED BREATH TESTS WHILE CLAIMING HE IS SOBER.** It was the prime time for drunk drivers, a Saturday night into Sunday at 1:40am (12/8/24). Town and Country Officer Ryan Schneider was WB on I-64 approaching Hwy 141 (Woods Mill Rd) and watching the driver of a Jeep weaving. The Jeep exited onto SB 141 and Officer Schneider used the patrol car's flashing lights and siren to stop the Jeep prior to Clayton Road.

When Officer Schneider contacted the driver, James D. Harter, 26, of Ballwin, it was clear that Harter was drunk. This is from the police report:

The routine verbal test of citing the alphabet from E-to-R was a good example of how drunk Harter was:

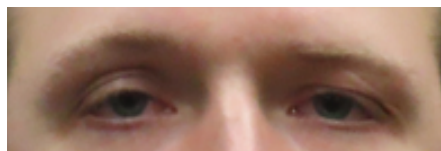
Next, I asked Harter if he was familiar with the alphabet, and he stated "Yes." I then asked Harter to recite the alphabet from "D-R" without singing. Harter recited the test as follows: "E,F,G,D,E,F,G,H,I,J,K,L,M,O,N,P,Q,R,S,T,U,V,W,X, sorry when did you ask me to stop?" I then explained the test for a second time and Harter

After failing balance tests Harter was asked if ZERO was sober and 10 was vary drunk, where would he rate himself. "He said "Zero" and added that he was sober.

He was given a chance to prove it by taking a Field Breath Test. He refused. He was arrested for DWI. At the police station he refused to take an official Breath Test or be interviewed.

**OUTCOME:** On 09/04/25 Harter pled guilty to DWI and was placed on a 2-years SIS Probation (No fine, No Points, No permanent record) Term. He also pled guilty to Weaving and was fined \$191.

(Ryan Schneider came to Town and Country from Ellisville PD. In the first of 2025 he left T&C to go to Maryland Heights PD.)

**NEAR CLOSING TIME THIEF FROM FLORISSANT ARRESTED AT CHESTERFIELD HOME DEPOT WITH A LOT OF LOOT:** Chesterfield Police on Thursday October 10, 2019 at 9:22pm were dispatched to the Home Depot store for suspicious person apparently stealing merchandise. On arrival officers were advised a thin white/male wearing a St. Louis Blues sweatshirt had been in the store 45 minutes, opening packages and stealing contents.



Officers waited outside and stopped the suspect, Mark Patrick Muehling, 30, of Florissant. On him was

Item 8: MILWAUKEE FASTBACK SPRING ASSISTED FOLDING KNIFE.

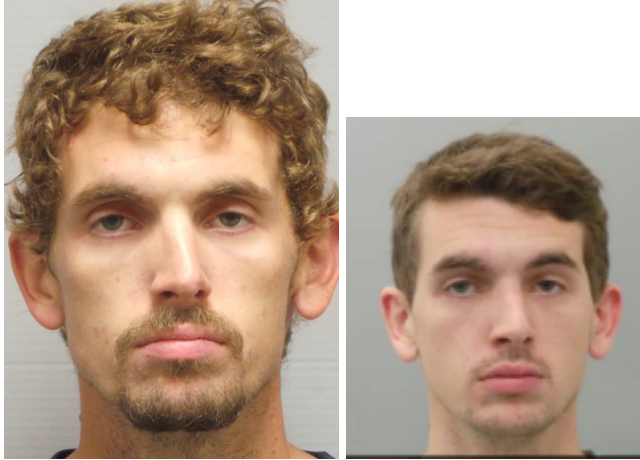

It was later determined that he had more items stolen from Home Depot in his car. Those items were:

Item 1: Dewalt 20-VOLT MAX XR CORDLESS BRUSHLESS HIGH TORQUE 1/2 IN. IMPACT WRENCH W/ DETENT PIN ANVIL, BATTERY 4.0A.

Item 2: Dewalt 1400 PEAK AMP JUMP STARTER WITH DIGITAL COMPRESSOR.

The total of stolen property recovered was \$492.60.. Despite having prior criminal charges, Muehling was released on a citation, instead of requiring a bond.

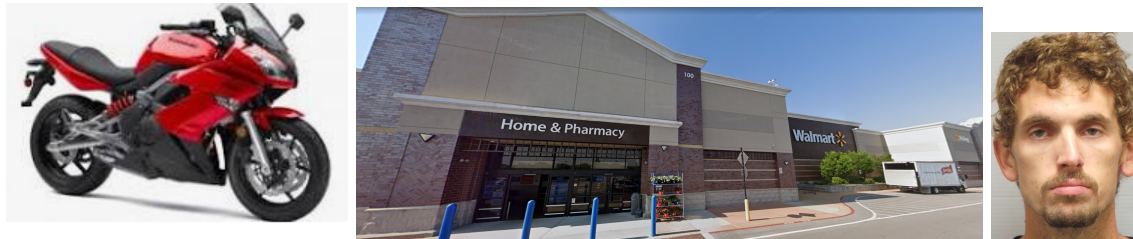
**OUTCOME:** Muehling failed to appear, a warrant was issued and he was arrested in St. Charles. Instead of taking custody of Muehling another court date was issued. On 07/28/21 he pled guilty to Stealing and another charge from 2020. He was sentenced to 10-days jail.



**THE RETURN OF MARK PATRICK MUEHLING, THIS TIME STEALING AT WALMART.** On Sunday June 7, 2020 Muehling returned to Chesterfield on a stolen 2009 Kawasaki motorcycle. This time he was at the Walmart store in Chesterfield Valley, where he had entered the store and stole a single package of two headlight bulbs.

He returned to the stolen motorcycle, installed the headlights and then discovered he could not find the key to the motorcycle. (The motorcycle was stolen out of St. Charles and had an Illinois license plate registered to a Suzuki motorcycle.)

Muehling went back into the store to look for the key. Walmart security trying to be helpful searched the store's video and discovered Muehling had stolen the headlights. They then called the police.



Officers found Muehling with the stolen motorcycle. When confronted with the theft of the headlights, he claimed he left them in the store in a trash can. The outside Walmart security video said otherwise. Muehling was told to get off the motorcycle. He then refused to put his hands behind his back to be handcuffed by Officer Steber. He resisting being arrested and his hands hand to be forcibly place behind his back. At the police station he gave a false name, but provided his real name as officers were about to identify him through computer images.

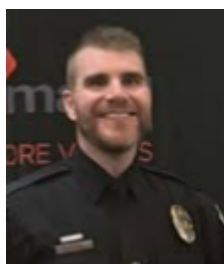
Walmart later declined to prosecute. The stolen motorcycle was towed off the lot.

Muehling was charged with Resisting Arrest and Making a False Declaration (fake name).

**OUTCOME:** The 2019 Stealing charge from Home Depot was still pending. On July 28, 2021, a short time before he was to go to prison on drug and theft charges, Muehling pled guilty to all the Chesterfield charges and was sentenced to 10-days jail.

**DRUNK DRIVER PULLS OUT FROM BAR BEHIND POLICE CAR AND STARTS WEAVING.** On Saturday night November 18, 2023 Town and Country Police Officer Zach Dorton was on S. Woods Mill Road when a 2022 Ford Edge pulled out of the strip

center where Dave's Famous Bar was located and was directly behind his patrol car. Dorton immediately noticed in his rearview mirror that the driver was weaving.

Officer Dorton pulled to the right and let the Ford pass. He then began to follow the Ford onto EB I-64 where he saw the driver weave twice more, when he stopped him.

He contacted the driver, Christopher Hartmann, 48, of Brentwood. It was clear to Officer Dorton that Hartmann had been drinking and was intoxicated. When asked if he had anything to drink, Hartmann said he had "one cocktail." Officer Dorton then pointed out the strong smell of booze coming from Hartmann's breath and the inside of the car, plus his eyes being red and speech slurred. Hartmann then changed the "one cocktail" to "cocktails."

Once outside of his car Hartmann was asked if he would do Field Sobriety Tests. His reply was "Why would I want to do that." Officer Dorton did give him some verbal sobriety tests which he failed. He was then arrested for DWI.

At the police station Hartmann did a 180. He agreed to take a breath test. The result showed he was more than 3x over the limit, testing at .241% BAC.

In an interview Hartmann admitted he thought he was intoxicated and had a drink every 30-minutes between 5:30 and 7:40 pm at Dave's Bar.

**OUTCOME:** Officer Dorton only issued a warning to Hartmann for weaving. On 01/18/24 Hartmann pled guilty to DWI and was placed on a 2-year SIS (no fine, no points, no permanent record) probation.

### **SIX BEERS AT A BIRTHDAY PARTY AND THEN DRIVING ACROSS THE CENTER LINE WILL GET YOU ARRESTED:**

It was Saturday night into Sunday morning on 02/23/20 at 12:48am. Chesterfield Officer Brandan Steber was on patrol in the area of Clarkson Road and Baxter when he observed a black Chevy Silverado weaving. He saw the Silverado turn onto NB Baxter Road and continue to weave but now weaving onto the shoulder. He immediately stopped the car.

Officer Steber contacted the driver, **Christian A. Munguia**, 39, from Little Rock, Arkansas. There was also a female passenger in the car. Officer Steber could smell plenty of BOB (booze on breath) from inside the car. This is from the police report.

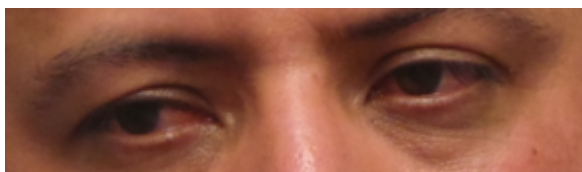

When asked if he had anything to drink recently, Munguia said he had five or six beers.

Munguia failed field sobriety tests, but agreed to take a field breath test. The result showed a BAC reading of .110%. He was then arrested for DWI. At the Chesterfield Police Station he agreed to take an “official” breath test. That test showed his BAC level was dropping, but he was still intoxicated at .100% BAC.

In an interview Munguia said they had been at a friend's birthday party. When asked if he had anything to drink, he replied, “Just six beers.”

He was charged with DWI and Improper Lane Use.

**OUTCOME:** Despite having a prior DWI arrest on 02/23/23 Munguia pled guilty to DWI and was placed on another SIS probation. The Improper Lane Use charge was **reduced to a Parking Violation with a \$191 fine.**

### **32-YEAR OLD FROM SHREWSBURY IS SEEN STEALING EXPENSIVE SHAMPOO AT HAIR SALON AND THEN DENYS HAVING IT WHEN LEAVING.**

On Tuesday March 12, 2024, Kelly Hebron, 32, came to the Ginger Bay Salon in the Town and Country Center, for an appointment. Before being called into the salon she walked around the lobby, stopped and placed a \$109.50 bottle of Lanza Shampoo in her purse. The theft was witnessed by an employee and was on store video.



At the end of Hebron's appointment the salon's manager asked her to give back the shampoo. Hebron denied stealing it and the manager then asked if she could look in Hebron's purse. Hebron said "No" and zipped the purse up and walked out of the store. The manager followed her and wrote down the license number on Hebron's blue Mazda, she then called the T&C Police.

Officer Ryan Schneider responded. He obtained Hebron's phone number since she was a regular customer at the salon. He then called her and asked her to come to the Town and Country Police Station.

She arrived that afternoon and at first denied the theft, but when told there was an employee who witnessed the theft and it was on video, she admitted stealing the shampoo, that was never returned. She was issued a citation and released.

**OUTCOME:** On 01/23/25 Hebron and her attorney appeared in T&C Muni Court. The stealing charge was reduced to Littering with a \$466 fine.

**DRUNK DRIVER PASSED OUT BEHIND WHEEL OFF SHOULDER INTO THE GRASS IS CONVICTED OF A PARKING VIOLATION.** On Saturday night into Sunday morning at 2:34am 12/19/21 Chesterfield Officer Austin Ramsey and Domenic Hoffmeister were dispatched to a drunk driver passed out behind the wheel of his car on North Forty Drive at Timberlake Manor.

On arrival a Town and Country Officer was already on the scene. The drunk driver, Dillian T. Mulverhill, 24, from Wentzville, was in his 2017 Chevrolet Cruz beyond the shoulder of North Forty Dr, in the grass. In the center of the front seat area in cup holders were two open cans of beer.

Mulverhill badly failed field sobriety tests and refused to take a field breath test. He was arrested for DWI. Officer Ramsey handcuffed him and drove him to the police station.

At the police station as Officer Hoffmeister booked him during which time Mulverhill refused to take the Official Breath Test or be interviewed. He asked to call a lawyer and as Officer Ramsey was getting him a phone he repeatedly told Officer Ramsey to "Fuck Off." During booking he told Officer Hoffmeister that Officer Ramsey was psychopath.



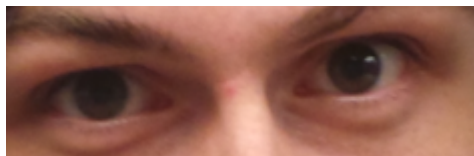

**THE MAN WANTED SHRIMP THAT SOLD \$7.88 A PACK. HE WAS ARRESTED FOR STEALING TWO PACKS AND THEN FINE \$300 FOR SHOPLIFTING.**

On Saturday April 23, 2022 just before 1pm Tracy T. Nash 48 from St. Louis was at the Chesterfield Walmart shopping. Store Security did not watch Nash shop, but a security officer was at the self-checkout to make sure all the items were scanned by shoppers.

Nash had three packages of frozen shrimp, but the security officer only saw him scan one package and hide the other two in a bag. She followed him outside and confronted Nash, along with a Chesterfield Police Officer Rouse who just arrived.

### **DRUNK DRIVER ON MASON ROAD AT 6:46PM CRASHES 3 TIMES. HIS BAC LEVEL IS .31 AND GOING UP.**

On Thursday August 10, 2023 at 6:46 Town & Country Officer Corey Gassier and Sgt. Dan Duddleston (now a Lt) responded to a one car crash on Mason at a ramp to I-64. The driver of the black 2015 BMW was, Ronnie Henley, 61, from Creve Coeuer.

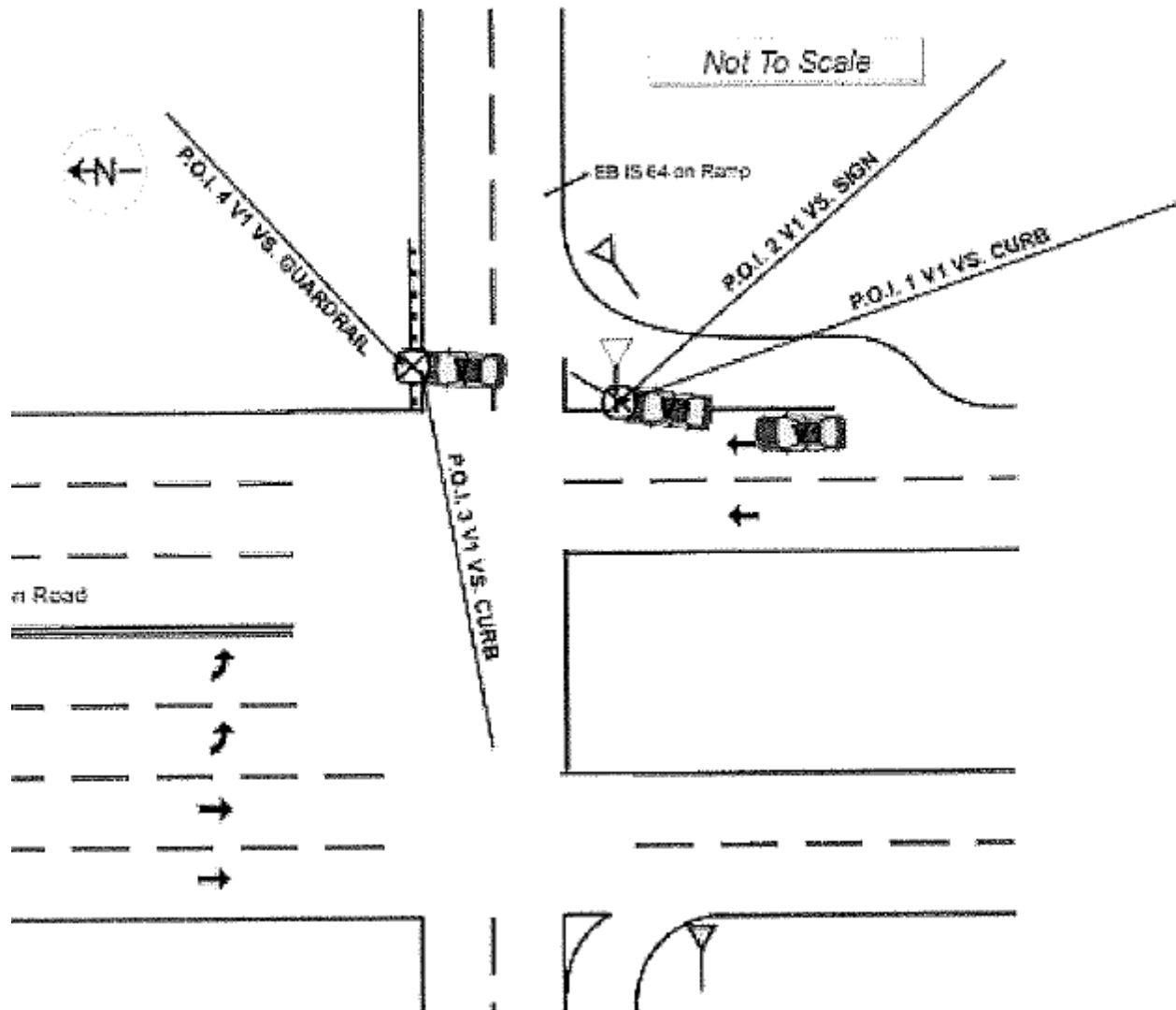
It was clear to the officers the Hanley was very intoxicated. He agreed to take field sobriety tests, some he failed and other he did not do as he did not understand the instructions. He agreed to take a field breath test. That show his BAC level at .316%. On the street before his arrest he said he had 2 beers at Hooters. That would later change

He was arrested, however due to his drunk condition and a former knee injury he could not get into the police car (but he could drive a BMW). He agreed to submit to a blood draw and an ambulance was called taking Henly to St. Johns' Hospital.

The blood test at the hospital showed that Henly's BAC level was going up. It was now at .35% BAC,

In an interviewed Henly stated he had been at Top Golf. He then again said he only had 2-beers, but then changed that to he didn't know how many beers be had between 4 and 6pm at Hooters. Despite testing 4x over the legal limit, Henely stated in the interview that he did not consider himself intoxication.

Henley was issued a citation for DWI and released at the hospital.



**OUTCOME:** Amazingly Henley did not have any prior citations or traffic arrests. On July 31, 2024 he pled guilty to DWI and was placed on a 2-year SIS (no points, no fine, no permanent record) probation by the Town and Country Court despite being four times over the limit and in a crash.

**31-YEAR-OLD FROM ST. CHARLES WAS NOT SHOPLIFTING AT LOWES, HE WAS OUT AND OUT FELONY STEALING**

It was Tuesday July 12, 2022 when Danial A. Neal, 31, of St. Charles arrived at the Chesterfield Lowes Store to steal.

Neal was a passenger in a Ford pickup truck. He was dropped off at the front of Lowes, got a cart and went to the Tool Department and started stealing. He stole the following items:

The theft was observed by the store's security manager reviewing store video. He was able to identify the thief as Dainel Neal. The Chesterfield Police were called on July 24 and provided with the suspect's name and given a copy of the video of Neal stealing.



Neal was entered into the police computer system with an arrest order.

On 07/24/22 after Neal was entered into the police computer system the ST. Charles City Police notified Chesterfield PD they were holding Neal on separate charges.

A Chesterfield Officer went to St. Charles, where Neal refused to make and statements ref the Lowes theft.

A felony arrest warrant was later issued by the St. Louis County Prosector.

**OUTCOME;** Despite Neal's lengthy felony stealing record, on 04/18/25 he Pled Guilty to the July 12, 2022 felony theft at Lowes. None of the stolen property was recovered. The St. Louis County judge place him on 4-years probation. He was later sentenced to prison on other Felony Stealing Charges in St. Charles County.
